Subject: *ORDINANCE NO. 01-2024: Adopting the City Ordinance prohibiting all business establishment in the City of Bacoor, Cavite to cater to minors during curfew hours and providing penalties for violations hereof (PNOA-503-2024) dated (May 13, 2024).*

The above-mentioned subject matter underwent first reading on May 13, 2024 during the 90th Regular Session of the Sangguniang Panlungsod. The said subject matter was referred by the Acting Presiding Officer City Councilor and President Pro-Tempore Hon. Reynaldo C. Palabrica to the Committee on Rules and Privileges, Laws and Ordinances.

The Committee on Rules and Privileges, Laws and Ordinances sent out invitations to the resource persons and conducted a committee hearing on May 16, 2024 at the Session Hall of the Sangguniang Panglungsod at 10:15 a.m.

FINDINGS:

Under Section 91 of City Ordinance No. 171-2021 also known as the "Child Protection and Development Code of the City of Bacoor" provides that the period from ten o'clock in the evening (10:00 p.m.) to four o'clock in the morning (4:00 a.m.) is hereby declared as "curfew hours" for minors all over the City of Bacoor. Minors apprehended for violating this provision shall be returned to their parents and/or guardians and the latter shall be required to pay a fine of Two Thousand Pesos (P2,500.00).

Minors are not allowed to stay within the business establishments during curfew hours. Allowing minors to stay on business establishments, owners are abetting minors to violate the afore-cited provision of law which cannot be countenanced by the City Government as it will defeat the purpose for which the said ordinance was made: to protect minors from criminals that prey upon the young at night.

BARANGAY ORDINANCE 01-2024

ADOPTING THE CITY ORDINANCE PROHIBITING ALL BUSINESS ESTABLISHMENT IN THE CITY OF BACOR, CAVITE TO CATER TO MINORS DURING CURFEW HOURS AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.

WHEREAS, Section 17 of City Ordinance No. 171-2021 (the "Child Protection and Development Code of the City of Bacoor") provides that "to be against compacted risk of a fine (ending at 1000 per 15 minutes) at the starting of 10:00 am and 10:00 hereby declared as "curfew hours" for minors all over the City of Bacoor. Minors apprehended for violating this provision shall be reported to their parents and/or guardians and the latter shall be expected to pay a fine of P5,000.00."

WHEREAS, the City Government has been zealously implementing the said Ordinance resulting of a substantial decrease in various crimes involving minors during the said curfew hours. However, it has come to the knowledge of the Sangguniang Pambayad that some internet cafes and cybernetic stores operating within the City of Bacoor which are open 24 hours are allowing minors to stay within their business premises so that they will not be seen and apprehended by city and barangay officials that are implementing the said ordinance.

WHEREAS, by allowing minors to stay within the said business establishments during curfew hours, the owners of the said businesses are basically allowing minors to evade the already existing provision of law which cannot be circumvented by the City Government as it will defeat the purpose for which the said ordinance was made, to protect minors from criminals that may harm the young citizen.

NOW THEREFORE, I, RANDY C. FRANCISCO, Punong Barangay - Barangay Poblacion City of Bacoor, do hereby adopt the City Ordinance.

Section 1. Scope and Prohibition. All business establishments operating in the City of Bacoor, Cavite which shall include but shall not be limited to convenience stores, mobile computer shops, internet cafes, coffee shops, and restaurants, are hereby prohibited from catering to, serving, and/or accommodating minors within their business premises between 10:00 pm to 6:00 am in violation of the pertinent provisions of City Ordinance No. 171-2021. The word "minors" shall refer to persons below eighteen (18) years old at the time of apprehension.

Section 2. Penalties. A fine of P5,000.00 for every minor found to have been caught, served, or accommodated by the business establishments mentioned in the preceding Section shall be imposed against the owner/s and/or manager/s of the said enterprise/s.

Section 3. Implementing Rules and Regulations. The Office of the City Legal Services is hereby directed to formulate the implementing rules and regulations of this Ordinance in light of the pertinent provisions of City Ordinance No. 171-2021, not later than sixty (60) working days upon the date of effectivity hereof, for approval of the City Mayor.

Section 4. Effectivity. This Ordinance shall take effect immediately after it has been published at least once in a newspaper of general circulation within the City of Bacoor, Cavite, and after
