
Acting on the proposed barangay resolution approving the separation of the City of Bacoor National High School Springville (CBNHSS) as an annex of Eastern Bacoor National High School (EBNHS) during the 97 Regular Session on 01 July 2024. It was referred to the committee by Sangguniang Panlungsod President Pro-Tempore Reynaldo D. Palabrica during the 91st Regular Session held on 20 May 2024 The committee chair on education, science, and technology, Hon. Alde Joselito F. Pagulayan, reports that:

The CBNHSS, located in Camella Springville West, Molino 3, City of Bacoor, Cavite, occupies a land area of less than one (1) hectare and includes three (3) buildings. Given the substantial and increasing number of students, there is a compelling need for CBNHSS to become an independent school.

FINDINGS:

During the committee hearing held on 23 May 2024, discussions focused on Barangay Resolution No. 075 Series of 2024 and the proposal to allocate open space donated by the Springville 1, 2, and 3 Homeowners Association (HOA) to the city government for establishing a separate school. The benefits of separation include an independent budget, distinct identity, and autonomous administration, which would facilitate growth and improve staffing for the school.

However, a significant barrier exists due to the land ownership issue. The property in question is under the names of either Paramount Development Corporation and/or Household Development Corporation. According to Section 18 of Republic Act No. 9904, otherwise known as the "Magna Carta for Homeowners and HOAs," HOAs must obtain the approval of the landowner or developer before any common area or open space can be transferred or donated to any entity. Thus, the consent of Paramount Development Corporation and/or Household Development Corporation is necessary for the donation to proceed legally.

RECOMMENDATION:

After thorough deliberation, the committee recommends TEMPORARILY ARCHIVING the matter due to the significant barrier posed by the land ownership issue.

The committee chair, Hon. Pagulayan convened the hearing regarding Barangay Resolution No. 075-S-2024, which seeks the approval for the separation of the City of Bacoor National High School Springville (CBNHSS) from its current annex status under Eastern Bacoor National High School (EBNHS). The hearing was attended by members of the committee, school officials, a representative from the Department of Education (DepEd), and a representative from the Office of the City Legal Services.

Hon, Buncio initiated the hearing by welcoming the attendees. The committee chair, Hon, Pagulayan clarified that the sole agenda of the hearing was to deliberate on the resolution concerning the separation of CBNHSS from the EBNHS.

Kagawad Criste provided further details on the resolution. She explained that the resolution was drafted at the request of CBNHSS and was supported by a joint resolution from the Springville West 1, 2, and 3 Homeowners Association (HOA). The resolution proposes the allocation of an open space, less than one hectare, donated by the HOA to the city government for establishing a separate school. Kagawad Criste emphasized that the separation would bring several benefits, including an independent budget, a distinct identity, and autonomous administration for CBNHSS.

Mr. Sarabusao supported the resolution, highlighting the operational and administrative challenges of managing the CBNHSS as an annex. He underscored that the separation would enable the school to grow and improve its staffing, including appointing a financial officer and additional teachers.

Mr. Mojica discussed the City Ordinance No. 8 Series of 2015, which established CBNHSS as part of the city's secondary schools. He clarified that CBNHSS was not technically an annex of EBNHS. He pointed out that one of the major obstacles to formalizing the school's establishment was the issue of land ownership, as the property was under the name of the Paramount Development Corporation and/or Household Development Corporation, and the HOA's were not in a position to donate the said lot (open space less than one hectare).

Atty. Mendoza elaborated on the legal challenges, noting the need for legislative action to address the land ownership issue before proceeding with the resolution. Despite the benefits of the resolution, the lack of clear ownership documentation for the school site posed a significant barrier.

The discussion concluded with a consensus on the necessity of addressing the land ownership issue through legal and legislative means. The committee agreed to continue working on the resolution, recognizing its potential benefits for the community and the necessity of meeting DepEd's requirements for establishing independent schools.

Further, Hon. Pagulayan committed to discussing the said resolution in the upcoming Local School Board (LSB) meeting and proposed a follow-up meeting in the coming week with Atty. Mendoza and with Kagawad Criste to resolve the outstanding legal issues.


