Subject: BARANGAY SK KAINGIN DIGMAN RESOLUTION NO. 007 - SERIES OF 2024: A RESOLUTION APPROVING THE SANGGUNIANG KABATAAN (SK) OF BARANGAY KAINGIN DIGMAN ANNUAL BUDGET FOR CY 2024 AMOUNTING TO EIGHT HUNDRED SIXTY-EIGHT THOUSAND FOUR HUNDRED SEVENTY-SEVEN PESOS AND TEN CENTAVOS (PHP868,477.10) - PNOA 556-2024 dated July 15, 2024

Referred to this Committee on the 99th Regular Session is the above-subject matter for appropriate action and recommendation.

Section 329 of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991", provides that, and we quote:

"SECTION 329. Barangay Funds. – Unless otherwise provided in this Title, all the income of the barangay from whatever source shall accrue to its general fund and shall, at the option of the barangay concerned, be kept as trust fund in the custody of the city or municipal treasurer or be deposited in a bank, preferably governmentowned, situated in or nearest to its area of jurisdiction. Such funds shall be disbursed in accordance with the provisions of this Title. Ten percent (10%) of the general fund of the barangay shall be set aside for the sangguniang kabataan."

While the Sangguniang Kabataan is financially independent in its operations, disbursements, and encashment of its funds, income, and expenditures the Committee adheres to the provisions of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 10742, as amended, and hereunder quoted for ready reference:

This refers to the FY 2024 Annual Budget of the Sangguniang Kabataan of Barangay Kaingin Digman involving an appropriation of P 868,477.10, passed and approved under Sangguniang Kabataan Resolution No.007 on Feb. 11, 2024 and received by this Office for review and evaluation.
