Subject: BARANGAY REAL: RESOLUTION NO. 04-2024: A RESOLUTION DECLARING THE ABANDONMENT OF THE VILLANUEVA AND REALVILLE SUBDIVISION, BARANGAY REAL, CITY OF BACOOR, CAVITE. (PNOA 572-2024 dated 05 August 2024)

Acting on the Barangay Real Resolution No. 04-2024, dated 19 August 2024. The aforementioned resolution was referred to the committee by the Sangguniang Panlungsod Presiding Officer, Hon, Rowena Bautista-Mendiola, during the 102nd regular session held on 05 August 2024.

The entire barangay council has expressed the need for the utilization and development of the Villanueva and Realville Subdivisions in Barangay Real, City of Bacoor, Cavite. This priority project is considered vital and relevant for the residents of the said subdivisions, as well as for the adjacent barangay. It was noted that there is currently no existing homeowners' association (HOA) for these subdivisions. The Council of Real has agreed to declare the abandonment of the said subdivisions.

#### FINDINGS:

During the committee hearing held on 16 August 2024, the following were discussed:

- The Department of Human Settlements and Urban Development (DHSUD) is the sole authority empowered to declare a subdivision abandoned. The legal framework emphasizes that neither the local government nor the barangay council has the jurisdiction to issue such a declaration.
- For a formal declaration of abandonment, the homeowners or residents must file a petition with the DHSUD's regional adjudicator. Essential documentation includes proof that the developer has been unlocatable for at least ten (10) years and has demonstrated no intention of completing the project.
- While the City Government and the Barangay Council can support the process by providing necessary documentation and coordinating with relevant parties, the

DHSUD must manage the initiation and adjudication of the abandonment process.

 The committee recognized the complexity of the legal process involved in declaring a subdivision abandoned. The importance of accurate and thorough documentation, as well as strong collaboration between homeowners, barangay officials, and the city government, was underscored.

#### RECOMMENDATION:

After a comprehensive evaluation, the committee recommends that the proposed resolution be ARCHIVED. The rationale for this recommendation is as follows:

Based on the legal opinion provided by the Office of the City Legal Services, the City Government of Bacoor does not have the authority to issue a Certification of Abandonment. The power to declare a subdivision abandoned and issue such certification lies solely with the Department of Human Settlements and Urban Development (DHSUD), as mandated by law. Further Action:

The committee suggests that the barangay council and the residents of Villanueva and Realville Subdivisions be guided to file the appropriate petition with the DHSUD to initiate the formal process. The city government may assist in this effort by facilitating communication and providing any necessary documentation to support the petition.

The hearing of the Committee on Housing, Land Utilization, and Urban Development was called to order by Hon. Pagulayan. The Chairperson recognized the members of the committee and various representatives. The Chairperson introduced the agenda item, Barangay Resolution No. 04-2024, a resolution declaring the abandonment

of the Villanueva and Realville subdivision in Barangay Real, City of Bacoor. The Chairperson invited the resource persons to identify themselves and state their offices.

The resolution sought the abandonment of the Villanueva and Realville subdivision due to the failure of the developer to complete the project, as a clamor for utilization and development has risen among the residents.

Atty. De Leon explained the legal framework surrounding the abandonment of subdivisions. He highlighted that, under current legislation, the authority to declare a subdivision abandoned lies with the Department of Human Settlements and Urban Development (DHSUD), not the city or barangay. He clarified that the homeowners of the subdivision must file a petition with the DHSUD's regional adjudicator for a formal declaration of abandonment.

The Chairperson inquired about the specific requirements for filing such a petition with the DHSUD, including the need for documentation proving that the developer has not been locatable for at least 10 years and has shown no intention of completing the project.

Atty. De Leon provided detailed steps, emphasizing that the petition must be filed by the homeowners and that the DHSUD regional office would handle the adjudication process. He also noted that once declared abandoned, the DHSUD would take over the subdivision in coordination with appropriate government agencies.

Engr. Quinatadcan and Engr. San Jose offered assistance to Brgy. Capt. Aganus in preparing the petition and organizing a meeting with DHSUD to expedite the process.

The Chairperson acknowledged the complexities of the legal process and stressed the need for accurate documentation and cooperation between the homeowners, barangay officials, and the city government. It was decided that a letter of inquiry would be sent to DHSUD to verify the existence of any registered homeowners' association (HOA) in the subdivision.

Engr. Quinatadcaan also raised the issue of the title of open spaces within the subdivision, noting that developers are responsible for the completion of promised developments and the payment of real property taxes (RPT) until they turn over these spaces to the city government.

The Chairperson concluded that the fastest and most expedient way to achieve the committee's objective—allowing city government projects to proceed in the subdivision—would be through the proper legal channels, starting with the homeowners filing a petition with DHSUD. The committee adjourned the meeting.


