



"REPUBLIC ACT No. 10742

AN ACT ESTABLISHING REFORMS IN THE SANGGUNIANG KABATAAN CREATING ENABLING MECHANISMS FOR MEANINGFUL YOUTH PARTICIPATION IN NATION-BUILDING, AND FOR OTHER PURPOSES

XXX

SECTION 20. Sangguniang Kabataan Funds. – The Sangguniang Kabataan funds shall be governed by the following provisions:

(a) All the income of the barangay derived from whatever source shall accrue to its general fund x x x. Ten percent (10%) of the general fund of the barangay shall be set aside for the Sangguniang Kabataap. The Sangguniang Barangay shall appropriate the Sangguniang Kabataan funds in lump-sum which shall be disbursed solely for youth development and empowerment purposes;" (sic)
