"REPUBLIC ACT No. 10742

AN ACT ESTABLISHING REFORMS IN THE SANGGUNIANG KABATAAN CREATING ENABLING MECHANISMS FOR MEANINGFUL YOUTH PARTICIPATION IN NATION-BUILDING, AND FOR OTHER PURPOSES

x x x

SECTION 20. Sangguniang Kabataan Funds. – The Sangguniang Kabataan funds shall be governed by the following provisions:

- (a) All the income of the barangay derived from whatever source shall accrue to its general fund x x x. Ten percent (10%) of the general fund of the barangay shall be set aside for the Sangguniang Kabataap. The Sangguniang Barangay shall appropriate the Sangguniang Kabataan funds in lump-sum which shall be disbursed solely for youth development and empowerment purposes;" (sic)

WHEREAS, the Sangguniang Kabataan would like to release of the allocated fund for "KK Assembly" amounting to fifty thousand pesos only (17,000.00) for purchasing of meals for the celebration of "Kagipman ng Kabataan Assembly";

WHEREAS, say that the Sangguniang Kabataan is undergoing on the transition processes regarding on budget transferring and disbursement of the SK ten percent (10%) fund;

WHEREAS, on the Joint Memorandum Circular No. 1 s. 2019 (JMC) released by the DOAG/PCA/EDA the province of disbursement of SK fund is same with the barangay following the rules of the Local Government Code and EDA auditing procedure;
