Referred to the Joint Committee on the 107th Regular Session is the above-subject matter for appropriate action and recommendation.

While the Sangguniang Kabataan is financially independent in its operations, disbursements, and encashment of its funds, income and expenditures, the Joint Committee anchors to the provisions of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 10742, as amended, and we quote:

"REVISED RULES AND REGULATIONS IMPLEMENTING REPUBLIC ACT (RA) NO. 10742, OTHERWISE KNOWN AS THE "SANGGUNIANG KABATAAN REFORM ACT OF 2015," AS AMENDED BY RA NO. 11768

X X X

d) The Sangguniang Bayan or Sangguniang Panlungsod shall x x x, review the annual budget and supplemental budget of the Sangguniang Kabataan on their compliance in the immediately preceding provision and other existing laws, rules and regulations. Noncompliance shall render said budgets inoperative either in whole or in part. x x x

All Sangguniang Kabataan funds derived from any source shall be stated in its financial records which shall be kept by the Sangguniang Kabataan treasurer x x x. All Sangguniang Kabataan funds shall be subject to **all existing accounting and auditing laws, rules and regulations.**"

The Sangguniang Kabataan Resolution No. 11, Series of 2024, as the basis of disbursement, complies with the existing accounting and auditing rules and regulations provided by the Commission on Audit.

WHEREAS, the Republic Act 10552 of the Sangguniang Kabataan (SK) Reform Act of 2015 under chapter 9, Section 30 (b) states that – the SK shall have financial independence in its operations, disbursements and procurement of their funds, income and expenditures, as such, the SK funds shall be deposited in the name of the SK of the concerned barangay in a government-owned bank situated in or nearest to its area of jurisdiction with the SK Chairperson and the SK Treasurer as the official signatories;

WHEREAS, the Sangguniang Kabataan Council of Barangay Aniban 2 unanimously agreed that for the continuous service of the Sangguniang Kabataan they need to request for the release of the said available fund;
