Referred to the Joint Committee on the 107th Regular Session is the above-subject matter for appropriate action and recommendation.

While the Sangguniang Kabataan is financially independent in its operations, disbursements, and encashment of its funds, income and expenditures, the Joint Committee anchors to the provisions of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 10742, as amended, and we quote for ready reference:

"REVISED RULES AND REGULATIONS IMPLEMENTING REPUBLIC ACT (RA) NO. 10742, OTHERWISE KNOWN AS THE "SANGGUNIANG KABATAAN REFORM ACT OF 2015," AS AMENDED BY RA NO. 11768

SECTION 8. Powers and Functions of the Sangguniang Kabataan. – The Sangguniang Kabataan shall:

(a) In consultation and with the concurrence of the Katipunan ng Kabataan, and within three (3) months from assumption to office, formulate a three (3)-year rolling plan, which shall be known as the Comprehensive Barangay Youth Development Plan, which shall serve as basis in the preparation of the **Annual Barangay Youth Investment Program.** x x x ;

(b) Approve the annual budget which is the annual slice of the **Annual Barangay Youth Investment Program** before the start of the succeeding fiscal year and, if the Sangguniang Kabataan funds allow, a supplemental budget. Any changes in the annual budget shall be in accordance with existing applicable budget rules and procedures;

SECTION 20. Sangguniang Kabataan Funds. – The Sangguniang Kabataan funds shall be governed by the following provisions:

x x x

d) The Sangguniang Bayan or Sangguniang Panlungsod shall x x x, review the annual budget and supplemental budget of the Sangguniang Kabataan on their compliance in the immediately preceding provision and other existing laws, rules and regulations. **Noncompliance shall render said budgets inoperative either in whole or in part.** x x x

All Sangguniang Kabataan funds derived from any source shall be stated in its financial records which shall be kept by the Sangguniang Kabataan treasurer x x x. All Sangguniang Kabataan funds shall be subject to **all existing accounting and auditing laws, rules and regulations.**"

FINDINGS:

The Sangguniang Kabataan Resolution No. 12, Series of 2024, as the basis of release of fund for free printing under its approved Annual Barangay Youth Investment Program complies with the provisions of Sangguniang Kabataan Reform Act and with the existing accounting and auditing rules and regulations provided by the Commission on Audit.

Further, the Joint Committee understood that the SK officials of Barangay Aniban 2 will strictly observe and comply with the **DILG Memorandum Circular No. 2024-061 in relation to National Youth Commission (NYC) Resolution No. 28, Ad Referendum Series of 2023, Re "A RESOLUTION APPROVING THE AMENDMENTS TO CERTAIN PROVISION ON THE GUIDELINES ON MONITORING THE IMPLEMENTATION OF THE LOCAL YOUTH DEVELOPMENT (LYDP), AND ANNUAL BARANGAY YOUTH INVESTMENT PROGRAM (ABYIP)"**, which covers all SK officials, Pederasyon Officers and LYDOs.
