(PNOA 616-2024 dated September 16, 2024).

Members of the committee met in order to call the committee meeting on 19 September, 2024 at 1:25 am. It was presided over by Chairperson of Environment and Natural Resources Hon. Levy M. Tela.

FINDINGS:

The advocacy of Barangay P.F. Espiritu 4 in "Clean and Green Campaign" must be fully implemented and enforced. The efforts of the Barangay alone are not sufficient enough in providing and maintain clean streets and sidewalks in Barangay P.F. Espiritu 4 without the help of the residents and dwellers.

The cleanliness of a barangay promotes healthy sanitation.

In compliance with R.A. 9003 also known as Ecological Solid Waste Management Program, to impose penalties for any violation and/or failure to comply with said ordinance.

All persons violating this Barangay Ordinance ("TAPAT KO, LINIS KO") shall be penalized as follows:

First Offense	Php 200.00
Second Offense	Phn 500.00
Third and Subsequent Offense	Php 1,000.00

"AN ORDINANCE REQUIRING ALL RESIDENTIAL AND COMMERCIAL ESTABLISHMENT WITHIN BARANGAY P.F. ESPIRITU 4, TO CLEAN THE SIDEWALKS FRONTING THEIR HOMES AND/OR ESTABLISHMENTS OTHERWISE KNOWN AS "TAPAT KO LINIS KO ORDINANCE" OF BARANGAY P.F. ESPIRITU 4, CITY OF BACOOR, CAVITE."

WHEREAS, the Barangay P.F. Espiritu 4 abides by "Clean and Green Campaign" must be fully implemented and enforced;

WHEREAS, the efforts of the Barangay alone is not sufficient enough in providing and maintain clean streets and sidewalks in Barangay P.F. Espiritu 4 without the help of the residents and business;

WHEREAS, the business and residents' cooperation are needed to discourage and stop the dumping of garbage outside their windows and establishments premises;

WHEREAS, the enforcement of a Barangay promoting healthy condition;

WHEREAS, in compliance with R.A. 9003 also known as Ecological Solid Waste Management Program, it is hereby ordered for any violation thereof, or non-compliance to comply with said ordinance;

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGCUNIANG BARANGAY OF P.F. ESPIRITU 4 THAT:

SECTION 2. TITLE. The Ordinance shall be known as "TAPAT KO LINIS KO ORDINANCE".

SECTION 3. It shall be the duty of the aforementioned persons to dispose of their garbage and refuse in a sanitary manner and keep their established premises or establishments premises, and the garbage collector collect them.

SECTION 4. The Barangay Ecological Solid Waste Management Council shall implement this Ordinance and provide for other implementing rules and Regulation it deems necessary for the full implementation of this Ordinance.

SECTION 5. All persons violating this Ordinance shall be penalized as follows:

First Offense	Php. 200.00
Second Offense	Php. 500.00
Third and subsequent Offense	Php. 1,000.00

SECTION 6. CITIZEN OBLIGATION.
Everyone who lives in the jurisdiction of Barangay P.F. Espiritu 4, shall have the obligation as their community or Barangay as good citizen of City of Bacoor, Cavite.

SECTION 7. It is understood that the fees collected shall be returned to the bank under the name of Barangay P.F. Espiritu 4 as Revenue.

Section 3. SEPARABILITY CLAUSE.

Any provision of this ordinance that is inconsistent with the existing law shall be repealed but the entirety of the ordinance shall remain in effect and continue to be enforced.

Section 4. EFFECTIVITY CLAUSE.

This Barangay Ordinance shall take effect after the approval of Sangguniang Panglungsod and fifteen (15) days after posting of conspicuous places within the jurisdiction of Barangay P.F. Espiritu 4, City of Bacoor, Cavite.
