

Subject: AN ORDINANCE REQUIRING ALL RESIDENTIAL AND COMMERCIAL ESTABLISHMENT WITHIN BARANGAY P.F. ESPIRITU 4, TO CLEAN THE SIDEWALKS FRONTING THEIR HOMES AND/OR ESTABLISHMENTS OTHERWISE KNOWN AS "TAPAT KO LINIS KO ORDINANCE" OF BARANGAY P.F. ESPIRITU 4, CITY OF BACOOR, CAVITE. (PNOA 616-2024 dated September 16, 2024).

Members of the committee met in order to call the committee meeting on 19 September, 2024 at 1:25 am. It was presided over by Chairperson of Environment and Natural Resources Hon, Levy M. Tela.

#### FINDINGS:

The advocacy of Barangay P.F. Espiritu 4 in "Clean and Green Campaign" must be fully implemented and enforced. The efforts of the Barangay alone are not sufficient enough in providing and maintain clean streets and sidewalks in Barangay P.F. Espiritu 4 without the help of the residents and dwellers.

The cleanliness of a barangay promotes healthy sanitation.

In compliance with R.A. 9003 also known as Ecological Solid Waste Management Program, to impose penalties for any violation and/or failure to comply with said ordinance.

All persons violating this Barangay Ordinance ("TAPAT KO, LINIS KO") shall be penalized as follows:

First Offense	Php 200.00	
Second Offense	Phn 500.00	
Third and Subsequent Offense	Php 1,000.00
