Members of the Sangguniang Panlungsod met in order to call the 110<sup>th</sup> regular session of the 5<sup>th</sup> Sangguniang Panlungsod of the City of Bacoor, at 10:30 am, on September 30, 2024. Presiding Officer Vice Mayor Hon. Rowena Bautista-Mendiola referred the subject matter to Chairperson of Environment and Natural Resources, Hon. Levy M. Tela.

**FINDINGS:**

To establish guidelines and targets for solid waste avoidance and volume reduction through source reduction and waste minimization measures, such as composting, recycling, reusing, recovering, and green charcoal process before collection, treatment, and disposal in suitable and environmentally sound solid waste management facilities. This program is systematic and comprehensive in nature.

To instruct, direct, control, and regulate the usage of recyclable waste bins on their property or within their sphere of responsibility for residents, owners of commercial and industrial institutions, hospitals, schools, churches, veterinary, medical, and private offices.

To implement standardized manufacturing, usage, and maintenance procedures for the recyclable bin. Additionally, to promote the recovery of potentially salvageable materials from solid waste for recycling or reusing in the production process, as a means of subsistence, or as a source of income.

The 110<sup>th</sup> Regular Session of the 5<sup>th</sup> Sangguniang Panlungsod started at 10:30 am on September 30, 2024. The presiding officer Vice Mayor Hon. Rowena Bautista-Mendiola referred the subject matter to the Chairperson of Environment and Natural Resources, Hon. Levy M. Tela.

Hon. Tela noticed and must be carried out that the aforementioned subject matter needs to implement to ensure the protection, preservation and conservation of the ecosystem within its territorial jurisdiction.

The provision of said Memorandum Circular No. 2018-1121 Series of 2018, further mandates that the barangay shall provide a support mechanism for segregated collection, setting up of redemption or eco-centers for non-biodegradable or recycle materials before selling in bulk to junk shops, to promote livelihood activities from waste materials, networking with private/business establishments within the barangay and microfinancing for livelihood projects from waste.

**BARANGAY ORDINANCE NO. 001, Series of 2024**

**"AN ORDINANCE PRESCRIBING FOR THE USE OF RECYCLABLE WASTE BIN IN PURSUANCE TO DILG MEMORANDUM CIRCULAR NO. 2018-112, SERIES OF 2018 AND PROVIDING PENALTIES IN VIOLATION HEREOF"**

**WHEREAS**, Republic Act No. 9003 otherwise known as the "Ecological Solid Waste Management Act of 2000", mandates a systematic and comprehensive ecological solid waste management program, sets guidelines and targets for solid waste avoidance and volume reduction through source reduction and waste minimization measures, including composting, recycling, re-use, recovery, green charcoal process before collection, treatment and disposal in appropriate and environmentally sound solid waste management facilities;

**WHEREAS**, Section 17 of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991" mandates that the barangay shall discharge the responsibilities as are necessary and appropriate, or incidental to efficient and effective provision of the basic services and facilities related to general hygiene, sanitation, beautification, and solid waste collection;

**WHEREAS**, in relation with Section 17 of Republic Act No. 7150, the Department of Interior and Local Government issued Memorandum Circular No. 2018-112 dated August 7, 2018 which provides the organization or reorganization of Barangay Ecological Solid Waste Management Committee (BESWMC) created or to be created in compliance with its preceding Memorandum Circular No. 2001-38, Series of 2001, and authorizes the Barangay to oversee the implementation of Ecological Waste Management Program, enact barangay ordinance on the establishment of awards system, sanctions and other rules and regulations to implement the program;

**WHEREAS**, the provision of said Memorandum Circular No. 2018-112, Series of 2018, further mandates that the Barangay shall provide a support mechanism for segregated collection, setting up of redemption or eco-centers for non-biodegradable or recyclable materials before selling in bulk to junk shops, to establish a system of buying and selling recyclable wastes including compost, to promote livelihood activities from waste materials, networking with private/business establishments within the barangay and microfinancing for livelihood projects from waste.

**WHEREAS**, Barangay Mambog I have fully organized its Barangay Ecological Solid Waste Management Committee (BESWMC), and is committed to strictly implement the provisions of Republic Act No. 7160, Republic Act No. 9003 and DILG Memorandum Circular No. 2018-112, Series of 2018, to ensure the protection, preservation and conservation of the ecosystem within its territorial jurisdiction.

**NOW THEREFOR, BE IT ORDAINED BY THE SANGGUNIANG BARANGAY IN SESSION ASSEMBLED THAT:**

**Section 1. Title of Ordinance** - This Ordinance shall be known as "The Use of Recyclable Waste Bin Ordinance".

**Section 2. Coverage** - This Ordinance shall apply to all individuals, commercial establishments such as restaurants, eateries, groceries, sari-sari stores, auto-repair shops; institutions like medical/dental/veterinary clinics, hospitals, schools, churches, public and private offices within the territorial jurisdictions of Barangay Mambog I, City of Bacoor, Cavite

**Section 3. Authority** - This Ordinance is enacted to implement the provisions of Republic Act No. 9003, Republic Act No. 7160 and the specific provisions of DILG Memorandum Circular No. 2018-112, Series of 2018 pertaining to Engineering (Items 5.3.10.2.1 & 5.3.10.2.2), Enforcement (Item 5.3.10.3.1) and Entrepreneurial (Item 5.3.10.4.1).

**Section 4. Purpose** - This Ordinance is enacted for the following purpose:

- a) To educate, guide, control and regulate the residents, owners of commercial and industrial establishments, medical/dental/veterinary clinics, hospitals, schools, churches, public and private offices for the use of the "Recyclable Waste Bin" within their premises or areas of responsibilities;
- b) To introduce a uniform design, fabrication, proper use and care of the "Recyclable Waste Bin".

c) Violators shall not be qualified for issuance of barangay clearance/s until he/she or the juridical entity has paid the fines and/or served the penalties herein prescribed.

For this purpose, the Barangay shall maintain a record consisting the names and addresses of individuals who committed an act in violation of this Ordinance. In the case of company/establishment, the name of the company and the personnel, whether directly hired or personnel of maintenance/security/janitorial service provider, who are fined/penalized in violation of this Ordinance shall be recorded accordingly by the Barangay.

**Section 6. Utilization of Fund Derived under this Ordinance.** The income from the selling in bulk to junk shops of recyclable wastes, particularly the plastic bottles and plastic containers, shall be considered a trust fund of the homeowner's associations in subdivisions and other private/public entities for their livelihood activities and projects from waste materials.

**Section 7. Enforcement.** The Barangay officials, members of Barangay Ecological Solid Waste Management Committee (BSEVMC), the environment aides, the president and officers of homeowner's association (HOA), the management of commercial and industrial establishment, schools and churches, and/or their designated representatives are hereby deputized and authorized to implement this Ordinance.

**Section 8. Miscellaneous Provision.** Any person or juridical entity may file an appropriate complaint in the Barangay against those who committed an offense in violation of this Ordinance. Likewise, all Barangay Mambog I residents or juridical entity are encourage to cooperate, report or call the attention of the Barangay against any person/s who committed or is committing an offense in violation of this Ordinance.

For the protection of the reporting person or juridical entity, their identity shall not be revealed. Provided, however, that the information or complaint is supported by a video or photograph which shows that the respondent/s is/are in the act of committing the violation.

**Section 9. Separability Clause.** If any provision of this Ordinance or the application thereof is declared unconstitutional by a competent court, the unaffected provisions, sections, or parts hereof shall remain effective and enforceable.

**Section 10. Repealing Clause.** All existing Ordinances and Resolutions of this barangay inconsistent herewith are hereby repealed and/or modified accordingly.

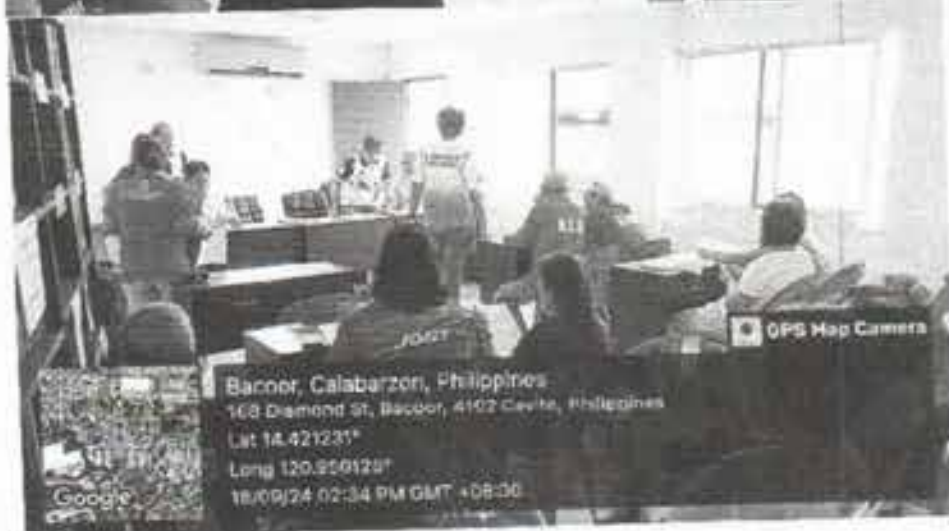

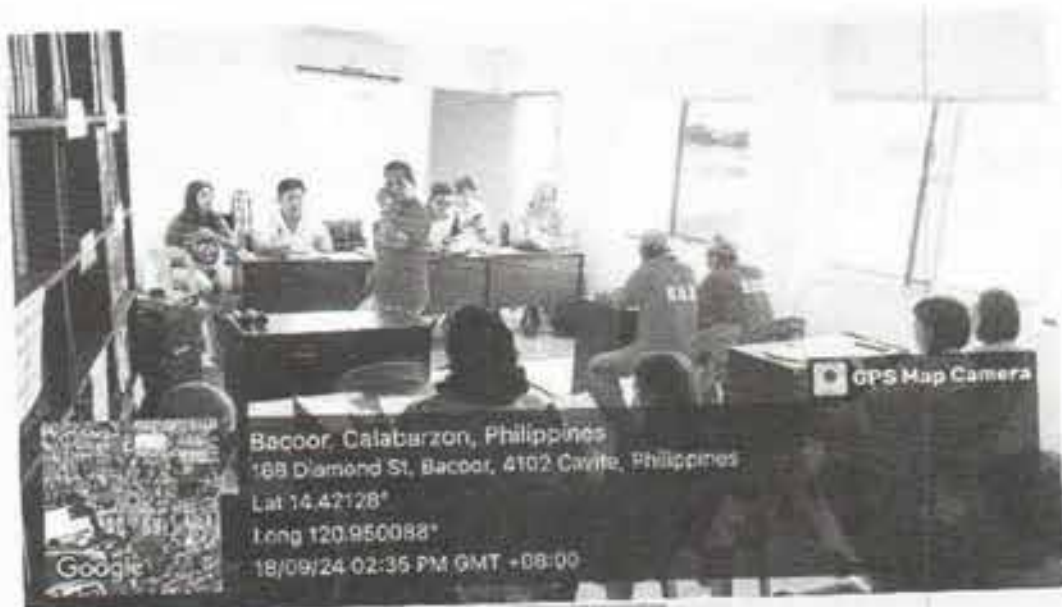

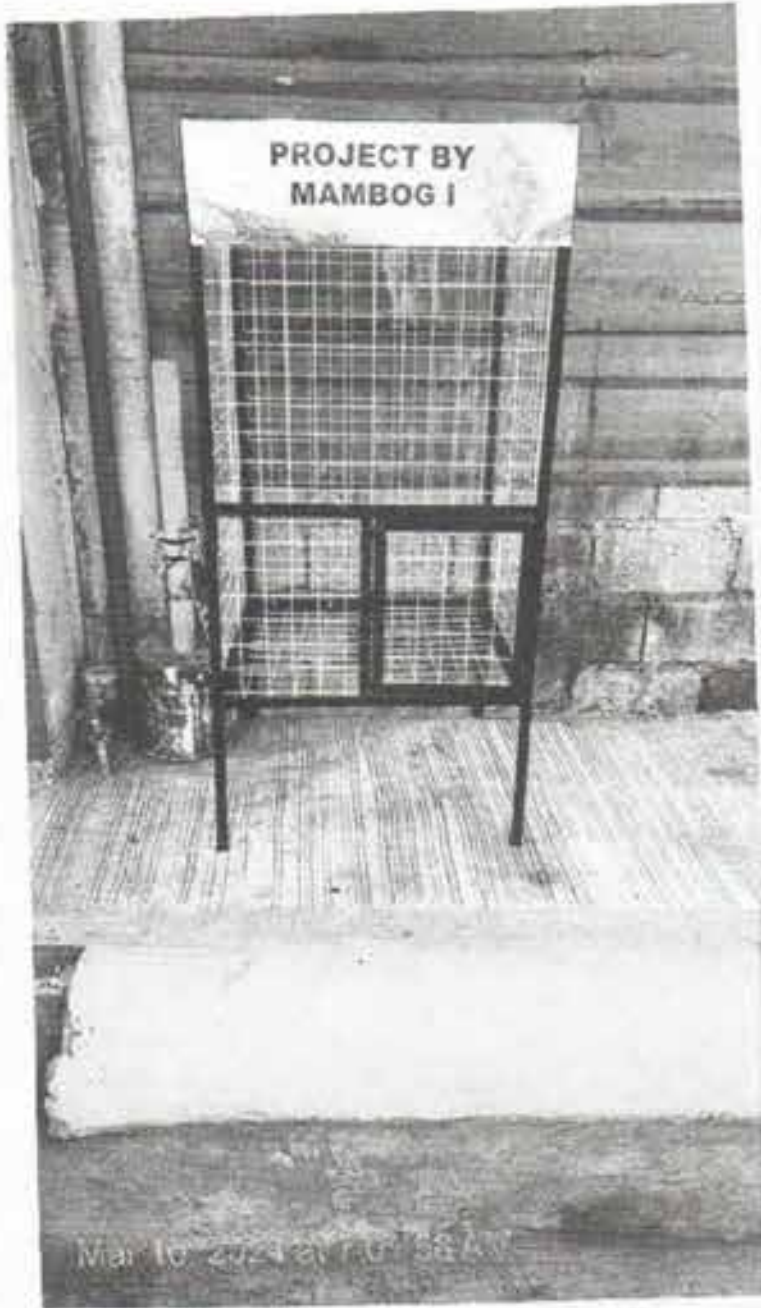

WHEREAS, Section 17 b (B) of Local Government Code of 1991, directs that barangay shall provide services and facilities related to general hygiene and sanitation, beautification and solid waste collections.

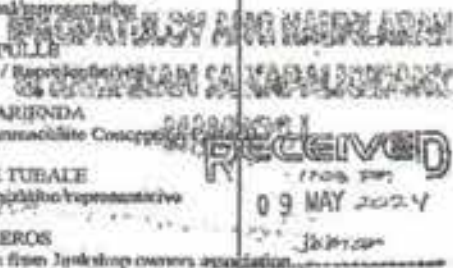

**Section 2. Functions.**

1. Formulate a community solid waste management program with the city to include education, engineering reinforcement and entrepreneurship;
2. Be responsible for the segregation and collection of solid waste specifically for biodegradable, compostable and reusable waste;
3. Establish within the barangay or cluster of barangay a Material Recovery Facility (MRF), a redemption or eco-centers in the barangay owned or leased land or any suitable open space to be determined by the Sangguniang Barangay;
4. Allocate barangay funds for the barangay ecological solid waste management program, approved by the Sangguniang Barangay;
5. Organize a Core Group/Street Coordinator to assist the BESWMC in the implementation of program and activities;
6. Conduct of trainings for the Barangay residents on segregation, Composting, recycling and Livelihood opportunities from the use of recyclable waste and to monitor their implementation;
7. Integrate the Ecological Solid Waste Management program in the Barangay Development Plan and/or Annual Investment Program;
8. Find alternative sources of funds other than the regular assess;
9. Submit a monthly report to the City ESWMB on the progress of the program, copy furnished the local DFLG Office;
10. Implement policies and plans of the following:
  - a. Education:
    - i. Develop and disseminate IDC materials on solid waste management to every household, business establishments, and other institutions in the barangay;
    - ii. Conduct of community trainings and seminars on ecological solid waste segregation, composting, reduction of waste for disposal and recycling;
    - iii. Issuance of community policies that will promote ecologically friendly products and packaging.
  - b. Engineering:
    - i. Provision of support resources for improved collection;
    - ii. Setting-up of redemption or eco-centers (MRF) within the barangay in suitable open spaces, including the use of existing rolling in bulk to public space.
  - c. Enforcement:
    - i. Enact Barangay Ordinance on the establishment of an awards systems and other incentives and sanctions in the barangay
  - d. Entrepreneurial:
    - i. Established system of buying and selling recyclable wastes including compost;
    - ii. Promote livelihood activities from waste;
    - iii. Networking with the private or business establishments within the barangay;
    - iv. Microfinancing for livelihood projects from wastes.
