Subject: FROM BARANGAY SINBANALI: BARANGAY RESOLUTION NO. 012-2024 – A RESOLUTION TO RE-ALIGN AND TO REVERT TO ORIGINAL PROPOSED PROJECT UNDER ANNUAL INVESTMENT PLAN (AIP) -PNOA 645-2024 dated September 30, 2024

Referred to the Joint Committee on the 110th Regular Session is the above-subject matter for appropriate action and recommendation.

It may be recalled that during the 107th (September 9, 2024) Regular Session of the Sangguniang Panlungsod, this Joint Committee recommended the approval of Resolution No. 010-2024 of Barangay Sinbanali on which the Barangay resolved to withdraw its two re-aligned projects and to re-allocate the funds therefor to a bigger project.

The Barangay Resolution was entitled as follows, and we quote:

"BARANGAY RESOLUTION NO. 010-2024: RESOLUTION TO WITHDRAW THE ALIGNMENT OF PROJECTS IN BARANGAY SINBANALI FROM REHABILITATION OF PATHWAY (Php500,000.00) AND INSTALLATION OF CCTV CAMERAS (Php246,950.40) TO ASPHALTING OF ROAD AT F. MIRANDA STREET, PUROK SINGUELASAN, SINBANALI, BACOOR CITY, CAVITE."


