Subject: RESOLUTION NO. 16, SERIES OF 2024 ENTITLED: "A RESOLUTION AUTHORIZING THE PUNONG BARANGAY , RANDY C. FRANCISCO TO ENTER AND SIGN INTO DEED OF DONATION AND ACCEPTANCE WITH THE CITY GOVERNMENT OF BACOOR PERTAINING TO THE DONATION OF COLLAPSIBLE TENTS." (PNOA-746-2024 dated November 20, 2024)

Barangay Poblacion has submitted *Resolution No. 16, Series of 2024*, which seeks authorization for Punong Barangay Randy C. Francisco to enter into and sign a Deed of Donation and Acceptance with the City Government of Bacoor. The resolution pertains to the formal acceptance of collapsible tents donated by the city government.

FINDINGS:

The key points in implementing this ordinance were:

1. Enhancement of Barangay Resources:

- The barangay received collapsible tents that can be used for disaster preparedness operations, relief operations, events, and outreach of the community. Barangay residents welfare and safety will be promoted with the use of resources.

2. Compliance with Legal Requirements:

- Allowing the Punong Barangay to sign the Deed of Donation and Acceptance will make the donation compliant with the law. It's very important to strictly comply with this to prevent any procedural problems and to formalize the barangay's ownership of the donations.

3. Strengthened Collaboration with the City Government:

- With the approval of the resolution, the barangay shows its strong partnership with the city government of Bacoor. This partnership encourages members to help each other out and share resources with each other as well as the community.

4. Improved Community Services:

- The collapsible tents that were donated could be used at the barangay level for events, emergency response operations, and temporary shelters during calamities.

5. Support for Disaster Preparedness:

- The barangay's disaster preparedness will benefit from collapsible tents. In emergencies, they can be set up fast to house those displaced.

RECOMMENDATION:

The committee believes that passing this resolution is essential for the following reason:

- This resolution is in the best interest of the barangay and its residents, as it enables the barangay to formalize the acceptance of a valuable donation that will enhance its capacity to deliver public services.




