Barangay Poblacion submitted Resolution No. 17, Series of 2024, requesting authorization for Punong Barangay Randy C. Francisco to enter into and sign a Deed of Donation and Acceptance with the Provincial Government of Cavite (PGC). This resolution pertains to the formal acceptance of transportation equipment donated by the PGC to the barangay.

#### FINDINGS:

The key points in implementing this ordinance were:

#### 1. Improved Mobility for Public Service:

The barangay will be better equipped to respond to community needs with the transport equipment. The multi-purpose vehicle will help in several ways including emergency response, supply transportation and support for barangay programs and services.

# 2. Compliance with Legal Requirements:

It is important to allow the Punong Barangay to sign the Deed of Donation and Acceptance in a legal manner. We need to formalize this to avoid problems in the process and for the barangay to own the donated equipment.


# Strengthened Partnership with the Provincial Government of Cavite:




