Barangay Poblacion submitted *Resolution No. 17, Series of 2024*, requesting authorization for Punong Barangay Randy C. Francisco to enter into and sign a Deed of Donation and Acceptance with the Provincial Government of Cavite (PGC). This resolution pertains to the formal acceptance of transportation equipment donated by the PGC to the barangay.

FINDINGS:

The key points in implementing this ordinance were:

1. Improved Mobility for Public Service:

- The barangay will be better equipped to respond to community needs with the transport equipment. The multi-purpose vehicle will help in several ways including emergency response, supply transportation and support for barangay programs and services.

2. Compliance with Legal Requirements:

- It is important to allow the Punong Barangay to sign the Deed of Donation and Acceptance in a legal manner. We need to formalize this to avoid problems in the process and for the barangay to own the donated equipment.

3. Strengthened Partnership with the Provincial Government of Cavite:

- Approving the resolution highlights the strong partnership between Barangay Poblacion and the Provincial Government of Cavite. It reflects the shared commitment to improving community services and addressing local needs collaboratively.
