Barangay Poblacion submitted *Resolution No. 18, Series of 2024*, which seeks authorization for Punong Barangay Randy C. Francisco to enter into and sign a Memorandum of Agreement (MOA) with St. Dominic College of Asia. The MOA pertains to the implementation of an On-the-Job Training (OJT) program, allowing students from the institution to gain practical experience through internships in the barangay.

FINDINGS:

The key points in implementing this ordinance were:
