### Barangay Resolution No. 013 Series of 2024

#### A Resolution Adopting and Implementing the Clean and Green Program for Barangay Sinbanali

**WHEREAS**, the residents of Barangay Sinbanali are committed to ensuring a safe, healthy, and sustainable environment for the present and future generations;

**WHEREAS**, the Clean and Green Program is designed to enhance environmental awareness, promote waste management practices, and foster community participation in maintaining a clean and green barangay;

**WHEREAS**, the Barangay Council of Sinbanali recognizes the importance of environmental protection and the need to act immediately to address issues such as waste disposal, deforestation, and pollution;

**NOW, THEREFORE, BE IT RESOLVED** as it is hereby resolved by the Barangay Council of Barangay Sinbanali, in session duly assembled:

#### Section 1. Creation of a Clean and Green Program.

The Barangay Council of Sinbanali shall implement a **Clean and Green Program** that aims to improve the environmental conditions in the barangay through the following initiatives:

- **Waste Segregation and Management:** Promoting segregation of biodegradable, recyclable, and non-biodegradable waste.
- **Tree Planting Activities:** Establishing annual tree planting events within the barangay and encouraging residents to plant and maintain trees in their own households.
- **Community Clean-up Drives:** Organizing regular clean-up activities, particularly in high-traffic areas such as streets, parks, and waterways.
- **Recycling and Upcycling:** Encouraging residents to recycle materials like plastic, paper, and glass, and promoting upcycling practices to minimize waste.

#### Section 2. Roles and Responsibilities.

The following offices and committees are tasked with the implementation of the Clean and Green Program:

- **Barangay Environment and Natural Resources Office (BENRO):** Oversee the program, coordinate clean-up drives, and monitor waste disposal practices.
- **Barangay Health and Sanitation Committee:** Conduct health education on proper waste management, hygiene, and sanitation. Ensure that sanitation facilities are maintained and accessible.
- **Barangay Youth Council:** Mobilize youth groups to engage in environmental activities, particularly tree planting, and organizing campaigns on environmental protection.
- **Barangay Councilor for Environment:** Serve as the local point for all environmental-related matters, ensuring that the program is effectively executed and that residents comply with established guidelines.

### Section 3. Waste Segregation and Disposal.

All residents and business establishments within Barangay Sinbanali are encouraged to implement **waste segregation** at the household and community levels. The Barangay shall provide:

- Clearly labeled waste bins for biodegradable, recyclable, and residual waste.
- A regular schedule for waste collection, with specific days for biodegradable and non-biodegradable waste.
- Information campaigns on the importance of proper waste segregation and its environmental benefits.

### Section 4. Annual Tree Planting and Green Spaces.

Barangay Sinbanali will hold an **annual tree planting event** to:

- Encourage the planting of indigenous trees within the barangay.
- Beautify public spaces such as parks, sidewalks, and vacant lots.
- Promote the creation and maintenance of community gardens to encourage green spaces and sustainable agriculture.

### Section 5. Community Engagement and Education.

The Barangay will implement the following programs to promote awareness and encourage active participation in environmental initiatives:

- **Workshops and Seminars:** To educate residents, especially the youth, on waste management, environmental protection, and sustainable practices.
- **School Partnerships:** Work closely with local schools to implement environmental programs, such as tree planting, clean-up drives, and environmental awareness campaigns.
- **Barangay-wide Competitions:** Hold contests like "Cleanest Barangay," "Best Green Space," or "Eco-friendly Household" to incentivize participation.

### Section 6. Penalties for Non-Compliance.

To ensure proper adherence to environmental laws and policies, the following penalties will be imposed for violations related to waste disposal and environmental irresponsibility:

- **First Offense:** A warning and educational session on proper waste management.
- **Second Offense:** A fine of Php 500.00 or mandatory participation in the next clean-up drive.
- **Third Offense:** A fine of Php 1000.00 or mandatory participation for one (1) month (every Saturday).

**Section 7. Funding and Resources.**

**Section 8. Effectivity.**

This resolution shall take effect immediately upon approval, and all provisions of this resolution shall be enforced from the date of effectivity.
