

Upon reading and referral of Agenda Item No. **F.7.1 – PNOA-752-2024 – “RESOLUTION NO. 2024-006 ENTITLED: A RESOLUTION APPROVING THE ADOPTION OF SUPPLEMENTAL INVESTMENT PLAN (SIP) FISCAL YEAR 2024 IN THE AMOUNT OF ONE MILLION FIVE HUNDRED TWO THOUSAND SEVEN HUNDRED NINETY-TWO PESOS AND 91/100 (PHP 1,502,792.91) OF THE BARANGAY GOVERNMENT OF BAYANAN CITY OF BACOOR CAVITE.”** Honorable Rogelio M. This is to respectfully submit the proposed Supplemental Budget No. 2 of Barangay Bayanan for Fiscal Year 2024.

The funding sources for the said Supplemental Budget are as follows:

1. Savings in the amount of ONE MILLION FIVE HUNDRED TWO THOUSAND SEVEN HUNDRED NINETY TWO PESOS AND 91/100 (P1,502,792.91) from the Increase in Actual RPT Collection and General Fund which has already been completed.


