Collection of Housing Maintenance Fees and Real Property Taxes. - The City Treasurer, or his/her duly authorized representative, is hereby authorized and directed to collect Housing Maintenance Fees from the beneficiaries of the socialized housing projects within the City of Bacoor covered by this Ordinance in the amount of P50.00 per month. INFORMATION:

The Endorsement letter dated January 23, 2025 of the Office of the City Administrator, Bacoor City, recommended to the Sangguniang Panlungsod the amendment of Section 4 of City Ordinance No. 303, Series of 2023, based on the recommendation of **CITY OF BACOOR URBAN DEVELOPMENT AND HOUSING BOARD (CBUDHB) Resolution No. 9, Series of 2024** (Attached as "**ANNEX A**" hereof).

In particular, a request for an amendment to increase the monthly Housing Maintenance Fee from **Php50.00** to **Php150.00**.

The said CBUDHB Resolution No. 9 also explained that in maintaining and improving the living conditions of the beneficiaries and to ensure the well-being of the residents, including the proposed maintenance and operation, security and safety measures, community development, emergency funds and administrative costs, the current Housing Maintenance Fees at Fifty Pesos (Php50.00) per month is **insufficient**.

In support of the proposed increase, the CBUDHB submitted a matrix prepared by the Housing Urban Development and Resettlement Department with title, "**Utilization and Disbursement of Housing Maintenance Fees**", which itemizes the particulars and costs.

The table of "Utilization and Disbursement of Housing Maintenance Fees" is attached herewith as "**ANNEX B**", and the same is copied for ready reference.

WHEREAS, additional purposes for the utilization and disbursement of the socialized housing maintenance fees including maintenance and operation, security and safety measures, community development, emergency funds and administrative costs was proposed during the meeting;

NOW THEREFORE, X X X **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to request the Sangguniang Panlungsod the amendment of City Ordinance No. 303-2023, pertaining to the collection of Fifty Pesos (php50.00) monthly housing maintenance fee from beneficiaries of socialized housing projects in the City of Bacoor, be augmented to One Hundred Fifty Pesos (php150.00).

PUBLIC HEARING:

As required under the Local Government Code, a public hearing was held on August 17, 2025 (Sunday), and the same was conducted by the Joint Committee together with the officers and staff of Housing Urban Development and Resettlement Department at the Ciudad de Strike Multi-Purpose Hall, Barangay Molino 1, Bacoor City, Cavite, or within the area where the socialized housing beneficiaries reside.

During the public hearing, the Joint Committee requested the Housing Urban Development and Resettlement Department, as the lead implementor of administration, operation and maintenance, to discuss and explain the particulars and costs reflected in the Utilization and Disbursement of Housing Maintenance Fees, including the scopes and coverages of the housing maintenance fees.

Further, the Joint Committee made clear of the following issues:

- The city government has nothing to do with the homeowner's associations collection of monthly dues as the same is within the Internal affairs and understanding of the association officers and members.
- The city government will provide the collector and official receipt for the monthly Housing Maintenance Fees.

- The payment for the electric consumptions within every unit, the building lightings on hallways, open spaces and the streetlights are at the expense of or will be shouldered by the housing beneficiaries/homeowner's associations, including the maintenance/upkeep of parks, open spaces, and facilities.
- The housing maintenance fees will cover the replacement of light bulbs/ luminaires and light fittings, security guards (day and night shift), servicing of utility system (water, sewerage, and power supply), garbage collection.
- There will be twenty-four hours personnel in-charge of the maintenance and emergency servicing for de-clogging and repairs to be hired from among the housing beneficiaries with the salaries to be taken from the housing maintenance fees.

FINDINGS:

AUTHORITY OF CBUDHB:

The City of Bacoor Urban Development and Housing Board was created pursuant to City Ordinance No. 2013-025, Series of 2013 entitled, "A CITY ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 13, SERIES OF 2008, ENTITLED, " AN ORDINANCE PROVIDING FOR THE INSTITUTIONAL, ADMINISTRATIVE AND FUNDING REQUIREMENTS OF THE RESETTLEMENT AND HOUSING PROGRAM OF THE MUNICIPALITY OF BACOOR".

In relation to its authority, we quote Section Nos. 5 and 7, Article III of City Ordinance No. 2013-025, Series of 2013, as follows:

ARTICLE III

THE CITY OF BACOOR URBAN DEVELOPMENT AND HOUSING BOARD

Section 5. Creation. There shall be created in the City of Bacoor Urban Development and Housing Board (CBUDHB) that shall formulate policies, operational guidelines, provide effective coordination, and oversee the implementation of the shelter plan of the city.

Section 7. Functions. The Board shall have the following functions:

- f. Submit for the consideration of the Sangguniang Panlungsod, proposals on taxation and such other modes of revenue generation to ensure the viability and sustainability of the City's housing program;

- o. Perform such other functions as may be necessary for the successful implementation of the housing program and projects of the city. "

PROPOSED AMENDMENT:

The CBUDHB submitted the proposed amendment to Section 4 of City Ordinance No. 303-2023, Series of 2023, which shall be read as follows:

"Section 4. Collection of Housing Maintenance Fees and Real Property Taxes. – The City Treasurer, or his/her duly authorized representative, is hereby authorized and directed to collect Housing Maintenance Fees from the beneficiaries of the socialized housing projects within the City of Bacoor covered by this ordinance in the amount of **P150.00** per month. The City Treasurer or its authorized shall be responsible for the collection of these fees, and for providing official receipts for payment received."

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Joint Committee hereby recommend **TO APPROVE** the proposed amendment to Section 4 of City Ordinance No. 303-2023, Series of 2023, particularly the increase of Housing

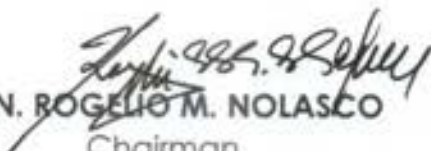

Para alam ng lahat ng nakatira dito sa Ciudad kung ano yung patungkol dito sa City Ordinance na ginagananap ngayong araw, dahil once na ito ay maaprubahan, ay kayo na naririto tapos silang wala pa yung mareklamo. Napakahalaga po mga ka barangay itong Public Hearing at assembly kaya dapat umaattend po tayo. Sa mga officers and members ng homeowner's associations ng ating socialized housing projects, sa lahat ng naririto, Magandang hapon po at mabuhay. Ang public hearing na ating ginagananap ngayon ay ayon sa probisyon ng republic Act no. 7160 o yung





tinatawag na "Local Government Code". Ito ay upang ang ordinansa ay ganap na maging epektibo. Particular po ito sa section 130 ng local government code, bilang fundamental principles sa pagbuo ng mga taxes, fees and charges at iba pang revenue generating ordinances. Para sa kaalaman ng lahat, nais ng ating city government na ang lahat ng socialized housing projects na ngayon ay pinakikinabangan na ng mga beneficiaries ay patuloy na maging maayos, at iyan ang dahilan kung bakit tayo naririto ngayon sa isang public hearing. Ang public hearing po ay uumpishan sa isang pagtatalakay na pangungunahan ng ating Housing urban development and resettlement Department, Kayo po ay aking hinihikayat na makipagtulungan, at tulungan ang ating pamahalaang lungsod ng Bacoor. Maraming salamat po. At ngayon po hayaan nating makapag umpisa ang mga kasama kong konsehal. Ngayon po ay ibibigay ko po sa ating Housing department.'

Ms. Elisa Gregorio: "Magandang umaga po sa inyong lahat, unang una Magandang umaga po sa ating masisipag na mga bumubuo ng Sangguniang Panlungsod from District 1 and District 2, maraming salamat po at pina unlakan nyo kami na makasama na bumaba sa inyo para sa ordinansa. Noong pong mga meron ng 3 months ago, nagkaroon po kami ng initial na pagsasalita sa mga taga Phase 2 ng Ciudad De Strike, nakapag bigay po kami ng mga explanation para sa ordinansa na ito po. Ito po yung City Ordinance na 303-2023 "An ordinance authorizing the collection of housing maintenance fees from beneficiaries of socialized housing projects in the city of Bacoor, Cavite and providing the penalties for violations hereof." So, ito po binigyan ko po ng kopya yung mga taga ciudad de Strike phase 2 kami po ay naririto para po ipaalam sa inyo na itong ordinasa na naibaba ay hindi pa po na Impliment, bagkus po ay nagkaroon ng isang masusing pagtalakay dahil napag alaman po na dito sa ordinansa na nakalagay ay 50 pesos para sa isang beneficiary ng taga socialized housing ng Bacoor ay hindi sapat so, kami po ay umapila, na i consider yung nagawang computation para naman po makita Ninyo na mayroon dahilan o basis kung paano natin itinaas ito na Php 150.00 per month for each beneficiary or household po dito sa Ciudad De Strike at Ciudad De Kaunlaran. Gusto ko lang pong sabihin sa inyo na ito po ay napag usapan na ng nakaraang lingo sa Sanggunian kasama ang mga officer's ng Ciudad De Strike 1 and Ciudad de Kaunlaran narinig na po nila at doon po namin tinalakay. So, ngayon po gusto raw nilang marinig ninyong lahat at kayo po ang mismo ay makapag bahagi ng





mga gusto ninyong sabihin tungkol diyan dito sa proposed ordinance na magbabayad po tayo ng Php 150.00 per month para po sa maintenance fee. Ipapaliwanag ko lang po yung Php 150.00 na sisingilin para sa maintenance fee covered na po nito ang maraming bagay, unang una po ang pagbabayad sa mga Security Personel dito sa Ciudad, kada Socialized Housing project kada isang building po kami po ay makakapag provide ng isang (1) security personnel, tag iisa po each housing project. Yun po ang kaya sa 150.00, isa sa Phase 1 at isa sa Phase 2 at isa sa Ciudad Kaunlaran, meron din pong tatlong helper or maglilinis para Ciudad 1 and 2 and Kaunlaran, tag iisa po iyon, at yung mga kukunin po namin ditong tagalinis ay hindi po niya obligasyon yung tapat ng bahay Ninyo, ang kanila pong obligasyon ay yung mga open spaces, dito po harap natin linis natin tapos kabilang po dito ang pag me maintain sa inyong tubig at kuryente, kapag may nagka problema po ay sagot ng city government para mag ayos kung nagka problema sa kuryente at tubig at magtatalaga din po nang tag lisang personnel at property manager na mag momonitor po dito sa inyong lugar para meron po kayong matatakbuhan sa lahat ng oras na mayroon po kayong kailangan. HOA Phase 1: "Mam clarify ko lang po, ang HOA po ba namin ay recognized na ng city government of Bacoor HURD?"

Ms. Elisa Gregorio: "Yes po recognized na."

HOA Phase 1: "Kung recognized po registered na po ba?"

Ms. Elisa Gregorio: "Ang pagkaka alam ko ang inyong organization ay recognized na."

HOA Phase 1: "Hindi ba po nag post na kayo ng ordinance 303-2023 kasama na po ang maintenance fee na Php 50.00?"

Ms. Elisa Gregorio: "Hindi pa po na implement iyon."





HOA Phase 1: "So, aside from Php 150.00 tapos mayroon pa po kaming Php 100.00 na monthly dues so, magiging Php 250.00?"

Ms. Elisa Gregorio: "Hindi na po namin sakop ang HOA dues."

HOA Phase 1: "So, kaya tinatanong ko po kung recognized na ng HUDRD? Kasi kung recognized na sila pwede na kaming magbayad sa building namin at makikita ang listahan ng gastos para maging transparent kung saan napupunta ang pinagbayaran namin."

Ms. Elisa Gregorio: "Okey naman regarding sa mga HOA collection namin kasi mayroon naman kayong mga HOA officer ina acknowledge naman po iyan ng city government. Ngayon po ina acknowledge naman namin kahit phase 1 i respeto po natin kung sino yung mga nanalo mayroon po kasing kaguluhan dyan sa inyo na hindi nasubaybayan, sila na lang po ang ina acknowledge ng city government na mag perform ng kanilang duties lagi ko pong pinapa alala na mag ingat po tayo para maiwasan ang conclusion po."

HOA Officer Ph 1: "Question ko lang po, paano po ang magiging ano po kasi yung sinabi kanina noong nagsalita ang HOA po kasi ang ginagawa namin, ang mga building leaders binibigyan namin ng empowerment ibig sabihin sila ang maniningil at sila magbayad ng kuryente ng building nila, mag project sila at kung ano ang sosobra saka lamang i ta turn over sa Treasurer ng HOA para naman sa pangkalahatang proyekto na pwede naming gawin. So, they are empowered ang tanong po namin kung papasa po ang ordinansang iyan sino po ang maniningil? Ang HOA po ba o ang city government po ba o may tao po ba kayo para siguradong masingil? Hon. Reynaldo Palabrica: "Yung mga hindi magbabayad, since Ordinansa ito, may violation ang ordinance. Ngayon ano ang gusto nyong parusa? Ang ibig ko lang sabihin naandito kami para dinggin ang proposal eh napakinggan namin kayo, napakinggan namin yung proposal para mabalanse namin. Pero yung tanong Ninyo ano ang gagawin doon sa hindi nagbayad? Malinaw na ordinansa ito pero kailangang tuparin ng lahat ng nasasakupan ng ordinansa, kung ano ang parusa pag iisipan namin, kaya tanong ko sa inyo bilang nasa public hearing tayo ano ang gusto nyong parusa? Resident Phase 1: "Thank you for the acknowledgement, sorry po kanina, since it is ordinance already, and this is consultative for the revision of section 4 and 5. I would like to suggest for a visual presentation para mabilis maintindihan. A visual monitor and implementation guidelines of this ordinance para mas madali naming maintindihan. Saan ang scope and implementations? Ano ang functions? Yun lang po kasi po sa HOA members namin marami ang hindi nagbabayad."

Hon. Reynaldo Palabrica: "Thank you. Karapatan ng bawat nasasakupan ng socialized housing kung saan ang pagpapatupad ng ordinansang ito kung saan ang bawat provision and an audio visual presentation kasi ang mga tao kung narinig nakakalimutan na pero ang mga tao pag may nakikita mas naaalala kaya suggestion gawin yun para maintindihan kaya lang unfortunately today for this Public hearing kanina nabanggit na yung mga scope ano siguro ang housing department they should provide the scope ng ordinansang ito para mas malinaw sa lahat. Ciudad de Kaunlaran and Ciudad De Strike, magkakaroon din tayo sa Zapote, Salinas at Dulong Bayan itong ordinansang ito ipapatupad sa lahat ng iyan. Alam nyo kung bakit? Nakita ni Mayor Strike dito sa Ciudad de Strike at sa ibang socialized housing project sa ibang LGU, specifically Metro Manila Housing Project nabubulok ang mga

building. Kawawa ang mga nasa tuktok kung sino ang nasa third floor kapag nabulok ang bubong na iyan magtuturuan na kung sino ang gagawa nyan kaya kawawa ang nakatira dyan. 19 **WHEREAS**, on 23 January 2025, Atty. Aimee
20 Torrefranca-Neri, the City Administrator, formally
21 requested the Sangguniang Panlungsod to amend
22 Section 4 of City Ordinance No. 303-2023 (entitled: "**AN**
23 **ORDINANCE AUTHORIZING THE COLLECTION OF HOUSING**
24 **MAINTENANCE FEES FROM BENEFICIARIES OF SOCIALIZED**
25 **HOUSING PROJECTS IN THE CITY OF BACOR, CAVITE AND**
26 **PROVIDING PENALTIES FOR VIOLATIONS HEREOF**") pursuant
27 to the recommendation of the City of Bacor Urban
28 Development and Housing Board through its Resolution
29 No. 9, series of 2024, dated 18 December 2024.
30

31 **WHEREAS**, the request to amend the said section of
32 City Ordinance No. 303-2023 will allow the City
33 Government to increase the Housing Maintenance Fees
34 originally provided in the said ordinance from P50.00 to
35 P150.00 per month and enable the effective
36 maintenance and operation of the various socialized
37 housing buildings owned and operated by the City
38 Government.
39

40 **WHEREAS**, Section 5, Article X of the 1987 Constitution
41 provides that "each local government unit shall have the
42 power to create its own sources of revenues and to levy
43 taxes, fees and charges subject to such guidelines and
44 limitations as the Congress may provide, consistent with the
45 basic policy of local autonomy."
46
47

48 **WHEREAS**, under Section 17 of Republic Act No. 7160
49 (the "Local Government Code of 1991"), local

50 government units were authorized to exercise powers
51 necessary to provide basic services and facilities,
52 including low-cost housing and other mass dwellings.

53
54 **WHEREAS,** the increase in the monthly Housing
55 Maintenance Fees to be paid by beneficiaries of the
56 various housing projects of the City Government shall help
57 in maintaining a livable and vibrant community.

58
59 **NOW THEREFORE, BE IT ORDAINED** by the 6th
60 Sangguniang Panlungsod in its regular session assembled
61 THAT:

62 **Section 1.** Section 4 of City Ordinance No. 303-2023
63 is hereby amended to read as follows:

64
65 **"Section 4. Collection of Housing Maintenance Fees**
66 **and Real Property Taxes.** - The City Treasurer, or his/her
67 duly authorized representative, is hereby authorized and
68 directed to collect Housing Maintenance Fees from the
69 beneficiaries of the socialized housing projects within the
70 City of Bacoor covered by this Ordinance in the amount
71 of P150.00 per month. The City Treasurer or its authorized
72 representative shall be responsible for the collection of
73 these fees, and for providing official receipts for payments
74 received.

77 **Section 2. Effectivity Date.** This Ordinance shall take
78 effect immediately after it has been published once in a
79 newspaper of general circulation in the City of Bacoor,
80 Cavite and after copies hereof has been posted in at least
81 three (3) conspicuous places within the City of Bacoor.

82
83 **Section 3. Repeal.** All city ordinances and resolutions
84 inconsistent with the provisions hereof are hereby
85 repealed.

86
87 **Section 4. Separability.** In case a provision of this
88 Ordinance is declared void by the court of law, the
89 remaining provisions hereof not affected by the said
90 declaration shall remain valid.

91
