Subject: AN ORDINANCE CREATING THE CITY SPORTS DEVELOPMENT DEPARTMENT OF THE CITY OF BACOOR, CAVITE AND THE PLANTILLA THEREOF, ESTABLISHING THE BACOOR CITY SPORTS DEVELOPMENT PROGRAM, CREATING THE BACOOR SPORTS ACADEMY, AND CREATING THE BACOOR CITY SPORTS DEVELOPMENT COUNCIL. (PCO 2025-013 dated 07 July 2025)

This committee report pertains to the joint committee hearing conducted on July 10, 2025 and August 28, 2025, relative to the above-stated subject matter. The hearing was presided over by Hon. Miguel N. Bautista, Chairperson of the Committee on Ethics, Appointments and Government Reorganization and was held at the Sangguniang Panlungsod Session Hall situated on the 6th Floor of the BLDR Building, Bacoor Government Center, Barangay Bayanan, Bacoor City, Cavite.

FINDINGS:

After due deliberation during the committee hearing on the above-captioned proposed ordinance, the Committee presents the following findings:

- Section 4 of the proposed ordinance lacks specific position titles and salary grades. The Human Resource Management Office (HRMO) recommended coordination with the Office of the City Mayor to determine appropriate titles and to finalize the department's organizational structure. The City Budget Office noted that no budgetary estimates can be computed in the absence of these essential details.
- Pursuant to the directive issued during the committee hearing, the Human Resources Development and Management Department (HRDMD) has thoroughly reviewed and evaluated the proposed positions based on current government standards, specifically:
 - Civil Service Commission's Qualification Standards Manual and related issuance; and
 - Department of Budget and Management's Index of Occupational Services, Position Titles and Salary Grades for Local Government Units (IOS-LGU), CY 2022 edition.
- The following plantilla positions are hereby recommended:

NEW POSITIONS FOR CREATION:

- City Government Department Head Assistant I (SG-25)
- 2. Band Master (SG-9)

EXISTING POSITIONS FOR TRANSFER/MERGER:

- 3. Youth Development Officer (SG 10)
- 4. Youth Development Assistant I (SG 5)

ADDITIONAL CONSIDERATIONS:

It is noted that the request also includes provisions for contractual personnel under job order arrangements (referees, band members, etc.), which are not included in this plantilla recommendation as these positions are covered by separate funding mechanisms and do not require permanent plantilla allocation.

The two (2) existing positions (Youth Development Officer I and Youth Development Assistant) currently under the Sports Development Unit will be administratively transferred to the new Sports Development Department structure without requiring additional budgetary allocation for new positions.

 The City Legal Officer pointed out the existence of a 2013 ordinance creating the Youth and Sports Development Council. Clarification is needed on whether

the proposed new council will supersede, absorb, or operate independently of the existing body.

- The Committee confirmed that the ordinance does not abolish the current Sports Development Unit but merges and expands it into a formal department. Existing personnel will be absorbed and transitioned accordingly, with the Sports Development Department assuming broader and more structured responsibilities.
- Several corrections were noted in the draft ordinance and they are as follows:

Original Provision of PCO 2025-013
Article I Section 3. Department Head. The head of the CSDD must be a Filipino, of legal age, must have a college degree from a reputable educational institution, with a proven track record in sports development and management, and must possess all the qualifications for such a position as provided in pertinent civil service regulations. He/she shall be appointed by the City Mayor on a co-terminus basis and shall receive all the benefits and emoluments of the head of a department.
Article I Section 4. Creation of Various Plantilla Positions. The CSDD shall have

Proposed Amendments of PCO 2025-013

Article I Section 3. Department Head. The head of the CSDD must be a Filipino, of legal age, resident of Bacoor, Cavite must have a college degree from a reputable educational institution, with a proven track record in sports development and management, and must possess all the qualifications for such a position as provided in pertinent civil service regulations. He/she shall be appointed by the City Mayor on a permanent position and shall receive all the benefits and emoluments of the head of a department.

- HRDMD confirmed that all plantilla positions must be aligned with the Index of Occupational Services, Position Titles, and Salary Grades (IOS) of the Civil Service Commission.
- The City Budget Officer reported that the estimated Personal Services (PS) cost of the CSDD is PhP 3,190,000.00, which will be incorporated into the City's Annual Budget once the ordinance is enacted.
- The creation of the City Sports Development Department is consistent with the City Government's thrust to institutionalize sports programs, promote youth development, and strengthen community participation in sports-related activities.

RECOMMENDATION:

In view of the foregoing, the Committee on Ethics, Appointments and Government Reorganization, after considering the technical corrections and compliance with Civil Service and budgetary requirements, recommends the APPROVAL of the proposed ordinance, subject to the incorporation of the necessary amendments as discussed.



MINUTES OF THE JOINT COMMITTEE HEARING

Subject: AN ORDINANCE CREATING THE CITY SPORTS DEVELOPMENT DEPARTMENT OF THE CITY OF BACOOR, CAVITE AND THE PLANTILLA THEREOF, ESTABLISHING THE BACOOR CITY SPORTS DEVELOPMENT PROGRAM, CREATING THE BACOOR SPORTS ACADEMY, AND CREATING THE BACOOR CITY SPORTS DEVELOPMENT COUNCIL. (PCO 2025-013 dated 07 July 2025)

A joint committee hearing was conducted on July 10, 2025 at the Sangguniang Panlungsod Session Hall regarding the aforementioned subject matter with the following attendees. (See attached attendance sheet)

The hearing was presided over by Committee Chair Hon. Miguel Bautista. He also led the prayer, gave his opening remarks and acknowledged the presence of all the committee members and resource persons as well.

The hearing was called to deliberate on the proposed ordinance seeking to institutionalize a city-level sports development framework through the creation of a Sports Development Department and supporting bodies.

The following key issues were raised:

HRDMD Head Ms. Natividad Ludwig Ople pointed out that the proposed **Section 4** lacks specific position titles and salary grades. She recommended coordinating with the Office of the City Mayor to determine the appropriate organizational structure. The City Budget Officer likewise emphasized that without such details, budgeting remains unfeasible.

City Legal Officer Atty. Salve Valenciano noted that a 2013 ordinance already established a Youth and Sports Development Council. The Committee must clarify whether the proposed new council will replace or operate alongside the existing one.

Concerns were raised regarding the lack of detail in the ordinance about the proposed Bacoor City Sports Development Council's composition. The Committee advised clarifying the roles of the Chairperson, Vice-Chairperson, and other members, and specifying the frequency of meetings (e.g., quarterly or biannual). Discussion also

included the possibility of providing honoraria or per diem subject to budget availability and the Mayor's approval.

The HRDMD proposed rewording Section 5 (Core Values) to align with city standards:

- A. "Holistic development through sports"
- B. "Teamwork and collaboration"
- C. "Every Bacooreño is a champion" (retained)

Mr. Sidney Solis, clarified that the proposed department will not abolish the existing Sports Development Unit but will absorb its personnel and expand its scope under the new structure.

After deliberations, the Joint Committee found the ordinance commendable in principle, subject to the following conditions:

- Insertion of detailed plantilla positions with corresponding salary grades.
- Clarification on the legal relationship between the proposed and existing councils.
- Definition of the council structure and its operations.
- Incorporation of the revised core values.
- Compliance check to prevent conflicts with existing ordinances.

Upon submission of the required technical inputs and revisions, the Committee agreed to endorse the proposed ordinance for second reading.

There being no other matters to be discussed, the meeting was suspended at around 9:43 AM.







The hearing was presided over by Committee Chair Hon, Miguel Bautista. He also led the prayer, gave his opening remarks and acknowledged the presence of all the committee members and resource persons as well.

The hearing was called to deliberate on the proposed ordinance seeking to institutionalize a city-level sports development framework through the creation of a Sports Development Department and supporting bodies.

1. Presentation by HRDMD Representative (Miss Ople)

- Reported that recommended position titles were submitted following consultation with Mayor Strike and the City Administrator.
- Clarified that the head of the City Sports Development Department must be a permanent employee and a resident of Bacoor, as only the City Legal Officer, City Administrator, and City Information Officer may be coterminous under Civil Service rules.
- Noted typographical errors in the draft ordinance, including references under "Judiciary and Functions," which should reflect supervision by the City Mayor, not the CSDD Head.
- Explained that the proposed "Band Conductor" position was mistakenly included; instead, the Civil Service index recognizes "Bandmaster."

2. Committee Concerns

- Members expressed concern that uncorrected documents delay hearings. They stressed the need for the committee to receive corrected versions of the ordinance before further deliberations.
- o It was agreed that HRDMD will finalize the corrected position titles and align the draft with Civil Service regulations.

There being no other matters to be discussed, the meeting was adjourned at around 9:35 AM.




