SUBJECT: AN ORDINANCE INSTITUTIONALIZING KATUWANG SA DIWA AT GAWA SA MASAGANANG ANI AT MATAAS NA KITA (KADIWA) NG PANGULO (KNP) IN THE CITY OF BACOR, PROVINCE OF CAVITE. Referred (PCO 2025-017 (PCO 2025-260) dated July 7, 2025

FINDINGS:

The above mentioned proposed ordinance underwent its first reading on July 7, 2025 during the 2nd Regular Session of the Sangguniang Panlungsod. The said proposed resolution was referred by the Presiding officer Hon. Rowena Bautista Mendiola to the Committee on Agriculture and Food.

The Committee on Agriculture sent out invitations to the resource persons and conducted a committee hearing on July 11, 2025 at the Session Hall of the Sangguniang Panlungsod at 1:00 pm.

FINDINGS:

On May 26, 2025, The Office of Sangguniang Panlungsod received a letter from the Office of the Mayor above on the subject matter : Request to Pass a City Ordinance Establishing a KADIWA NG Pangulo Outlet In the City of Bacoor. Inilabas ng Department of Interior and Local Government (DILG) ang Memorandum Circular No. 2024-003 na naghihikayat sa pamahalaan na magpatupad ng KADIWA ng Pangulo (KNP) sa kanilang mga lokalidad sa pakikipagtulungan sa DA, DTE, DOLE, at DILG. Ang mga layunin ng Memorandum Circular na ito ay upang matiyak na ang mga local na pamahalaan ay nakikibahagi sa KNP sa mas mataas na antas, matiyak na ang mga produkto ay maihatid nang maayos, upang matiyak ang seguridad sa pagkain, paghahatid ng masusustansyang pagkain at pag-access sa abot-kayang mga produkto at kalakal; suportahan ang mga magsasaka na magbenta ng mga produktong agricultural, upang mapadali ang regional na palitan ng mga produktong OTOP, at upang bigyan ng pagkakataon ang mga local na micro-entrepreneurs na i-market ang kanilang mga produkto, upang magbigay ng mga oportunidad sa mercado sa mga MSME sa pamamagitan ng local na pagsusulong ng produkto at pagtanggap ng maraming patong sa marketing, na nagpapahintulot sa mga tagagawa na kumite ng mas malaking kita mula sa direktang pagbebenta ng kanilang mga produkto sa halip na gumamit ng mga tagapamagitan na mangangalakal.

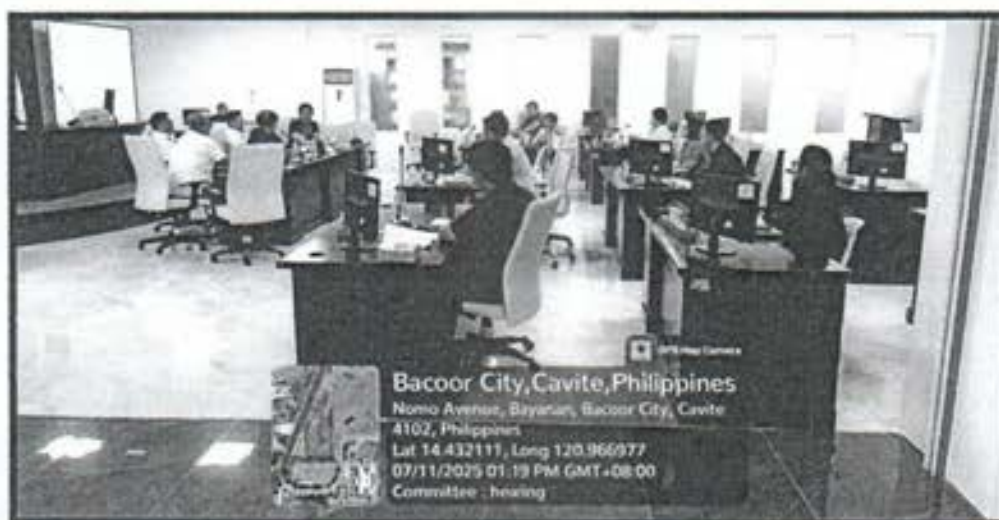
