Subject: AN ORDINANCE DECLARING MARCH 2 OF EVERY YEAR AS "BACOR STRIKE FAMILY DAY" IN THE CITY OF BACOR. (PCO 2025-022 dated July 14, 2025)

The above-captioned legislative measure was submitted on First Reading before the City Council on July 14, 2025. A joint public hearing was conducted by the committee on September 5, 2025 at 9:44 AM, presided over by the Chairman of the Committee on Social Services, Hon. Horacio M. Brillantes Jr. The minutes, attendance sheets, and pictures taken during the said hearing are attached hereto and shall be made integral parts of this report.

Invitations were personally delivered, and notices regarding the schedule of the public hearing were published on the official website of the Sangguniang Panlungsod. The Notice of Hearing was also posted at the following places: the Zapote Public Market, the Bacor Government Center, and the Padre Mariano Gomez Plaza near the Hall of Justice.

Copies of the proposed ordinance were posted on the official website of the Sangguniang Panlungsod (www.bacoorcitysp.com) and a link was provided to facilitate access to and free downloading of the proposed legislation.

FINDINGS:

The proposed ordinance carries significant relevance not only for the City of Bacor but also for the broader community that acknowledges the critical role of family values, community cohesion, and athletic development in shaping responsible and engaged citizens. The institutionalization of the annual Strike Family Day through official





legislation will reinforce its importance as a meaningful tradition that celebrates unity, civic pride, and the City's commitment to inclusive and community-centered governance.

After considering the various suggestions presented during the public hearing, the Committee believes that certain provisions of the proposed ordinance should be revised. The specific provisions recommended for amendment are as follows:

Additional Proposed Recommendations

- It shall be incorporated into the Annual Investment Plan. The Bacoar Strike Family Day will be fully funded by the City Government to ensure that the constituency is inform of the city's financial status.





- A schedule will be set where in all departments involved in the implementation of Family Day shall visit the barangays. Family coordinators, in partnership with barangay councils, will identify residents in need of the services provided by the City Government.
- No separate funding shall be appropriated. Instead, the existing program funds shall be utilized and allocated in accordance with the planned activities.
- In coordination with CSWD, it is suggested that beginning on March 2, or during the week-long celebration, each barangay shall conduct its own Strike Family Day activity. The barangay shall allocate funds for the conduct of Family Day within its jurisdiction, and may also initiate additional family-oriented activities at its discretion.
- Every Saturday shall be designated as Family Day. In the forty-seven (47) Saturdays preceding March 2, Family Day shall be observed in each barangay accordingly with the schedule to be set by the City Government.
- As mentioned by the author, Honorable Manolo Galvez, the barangay governments will have major involvement. Funding for Family Day celebrations will also be provided for in the ordinance. Each barangay in Bacoor will be required to conduct Family Day, scheduled by the city government, and provide funding for it. Failure to include this in the annual budget will result in the non-approval of the barangay's annual budget.
- The City Social Welfare and Development Office (CSWD) shall serve as the lead agency of the program. All volunteer groups shall be scheduled by the CSWD as to the specific Strike Family Day activities to which they will be assigned. The CSWD shall oversee and regulate the participation of organizations, and no group shall be allowed to participate outside the schedule provided by the CSWD.
- Non-Government Organizations (NGOs) shall serve as partners and implementing arms of the City Government in carrying out this ordinance. Their primary responsibility shall be to disseminate information and encourage citizen participation at the grassroots level, rather than relying solely on the direct presence of government officials. This approach is intended to bring





government initiatives closer to ordinary citizens, thereby enabling them to directly experience and appreciate the services of the City Government.

- It is likewise proposed that this ordinance include a provision allowing each barangay to conduct its respective Family Day activity within seven (7) days from March 2. This scheduling is intended to ensure that such activities will not interfere with regular school days of children.
- Barangays shall be allowed to outsource support for Family Day activities. Local organizations or businesses within the barangay that are willing to extend assistance or provide services in connection with the celebration may be engaged. This approach is encouraged to promote inclusivity and ensure wider community participation in the activities.
- Barangays that conduct Family Day activities shall submit their respective programs and reports to the City Social Welfare and Development Office (CSWD), as the lead implementing agency. The CSWD shall evaluate these activities, and the barangay with the most outstanding implementation shall be conferred the Best Strike Family Day Award within the seven (7) days allotted for barangay-level activities.
- The HR Head requests a provision allowing employees who work on Saturdays and exceed 40 hours per week to offset their extra hours, especially if the arrangement will be long-term.
- The city-wide Grand Strike Family Day will be held on March 2, open to all Bacoor residents of all ages, with access to all services and activities.

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Joint Committee hereby recommend **TO APPROVE** the city ordinance declaring March 2 of every year as "Bacoor Strike Family Day" in the City of Bacoor.

The joint committee hearing was executed on September 5, 2025, at 9:44 AM at the Sangguniang Panlungsod Session Hall, 6th floor, Bacoor Legislative & Disaster Resilience Building, Bacoor Government Center, Bacoor Boulevard, Brgy. Bayanan, City of Bacoor, Cavite regarding the aforementioned subject matter with the following attendees (see attached attendance sheet).

HON. HORACIO BRILLANTES JR. "PCO 2025-022 - An ordinance declaring March 2 of every year as "Bacoor Strike Family Day" in the City of Bacoor. For the record, we would like to acknowledge the presence of the following Honorable Members of the City Council from District 2, Councilor Obet Advincula"

HON. ROBERTO ADVINCULA "Good morning. Thank you, Mr. Presiding Officer. Sa lahat po ng resource persons na nandito po ngayong umaga my dearest colleagues, magandang umaga po sa ating lahat. Mabuhay."

HON. HORACIO BRILLANTES JR. "Thank you, Councilor Obet. From District 2, Councilor Simplicio Dominguez."

HON. SIMPLICIO DOMINGUEZ "Magandang umaga Chair, magandang umaga sa ating mga panauhin, at masisipag na mga kapitan, sa lahat po ng nandito. Magandang umaga po at mabuhay po tayo."

HON. HORACIO BRILLANTES JR. "Thank you. From District 1, Councilor Pastor Mike Bautista."

HON. MIGUEL BAUTISTA "Good morning, Mr. Chair, to all our Honorable Councilors present, to all department heads, unit heads and barangay chairmen present and also to all our visitors today, mabuhay po."





HON. HORACIO BRILLANTES JR. "And also, from District 2 again, Councilor Rey Palabrica."

HON. REYNALDO PALABRICA "Magandang umaga po Ginoong Tagapangulo, magandang umaga sa mga kasama sa konseho ng Lungsod ng Bacoor at sa lahat ng nandito ngayon, magandang magandang umaga po sa inyong lahat. Maraming salamat at narito kayo, mabuhay."

HON. HORACIO BRILLANTES JR. "Thank you. And from District 1, Councilor Noly Galvez."

HON. MANOLO GALVEZ JR. "Good morning, Mr. Chair. Good morning to my fellow City Councilors, good morning to all resource persons at maraming salamat po. At ngayon at tatalakayin na natin ang isang pinakamagandang proyekto para sa buong pamilya. Yun lamang po Mr. Chair, magandang umaga po sa ating lahat."

HON. HORACIO BRILLANTES JR. "Salamat ng marami sayo Councilor Noly Galvez. Since na marami po tayong resource persons ngayon, minumungkahi ko na lang po na hindi na po natin babanggitin ang bawat isa para masimulan na po natin ang ating public hearing na ito. So ngayon, regarding dito sa ating ordinance na ipapasa, gagawin na po nating official ang Strike Family Day. So, ito'y sa pamamagitan ng proposed as an author si Councilor Noly Galvez na gawin na po itong official na ordinance. So, with that, gusto ko lang po humingi ng konting salita na magmumula po sa ating butihing konsehal ng bayan ng District 1."

HON. MANOLO GALVEZ JR. "Maraming salamat po, Ginoong Tagapangulo. Muli, bibigyan ko lang po kayo ng konting background ung atin pong Strike Family Day. Ito po ay nasimulan po namin ng ating Mayor Strike Revilla sa maliit po na Gawain na ginagawa po natin sa iba't ibang barangay. Ito po ay meron na po sigurong isang taon na naigawa po natin. Binaba po natin ito, meron po tayong mga inflatable palaruan para sa mga bata, meron din po tayong mga feeding program na ginagawa. Meron din po tayo kinuhang libreng gupit na kinuha through our livelihood kay Ate Lita and some volunteers po. Naisip po namin to ni Mayor na at least mabigyan po natin ng bonding ang pamilya di lamang po ung nanay, tatay o anak ang binibigyan po natin ng bonding. Kasi ang family po ng Pilipino ay di lamang po doon lang na kasi po extended family po lagi ang family nang Pilipino, kasama po ang tiyo, kasama po ang lolo at lola. Kaya naisip po nang ating butihing Mayor na palawakin na po ung ating Strike Family Day kasi ho nakita rin po natin na ang pamilyang Pilipino ay talagang bonded po ito eh, talagang bonding po ang kailangan din po ng bawat pamilya. Eh pag nag-bonding kayo medyo pricey din, so naisip po ng ating Mayor na at least kung di man kaya ng malaking gastusin para sa pamilya ay sila ay magkaroon ng activity, gobyerno na po o tayo na po LGU ang magbababa po sa kanila nang wala po silang babayaran. Tapos, mangyari po lamang ay nagkaroon po kami





ng pag-uusap ng ating CSWD upang ito nga po ay palawakin at ibaba po ang iba't ibang ahensya upang lalo pa pong mapaganda ang Strike Family Day. Yun lamang po, Ginoong Tagapangulo at maraming salamat po sa pagkakataon."

HON. HORACIO BRILLANTES JR. "Salamat Konsi Noly Galvez. Siguro doon sa main department na concern dito, I would like to acknowledge from CSWD, Ma'am Lilian Ugalde."

MS. EMILIANA UGALDE "Maganda umaga po sa ating Kagalang-galang na Sangguniang Panlungsod, sa atin pong kasamang Department Heads and NGO's na nandito rin to attend this public hearing nang gagawin nating family day ng City of Bacoor."

HON. REYNALDO PALABRICA "So, with your kind indulgence po Mr. Presiding Officer, Ma'am Lilian ibig sabihin magkakaroon din nang parang financial report"

HON. HORACIO BRILLANTES JR. "Sa mga kasama po natin na mga City Councilor, baka, sige go ahead Councilor Palabrica"

HON. REYNALDO PALABRICA "Ma'am Lilian, bali ang role ni finance, bali Budget Office, we are referring to Budget Office?"

MS. EMILIANA UGALDE "Yes po, yung finance office po."

HON. REYNALDO PALABRICA "Ah ung Finance mismo. Finance group, oo. Kasi dito sa Section 4, malinaw naman dito na isasama na natin ito sa Annual Investment Plan noh, ung funding nito, meaning in every year this type of activity, the Strike Family Day will be funded fully by the City Government. Ngayon, uhm maganda din kaya ang suggestion ni Ma'am Lilian, so that the constituency will be aware of the financial status of the city, mas Maganda kung may reporting sila. This is a form of transparency on the part of our local government. Maganda to, so Mr. Chair, may we must take note of that suggestion and I strongly suggest that the suggestion be included in this proposed ordinance."

HON. HORACIO BRILLANTES JR. "Ok, Councilor Rey, noted po yan. So, ating mga kasama na naririto, baka meron po tayong mga suhestiyon o other concerns regarding this ordinance, open naman po tayo. Sige po kagawad."

KAG. MANNY DUMALI "Good morning po Mr. Chair, I'm Kagawad Manny Dumali po from Ligas 1. Sir, tanong ko lang po kung ito po bang eksaktong date, March 2 eh meron special non-working holiday declaration?"

HON. MANOLO GALVEZ JR. "Mr. Chair, tingin ko po hindi po natin pwedeng...kumporme po yan sa Presidente, pag umabot po tayo ng Presidente kasi ang pagdedeclare po nang non-working holiday ay nanggagaling po yan sa National Offices po or sa Malacañang, siya lang po ang pwedeng magdeklara po nun."





KAG. MANNY DUMALI "I mean sa ano lang po sana sa Bacoor kung meron tayong sariling ano about this event kasi kung special family day po di ba ung mga bata, especially kung matatapat ng may pasok."

HON. MANOLO GALVEZ JR. "Ah, konsehal ang mangyayari po dyan siguro sa mga bata kung may pasok man, halimbawa kung Lunes o Martes, meron naman po kasing pwedeng gawin na activity ang barangay nang 5:00 PM beyond po para lang po sa Mach 2. Alam ko po ang pinopropose po nila Ate Lilian din dito ay tuwing Saturday and Sunday ay magkaroon din po tayo ng Strike Family Day. Ang pinaka anniversary po lang ng Strike Family Day is March 2 lang po. Ah, please, Ate Lilian, yes po."

MS. EMILIANA UGALDE "Salamat po konsi. Enrichment po sa family day celebration ay nag create po tayo ng activities sa ating mga barangay na gaganapin po ito every Saturday. Magkakaron po tayo ng schedule kung saan ang lahat ng departamento involved dito sa ating implementation ng family day bababa. This is different, this is look like caravan, but since ang caravan is very boring alam na ng mga tao, hindi naman sila pupunta dyan eh kung ganun ang gagawin. Nagkaroon po nang, as per our mayor baguhin namin ang konsepto kung saan meron tayong mga family coordinators bababa before the Saturday to identify together with the barangay councils to identify sino sino ba sa mga barangay, kung sino ba ang nasa barangay ang may mga kailangan sa City. Kung ito ba ay tungkol sa amilyar, kung ito ba ay tungkol sa health, kung ito ba ay tungkol sa social service para pag baba ng mga taga city alam na ng mga departamento kung ano pa ang kailangan nilang need satin. So, ang magiging set-up po nito, meron tayong 2 to 3 hours ang hinihingi lamang po namin sa barangay and sa community kung saan kami ay magsasagawa ng activity. So magiging festive and dating as per Mayor dahil ayaw nga nya ng nandodoon lang tapos kakain lang ng kung anong whatever nandodoon. Gusto nya maramdaman ng mga tao na bumaba ang local na pamahalaan at sila ay ilagay kung ano yung kanilang mga kailangan."

HON. HORACIO BRILLANTES JR. "So doon sa concern ni kagawad, siguro nasagot naman, naaddress naman po ung concern nyo. So, meron pa po bang gusto magtanong o magsuggest? Sige po Dra. Ivy."

DR. IVY MARIE YRASTORZA "Siguro po address ko lang po kay Ma'am Lilian. Ma'am dun po kasi sa services, may nakalagay po kasi na wellness caravan, kasi baka po maging duplication po sa services ng City Health Office, so kung may medical mission po and it's a private group or any organization po na mag-join sa family day sa amin na lang po sana mag-coordinate. Opo, under na lang po ng office namin."

HON. REYNALDO PALABRICA "Mr. Chair, sagutin ko lang, Kung concern nyo Dra. Ivy ay napapaloob sa isang ordinansa yan, we already have an existing





ordinance that all medical missions to be conducted by private organizations within the jurisdiction of Bacoor should seek permit from your office and the Mayor's Office. Kaya hindi pwedeng sumama rito sa family day ang sinumang private organization to conduct medical mission, wellness mission unless permitted by the mayor and your office. Kaya siguro okay na un dun."

HON. HORACIO BRILLANTES JR. "Thank you Councilor Rey. Sige po Ma'am Lilian."

MS. EMILIANA UGALDE "Dito po pala sa family day, hindi ibig sabihin na kung ang services ng barangay 1 ay kapareho sa iba, iba-iba, depende, magkakaran po ng assessment before that event ng pangangailangan ng barangay na un, kasi baka naman hindi na kailangan, hindi na namin dadalhin. Kung ano ung kailangan nila na sabi ng barangay, kamukha po ng Molino 3 and Zapote areas magkaiba sila ng services na kailangan. So ung nakalatag dito hindi pwede lahat ito maavail ng isang barangay, pwedeng meron sa isa, wala naman sa isang ito, so hindi po un, kung ano po yung needs under that barangay."

HON. HORACIO BRILLANTES JR. "Okay, thank you po, Ma'am Lilian. I would like to acknowledge our good Councilor Rey Palabrica for the further explanation for this public hearing."

HON. REYNALDO PALABRICA "Thank you Mr. Chair. Siguro para na mas malinaw sa lahat, ang ordinansa na ito ay tinatawag na Strike Family Day to be conducted annually every 2nd day of March. Sa activity na ito, mapapaloob dito ang maraming serbisyo publiko, bababa ang mga serbisyo publiko. Marami. Actually, all the offices, department of the City Government, their services, ay i-offer or dadalhin sa baba. Napapaloob yan sa Section 4. So ang dami nito: City social welfare, local youth development, public employment, city information, city livelihood, lahat ng departamento ng city government ay may additional na trabaho sa araw na yan, bababa sa mga tao. Kaya nandito ang ating mga iba't-ibang department heads. Ngayon, katulad ng binanggit kanina ni Konsi Noly Galvez, actually, Mayor Strike and the City Government of Bacoor is really promoting the strengthening of every family in Bacoor. Kaya nga gusto niya lagi kung maaari every week, every Saturday mayroong family day. Pero ung pinaka grand celebration or grand activity ng Strike Family Day based on this ordinance is every 2nd day of March every year. So, may tatanong lang ako Mr. Chair kay Ma'am Lilian. Kasi kung grand celebration to ng March 2, ito ba lahat ng barangay ito? Or nasa isang lugar lang to? Kasi yun ang medyo hindi natin na-cover? Simultaneous ba to sa 47 barangays or concentrated sa isang lugar? Papaano?"

MS. EMILIANA UGALDE "Sa nangyayari, before nagagawa na natin. Meron yung activity dito sa city level, then we have yung ibang activities sa bawat barangay natin na ang gumagawa yung mga social workers at other NGO's just to celebrate the occasion. Kasi this is similar sa ating ginagawa ng Women's Month





every March. So, yung Women's Month celebration natin during March 8 ay meron tayo rito and meron tayong 47 barangays, pero ito yung activity na ginagawa nang pangbarangay lang, yung hindi nakakarating dito. And ako po, I suggest na since ito po ay bago, I think mga kagalang-galang na mga konsehal, gawin natin dito sa barangay at dito sa gym."

HON. REYNALDO PALABRICA "Maganda yun. The question is, kaya ba nang manpower natin? Kasi halimbawa, may grand celebration dito sa Strike gym or dito sa City Hall compound, sabihin na natin, meron tayong mini-carnival dyan, meron tayong mga pa-games sa mga bata, meron tayong sack race para sa mga lolo at lola, family day, syempre kailangan festive, kailangan masaya. O tingnan nyo, sumaya kayo. Natuwa kayo sa sack race, parang gusto nyo mag-sack race din. May mga PWD, pwede mga 100-meter dash. My point is, maraming klasing activities na gagawin according to age bracket. Merong youth, merong ga-youth, meron hanggang senior citizen. Ngayon, meron dito sa city government, dito sa City Hall compound on March 2, malaki, parang magiging simultaneous. Ngayon, kung meron sa every barangay, ano naman yung activities? The same activities ba na gagawin dito sa City Government, sa City Hall? Ganun din ba ang gagawin dito sa 47 barangay, simultaneous?"

MS. EMILIANA UGALDE "I think konsehal since ito ay long week celebration."

HON. REYNALDO PALABRICA "Long week."

MS. EMILIANA UGALDE "Ang nakita lang naman namin dito during the meeting is, para naman maramdaman ng mga tao na talagang we are celebrating March 2 as a family day. So tulad nga po ng sinabi ko kanina na every March is a Women's Month celebration, not only March 8, but the whole month of March is a celebration. So yung awareness ang gusto natin makita. And then also kailangan natin dito ay yung funding."

HON. REYNALDO PALABRICA "Yes, of course."

MS. EMILIANA UGALDE "That's why, may mga city, mga department heads dito ngayon, yung sinasabi nyo po kung may maibibigay na activity? I think pwede nang mag tig-isa-isa ngayon, let's say 47 barangays, ano ang pwedeng macover ng CSWD, ano yung sa CHO activity na pwede magpakita ng Family Day Celebration. I think pwede namin gamitin namin yung existing fund. Kasi nakalagay naman dito sa sinabi ni Mayor, hindi na maglalagay ng another funding for that but use the existing fund based on your program. So itatapat lang namin un sa ating mga activities, I think pag-usapan na lang ito ng mga department heads."

HON. REYNALDO PALABRICA "With regards to the required budget, meron naman dito sa ordinance na yung section kanina na, the city government will be providing funds for this purpose. Hindi ako oppose dito sa ano, I really want this





activity to be perfect kaya tinatanong ko ngayon. Kasi baka mamaya pag nandun na tayo, palpak tayo, para namang sinabi pang matatalino yung mga konsehal dito, palpak din naman. Kaya nga if we do this, we do this perfectly. Ngayon, ang tanong ko ulit, kasi gusto ko perfect eh. Kung ngayon long week na tayo, one week celebration na tayo. Ngayon, for every barangay, ang tanong ko lang naman, the same activity ba? Yung magaganap dito, hindi na magaganap sa mga bara-barangay? Sige, Konsehal Noly."

HON. MANOLO GALVEZ JR. "Thank you, City Councilor Palabrica, our pro tempore. Ang minumungkahi po namin with the CSWD, ang barangay po, pagdating ng March 2 or the long week ng activity, kanya kanya po ng gawa ng Strike Family Day activity ang barangay. Kung paano po niya gagawan ng programa yung barangay para po sa pampamilya pagdating po ng March 2. So, hindi po ung buong activity po, yung binababa every Saturday na ibababa po sa kanila. Sila na po ang barangay ang mag-mamampanpower, sila na rin po ang barangay ang maglalagay ng sarili nilang pondo para po sa Family Day ng March 2. Ayun po ang nirerequest naming kagalang-galang Konsehal Rey Palabrica. Yung mga barangay po ay maglaagy ng fund para sa family day ng March 2 at yung programa po noon ay sila na rin po yung gagawa. Pwede po silang maglagay ng sarili nilang activity na pampamilya po. Yun lamang po."

HON. REYNALDO PALABRICA "Okay. Kasi nakalagay dito sa ordinansa, ibababa natin ang lahat ng serbisyo ng bawat departamento. Ang inaalala ko kasi, we have 47 barangays. Halimbawa, si Doc Bob, magpapa-job fair, job fair ka sa 47 barangays, kasama pa rito sa City. Kaya mo ba?"

DR. ABRAHAM DE CASTO "Good morning po. Thank you po. Maganda po yung nire-raise niyo, sir. Sa totoo lang po, hindi. Pero po, yung every Saturday po, na pagbaba po, yun ang pinag-uusapan po natin yun is yung every Saturday po. Yung every Saturday po, kasi naplano na po namin ito with the other department heads, na every Saturday, on top of the March 2 po ha, yung Saturday po, na magkakasama po kami, kakayanin po namin. Pero yung simultaneous po, yung 47 on March 2, parang ibang usapan na po yun."

HON. REYNALDO PALABRICA "So, ganito mangyayari. Every Saturday, kasi kulang ang nakalagay dito sa ordinansa eh. Kaya nag-hearing tayo para malaman namin ano ilalagay sa ordinansa. Pasensya na kayo kung tatanungin ko kayo ha. Kasi ipeperfect natin ito. Magtulung- tulong lang tayo. Kasi pag ginawa natin ito, palpak naman, di balewala ito."

HON. MANOLO GALVEZ JR. "Hindi, yun nga po, Mr. Chair, Kagalang-galang na Konsehal Palabrica. Muli po, nililinaw ko po, yung para po sa barangay na mismong March 2, ay gagawa po kayo ng sarili niyo activity for Family Day ninyo. Magpapondo po kayo ng sarili niyo. Wala pong ibababa ang city po ng March 2. Para po mas malinaw, halimbawa po nga eh, sinabi ni PESO, hindi po siya





magbababa ng kanyang activity sa March 2 sa 47 barangays, hindi po. Doon po siya sa main event. Ang kanya-kanyang barangay po, from March 2, long weekend to 7 days, any of that day po, gagawa po kayo ng activity ninyo po na pang barangay, pampamilya, sa sariling pondo niyo po manggagaling. Yun lang po, Kagalang-galang na Konsehal Palabrica."

HON. REYNALDO PALABRICA "Thank you very much for the enlightenment. Yes, Dr. Bob."

DR. ABRAHAM DE CASTO "Maraming salamat po. Thank you po, Councilor Rey, for that clarification. Tama po kayo, sir. Yung every Saturday po, naplano na po namin to together with Ma'am Lilian."

HON. REYNALDO PALABRICA "Dr. Bob, saglit lang. Ladies and gentlemen, may nagsasalita po, may pinaunawa po kanina yung rules ng hearing. Paki observe lang po natin."

DR. ABRAHAM DE CASTO "Salamat po, Councilor Ray, for that clarification. Nililina po namin, noong nag-meeting po ang mga department heads together with Ma'am Lilian tsaka po si Councilor Noly Galvez, malinaw po sa amin na yung pong every Saturday po na pagbaba po, na ina-identify po bawat needs po ng bawat barangay na bababaaan namin. Lahat po ng mga departamento po ay nandoon po. Maraming salamat din po na nilina nyo po na doon sa September 2 po, lahat po ng department heads"

HON. REYNALDO PALABRICA "March 2"

DR. ABRAHAM DE CASTO "March 2 po, sorry po. March 2 po ay converge po sa main event at bawat barangay po ay may kanya-kanyang activity. Kaya maganda po na na-clarify po. Salamat po, sir."

HON. REYNALDO PALABRICA "Ayun, malinaw na. Every Saturday will be a family day. And yung pinaka- grand family day is on March 2. Ayun, malinaw. So, every Saturday before March 2, siguro 47 Saturdays before March 2, iikot sa bawat barangay itong family day. Ayun, malinaw na. Ilalagay natin sa ordinansa yan na every Saturday is a family day to be celebrated in every barangay, 47 Saturdays before March 2. And then March 2 is the grand family day of Bacoor. Ayun, malinaw na ba? Ayun. Tapos, linawin din lang natin, ilalagay din natin sa ordinansa, as mentioned by the author, Honorable Manolo Galvez, na malaki ang involvement dito ng barangay government. Nabanggit kanina na kailangan may funding kayo dito sa celebration ng family day. So ilalagay namin yan dito sa ordinance na every barangay in Bacoor, will be required to conduct family day, Strike Family Day, scheduled kung kailan kayo ma-schedule ng city government. Kailangan i-conduct ninyo yan, at kailangan pondohan ninyo yan. Kapag wala yan sa inyong annual budget, hindi namin aaprubahan ang inyong annual budget dito sa Bacoor. To ensure that the family day in your barangay will





be celebrated according to this proposed ordinance. Malinaw ba yan sa mga kapitan? Sa mga kagawad, malinaw? Parang ayaw nyo ah. So malinaw na po lahat, malinaw na. May tanong ba? Buong Bacoor po ay sa March 2, grand celebration ng Strike Family Day, o grand activity ng Strike Family Day based on this ordinance. Buong Bacoor po ay bukas para sa lahat ng edad, sa lahat ng taga-Bacoor. Kasi open ang lahat ng serbisyo dyan at nang activities. Buong Bacoor po, grand celebration ng Strike Family Day o grand activity ng Strike Family Day based on this ordinance. Buong Bacoor po ay bukas para sa lahat ng edad, sa lahat ng taga-Bacoor. Kasi open ang lahat serbisyo dyan at activities."

MS. MARILOU ARRIESGADO "Sir, tatanong ko lang po. March 2 ang declared grand family Strike...Strike Family Day. Ngayon po pwede po bang bababa nalang sa mga barangay katulad po ng mga general services tulad po nila Doc Bob, ni Ma'am Lilian nang hindi po tatama sa March 2."

HON. REYNALDO PALABRICA "Definitely, ganun ang mangyayari. Katulad ng binanggit ko kanina, 47 Saturdays before March 2 ay magkakaroon tayo ng Strike Family Day sa bara-barangay. Ang schedule ay ibibigay ng City Hall para walang conflict doon sa other schedule. Ibig sabihin, kapag na-schedule ang barangay na yan, nang ganung Sabado, ang mga serbisyo ng iba't ibang departamento bababa din doon sa barangay. Ngayon, sinasabi ninyo na ang City Government ang magbibigay ng schedule. Definitely, ang City Government ang maglalagay ng schedule sa mga bara-barangay."

MS. MARILOU ARRIESGADO "Follow-up lang po. Pwede po ba magkaroon sa amin ng mga medical mission?"

HON. REYNALDO PALABRICA "Para sa kaunawaan ng lahat, marami naman nandito, may mga NGO dito, may mga barangay government, SK government na nandito ngayon, SK officials. Linawin lang po natin, we have an existing ordinance, na anumang medical mission na gagawin ng sinumang private organization, kahit sabihin natin, barangay nag-sponsor niyan pero may private organization na partner o kahit City Government pa, basta may private organization, kailangan ng permiso. Kailangan ng recommendatory approval from the City Health Office and the approval of the City Mayor. Yes po, dapat po silang humingi ng approval. Yes po, kapag wala po magkakaroon ng violation sa ordinansa, kulong ang mga doktor."

MS. MARILOU ARRIESGADO "Thank you po."

HON. REYNALDO PALABRICA "For medical malpractice."

MS. CAROLINA MACALINAO "Good morning po. Clarification lang po... magtatanong lang po ako regarding sa Strike Family Day every Saturday. Ang tanong ko lang po, yun po bang Family Day natin na every Saturday per barangay, kung saan nandoon ang mga NGO, ay kami po ba ay maiimbitahan?"





Kasi po kami po ay nakakalat per barangay. Napakadami pong NGO, so ang tanong ko lang kung sino pong NGO ang nasa barangay kami po ba ay malimbihan? Yun lamang po Si, salamat po."

HON. HORACIO BRILLANTES JR. "Thank you for that question. I would like to acknowledge that question for Councilor Noly Galvez to answer it."

HON. MANOLO GALVEZ JR. "Thank you Mr. Chair. Ang magiging head ng ating programa ay ang CSWD, so lahat po ng mga volunteer groups, si CSWD po mag-iischedule sa inyo kung saan po kayo mag-aattend ng Strike Family Day. So si CSWD po ang mag-hehead or mag-lelead ng Strike Family Day. So sila po ang magsasabi sa ating organization kung saan po kayo ma-aassign. So hindi po porket organization tayo at may nakita po kayo Strike Family Day, pupunta po kayo roon, di po ganun. CSWD will give you the schedule, at hindi po lahat nang organization, dahil baka po sa unang Sabado pa lang po ay mawalan na po kami ng pondo. Kailangan po talaga schedule po tayo, through our CSWD. Yun lang po, Mr. Chair. Maraming salamat po."

HON. REYNALDO PALABRICA "Siguro Mr. Chair, Honorable Galvez, with your kind indulgence, siguro ang role ng mga NGO rito, I propose, kayong mga NGO ay maging arm ng City Government with regards to the implementation of this ordinance na kayo ung mag-inform, maghikayat ng ordinaryong tao, hindi ung tayo mismo nandun. Ibaba natin sa ordinaryong tao, walang kinalaman dito sa gobyernong ito para maramdaman nila ang gobyerno natin. Kayo dapat ang, kayong mga NGO, honestly speaking ang mga NGOs natin ang political partners din ng City Government. So, kayo ung ano, kung maari kayo ung magdala sa mga taong hindi naabot ng serbisyo ng gobyerno. Kasi baka mangyari, papupuntahin nyo lahat ng mga member ninyo, un din naman ang mag-aavail ng serbisyo ng gobyerno, the same faces, the same persons. Kaya tuloy sa facebook, ung di naabot ng gobyerno ang sasabihin hindi naman namin alam yan eh, nababash pa tayo. So, if we love the mayor at talagang may prinsipyo kayo para sabi nyo dito, pag na- accredit kayo dito gusto ninyo tumulong sa kapwa tao, kaya minsan gusto ko maging kapwa na lang. Gusto nyong tumulong sa kapwa tao this is the right time, dahil bababa ang City Government, ang services ng City Government. Tulungan ninyo and City Government na marating ang serbisyo publiko na marating ang taong gusto maka-avail, hindi ung kayo ang pupuno ng venue. Kayo ang magdadala ng tao papunta dun sa venue para mapagsilbihan natin. Pwede kaya un sa mga NGO?"

ALL NGO "Yes."

HON. REYNALDO PALABRICA "Sabi nyo yan ah. Teka lang, baka magkaproblema sa pagkain pagdating dun. Ang hindi abutin ng pagkain, pasensya na, kasi di naman mabibilang ng CSWD yan eh. Sa totoong buhay, hindi nila mabibilang yan, maglalaan lang yan ang sasabihin ng partner NGO ganito maglalagay sila





10 pagkain ang dumating 20, abay galit na galit na. Hindi dapat ganun. Fiesta 'to, birthday ni Mayor 'to, kung nagugutom, birthday ni Mayor, dami lechon dito. Pero dun sa family day, sa kanya-kanyang lugar, dapat unawain din ninyo ang kakayahan ng City Government kung hanggang saan kayo magpuno. Pwede kaya un?"

AUDIENCE "Opo."

HON. REYNALDO PALABRICA "Parang hindi, parang hindi."

HON. HORACIO BRILLANTES JR. "Parang isa lang ung nagsalita. Yes po, Ma'am Naty, acknowledge po."

MS. NATIVIDAD LUDWIG OPLE "Your honors, I would like to manifest that we are all in support of this project. However, I would like to see it on a long-term basis, as an HR Head, I know that there would be a clamor from the employees who will do their duties on a Saturday. So, if there'll be a long term, then that would mean the employees assigned on this project or endeavor will be serving more than 40-hours a week."

HON. REYNALDO PALABRICA "Yes."

MS. NATIVIDAD LUDWIG OPLE "May we request that there will be a provision, stating that the Department Head or the City Government allows the employee to offset it."

HON. REYNALDO PALABRICA "Pwede naman, pwede un. Kasi, sabagay namumpa kayo na maglilingkod ako na lampas sa takdang oras kung kinakailangan. Eh kinakailangan 'to. Oh, baka may reklamo ka rin. Mahal mo ba bayan mo? Mahal mo kapwa mo? O, maglilingkod hanggang sa huling hininga, hanggang sa huling patak ng iyong dugo. Kidding aside Mr. Chair, we take note of the concern of the HR Head, tama naman un. Kasi ganito un eh, ganito un. Prinopromote natin ang family day pero sa empleyado, hindi nya na-eeenjoy ang family day di ba? Napaka ironic. Parang si Ma'am Lilian, family day yan pag Sunday, ngayon andoon ka sa site. Sasama kami para family pa rin. Pero anyway, that is a very good point Ms. Naty, we will take note of that."

HON. HORACIO BRILLANTES JR. "Yes po, Tita Lita, acknowledge po."

MS. CARMELITA F. GAWARAN "Good morning po sa lahat."

MS. EMILIANA UGALDE "About NGOs. The other day, may meeting ako with NGOs, we encourage them, ang gusto nila as 1. And kung natatandaan nyo na sinabi sa inyo ni Mayor na kayo ang helping hand with the implementation of the family day. So tama po si konsehal, hindi sila kliente kundi sila ay extension or helping hand of the mayor para humanap ng mga kliente na pwede makasama. So un pong meeting natin the other day is for this ordinance kaya ung invitation po as





per instruction meron po kayong launching and meron pang isang pagmemmeeting ng lahat ng mga key persons na involved sa implementation para po mas maayos ang pagbaba at pag implement, yun lang po."

HON. REYNALDO PALABRICA "Mr. Chair, siguro isama na rin dito sa ordinance din ung role ng NGOs para defined na rin especially those NGOs accredited by the Sangguniang Panlungsod. Nanumpa kayo rito kay Konsehal Rey Fabian na tutulong kayo sa kapwa, sinabi nyo un, narinig ko un. Kaya ngayon ipatutupad na natin yan, isasama na natin yan sa ordinansya para sa ganun may guide tayo kung papano ang role ng bawat isa sa atin. Wala na sigurong tanong."

HON. MANOLO GALVEZ JR. "Meron ako."

HON. HORACIO BRILLANTES JR. "Go ahead, Councilor Noly."

HON. MANOLO GALVEZ JR. "Thank you Mr. Chair. Kanina po nagkaroon tayo ng kuro kuro o nagkaroon po tayo ng question dun sa ordinance declaring March 2, every year for Strike Family Day. Tama po ang ating kagalang-galang na Konsehal Rey Palabrica na dapat po ito ay magkaroon pa ng masusing pag-aaral para po sa correction ng title, then minumungkahi ko rin po na mai-add po sa ordinansang ito na gawin po natin na sa kada kanyang barangay na activity mula po March 2, seven (7) days mula March 2, dun po sila pwede mag-activity para po hindi matamaan ung araw na may pasok ang mga bata. So minumungkahi ko po, Kagalang-galang na tagapamahala na isama po mula Marso 2, ang bilang po ay pitong (7) araw para po sila ay magcelebrate ng Strike Family Day sa kanilang mga barangay. Yun lang po kagalang-galang na tagapamahala."

HON. HORACIO BRILLANTES JR. "Okay, thank you Councilor Noly Galvez. Yes, Ate Lita, go ahead."

MS. CARMELITA F. GAWARAN "Good morning, everyone. Nais ko lang din po sana imungkahi natin na ma-specify natin sa ating ordinance kung ilang pong percentage ng pondo ng barangay ang i-aalot para po dito sa Strike Family Day. Kasi para po maging general, kunyari po 5% of their fund."

HON. HORACIO BRILLANTES JR. "Sa madali pong sabi ate Lita, iminumungkahi nyo po na idagdag sa budget ng barangay ang Strike Family Day kung nila pupwede pagkunan. Tama po ba? So un po ung minumungkahi?"

HON. REYNALDO PALABRICA "Yung percentage po, hindi po natin madedefine, hindi natin pwede ilagay sa ordinansa na mandatory ang percentage. Kasi katulad ng City Government, ang Barangay Government ay may ganung function din, malawak din. So meron silang disaster preparedness, meron silang peace and order, everything. Tapos ung mga iniimplement natin na mga program katulad ng mga nutrition at kung ano-ano pa ay pinopondohan din ng





barangay government yan. Kaya hindi tayo pwedeng maglagay ng specific percentage para sa Strike Family Day. Ang pwedeng gawin ng barangay ay ganito, katulad ng sa City Government, ung mga pondo nyo ngayon, un ang ginagamit nyo sa Strike Family Day activities. So yung pondo nila ngayon, aligned dun sa mga programa, halimbawa, ang VAWC or pang Women's, pang Nutrition, pang child protection na programa, pwede nila gamitin para dito sa Strike Family Day. Pero pag sasabihin na maglagay ng specific percentage para sa Strike Family Day, mandatory, it will be detrimental on the part of the barangay government. Hindi naman pwedeng ganun, ang pwedeng gawin i-align sa programa ng City ang programa ng barangay pati funding naka-align para magsama na lang. Thank you."

HON. HORACIO BRILLANTES JR. "Sige po Doktora Ivy."

DR. IVY MARIE YRASTORZA "Regarding that po. Usually ina-allow naman po natin ung mga barangays po natin na kapag may mga ganyan po activities to outsource. So pwede po kasing, kunwari within the barangay may mga organizations or businesses na willing po tumulong or magbigay po ng services in relation po sa ating family day, mas maganda po un kasi po para lahat po talaga is nakakasali. Kanina po nag-uusap usap po kaming mga Department Heads, na baka po pupwede dun sa mga barangay na after po nung March 2 is gawin po nating pa-contest sa mga barangays, kung baga they can be innovative para po kung ano po ung makita natin na practices ng mga barangay para sa kanilang mga pamilya un po ung pwede magbigay ng award ang City Government para din po hindi same same services lang po ung ibababa sa mga barangay."

HON. REYNALDO PALABRICA "So kung meron kunwari agricultural barangay, pagtatanim yun naman ang isasama nila dito sa Strike Family Day, magtuturo sila. Kung halimbawa may barangay na magagaling sa, kung ano ung kanila kagalingan. Yan ba ibig mo sabihin doktora? Yun ba ung ibig mo sabihin, un ba ung suggestion mo?"

DR. IVY MARIE YRASTORZA "Yes po Konsi. Saka un nga po kung may mga within the barangay po nila na nasasakop nila like businesses or schools na gusto po mag-join or magbigay ng programa, it should be encouraged po kasi para po lahat po talaga ay makasali."

HON. REYNALDO PALABRICA "Maganda nga yun."

HON. MANOLO GALVEZ JR. "Mr. Chair, Kagalang galang na Konsehal Palabrica. Parang nakikita ko yung suggestion ni doktora, kung ang isang barangay ay gumawa ng isang activity para sa Strike Family Day, ipapasa po nila sa ating lead, ang CSWD para po kung ano ung the best family day na ginawang barangay, dun po tayo mag-aaward ng the best Strike Family Day sa 7 days po na activity





po na ginawa nila dun sa barangay nila. Tama po? Nililina ko lang po ung ano po ni Dra. Ivy, tapos po kung agriculture po, sa nagtatanong, pwede rin po un. So noted, siguro isama rin po natin sa ordinansa Ma'am Lilian siguro po magkaroon tayo ng pagpupulong para lalo pa ho nating mapaayos at mapaganda ang ordinansang ito."

HON. HORACIO BRILLANTES JR. "Thank you, Councilor Noly Galvez. Yes po, ma'am."

MS. ROSE MATTA "In relation po dun sa suggestion ni Dra. Ivy, kasi may nabasa ako dito sa Section 5, letter E. It says barangay family challenges friendly competitions amongst families in different barangays. So palagay ko macocover na sya dito."

HON. REYNALDO PALABRICA "Noted po un. Actually, marami pa dapat baguhin dito sa mga provisions katulad dito specific, March 2 lang 'to, pero ang pinag-uusapan natin dito every Saturday for the 7 Saturdays so isasama na rin natin yan including your concern doktora. Thank you po."

HON. HORACIO BRILLANTES JR. "Thank you. Any questions coming from the resource persons or barangay? Sa mga City Councilors? Sige po, go ahead."

HON. REYNALDO PALABRICA "Last question."

MS. EVA BALINOG "Meron lang po akong itatanong. Kasi po bilang hindi po sya maide-declare as holiday, di ba per barangay yung activity. Paano kung yung barangay na un, ang activity involved ang mga bata. Eh March 2 aalm ko po nakaschedule si DepEd na exam ung mga bata. So masasagaan ung..."

Definitely syempre, matatalino mga department heads natin, hindi nila sasagasaan ang napaka-importanteng activity ng isang tao kaya ang madedesign na activity dito definitely hindi sasagasa sa concern mo. Thank you."

HON. HORACIO BRILLANTES JR. "Thank you Councilor Rey Palabrica for that answer. Siguro pwede nako magdeclare ng one more last question. Baka meron pa? Wala na? Dun sa mga kasamahan ko pong City Councilor? Councilor Mike?"

HON. MIGUEL BAUTISTA "Mr. Chair, sa tingin ko wala naman tututol dito ung magkaroon tayo ng ganitong programa yung Bacoor Family Day at ano ba magiging bunga nito to our family? Syempre, it's ang opportunity for us to celebrate with our family, sa community dun ung unity at sabi nga kanina ung





mga services na mararamdaman ng ating mga constituents. So sa tingin ko ay maganda 'to para sating lahat. Yun lang po Mr. Chair."

HON. HORACIO BRILLANTES JR. "Thank you Councilor Mike Bautista. Councilor Dominguez."

HON. SIMPLICIO DOMINGUEZ "Maganda umaga po uli. Maganda po itong ating programa, tayong lahat suportahan nating itong programa na ito sapagkat bihira lang po mangyari. Yun lang po, maraming salamat."

Mr. Chair, there being no more questions being raised, nagpapasalamat ko kami sa inyong lahat dahil sa pakikiisa ninyo sa panukalang ito Strike Family Day na ipinanukala ni Konsehal Manolo Galvez at pinapangalawahan ng lahat ng konsehal. Maraming maraming salamat sa suporta ninyo. Tunay na pinapakita ninyo na tayo dito sa Bacoor ay iisang pamilya, kaya meron tayong Strike Family Day na gagawin. With that Mr. Chair, I respectfully move for the adjournment of this public hearing. So, I move."

HON. HORACIO BRILLANTES JR. "Any second?"

HON. MANOLO GALVEZ JR. "Second."

HON. HORACIO BRILLANTES JR. "Is there any objection to this public hearing?"

HON. MANOLO GALVEZ JR. "None."

HON. HORACIO BRILLANTES JR. "Hearing adjourned."

The committee hearing was adjourned at 10:45 AM.

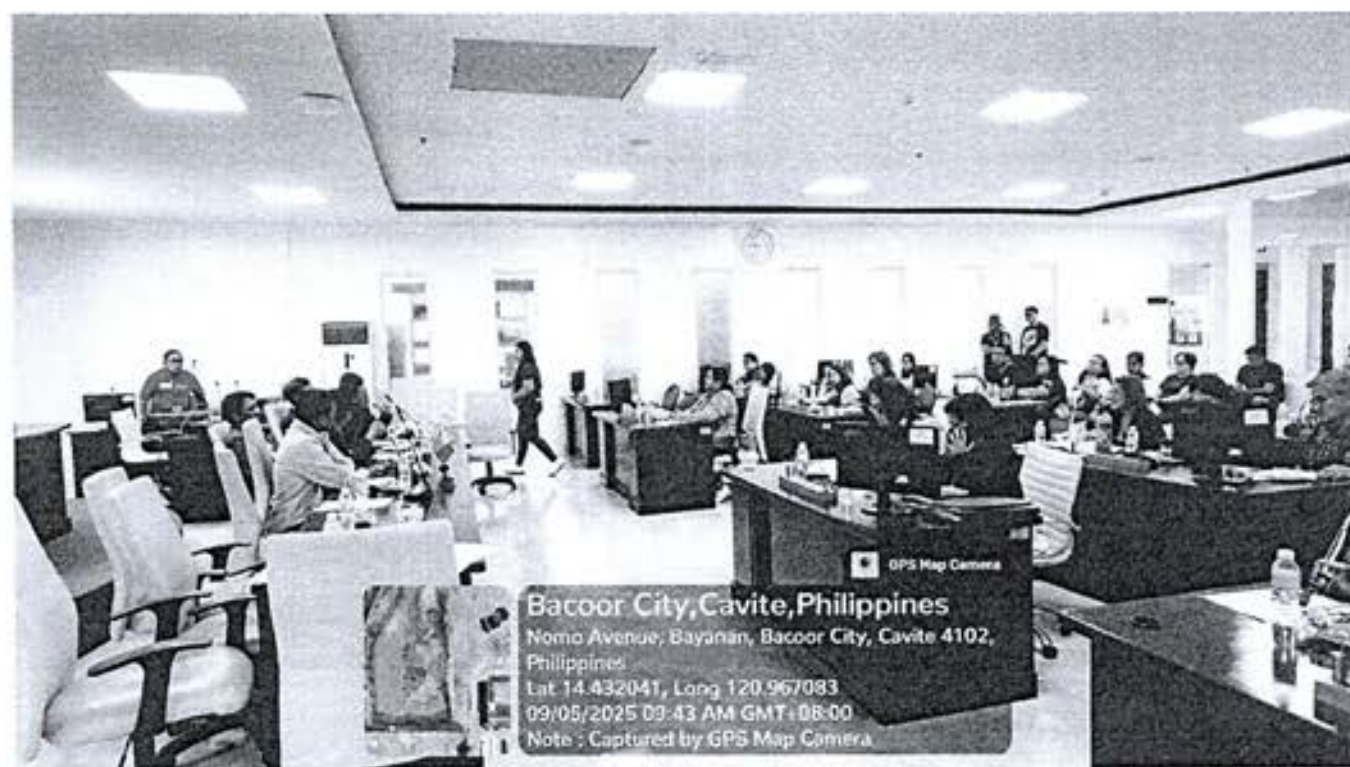

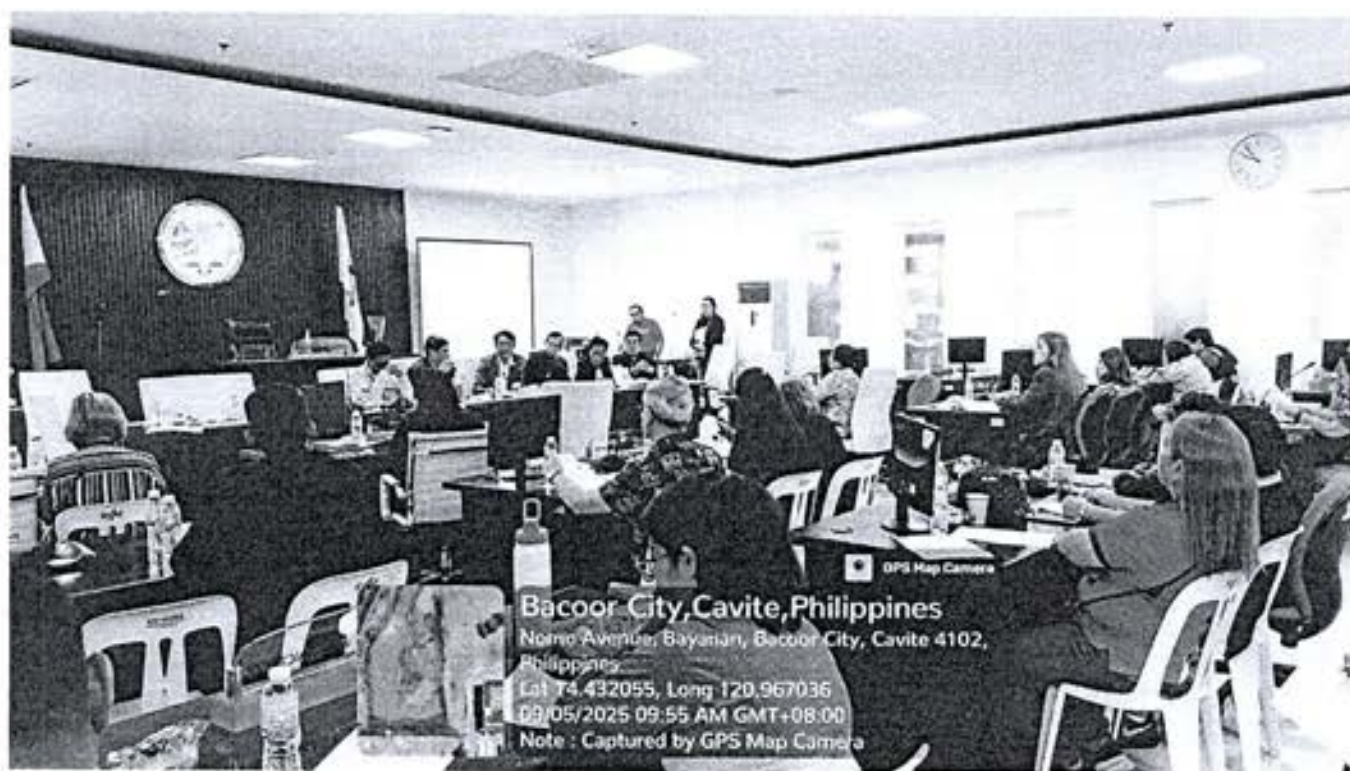

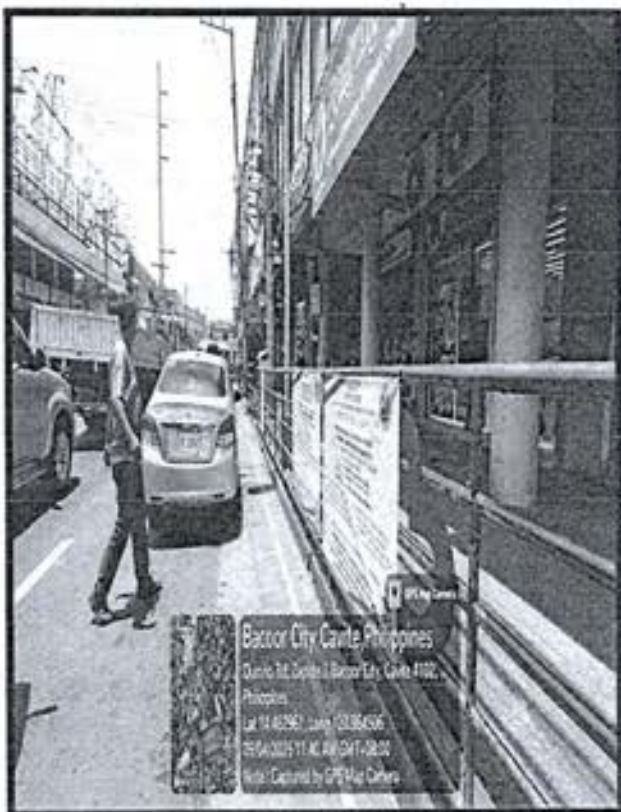

WHEREAS, commemorating March 2 annually as Bacoor City Strike Family Day seeks to institutionalize activities that foster community cohesion, family bonding, civic participation, and a culture of excellence in governance;

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Bacoor, in session duly assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as the "Bacoor City Strike Family Day Ordinance of 2025."

SECTION 2. DECLARATION OF A SPECIAL CITY CELEBRATION. March 2 of every year is hereby declared as "Bacoor City Strike Family Day," in celebration of the Filipino family as the foundation of nation-building.

SECTION 3. OBJECTIVES. The celebration shall aim to:

- a. Promote the values of unity, service, compassion, and love within families and communities;
- b. Recognize the Strike Revilla Family as a symbol of leadership rooted in family values and public service;
- c. Encourage public and private sectors to engage in activities strengthening family ties and civic participation;
- d. Institutionalize community-wide programs that honor family-oriented governance.

SECTION 4. LEAD AGENCY AND IMPLEMENTING OFFICES. The Office of the City Mayor shall be the lead agency for the implementation of this Ordinance, in coordination with:

- City Social Welfare and Development (CSWD)
- Local Youth Development Office (LYDO)
- Public Employment Service Office (PESO)
- City Information and Community Relations Department (CICRD)
- City Livelihood and Development Department
- Office of the Agricultural Services
- E-Governance Department/MIS
- Liga ng mga Barangay
- Sangguniang Kabataan Federation
- Department of Education – Bacoor Division
- Accredited civic organizations

SECTION 5. SUGGESTED PROGRAMS AND ACTIVITIES. The City Government shall conduct and support the following activities during the week of March 2, culminating on Bacoor City Strike Family Day:

- a. Family Day Fair- A community fair featuring booths, games, food stalls, and family-centered activities.
- b. "Strike ng Bayan" Awards- Recognition ceremony honoring exemplary Bacoor families in various sectors (e.g., education, health, volunteerism, entrepreneurship).
- c. Public Service Caravan- One-stop-shop for government services (medical/dental missions, job fairs, livelihood programs).
- d. Unity Fun Run and Zumba- Family wellness activities promoting health and togetherness.
- e. Barangay Family Challenges- Friendly competitions among families from different barangays.
- f. Parenting Seminars and Youth Development Forums- Talks on strengthening family relationships, responsible parenthood, and youth empowerment.

SECTION 6. BUDGET APPROPRIATION. The necessary funds for the implementation of this Ordinance shall be included in the Annual Investment Plan and appropriated from the General Fund of the City Government or sourced from other available lawful sources, subject to existing accounting and auditing rules and regulations.

SECTION 7. PUBLIC INFORMATION. The City Information and Community Relations Department (CICRD), in coordination with barangay officials and schools, shall ensure widespread dissemination of this Ordinance and its related activities through posters, announcements, and social media campaigns.

SECTION 8. SEPARABILITY CLAUSE. If any provision or part of this Ordinance is declared unconstitutional or invalid, the remaining parts or provisions not affected shall continue to be in full force and effect.

SECTION 9. REPEALING CLAUSE. All ordinances, executive orders, and other issuances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 10. EFFECTIVITY. This Ordinance shall take effect immediately upon approval by the City Mayor and its publication of at least once in a newspaper in a general circulation within the Province of Cavite.
