

AGUIRRE, LOCATED IN BARANGAY MOLINO II, BACOOR CITY, CAVITE FOR THE ESTABLISHMENT, DEVELOPMENT AND CONSTRUCTION OF AN IN-CITY RESETTLEMENT AND RELOCATION SITE AND TOWNSHIP DEVELOPMENT PROJECT FOR THE BENEFIT OF INFORMAL SETTLER FAMILIES AND ECONOMICALLY CHALLENGED FAMILIES IN THE CITY OF BACOOR, CAVITE (PCO 2025-024 dated July 14, 2025).

The committee held a joint committee meeting on July 31, 2025, at 11:45 AM and a joint committee hearing on August 14, 2025, at 1:27 PM. It was presided over by the Chairperson of the Committee on Housing, Land Utilization and Urban Development, Hon. Horacio M. Brillantes Jr. The minutes, attendance sheets, and pictures taken during the said hearing are attached hereto and shall be made integral parts of this report.

FINDINGS:

Pursuant to Section 19 of the Local Government Code of 1991 (Republic Act No. 7160) authorizes local government units, through their chief executive and under an ordinance, to exercise the power of eminent domain for public use.

The City Government assessed several potential sites for the establishment of a township project as part of an in-city resettlement and relocation program for informal

settler families residing in danger zones, coastal areas, roadways, railroads, and those displaced by government projects. After evaluation conducted by the City Government, the most suitable site was identified in Barangay Molino II, Bacoor City, Cavite, more particularly described as follows:

To carry out this project, it is necessary for the City Government of Bacoor to expropriate the property owned by Tomas B. Aguirre for the purpose of establishing and constructing the said resettlement and relocation site.

In accordance with the Constitution, applicable laws, and due process requirements, the City Government offered to purchase the property. The said written offer was not accepted by Mr. Aguirre and by his successors-in-interest.

Despite such offers, the registered owner has not responded.

Given the urgent need to provide an adequate in-city resettlement site for the poor, landless, underprivileged, and homeless, the City Government of Bacoor must proceed to acquire the entire property of Tomas B. Aguirre.

However, before expropriation proceedings may be initiated under Section 19 of the Local Government Code, an ordinance must first be enacted authorizing the City Mayor to acquire the above-described property by expropriation.

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Joint Committee hereby recommend TO APPROVE the proposed city ordinance authorizing the City Mayor -Hon. Strike B. Revilla to initiate and file expropriation proceedings over the seventy-one thousand thirty-six square meter (71,036.00 SQMS) lot covered by TCT NO. T-79371 under the name of Tomas B. Aguirre, located in Barangay Molino II, Bacoor City, Cavite for the establishment, development and construction of an in-city resettlement and relocation site and township development project for the benefit of informal settler families and economically challenged families in the City of Bacoor, Cavite.

The joint committee hearing was executed on August 14, 2025, at 1:27 PM at the Sangguniang Panlungsod Session Hall, 6th floor, Bacoor Legislative & Disaster Resilience Building, Bacoor Government Center, Bacoor Boulevard, Brgy. Bayanan, City of Bacoor, Cavite. It was presided over by Committee on Housing, Land Utilization and Urban Development Chairman, Hon. Horacio Brillantes, Jr. and proceeded with the roll call.

Ms. Anne Medina from the Housing, Urban Development and Resettlement Department pointed out that above mentioned land, once acquired, will be used for a socialized housing project. It was also cited that this parcel of land is near another socialized housing project namely the Ciudad de Strike.

According to Engr. San Jose, the land is classified as socialized housing based on the approved comprehensive land use plan and that it already has an adjacent access road. As reported by Ms. Therese Leoncio from the City Assessor's Office, the market value of the land is at Php4,732 per square meter based on the adjoining properties that have been declared as residential.

Atty. John Philip Cabugao, the Corporate Secretary of El Grande Corporation, appreciates the fact that he was invited formally through the City Council. He was at the

same time asking what is the difference between this project and Ciudad Pagbabago. Ms. Anne Medina clarified that Ciudad Pagbabago is also a socialized housing project of the City Government of Bacoor in a 35-hectare land located in Daanghari, Molino 4.

Atty. John Philip Cabugao also made it clear that El Grande Corporation redeemed the land as stated in the title's annotation and is basically now owned by the said corporation. Honorable Reynaldo Palabrica has instructed the Zoning and Legal Departments to identify who is the proper body to talk to with regard to the expropriation of the land.

Atty. Marco Mendoza emphasized that correspondences were sent to El Grande Corporation sometime July or August of the previous year, however, a decision has not been made up until this day. He would also like to know if El Grande Corporation will accept or refuse the offer to buy.

Atty. Cabugao disclosed that there are still classified issues that need to be resolved before they are able to make a decision regarding the city's offer to buy.

With this information, Honorable Reynaldo Palabrica moved for an executive session at 1:52 PM so that Atty. Cabugao may privately discuss the reasons behind the delay in deciding with regards to the City Government's offer. The executive session ended at 2:00 PM.

Honorable Reynaldo Palabrica moved for the suspension of the Joint Committee Hearing and was duly seconded by the presiding officer Honorable Horacio Brillantes, Jr. The Joint Committee Hearing was suspended at exactly 2:01 PM.

Honorable Reynaldo Palabrica, wanted to make sure if the land in question has a title since this hearing is about filing an expropriation case.

Atty. Marius Sumira confirmed that the land is titled but with the following issues:

1) No denial/refusal - it was indicated in the title that the land was subject for public auction since it was mortgaged to Banco Filipino, which was later redeemed by El Grande Corporation. An offer to buy the land was sent in September, to which the Corporate Secretary responded that they still need to discuss the matter with the Board Members. There is a need for the City Government to know if they are accepting the offer to buy or refuse it.
