Subject: *An ordinance formulating the system of cleansing the directory of Senior Citizens, Persons with Disabilities and Solo Parents residing in the City of Bacoor and mandating the registration of the said individuals in the said directories.*

(Date referred: July 14, 2025)

The above-mentioned proposed resolution underwent its first reading on July 14, 2025 during the 2nd Regular Session of the 6th Sangguniang Panlungsod. The said proposed resolution was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

The Committee on Rules, Privileges, Laws and Ordinances sent out invitations to the resource persons and conducted several committee hearings on the above-mentioned subject matter at the Session Hall of the Sangguniang Panlungsod.

After due consultation and deliberation hereby report back to this August Body the findings, information gathered, and recommendation on the above-subject matter. Attached hereto are the attendance sheet and photos taken during the said hearing.

FINDINGS:

This proposed City Ordinance was written and lobbied upon the determination of the Sangguniang Panlungsod that persons with unsavory character have fraudulently obtained senior citizen cards, PWD cards, and solo parent cards and have used the same to dupe the City Government and various business establishments operating within the City of Bacoor.

Ordinance cleansing the directory of Senior and PWD





Republic Act No. 9994 or the "Senior Citizens Act of 2010", Republic Act No. 10754 or the "Expanded Benefits and Privileges of Persons with Disability Act" and Republic Act No. 11861 or "the Expanded Solo Parents Act" are laws enacted to guarantee compliance by local governments and the private sector with the aforementioned constitutionality guaranteed rights of senior citizens, persons with disabilities, and solo parents.

The Office of the Senior Citizens Affair (OSCA), City Social Welfare Development Department (CSWDD), and Persons with Disabilities Office (PDAO) need to formulate a system that will enable them to cleanse their respective master lists and convert the same into digital directories that can be accessed online by any government agency or by any business establishments as a way of verification to prevent the commission of various fraudulent acts.

In this proposed ordinance, the E-Governance Department in close coordination with the OSCA, CSWDD, and PDAO is mandated to a digital directory for senior citizens, persons with disabilities, and solo parent residing in the City of Bacoor.

Upon the manifestation of the E-Governance Department that they are not recommending to impose subscription fee for the access to digital directories, for it will give a bad impression to the City Government by imposing such fee, Section 6 of this proposed ordinance is deleted/removed.

"SECTION 6. Subscription Fee for Access to Digital Directories"

RECOMMENDATION:

After a thorough review of all the circumstances and statements from the resource persons, and the provisions of the proposed ordinance, the Committee respectfully recommends that the Sangguniang Panlungsod approve the above subject matter on 2nd reading during its next regular session.

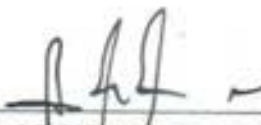

Ordinance cleansing the directory of Senior Citizens and Persons with Disabilities





COUN. REYNALDO PALABRICA "Good morning, everyone. The hearing regarding the proposed ordinance entitled an ordinance formulating the system of cleansing the directory of Senior Citizens, Persons with Disabilities and Solo parents residing in the City of Bacoor and mandating the registration of the said individuals in the said directories is now called to order."

COUN. REYNALDO PALABRICA "For the record, in attendance to this hearing are honorable members of the city council, whom we are requesting for their opening statement, we start from District one, Councilor Levy Tela."

COUN. LEVY TELA "Thank you, Mr. Chair, good morning, also, good morning to all resource persons present, all the senior citizens. Thank you."

COUN. REYNALDO PALABRICA "Thank you very much, next is the senior citizen committee chairman, honorable councilor, Simplicio Dominguez."

COUN. SIMPLICIO DOMINGUEZ "Magandang-magandang umaga sa kapwa natin senior, mabuhay po tayo."

COUN. REYNALDO PALABRICA "Thank you very much, next is from District one, honorable councilor Mike Bautista."

COUN. MIGUEL BAUTISTA "Magandang umaga po sa ating lahat, mabuhay."

COUN. REYNALDO PALABRICA "Thank you very much, mabuhay. Next from District two, honorable councilor Bok Nolasco."

COUN. ROGELIO NOLASCO "Maraming salamat laga pangulo, isang pagbati po ng magandang umaga sa atin pong lahat ng panauhin, maraming salamat po at mabuhay."

COUN. REYNALDO PALABRICA "Maraming salamat councilor Bok Nolasco, mabuhay. Last but not the least, from District one, honorable councilor Eric Ugalde."

COUN. RICARDO UGALDE "Thank you Mr. Chair, good morning, everyone, I am Ricardo Ugalde councilor from District one, thank you."

COUN. REYNALDO PALABRICA "Thank you very much. May request the resource persons present to introduce themselves and their representation, for the record, we start with president of senior citizens federation."

NENITA REYES "Good morning to all, its nice to be with you today, Nenita Reyes, president of Federation of Senior Citizen sa Bacoor City."

COUN. REYNALDO PALABRICA "Thank you very much."

ROSS ARIEL RUBION "Good morning po sa lahat, Ariel Rubion, representative from City Social Welfare Development."

COUN. REYNALDO PALABRICA "CSWD? Okay, next."

CHRISTOPHER RIVERA "Christopher Rivera po from BMIS."

COUN. REYNALDO PALABRICA "BMIS? Next. Of course, our OSCA Chairman, the honorable former councilor Attorney Venus De Castro."

ATTY. VENUS DE CASTRO "Magandang umaga po sainyong lahat, sa atin pong mga kasama dito, but most especially to our honored law makers, councilors from District one and two, marami pong salamat, napakaganda at importanteng-importante ang ating pag-uusapan natin





ngayon, thank you very much for your concern sa aming mga seniors, PDAO at sa mga solo parents, very timely po ito, maraming salamat po."

COUN. REYNALDO PALABRICA "Thank you very much Atty. De Castro. Also, the assistant, kindly introduce yourself for the record."

MERCY MANSANIDA "Ako po si Mercy Mansanida, assistant po ng OSCA Bacoor."

COUN. REYNALDO PALABRICA "Thank you, from the legal services department."

ATTY. REY MARCO MENDOZA "Good morning po Mr. Chair, attorney Marco Mendoza po, from the Office of the City Legal Services."

COUN. REYNALDO PALABRICA "Thank you very much attorney Marco. Next. The district two federation president of senior citizen."

LORNA PALO "Good morning po sa ating lahat, ako po si Lorna Palo, presidente po ng Confederation ng Senior Citizens Association ng District two at presently ako rin po ang presidente ng Queen's Row Central Senior Citizen Association."

COUN. REYNALDO PALABRICA "Thank you very much po pres. Next po,"

ARZENIA CONSTANTINO "Magandang umaga po sa ating kagalang-galang na mga city councilors of Bacoor, ako po si Arzenia Constantino, president of Federation of Senior Citizen of District one."

COUN. REYNALDO PALABRICA "Thank you, mabuhay. Next, from Persons with Disability Office."

GINA ABUAN "Good morning po, ako po si Gina Abuan, staff po ng PDAO Office po."

COUN. REYNALDO PALABRICA "Thank you. Next."

MELODY TUBICE "Good morning po, Melody Tubice, PDAO Staff and at the same time president of PDAO in Maliksi 1 po."

COUN. REYNALDO PALABRICA "Thank you very much. Next po."

RESOURCE PERSON "Hello, good morning po sa ating lahat, PWD Federation officer po, treasurer, president po sa Molino 4."

COUN. REYNALDO PALABRICA "Thank you very much, next po."

MA. CONCEPCION MALINIS "I'm Ma. Concepcion Malinis po, federation officer po, auditor po, residente po ng Kaingin Digmaan."

COUN. REYNALDO PALABRICA "Thank you."

COUN. REYNALDO PALABRICA "Ang pag-uusapan po natin today is papaano lilinisin, aayusin ang listahan ng directory ng mga senior citizens at PWD. So before anything else, we would like to get some information from BMIS, mayroon ba tayong record ngayon sa sistema? Kung anong mayroon kayo pakipaliwanag sa committee."

BMIS STAFF. "Magbabased po doon sa COMELEC registration at sa iprepresent nilang Senior ID, para ma justify po na talaga po sila sa atin."





COUN. REYNALDO PALABRICA "So, yung pinaka database natin ang pinanggagalingan, or data, nanggaling doon sa COMELEC registration, so kasi nakalagay doon kung kailan yung birthday tapos tapos ang inyong system ageing, pagka sixty, automatic yung pangalan nay un ay mapupunta sa list, tama? Ang problema lang, ang nakikita ko diyan, papaano yung mga naka rehistro, kasi may sakit? Paano kung hindi na siya actively participating on elections kasi yun nga yung iba bedridden na? tapos yung iba naman hindi talaga makalakad? Kumbaga, physically unable to participate such activities, so possible na wala, hindi rehistrado, hindi siya kasali sa Senior Citizen list natin."

(AUDIO UNAUDIBLE)

COUN. REYNALDO PALABRICA "Mayroon naman tayong non-active list? Kasama sa directory? So, hingi lang kami ng opinyon kay Attorney Venus. Yung data na hawak niyo is the same data na hawak ng BMIS? Magkaiba?"

ATTY. VENUS DE CASTRO "Sa amin po, ang nasa listahan po namin ang mga nag-apply lang ng OSCA ID, sa kasalukuyan po, sa record namin, 2019 to 2024, ang total na ID na naissue namin ay sa aming palagay ay ang population na pumapasok sa amin ay eighty thousand, seventy-five (80,075) persons, ang female po ay forty-six thousand, eight hundred seventy-two (46,872), at male ay thirty-three thousand, two-hundred three (33,203). Regularly, monthly ang LCR po nagpropose sa amin ng listahan ng mga deceased persons at nagpapasalamat po kami sa mga various associations especially ng federation, kasi nagbibigay po sila ng listahan nung mga seniors na delisted, deceased, at saka yung unlocated, kami po ay updated sa aming mga records, para sa ganun malaman po namin kung ilan po ba talaga ang senior citizen na wala na po yun. Yung mga deceased, transferred, may tallo po kaming separated folders, kaya po, alam po ninyo, napakaganda po nito kasi mayroon kaming na nawitness po sa isang restaurant, isang PWD, nagbigay ng kanyang PWD ID para sa deductions pero po, vinerafy po nung sa loob at nalaman nilang hindi iyon ang proper ID, kasi wala sa listahan, kaya hindi siya nabigyan. Mayroon din instances na may fake ID, tapos yung mga ID na binibili, kaya napakaganda po nitong proposed ordinance ninyo."

ATTY. VENUS DE CASTRO "On the part of OSCA po, we aim po namin na at least we are accurate, accurate number ng mga seniors na nandito sa Bacoor, pero po, hindi rin matatawag na complete kasi tulad ng sabi ninyo, senior citizens na hindi nakakaregister sa OSCA o sa barangay, kasi wala silang COMELEC ID. Mayroon po akong nakitang ganun po, hindi tinanggap sa barangay, sa associations, hindi sila voters."

COUN. REYNALDO PALABRICA "Ang record po ninyo nasa computer data base? Hindi naman mano-mano?"

ATTY. VENUS DE CASTRO "Hindi po. Nasa drive po."

COUN. REYNALDO PALABRICA "BMIS, sabi ni Atty. Venus, ang ating population ng Senior Citizens ay eighty thousand?"

ATTY. VENUS DE CASTRO "Eighty-thousand, seventy-five, 2019 to 2024."

COUN. REYNALDO PALABRICA "Eighty-thousand, seventy-five?"

ATTY. VENUS DE CASTRO "Opo."

COUN. REYNALDO PALABRICA "Sa inyo ilan?"





ATTY. VENUS DE CASTRO "With your kind permission Mr. Chair, dito po sa aming listahan, nandiyan po yung 60 to 65, 66 to 71 and so on, hanggang sa 100 years po yan."

COUN. REYNALDO PALABRICA "BMIS, ilan yung population sainyo? Based on your record."

BMIS STAFF "Bale po yung 60 to 64..."

COUN. REYNALDO PALABRICA "Yung total lang. For the meantime, sa PWD, ilan yung population niyo ngayon sa record ninyo?"

MELODY TUBICE "As of now po, we issued PWD ID of 11, 959."

COUN. REYNALDO PALABRICA "11, 959? Yung record niyo nasa BMIS din?"

MELODY TUBICE "Yes po."

COUN. REYNALDO PALABRICA "So, nagtatally kayong dalawa?"

MELODY TUBICE "Yes po, kung ano po yung ID number po na iniissue po ni MIS, yun po yung tally sa record po namin."

COUN. REYNALDO PALABRICA "Ah so yung basis sa record natin yung nagpalista talaga sa atin."

MELODY TUBICE "Opo."

COUN. REYNALDO PALABRICA "Yung naissuan ng PWD ID."

MELODY TUBICE "Opo."

COUN. REYNALDO PALABRICA "Yes, ma'am?"

RESOURCE PERSON "Ito naman po ang list sa federation. Ang aming pong list ay according to the age from 60-101, as of March 31, 2025, ang male po naming ay twenty-three thousand, nine-hundred thirty-eight (23,938) and the female is thirty-three thousand, five hundred seventeen (33,517) with a total of fifty-seven thousand, four-hundred fifty-five (57,455)"

COUN. REYNALDO PALABRICA "District one lang po iyan?"

RESOURCE PERSON "No po."

COUN. REYNALDO PALABRICA "Buong Bacoor ba yan?"

RESOURCE PERSON "Ngayon po, ito po ay as of March 2025, ito po ay kinuha namin doon sa members namin and the Kalinga sa matanda kaya po I think there is a big difference."

COUN. REYNALDO PALABRICA "Pag sinabing kalinga, iyan ay galing sa barangay, nagsusubmit ang barangay association ng senior citizen."

RESOURCE PERSON "Kahit hindi sila member."

COUN. REYNALDO PALABRICA "Sinasubmit niyo sa CSWD kasi sila ang concerned office in performing sa Kalinga sa matanda program. CSWD, ilan ang record niyo?"





ROSS ARIEL RUBION "Based po sa data ni CSWD from the recent Kalinga sa matanda po, sixty-one thousand, sixty hundred thirty-three (61,633) po yung nabilang namin ito po ay is coordination with senior presidents po and coordination with the barangay captains din po natin. So, yearly po, nag coconduct po kami ng updating po sa kalinga sa matanda master list and PWD po, na which is nabilang po namin is twelve thousand, one hundred forty-two (12,142) po."

COUN. REYNALDO PALABRICA "PWD ito?"

ROSS ARIEL RUBION "Yes po."

COUN. REYNALDO PALABRICA "Eleven thousand sa kanila? So may discrepancy rin. Papaanong nangyayari yun? Sa inyo ba nirerequire niyo ng ID? O dumadaan sainyo yung application ng PWD ID's?"

ROSS ARIEL RUBION "Sa amin po kapag nagpasa po ng masterlist ang presidents po at ang barangay captains po, ginagawan po namin ng master list upon verification po during the Kalinga sa matanda, hinihingan po namin sila ng senior ID and PWD ID po, para po macheck at mareverify po kung Senior and PWD po sila sa amin before po sila makatanggap po sila ng assistance po from the City of Bacoor po."

COUN. REYNALDO PALABRICA "When is the last time nagbigay tayo ng Kalinga sa mga matanda at saka PWD?"

ROSS ARIEL RUBION "Ito po is dated from February."

COUN. REYNALDO PALABRICA "Ngayong February?"

ROSS ARIEL RUBION "Yes po. Then, ngayon po is nagawa po kami ng isang master list para in coordination po sa lahat ng senior presidents po at barangay captains, at magbaba po kami ng panibagong master list po, then release po ulit sa barangay."

COUN. REYNALDO PALABRICA "Ayun nga ang problema, kung gagawa kami ng ordinansa, na susundan ng lahat, kasi kung mapapansin ninyo, sinadya ko po tanungin ang bawat isang opisina or stakeholder kung ilan yung population, para makita natin lahat na hindi kayo pareho-pareho and there's something wrong. So, with this ordinance, laayos natin ito, at isang listahan nalang, lalagyan natin ng sistema, papaano mapupunta sa listahan o maalis sa listahan, using the technology, para hindi kayo mahirapan, tulad ng sinabi ng CSWD, ngayon, kailan nga ulit yung programa ng Kalinga? Anong month ang susunod?"

ROSS ARIEL RUBION "December?"

COUN. REYNALDO PALABRICA "So, sa December, ngayon palang mag-uupdate nanaman kayo, so mababalewala nanaman yung naunang listahan, so dapat isang listahan nalang lahat, lagyan natin ng sistema kahit papaano. Pero anyway, the very purpose of this first hearing is for everybody, all the stakeholders to be informed, that we are crafting an ordinance that everyone should follow, on how to put a base system of list or the directory ng ating mga senior citizens and PWD, living or residence of Bacoor. Kasi BMIS iba rin, ang lalayo, ilan na yung total ng senior?"

BMIS STAFF "Sa senior po, a hundred and fifty-four."





COUN. REYNALDO PALABRICA "Mas marami yun. One hundred fifty-four thousand, eighty-nine thousand, sixty-seven thousand. Anyways, hindi lang naman ito ang hearing natin, this is the only the start, para ma put-up na natin yung tamang sistema. Medyo mahabang proseso ito, kung papano natin masasabatas yung perfect system of directory ninyo, ngayon, maraming salamat at nagbigay kayo ng input para alam niyo rin sa sarili niyo na may mal isa listahan ninyo. Nagiging problema din kapag nagbibigay tayo ng giveaways, kaya yung iba may naleft out, yung iba naman nakakadoble because of the existing list that we have, kasi iba-iba."

COUN. REYNALDO PALABRICA "Ang CSWD dapat definitely mayroon, ang basis ng programa ng City Government is the list of CSWD, and supposedly, parehas kayo ng office of the senior citizens, kasi pareho kayo ng city government, pero clearly, hindi magkapareho at malayo, much more malayo sa BMIS, less naman, naiintindihan ko naman, mas less yung sa senior citizens associations, madam presidents, associations, mga barangay, hindi sinasali kung walang membership fee, kaya wala sa listahan, maaring may ganun, tapos galit si presidente sa senior na yun kaya hindi kasali sa listahan, naiintindihan pa rin natin yun, tapos ganun rin naman sa PWD, so kailangan talaga namin pagtrabahuhan pa lalo ng matindi ito."pero ganito po ang gagawin natin, for the meantime, hindi namin mapagsabay-sabay ito, siguro ang magiging steps ng magkaroon kami bg concrete perfect draft ng ordinansa, isa-isahin nalang muna namin, tulad ng PWD or Senior muna, para maiayos namin, not today, hindi natin kaya, kasi kailangan din natin maiayos ang BMIS sala ang MIS, kasi malamang magkaiba rin kayo ng record, kasi kanya-kanyang sistema tayo."

COUN. REYNALDO PALABRICA "So again, we are officially and formally informing everyone that we will drafting an ordinance that everybody should follow, kung papaano ang magiging listahan or directory ng bawat sectors, senior citizens at PWD. May I give the floor to Councilor Nolasco? Yes?"

COUN. ROGELIO NOLASCO "Thank you, Mr. Chair. Kasi ang napag-usapan po natin sa ngayon, is yung senior citizen at PWD, how about the solo parent? Mayroon po bang representative dito po ng solo parent?"

COUN. REYNALDO PALABRICA "Mayroon po Councilor Nolasco, ako po ay solo parent."

COUN. ROGELIO NOLASCO "Sana sa susunod po na hearing natin ay mayroon."

COUN. REYNALDO PALABRICA "Councilor Nolasco, the solo parent representative was invited but unfortunately, hindi siya nakarating ngayon. So isa pa yun sa aayusin natin. Any other concern from the members of the council? Councilor Ugalde?"

COUN. ROGELIO NOLASCO "Mr. Chair, mayroon lang po akong tanong."

COUN. REYNALDO PALABRICA "Yes?"

COUN. ROGELIO NOLASCO "Kung ang isa pong applicant, noong hindi pa siya senior, nakakuha siya ng PWD, example, PWD siya, ngayon nafa sixty years old na siya, kumuha pa rin ng ID ng senior, papano po ba yung record nun? Ang tanong ko, yun ba po ay naiaalis na po sa record ng PWD, at pumapasok na siya sa Senior Citizen kasi hindi naman po pupuwedeng gamitin natin ang dalawang IDs, ng PWD at ng Senior Citizen, kailangan kasi maging aware po tayo doon,





para ang record po ng isang PWD ay nacacancel na bilang nakakuha na ng senior citizen ID. Thank you."

MELODY TUBICE "Sa PDAO po, sa PWD po, automatic po na once senior na po siya, inaalís na po namin siya sa database po namin, sa records po namin, and inaadvised po namin na on the day na senior na po siya, surrender lang po ng PWD ID po at apply na po siya ng senior citizen ID."

COUN. REYNALDO PALABRICA "May concern ako diyan. Ang ganda ng tanong ni Councilor Nolasco, paoano kung may porograma, para sa PWD, at dinilist siya sa PWD, ang pinag-uusapan natin dito ay yung sa twenty percent discount, pero papaano kung may exclusive program sa PWD, regardless sa age, tapos dinilist na sa siya sa list ng PWD, he or she will be deprived for the benefits, government benefits to a particular program na ibabababa, sample ng sinasabi ko. Siguro hindi dapat aalisin, it will remain in the list, para madali natin ma define kung ang Senior Citizen ay PWD at may programa para exclusively for PWD, kasama pa rin dapat siya kasi PWD pa rin siya. Halimbawa, bulag, or kitang mong visible sa atin sa public na PWD, ngayon, ang programa ay magbigay ng saklay, kunwari, example lang, wala na siya sa listahan ng PWD, dahil senior citizen na siya, edi na deprived na siya doon sa programa, kaya dapat hindi inaalís siguro, Mabuti at niraíse ni Councilor Nolasco, we will take on that Councilor. Yes, doktora Ivy?"

DRA. IVY MARIE YRASTORZA "Good morning po, narinig ko lang po yung concern? Ang alam ko po, senior citizen can still avail a PWD ID as provided ng law pero, when availing discounts po, isang ID lang po ang puwede pong gamitin ng senior citizen na at the same time PWD rin po."

COUN. REYNALDO PALABRICA "Napakatalino naman ng ating City Health Officer natin, thank you very much for the information. Tama, so hindi niyo na dapat I delist ang PWD na naging Senior Citizen, pero yun ay isa pa sa mga aayusin natin sa record, kung paano yun, dapat may isa pa rin column yun, sa excel o kung saan man yun na system na gagawin niyo, na nanduduong yung PWD na at Senior Citizen pa. So, hindi natin ito kayang tapusin ngayon ito. Yes, Pres Lorna?"

LORNA PALO "Thank you Mr. Chair, gusto ko lang pong ipaalam po sa lahat na yung proseso po doon po sa Kalinga master list, ang gawa po kasi ng CSWD, mayroon na po silang master list na pinapadala sa bawat barangay, at may kopya po ang Senior Citizens Association, so that is the first thing, second thing po, the president of the associations and the barangay, are meeting together to check kung anong nandodoon, so inaalís na po doon ang patay, transferred, unlocated at unknown, that's the first po."

LORNA PALO "Tapos babalik po tayo ulit sa CSWD na naalís na po yung iba, ngayon yung mga bago po, na hindi po na incorporate doon sa master list ng CSWD, naglalagay po tayo ng additional list at iaattach to that master list para mainclude ng CSWD doon sa kanilang system, and then babalik nanaman po ito sa barangay, we double check again, kung tama ba yung nailagay nila na mga data doon, plus yung inadditional natin doon sa ating master list, pagbalik po noon, may mga cases kasi inalís na po natin pero nandun pa rin po sa listahan, pagbalik sa atin ng CSWD, another na gagawin po ulit yun and kung clean na po lahat, ginagather po ng federation yun and then isinasubmit po yun pabalik sa CSWD po. Gusto ko lang poing iexplain yung process."

COUN. REYNALDO PALABRICA "Maganda po yung proseso kasi multi-checking na yun, para masigurong malinis, pero kung mapapansin niyo, it will take so much time, paulit-ulit, at the end, just like today, magkakaiba pa rin kayo ng inyong listahan, so kailangan talaga nating maayos



ito. So for the meantime, we will suspend this hearing. Iapos isa-isa po namin kayong ipapatawag, halimbawa, OSCA together with senior citizens, federation officers, PWD and Solo Parent, Iapos magkakaroon ng separate hearing, yung BMIS, MIS, CSWD, para mabuo natin yun. Nakita na po natin kung saan ang diperensya at kailangan po natin gawan ng batas, na susundan niyong lahat."

COUN. REYNALDO PALABRICA "We would like to acknowledge the present of Mr. Neil Esguerra, the head of BMIS, for the record. According to your list, iba-iba yung listahan dito, informed lang kita, iba from the Senior Citizens Federation, ang listahan nila ay nasa 57,000 senior citizens sa Bacoor, dito sa OSCA, kila attorney De Castro, 80,000, sa CSWD, 61,000, according to your staff kanina, 154,000."

NEIL ESGUERRA "May correction po doon. Yung senior citizen record namin is 76,947, yung naka record po sa barangay as of now po. May clarifications din po kami doon, mayroon doon po na resident, hindi ko po nilalahat, may mga senior citizen na gumagamit ang pagkadalagang pangalan, actually nasa cleansing na po kami ngayon, chinecheck lang po ng system namin to check facial recognition kasi po pag napapicture po sila sa barangay pinuntahan niya, na doon po kinukuhaan niya, nagkaroon po ng..."

COUN. REYNALDO PALABRICA "Duplication?"

NEIL ESGUERRA "Then navavalidate na po ng system namin using the facial recognition, kasi nga po nag-upload po ng picture, ang problema po namin is yung records po doon sa iba, hindi pa na uploadan ng picture, so wala po kaming determining factor, kung alin po doon."

COUN. REYNALDO PALABRICA "Anyway, ang the very purpose of this ordinance is to create a system na susundin ng lahat, para isa nalang yung listahan, hindi kanya-kanyang listahan, ang importante ma put up kung papaano gagawin yung listahan, ano yung requirements ng listahan, pag nagawa natin yun, shoot lahat yan. So ang sinasabi ko kanina, definitely we will be calling for a hearing or meeting, ididigest namin, kapag ganito hindi pala namin kaya, akala ko madali hindi pala. So, anyway, thank you for your attendance and your concern, regarding this matter, pagtulong-tulungan nalang natin, huwag na layong magturuan, walang ganun, kundi magtutulongan tayo for us to come up with the perfect system. So any ending from the members present kung may gusting sabihin, before we suspend? Councilor Brillantes may gusto ka bang sabihin?"

(UNAUDIBLE FROM COUN. BRILLANTES)

COUN. REYNALDO PALABRICA "Yes?"

NEIL ESGUERRA "Para po magawa po natin yung consolidation nung data, para po maging precise, may I ask po doon sa OSCA Office and CSWD, if they have the system na rin po, para po mag AVI nalang po kami, cross-checking nalang po iyon sa system automatically para mabilis na din po."

COUN. REYNALDO PALABRICA "Actually, yan ang magiging diskarte ng committee sa next hearing tatawagin namin yung mga IT nila para magkaroon tayo ng, kasi ang kailangan ayusin natin dito ay yung administrative list, yung system ng list, according to technology kaya, iseseparate natin yun, kasi technical masyado yun, hindi maiintindihan ng mga tulad namin yun. So yung mga personnel na may hawak nun ay yun ang lipunin natin para ayusin natin, Iapos yung sa administration ng paggawa ng list, kung papano tayo naman nun, pag isa-isahin naman

ATTY. VENUS DE CASTRO "Marami pong salamat sa inyong pag-aaral at pagtalakay nito, dahil dito na mention yung Data Privacy Act, ngayon, on the part of OSCA, lahat ba ng data puwedeng ma access? Or only particular like name, OSCA ID number, date of issuance, yun lang ba or more? Lahat ba kailangan ibigay ang data or only the relevant lang?"

COUN. REYNALDO PALABRICA "Ganito po yan, ang mag-uusap naman po diyon ay yung legal at Sanggunian, together with the representative of Office of the Mayor, para ma guide tayo ng legal hanggang saan yung information na puwede."

ATTY. VENUS DE CASTRO "Alam niyo po mabigat yung penalty. Sa Data Privacy?"

COUN. REYNALDO PALABRICA "As long as for the eyes of authorize person in the city government, lahat ng details puwede yun, kaya lang, isasafeguard natin sa batas yun, for us not to contradict with Data Privacy Act, ililimit din naman yung taong may authorize with regards to data management."

ATTY. VENUS DE CASTRO "Maganda po itong section 3 ninyo, mahusay ito, Maganda po ang inyong draft."

COUN. REYNALDO PALABRICA "Kasi mahusay po kayo, inspire po kami at sa mga bagong konsehal ngayon, ang sisipag. Anyway, we will suspend this hearing for today and expect for another invitation in appropriate time, tapos pag-usapan natin para malinis ito."

COUN. REYNALDO PALABRICA "May I request honorable Brillantes to place a motion for suspension of this hearing."

COUN. HORACIO BRILLANTES "I moved the motion to suspend the hearing for the next."

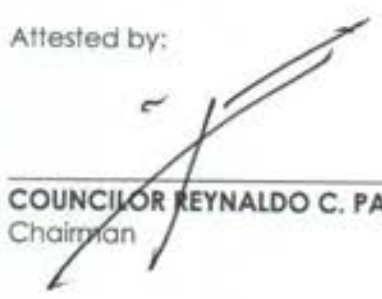

KIM DE CASTRO "Good afternoon po, Kim De Castro po, E-gov."

COUN. REYNALDO PALABRICA "Thank you, next."

BILL ALLAN GUBA "Good afternoon po, Bill Allan Guba, E-gov din po."

COUN. REYNALDO PALABRICA "Thank you, mga wala ka ring updating kasi kung namatay na hindi mo na alam. Kumuha ka ng MSBR card, ngayon, bukas namatay, hindi niyo alam na deceased na. So ang ibig ko lang sabihin, maconsolidate lang sana CSWD, papunta sainyo MIS at BMIS, para iisa list natin, sabog-sabog talaga, sa sinabi mo lang MSBR card papaano yung hindi kumukuha ng MSBR card, hindi na kasama sa list. COUN. REYNALDO PALABRICA "May kanya-kanyang listahan din kasi pero ayun nga."

LODGENE ASUNCION "Isa sa recommendations, based doon sa recommendations din ng CSWD, yung barangays, BMIS, OSCA. Ang recommendations nila sa amin, from the list of the barangays, mayroon listahan sa barangay, mayroon ding data base ang barangay, from there if forward sa CSWD, from the CSWD, iverify sa dapat nila, kung resident or hindi, then yung second step is icocompile sa isang central database yung cleanse list ng Senior Citizens, hindi lang po yun, pati sa PWD at Solo Parent. Kanina po, nagdidiscuss na rin po kami sa naging dilemma namin previously, regarding sa implementing ng solidarity sticker, is yung residency ng mga seniors, pati sa barangays po."

COUN. REYNALDO PALABRICA "Minsan kasi iba nakatira sa Maliksi, naka member sa Kaingin, tapos sa listahan nasa Kaingin siya, pag naglistahan na pero nasa listahan pa rin ng Maliksi, pero may double entry din."

LODGENE ASUNCION "Yes po Konsi, okay lang naman po iyon kasi halimbawa, residente siya and multiple lang ang residency niya, mayroon siyang residente sa two or more barangays, pero major concern po namin, lalo na dito po sa listahan ay issuance po ng senior citizens ID, is the residency. Share ko lang po yung experience namin, mayroon po, pero hindi naman lahat, mayroon pong naisyuhan ng barangay certificate of clearances or certificate of residency, pero hindi taga Bacoor, yun po yung isa sa mga concern namin, kasi may mga encounter po kami na madaming attempt na applications po na solidarity sticker nang non-Bacoor resident. Tapos naisyuhan ng barangay clearance, isa yun sa naging challenge namin, kaya naghigpit kami, kahit may barangay certificate ka, barangay ID ka, kung wala kang any government-issued ID that shows Bacoor address, so doon kami naghigpit, at naging problema din po namin kami yung naghihipit, pero kami yung namumura ng tao, bakit hindi namin sila inaccomodate, pero inusyahan sila ng barangay certificate, so yun yung naging dilemma namin that time, namumura kami, dahil bakit daw may ID naman sila ng barangay pero wala silang any government-issued ID ng Bacoor."

LODGENE ASUNCION "At ito pa pong isang experience namin, nangyari ito sa issuance ng senior citizens ID, hindi ko po sinasabing lahat po ng barangay po pero may ilang barangays po na mayroon silang accommodations, sabihin natin kaibigan, kamag-anak, in the different cities and municipalities, to have a benefits of seniors dito sa Bacoor, inaccomodate nila, binibigyan nila ng barangay clearance, dito po siguro yung first step natin paano ilinis, paano natin iensure ang lahat ng isyuhan ng barangay clearance ng barangay ay talagang residente ng Bacoor. Kasi ayaw din po nating masayang yung resources ng city of Bacoor, na naibigay natin yung benepisyong hindi po natin residente. Isa po yan sa concern po ng office namin. Una po, first step, kailangan po nating maghiipit sa pagverify sa mga residency ng mag apply for senior citizens ID? Ano yung magiging penalty ng mga barangays na nakitaan natin ng ebidensiya na nag isyu sila ng certifications nang hindi residente ng Bacoor."

COUN. REYNALDO PALABRICA "Maglagay nalang penalty provision dito. Pag ayun ang concern, that to ensure yung authority of the barangays na abuse, so to prevent the abuse in the barangay on issuing clearances and other barangay forms, maglagay tayo ng penalty para diyan. Ngayon, going back to this proposed ordinance, sayo lahat mapupunta yung list at inaatasan sa ordinansa lahat ng list ay magkaroon ng sharing, hindi puwede yung hindi pero, sanyo kasi yung pinaka database, sayo mapupunta, at kung kailang din nila, kailangan mong iprovide din sa kanila at nakalagay iyon sa ordinansa."

LODGENE ASUNCION "Yes po, actually o Konsi, yung process po namin ngayon, for all services, sa Senior Citizens, PWD, Solo Parent. Ang senior citizens po ay mayroon silang access, correct me if I'm wrong po, alam ko po may access po sila, sa lahat ng inisyuhan ng senior citizens ID, they have an access to the database, though kami po yung nag encode, kami po yung nag preprocess, kami yung nag capture ng pictures/photographs ng mga applicants, we also give the access to the concern departments processing the applications and then katulad ng PWD, kung wala silang access sa database, hindi po nila kayang maisubmit yung list applications ng PWD ID sa central database sa national agency, yung Persons With Disability national office yun, so may access po sila doon, kasi hindi po porke naisyuhan sila ng PWD ID, ay puwede ng



magamit, kailangan pa rin pong submit yung application nyo sa national through online din po yun."

COUN. REYNALDO PALABRICA "Ano yung take mo dito sa business section six? Subscription fee for access digital directories business establishments operating within Bacoor shall given online access in digital directories if they are duly authorize in writing to only use the said directories purpose in the above mentioned in section three, after paying a subscription fee of one thousand (Php 1,000.00) pesos."

LODGENE ASUNCION "Ano po Konsi, hindi ko po nirerecomend po ang subscription fee."

COUN. REYNALDO PALABRICA "Parang ishashare natin yung data natin sa mga business establishments parang ganun yung sinasabi."

LODGENE ASUNCION "Hindi ko po nirerecommend po ito, hindi rin po ako ang nag rerekomenda na ilagay ito sa ordinansa, ito ay nakikita ko is parang hindi magandang impression sa city government, na binebenta natin yung data natin for a fee. So, parang binebenta natin yung data ng mga constituents natin sa mga business establishments, which is hindi magandang tignan and hindi natin alam baka magkaroon layo ng violations, yung data privacy act, pertaining doon sa subscription na ipapasa nating ordinansa. Sa process po kasi natin ngayon, to be aware lang po kayo sa ginawa naming sistema, yung mga ID po na iniisu sa mga senior citizens even PWD and Solo Parents, ay yung ID po na bago nila is you can verify the authenticity of the ID, using the QR Code sa online access, via QR code din po. So lahat po ng IDs na naisue na more than twenty thousand, lahat po yan ay naka QR Code na, if we going to cleanse the data, we will all require the senior citizens to apply for the senior citizens ID, para ito na yung proseso natin ng data cleansing, may maaccess na silang business establishments, kung yung ID po nila is official or legitimate po na ID na inisyu ng city government. Isa po yun sa pwede nating gawin, irequire po natin lahat ng senior citizen na mag apply ng bagong ID, kasi from there, ito na po yung magiging process ng data cleansing."

COUN. REYNALDO PALABRICA "Tama, kumbaga yung dati, parang sa pera, idemonitize tapos mag print ng bago."

LODGENE ASUNCION "Yes po, isa po yun sa process."

COUN. REYNALDO PALABRICA "But it will have cost. Kinakailangan ng pera, kaya bang budgetan?"

LODGENE ASUNCION "Dapat po, hindi naman po ito ganun kadali, tulad po ten thousand po ang senior citizens natin, or more or less seventy thousand na, if ileless po natin yung naisyuhan na yung twenty thousand, we still have to issue fifty thousand more senior citizens ID, seniors citizen palang po ito, wala pang PWD, so additional fifty thousand more IDs yung kailangan natin. Para mabigyan lahat dito sa Bacoor, I believe hindi lang din fifty thousand yung senior citizens natin dito, naabuso lang po ng ibang tao."

COUN. REYNALDO PALABRICA "Bakit yung sa ayuda eighty thousand, sa DSWD. So hindi nauubos yung ayuda? According to the list na binudgetan, nasa eighty-two thousand, tinalanong ko yan sa ayuda, tama?"

ROSS ANIEL RUBION "Bale po ang budget po sa kalinga po ay one thousand per senior citizens."

COUN. REYNALDO PALABRICA "Pero ang pinag-uusapan nilang bilang, pag tinalanong ko doon, eighty-two thousand yung sa budget."

ROSS ANIEL RUBION "Around seventy million po yun."

COUN. REYNALDO PALABRICA "Sige, sabihin natin seventy, according to the estimate record na nahawak ng E-gov, twenty thousand lang."

LODGENE ASUNCION "For clarification po, yung twenty thousand yun po yung nag renew ng ID, yun na po yung may hawak ng bagong ID, you can verify the authenticity."

COUN. REYNALDO PALABRICA "So Lods, ang gagawin natin, alisin nalang natin ang subscription fee, kasi hindi katanggap-tanggap yun. Attorney Venus, ano pong masasabi mo?"

ATTY. VENUS DE CASTRO "Nakikinig po ako doon po sa observation ni sir Lodgene, and I agree kasi po yung experience namin sa OSCA, minsan po yung barangay certification, totoo po yung kanyang observation, nangyayari yan, pagkatapos po, mayroon pong senior citizen na mayroong ID sa Las Pinas tapos may ID din dito sa Bacoor, tulad ng isang senior citizen na malakas, tinanong namin siya, siya ay taga Manila, kaya yung observation ni sir Lodgene, totoo po talaga iyon, pero yung digitalization ang mangyayari yan, magkakaroon ng cleansing, kasi first step yan sa cleansing, kasi doon po sa amin, halimbawa, nawala yung ID, papalitan ng panibagong ID, yung number sa old at saka sa new, magkaiba, kaya lumalabas na parang dalawa ang nasa record nang iisang tao lang. tapos po, ang maganda sa digitalization parang it is very timely in this legislation, kasi it will enable the senior citizen to received twenty percent discount, kung nalimutan man yung ID, doon sa digitalization makikita agad na siya ay holder, qualified holder ng senior citizen ID. Pero magandang observation ng purpose ng batas, we should take on the consideration the Data Privacy Act kasi doon sa batas na yun, para madisclose mo yung information, kailangan ng express at written consent sa subject na kailangan. Kaya minsan naisip ko, doon sa application, halimbawa magkakaroon ng bago, hindi kaya magkaroon ng note or bracket na I agree..."

COUN. REYNALDO PALABRICA "Parang may waiver na."

ATTY. VENUS DE CASTRO "Yes po, and answering with yes or no, magchecheck siya then magsignature siya. That is already express and written consent para sa ganun para macomply tayo, pero nakikita ko, maganda naman itong digitalization, kasi ako mismo hindi ako nabibigyang twenty percent, hindi tulad nito, isang pindot nalang makikita na nila yung pangalan po. Parang timely at saka very recent to address the circumstance of the senior citizens."

COUN. REYNALDO PALABRICA "Maganda nga sana, observation din na pag nawala yung ID, gumawa ulit ng bagong ID number. Dapat may lifetime ID number na."

LODGENE ASUNCION "Konsi, yung ID natin ngayon, across different, halimbawa may ID ka ng senior citizens, may ID ka ng PWD, isa nalang po yung ID number. Yun po yung gimawa nating sistema, yung isang residente natin, hindi na kailangan ng maraming ID number, parehas na po yang ID number, halimbawa po senior citizen siya, PWD, parehas po iyan ng ID number. Same as solo parent po."

COUN. REYNALDO PALABRICA "So, solve na tayo doon, so CSWD, okay na rin ba kayo? may comment ba kayo sa provision na nakalagay doon sa proposed ordinance?"

COUN. REYNALDO PALABRICA "BMIS?"

CHRISTOPHER RIVERA "Good morning sir, wala naman pong problema po doon."

COUN. REYNALDO PALABRICA "Pag-aaralan nalang namin at natatangalin ang isang provision na iyon, lahat tayo opposed, pangalawa, kung paano natin idadagdag sa ordinansa yung regulation and penalty sa mga barangay, na nag-iissue ng barangay clearance na hindi naman taga doon sa kanila, may mga instances na may report. COUN. RANDY FRANCISCO "Okay naman po. Para maiwasan po, sa BMIS nakalagay doon kung taga ibang barangay ka, tapos kukuha ka, halimbawa taga Dulong Bayan ka, kukuha sa akin, pero naka register ka sa barangay, magpapaalam ka sa Dulong Bayan na lilipat ka ng barangay, ganun po yung nangyayari., hindi po pwede dalawa po, dapat lilipat ka ng barangay or else madedelete yung record mo doon sa dati."

LODGENE ASUNCION "Sa akin naman po, okay lang yung residente ng Bacoor, kahit nasaan siyang barangay, siguro mabigat na po yung penalty na kung proven na hindi taga Bacoor binigyan, saka po tayo magbigay ng penalty po sa mga barangay na mag certify na hindi taga Bacoor. Kasi ito naman, hindi natin maiwasan yung mga residente natin sa Bacoor or migrants maltransfer sa iba't-ibang barangay, minsan hindi din nila alam iproseso sa barangay na kailangan magpalista sa barangay bago lumipat sa ganitong barangay, siguro acceptable naman po iyon, siguro yun lang pong mabigat na penalty."

COUN. ROGELIO NOLASCO "For example, yung isang residente ng isang barangay, lumipat ng Imus, pero dito pa rin rehistrado sa Bacoor, yung ganun cases allow pa rin bang magbigay ng certifications? Kasi sa atin naka register."

LODGENE ASUNCION "Isa po sa verification natin, para mas mabilis ang verification, once kung sila ay registered voter, pero kung inactive na siya or hindi siya naka rehistro, yun po ang titingnan natin kasi posibleng hindi taga Bacoor."

COUN. ROGELIO NOLASCO "Actually kung nalilipat lang sila ng Imus pero dito pa rin naka rehistro, siguro possible na puwede pa ring bigyan dahil registered pa rin siya sa barangay na yun."

LODGENE ASUNCION "Yes po, once na active voter naman po."

COUN. ROGELIO NOLASCO "And also, puwede ba nating maimprove yung ID natin kasi ang ID natin ay nabubura yung pangalan. Example itong sa akin, nabubura yung apelyido at number."

LODGENE ASUNCION "If may naexperience po kayong ganyan, irereprint nalang. Ipareprint nalang po namin."

COUN. ROGELIO NOLASCO "Okay, thank you."

COUN. RANDY FRANCISCO "May mga instances kasi yung iba may kamag-anak sa ibang bansa, mga senior na uuwi dito, and then gusto nilang i-avail yung senior citizen habang nandito sila, puwede ba naming bigyang certification yun? Pero syempre one or two months lang sila dito, babalik pa ng ibang bansa, kasi may ganyang instances, puwede ba yun?"

LODGENE ASUNCION "Depende po sa konseho kung ano pong mapagkakasunduan pero puwede naman pong ilagay sa provision po ng IRR. Sa implementing of rules and regulation, puwede naman po natin incorporate yung recommendations niyo, na to accommodate or to allow like OFW po, puwede natin ilalagay po doon."

COUN. REYNALDO PALABRICA "Sa IRR nalang. Yes, attorney Venus?"

Number three, order of approval and number four cause of allegiance. Ngayon, ang sabi ni senior citizen ay marami naman niyan, kaya nirerequire nalang namin ay auto allegiance kapag mayroon yun, automatically yung 1, 2 and 3 macomply na. marami po kasing instances na dati po ay pinapayagan na mabigyan ng ID ng OSCA yung foreigner, provided na married siya sa isang Filipino citizen at saka may lupa dito na nagbabayad siya ng amilyar pero iyan ay kontra sa batas, kasi Filipino citizen residing in the Philippines. Yung tungkol po sa certifications na iniisu na barangay certifications, na halimbawa nandito siya sa Bacoor, pagkatapos Imus ang kanyang certification, hindi po iyon pinahihintulutan, kasi kinakailangan yung senior citizen ay residente sa particular na barangay."

COUN. REYNALDO PALABRICA "Mayroon kasing insidente taga rito sa atin, tapos syempre pag may edad na nagkakasakit na, walang mag-aalagang kaanak dito sa Bacoor, kinukuha muna nang kaanak doon sa Imus, pero ang kinikilalang residence niya ay Bacoor, may mga ganung instances."

ATTY. VENUS DE CASTRO "Tama naman po kayo."

COUN. REYNALDO PALABRICA "Not necessarily na nag register siya sa Imus, doon lang siya nagreside doon sa Imus kasi doon may mag-aalaga sa kanya, iba-iba yung mga sitwasyon diyan, the same with concern ni konsehal Randy, na galing sa abroad naman, two months lang dito, dito talaga yung hometown nila, kaya minsan gusto din nilang mag-avail ng Kalinga sa Matanda or any senior citizen program, yung twenty percent discount, hindi naman natin kailangan maging stiff, case to case basis nalang tayo, adjustable din tayo, kasi kung magiging stiff tayo masyado it may result to deprive our senior citizen from abroad in the rights being resident in the city. Pero ang tamang concern ni Lodgene, kung intentional, na taga Imus or taga ibang municipal o lugar tapos gusto lang maka avail ng serbisyo dito sa Bacoor, icecertify ni Kapitan para mapalabas na qualified sila dito sa Bacoor, yun ay mali, yun ay ilalagay natin sa penalty. COUN. REYNALDO PALABRICA "Opo, ilalagay natin yun sa batas at mahuhuli naman po yun, tsaka makikita naman po kung may duplication man. Siguro nga baka may facial recognition sila Lodgene."

ATTY. VENUS DE CASTRO "Your honor, isa pa po, maikili lang. Iyon pong data na nilalagay natin na puwede doon sa digitalization, ano yung mga data na nilalagay natin? Only those appearing in the OSCA ID? Complete name, date of birth, at saka address."

COUN. REYNALDO PALABRICA "Yun lang naman po."

ATTY. VENUS DE CASTRO "Yun lang?"

COUN. REYNALDO PALABRICA "Yun lang po, other than that, wala na pong iba."

ATTY. VENUS DE CASTRO "Kasi yung data doon sa OSCA ID, open to the public yun, walang violation doon?"

COUN. REYNALDO PALABRICA "Wala po. Basic information lang naman po iyon. Anyway, yes, Lods?"

LODGENE ASUNCION "Actually mayroon po tayo dito sa Sanggunian, yung ESBR Card, bago natin implement yung senior citizen ID, siguro sa IRR nalang naming ilalagay, example po yung mga konsehal, pag nakapag-avail sila o nabigyan sila ng senior citizen ID, qualified na rin silang mag-apply for ESBR card, para hindi na rin po multiple ang process ng application, they are qualified to apply the ESBR card, with the consent of the data subject na pinapayagan niya tayo

ATTY. VENUS DE CASTRO "Your honor?"

COUN. REYNALDO PALABRICA "Yes po?"

ATTY. VENUS DE CASTRO "Yung mga relocaties po natin, from Bacoor to Naic, kung minsan po yung kanilang OSCA ID..."

COUN. REYNALDO PALABRICA "Dalawa na?"

ATTY. VENUS DE CASTRO "Opo, then kinakansel na."

COUN. REYNALDO PALABRICA "Kapag dalawa na, nag register na sila sa Naic, kailangan na natin icancel yung dito."

ATTY. VENUS DE CASTRO "Yung kanilang allegations naman is, botante naman daw sila ng Bacoor."

COUN. Anyway, any concern po ay ipadala nalang sa opisina namin, kung ano pa yung mga suggestion or any opinion na iparating sa amin. I'll be asking for motion for adjournment, the honorable gentleman from Molino 1?"

COUN. SIMPLICIO DOMINGUEZ "Motion adjourned."

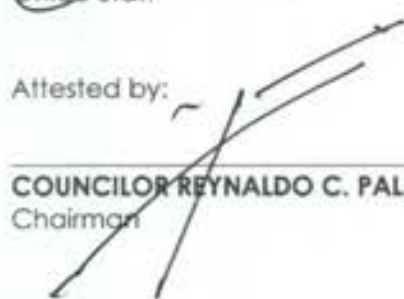
