Subject: "AN ORDINANCE AMENDING SECTION 7 AND 9 OF CITY ORDINANCE NO. 432-2025 (The KATIPUNAN NG KABATAAN ID REGULATION ORDINANCE)." (PCO 2025-033 referred August 18, 2025)

Referred into this committee on 7th Regular Session on August 18, 2025 of the 6th Sangguniang Panlungsod is the above subject matter for appropriate action and recommendation. The minutes, attendance and photos taken during the committee hearing as well as the Executive Order No MSBR-078-2925 are hereto attached for immediate reference.

FINDINGS:

- Republic Act No. 10160 or the Charter of the City of Bacoor provides under Section 11 that the Sangguniang Panlungsod has the power to enact ordinances, approve resolutions, and appropriate funds for the general welfare of the City and its inhabitants including the youths pursuant to Section 16 of the Local Government Code of 1991.
- City Ordinance No. 432-2025 otherwise known as the "Katipunan ng Kabataan ID Regulation Ordinance of the City of Bacoor" mandates the establishment of a Sangguniang Kabataan Database and regulates the issuance, renewal, and use of Katipunan ng Kabataan Identification Cards (KK-ID) in the City of Bacoor, including the imposition of reasonable fees for such issuance and renewal.
- The imposition of fees for the issuance, renewal, and replacement of Kabataan Identifications Card has been **TEMPORARILY WAIVED** in accordance to Executive Order No. MSBR-078-2025.

SECTION 7 EFFECTIVITY OF KK ID A KATIPUNAN NG KABATAAN ID shall valid for two (2) years and shall be issued either free of charge or with fee of not more than One Hundred Pesos	SECTION 7 EFFECTIVITY OF KK ID A KATIPUNAN NG KABATAAN ID shall valid for one (1) year and shall be issued FREE of charge.





ORIGINAL PROVISION	AMENDMENT
SECTION 9. ID FEES a. An amount of not more than Php 100.00 shall be charge to applicants of the SK ID b. An amount not more than Php shall be charged to the applicants for the renewal of the SK ID. c. In case of loss or damage of the SK-ID a replacement fee of the same amount shall be charge to the applicant	SECTION 9. KK ID a. The Sangguniang Kabataan will provide the funds for the KK ID as part of their Katipunan ng Kabataan Profiling. b. No amount shall be charge to the applicants for the renewal of KK ID. c. <u>In case of loss or damage of the KK ID, the applicant shall be given a replacement ID free of charge."</u>

- The policy of the City Government of Bacoor to recognize the vital role of the youth in nation-building and to ensure that youth-related benefits, programs, and services shall not be hindered by financial strains.

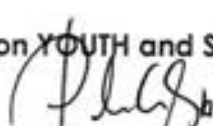
Recommendations:

In order to remove financial barriers and might prevent the youth for registering, these steps are meant to promote more involvement and guarantee that no youths are denied the privileges provided by this ordinance. Wherefore, the committee respectfully recommends for the **Approval** of "**AN ORDINANCE AMENDING SECTION 7 AND 9 OF CITY ORDINANCE NO. 2025-033 (The KATIPUNAN NG KABATAAN ID REGULATION ORDINANCE)**".

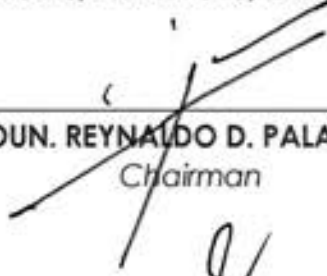

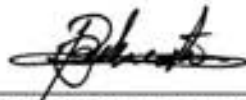

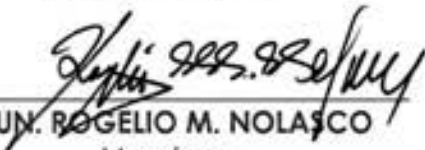

- Hon. Buncio: You may now take your seats. Before we proceed, I would like to acknowledge the presence of our city councilors first from District 1.
- Hon. Gawaran: Good afternoon, Madam Chair. Good afternoon, my fellow city councilors, department heads, especially Ma'am Lillian Ogalde, head ng CSWD and officers and members. - Hon. Buncio: From my left side, City Councilor from District 1.
- Hon. Galvez: Thank you, Madam Chair. Sa ating mga elected officials, my city fellow councilors, sa ating mga S.K. Chairman, S.K. Kagawad. - Mr. Esguerra: Good afternoon po sa ating mga kagalang galang na mga konsehal ng bayan, to our S.K. Federation. Ako po si Ferdineil Esguerra, ang head po ng BMIS. Good afternoon po.
- Hon. Buncio: Okay, sir. Next, please.
- Mr. Redondo: Good afternoon. I'm John Redondo from LYDO.
- Hon. Buncio: Sa likod nalang po siguro ni Sir Neil. We would like to acknowledge.
- Hon. Palabrica: Madam Chair. Please, sige tapusin na muna natin.
- Ms. De Leon: Good afternoon po sa lahat. I'm Marisa De Leon from City Budget Office. Thank you.
- Hon. Palabrica: Madam Chair, may I respectfully move that we dispense the recognition ng bawat nandito kasi may attendance naman. So, the attendance will be formed part of our record on this hearing para medyo maexpedite natin ang process. So, I move, Madam Chair.
- Hon. Buncio: So, the motion for the recognition is moved. So, we'll now proceed for the agenda for this afternoon. So, first po, yung amendment po natin. So, the Sangguniang Panlungsod have received a letter from the, an endorsement letter for the amendment of the Section 9 of the City Ordinance Number 432-2025 in which, in the City Ordinance, otherwise known as Katipunan ng Kabataan I.D. Regulation Ordinance of the City of Bacoor, na-evade po, no? Sir, evade po natin yung fees na kasama po dito in which nakalagay po sa ating Section 9. So, before, nung naghearing po tayo, nakalagay po sa ating hearing na magkakaran po tayo ng bayad ng below not more than P100. So, doon sa amendment po na natanggap po natin from the Executive Order from the Mayor's Office, specifically our Honorable Strike B. Revilla na-evade po yung ating fees in which, naging libre po ito. So, I would like to ask po if there are other comments or suggestions from our resource speakers with regards to this po.
- Hon. Palabrica: Siguro Madam Chair, ang tatanungin natin yung mga SK officials, okay lang ba sa inyo na libre na yan? Hindi na kayo papahintulutan na magcharge ng fees regarding issuance of KKID. Isa-isahin mo na sila. Isa-isahin mo na yung bawat barangay.
- Hon. Buncio: Sige po. From Molino 3 po.





- SK Molino 3: Hello po. For Molino 3 naman po, okay lang naman po ma-waive or walang finance po. Pero ang aask ko lang din po, paano po yung mga expenses? Like CARB po, sana?
- Hon. Buncio: Yung expenses po. So, as far as nag-usap po kasi ang SK Federation din po of Bacoor, actually nag-emergency meeting kami with regards to expenses, sasagutin po ito lahat ng SK Federation of Bacoor, yung expenses natin sa ID. Sige po. From Molino 1 po.
- Hon. Alonzo: Hello. Magandang hapon po. From barangay Molino 1 po, SK Chairperson. Agree po ako na libre na po yung ID po na sasagutin ng Sangguniang Kabataan ng SK Fed po. Thank you po.
- Hon. Buncio: Thank you po. From Molino 2 po, SK Chairperson.
- Hon. Miranda: Good afternoon po. Yes, For Molino 2 po. Agree rin po kami doon na libre po yung fees yun lang po. Thank you po.
- Hon. Palabrica: Maybe Madam Chair, pataasin na lang natin ang kamay yung gusto pang maningil. Kasi parang sa 3 barangays called upon, ay ano naman, libre na sila. Baka meron pang barangay dito na ang SK Chair ay naniningil ng KKID. Pakitaas lang ang kamay para mapag-usapan po natin. Wala? So okay na sa inyo libre. Tapos na.
- Hon. Buncio: Any other question? May question po si Kapitana. Sige po, Kapitana.
- Hon. Camarce: Kasi kami po sa barangay, may bayad po yung sa amin. So, kung magkakaroon po ulit sa SK, ano po ang gagamitin niyong pang-print? Kasi binibili po namin yun eh. Magsasarili po ba ang SK Fed ng kanilang pag issue ng KK ID?
- Hon. Buncio: Maraming salamat po sa inyong tanong. Acknowledge po yung question. We would like to call si Sir Neil po para sagutin po yung question po natin with regards this po.
- Mr. Esguerra: So, Kapitana, ang procedure po kasi sa barangay is nag-issue po tayo ng ID para sa ating residents for identification. This ID is different po. This is one for the SK with provisions po na ma-expedite yung mga process o pagtulong ng mga serbisyo para sa ating mga KK individual members. Yung po ID will be produced sa office po ng LYDO, hindi po sa barangay natin mangagaling. So, different entity po yung pangagalangan ng ID.
- Hon. Palabrica: Madam Chair, may follow up question lang ako. So, ang issuance ng barangay ID is from the barangay secretary or barangay clerk? Yung





issuance ng KK ID, different yun? Ang mag-issue nun yung Sangguniang ng Kabataan? Provided ba sila ng printer ng equipment for printing of those IDs?

Mr. Esguerra: Yes, meron po provision ng printer ID po dun sa office.

Hon. Palabrica: Lahat ng SKs? Do you confirm mga SK? Binigyan kayo? Ah, hindi niyo binigyan, bibili sila?

Mr. Esguerra: Hindi po, meron po provision sa office na isa na magpi-print po ng ID. Pre-produced na po yung mga IDs.

Hon. Palabrica: Ah, sa inyo na nag-printing. Dadalin ng application sa inyo kayo mag-print?

Mr. Esguerra: Yes po.

Hon. Palabrica: Ah, okay, Online na lang. Pero paano yung physical ID ipapadala niyo, kukunin nila?

Mr. Esguerra: Opo, kukunin po ni SK Chairman sa office kapag mga approved applications na po ng ating mga KK members identified, pipick-upin na po nila yung pre-produced.

Hon. Palabrica: So, those applications, paano yung applications ng mga members nila through online application or manual kayong mag-fill up sa isang form?

Mr. Esguerra: Ah, bali po sa ngayon, we have the unified records. So, meron na po mga pre-identified KK members nandun po sa barangay system natin. Included na rin po sila. We need to validate na lang if they are valid recipients ng ating mga...

Hon. Palabrica: So, meaning nasa list of voters?

Mr. Esguerra: Nasa list of voters po, and individuals na...

Hon. Palabrica: Papano kung hindi botante, tapos siyempre matagal pa registration, kundi nalagpasan ka ng registration, tapos resident ka na, tapos gusto mo magkaroon ng KK ID, paano yun?

Mr. Esguerra: Dito po ato sa ating ordinance, nakalagay po is voter and non-voter residents of Bacoor.

Hon. Palabrica: Kaya nga, pag non-voter, wala pa kayo record?





- Mr. Esguerra: Meron na po. On-going po kasi yung barangay system natin, going today, as of today po, we actually gathered 200,000 individuals...
- Hon. Palabrica: So, may census na ang kada barangay?
- Mr. Esguerra: Yes po.
- Hon. Palabrica: Ang mga SK may mga census na kayo? Okay na. So, complete na tayong data.
- Mr. Esguerra: Yes po.
- Hon. Palabrica: So, the process is, mag-apply sila dun sa barangay, sa SK, tapos ifo-forward sa inyo, ipoprovide ninyo ang ID. So, yung question kanina ni Kapitana Alma, hiwalay pala, ba't may printing ba sa inyo? Kapitana, may printing ba sa Niog? Nagpiprint ba ng ID ang SK ninyo?
- Hon. Camarce: Binaba rin po sa amin, lahat ng barangay po may printing po, kaya inaano ko rin po kung ibababarin po yan sa SK, para sa SK na po mismo ang magpiprint. Ngayon po, nalinawan po na sa kanila po mang gagaling, parang i-gather lang po yung data ng aming Sangguniang ng Kabataan, then dadalin po sa kanila.
- Hon. Palabrica: Kapag ka may kukuha sa inyong KKID sa barangay ninyo, ipo-forward ninyo papun ta sa BMI.
- Hon. Camarce: Okay po, noted po. Thank you.
- Hon. Palabrica: Thank you.
- Hon. Buncio: Maraming salamat po. SK, di ba may mga ni-raise kayong concern in regards naman po sa printing po sana? Baka pwede po may mag-motion po sana. Yung... na...
- Hon. Ignacio: Ma'am, good afternoon po. SK Chairperson po ng barangay sinbanali. Yung ibang co-chairperson ko po kasi is nag-request, since SK Fund naman daw po yung gagamitin, baka daw po pwedeng kunin na daw po yung ID sa SK Fed Office at hindi na daw po sa LYDO. Since ang fund daw po nagagamitin for this is SK Federation Fund po.
- Hon. Buncio: Kung ano lang daw po, kasi po para mas hindi daw po silang mahirapan po at na... Ano ka daw motion niya baka sa SK?





- Hon. Ignacio: Parang ang concern lang po para ma-acknowledge daw po kasi yung SK Fed Office. Since kung ang pagki-claim po kasi ng ID is sa LYDO, pano po kasi if ever po na may KK po na magpa-register po samin at gusto po agad makuha yung ID? Para po maganda po sana na ibabato po agad namin sa SK Fed Office, hindi na po sa LYDO. Para ma-acknowledge po sana yung office po ng federation, since fund naman po ng SK Fed po yung gagamitin.
- Mr. Esguerra: Actually po, nasa section 8 po ngayon ang usapin natin yung regarding po dun sa office, implementing office para po sa pick up ng IDs. If may concurrence po ang lahat ng SK Chairman's natin regarding to this, pwede naman po.
- Hon. Palabrica: Paano niyo iri-resolve yan? Kasi baka magkalituhan, saan ba pupunta sa LYDO ba o sa SK Fed Office?
- Mr. Esguerra: Yun po, sa tingin ko po we need to vote ngayon kung okay po sa inyo na sa SK Fed na po natin ibagsak yung produced IDs. As of now po kasi we have 143,600 plus na SK records. Hindi pa po siya pre-determined. Ang pre-determined po is 31,878. So ito na po yung poproduce na namin, tapos po forward na po namin sa office ng SP.
- Hon. Palabrica: Anong comment ng LYDO? May we have the opinion of the LYDO?
- Mr. Redondo: Regarding don Konsi, okay naman po kung if ever nasa...
- Hon. Palabrica: Your office has no opposition on the proposal of the BMIS that the printed ID will be forwarded to SK Fed Office and the SK Fed Office will be the one to release all those IDs.
- Mr. Redondo: Okay lang naman po in voice of LYDO.
- Hon. Palabrica: Okay, settled. Okay na. So ilalagay natin dito sa IRR na lang nito.
- Hon. Buncio: Kailangan po mailagay. So yun lang naman po yung concern naman with for the information na lang din po ng lahat po, ito po ng fund po ay kukunin po natin sa SK Federation Bakor which is sa annual dues po natin na collected 20% of every barangays po in the city of Bacoor.
- Hon. Palabrica: Kaya ba ng SK Fed Funds?
- Hon. Buncio: Opo, kakayanin naman po namin po.
- Hon. Palabrica: Hindi, kasi we are talking about hundreds of thousands of IDs. How much it will cost, Neil? magkano?

- Mr. Esguerra: Ang isang ID po is cost 48 pesos.
- Hon. Palabrica: 48 pesos times 200,000. Pag na-issue mo yun na 200,000 lang.
- Mr. Esguerra: Almost nasa 7 po, mga 7.
- Hon. Palabrica: Magkano yun?
- Mr. Esguerra: 9 million.
- Hon. Palabrica: 9.6 million. May pera ba ang SK Fed na 9.6 million? Wala? O paano yun?
- Mr. Esguerra: Bali nagkaroon po kami ng pag-uusap regarding diyan. As of now po, yung initial na nandidito po, na predetermined, kaya na po dun sa fund na inallocate nila. So meron din po kasing supplemental budget na papasok po siguro diyan.
- Hon. Palabrica: Iso-shoulder ng city?
- Mr. Esguerra: Yes, shoulder po ng city.
- Hon. Palabrica: Kasi sa 200,000, 9.6 million, di ba?
- Mr. Esguerra: Yes po. And possible din po kasi upon implementation, we have to produce din po na digital copies of the ID. So less ano na lang rin po.
- Hon. Palabrica: So ia-allow yun digital copies?
- Mr. Esguerra: Yes po.
- Hon. Palabrica: May QR code?
- Mr. Esguerra: Yes.
- Hon. Palabrica: Baka ang pera ng SK Fed mapunta lang sa mga ID, paano ang iba nilang gastusin sa SK Fed? Halimbawa, siyempre may mga activities din kayo sa SK Fed or kahit uniform man lang ninyo. Paano yun, ubos ang pera niyo diyan?
- Hon. Buncio: Bali ano po Konsi, napag-uusapan po ng Fed, may portion po kami naiallocate po dito. Then, for the next, kasi po medyo patapos na rin po ng taon. For the next year po, ilalagay na po namin sa plan namin yung number po ng parang pre-registered na po doon sa ano na.





Tapos pag-hahatian po namin siya, based po doon sa population po na-registered na po sa bawat barangay.

Pursuant to Executive Order No. MSBR-078-2025, issued on 11 August 2025, the imposition of fees for the issuance, renewal, and replacement of Kabataan Identification Cards has been **temporarily waived** to remove financial barriers that may hinder the registration of our youth. This measure is intended to encourage wider participation and ensure that no qualified youth is excluded from the benefits and privileges granted under the said Ordinance.

In view of the foregoing, we recommend that the Honorable Body consider **permanently removing or adjusting the payment provisions** under Section 9, to institutionalize free or more affordable access to the Kabataan Identification Card, subject to the legislative process and any necessary safeguards.

We trust in the wisdom of the Honorable Sangguniang Panlungsod to act favorably on this request for the benefit of our youth sector.

EXECUTIVE ORDER NO. MSBR-078-2025

AN ORDER SUSPENDING THE IMPOSITION OF THE PAYMENT REQUIREMENT UNDER CITY ORDINANCE NO. 432-2025 FOR THE ISSUANCE, RENEWAL, AND USE OF KATIPUNAN NG KABATAAN IDENTIFICATION CARDS IN THE CITY OF BACOR

WHEREAS, City Ordinance No. 432-2025, otherwise known as the "Katipunan ng Kabataan ID Regulation Ordinance of the City of Bacoor", mandates the establishment of a Sangguniang Kabataan Database and regulates the issuance, renewal, and use of Katipunan ng Kabataan Identification Cards (KK-IDs) in the City of Bacoor, including the imposition of reasonable fees for such issuance and renewal;

WHEREAS, the City Government of Bacoor fully recognizes the importance of the KK-ID system in promoting accurate youth profiling, preventing misuse of identification, and ensuring efficient delivery of youth-related programs and services;

WHEREAS, it is the policy of the City Government to ensure that youth participation in governance and access to youth-related benefits, programs, and services shall not be hindered by financial constraints;

WHEREAS, pending the review and amendment of City Ordinance No. 432-2025 by the Sangguniang Panlungsod to address the foregoing concerns, there is a need to temporarily suspend the implementation of the payment provisions of the Ordinance to allow uninterrupted and equitable access to the KK-ID by all qualified youth members;

WHEREAS, pursuant to the general welfare clause under Section 16 of the Local Government Code of 1991 and other relevant laws, the City Mayor is empowered to take measures necessary to promote the general welfare of the constituents, particularly in ensuring inclusive and accessible programs for the youth sector;

NOW, THEREFORE, I, STRIKE B. REVILLA, City Mayor of Bacoor, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. Temporary Waiver of ID Fees under Section 9 of City Ordinance No. 432-2025. In the interest of promoting youth participation and ensuring equitable access to the Kabataan Identification Card, the collection of fees for the issuance, renewal, and replacement of said IDs, as provided under Section 9 of City Ordinance No. 432-2025, is hereby temporarily waived until further notice. This waiver shall apply to all qualified applicants within the City of Bacoor.

SECTION 2. Monitoring and Evaluation. Concerned offices shall monitor the impact of this suspension and submit periodic reports to the Office of the City Mayor to aid in policy review.

SECTION 3. Legislative Review. Findings from the monitoring process shall be consolidated for submission to the Sangguniang Panglungsod as part of the recommendation for possible amendment of City Ordinance No. 432-2025.

SECTION 4. Effectivity. This Executive Order shall take effect immediately and shall remain in force until revoked or amended.

The Bacoor City Katipunan ng Kabataan Identification Card shall solely and exclusively be used for monitoring and efficient processing of information of the elected members qualified to avail and/or actually availing the programs and projects of the City Government.

SECTION 7. EFFECTIVITY OF KK-ID. A KATIPUNAN NG KABATAAN ID shall remain valid for two (2) years and shall be issued either free of charge or with a fee of not more than One Hundred Pesos (Php 100.00).

SECTION 8. KATIPUNAN NG KABATAAN ID APPLICATION. The Sangguniang Kabataan Federation, in coordination with the Local Youth Development Office (LYDO), shall implement the following procedures for the issuance of SANGGUNIANG KABATAAN ID applications done in person (walk-in) by an applicant:

Applicant must fill up the registration form and submit the following documentary requirements:

- Barangay Certificate as proof of residency
- 2 pcs of 1 x 1 picture
- Birth Certificate or Valid ID

SECTION 9. ID FEES.

- An amount of not more than Php 100.00 shall be charged to the applicants of the SK-ID.
- An amount of not more than Php shall be charged to the applicants for the renewal of the SK-ID.
- In case of loss or damage of the SK-ID, a replacement fee of the same amount shall be charged to the applicant KK member.

SECTION 10. RENEWAL OF KK-ID. The following procedures shall be observed for the renewal of a KK-ID.

- The SK official shall accomplish and submit the prescribed **KATIPUNAN NG KABATAAN ID Renewal Application Form** to the Barangay SK office at least thirty (30) days prior to the expiration of the current ID.
- The following documents shall accompany the application form:
 - Copy of the expired KK-ID;
