The above-captioned legislative measure was submitted on First Reading before the City Council on August 26, 2025. The committee held a joint committee hearing on September 10, 2025 at 10:23 AM. It was presided over by the Chairman of the Committee on Social Services, Hon. Horacio M. Brillantes Jr. The minutes, attendance sheets, and pictures taken during the said hearing are attached hereto and shall be made integral parts of this report.

FINDINGS:

To further enhance the effectiveness of the *Strike sa Serbisyo Action Center*, the city's primary vehicle for delivering social services, the City Mayor respectfully requests the amendment of City Ordinance No. 358-2024, Series of 2024.

- The proposal includes renaming the Mayor's Socialized Benefits for Residents Committee to the **R.E.V.I.L.L.A. Action Center** (Response to Economically-disadvantaged and Vulnerable Individuals in the Locality to Live At home), to better reflect its expanded role and the city's commitment to inclusive, responsive social welfare, to wit:

WHEREAS, Section 458 (a)(1)(viii) of the Local Government Code provides that the Sangguniang Panlungsod has the power to enact an ordinance to determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the city government;

WHEREAS, Section 458 (a)(5)(xiv) of the Local Government Code provides that the Sangguniang Panlungsod has the power to pass an ordinance to provide for the care of disabled persons, paupers, the aged, the sick, persons of unsound mind, abandoned minors, juvenile delinquents, drug dependents, abused children and other needy and disadvantaged persons, particularly children and youth below eighteen (18) years of age; and subject to availability of funds, establish and provide for the operation of centers and facilities for said needy and disadvantaged persons;

WHEREAS, it also has the power to pass an ordinance to formulate policies and adopt measures mutually beneficial to the elderly and the community; provide incentives for non-governmental agencies and entities and, subject to the availability of funds to support programs and projects for the benefit of the elderly;

WHEREAS, Section 17 of the Local Government Code empowers the Local Government Units (LGUs) to execute necessary, appropriate, and incidental provisions of the basic services and facilities, including social welfare services;

WHEREAS, the City Government of Bacoor, through the leadership of the City Mayor – Hon. Strike B. Revilla, envisions a local government that is responsive and empathic to the needs of the residents of the City of Bacoor, most especially the marginalized sector of the City: the elderly, the persons with disabilities, the solo-parents, and the underprivileged.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Bacoor, Cavite, that:

Section 1. Short Title - This Ordinance shall be known as the **"Mayor's Socialized Benefits for Residents (MSBR) Committee Ordinance of 2024"**

Section 2 CREATION OF THE MAYOR'S SOCIALIZED BENEFITS FOR RESIDENTS (MSBR) COMMITTEE - The Mayor's Socialized Benefits for Residents Committee is hereby created and will be manned by concerned offices / agencies that provides various social programs and services that respond IMMEDIATELY to the issues and concerns of the people in the community.

SECTION 10. DATE OF EFFECTIVITY. This Ordinance shall take effect immediately after it has been published once in a newspaper of general circulation in the City of Bacoor, Cavite.

SECTION 11. AUTOMATIC REVIEW. The Sangguniang Panlungsod shall automatically review this Ordinance once every three (3) years after its approval or whenever the need for such review arises.

SECTION 12. REPEALING CLAUSE. All local ordinances, executive orders, resolutions, memoranda, regulations, or part thereof in conflict or inconsistent with any provisions of this Ordinance shall be considered hereby revoked and/or modified accordingly.
