Local Government (DILG) as it would enable local chief executives to forge commercial culture, and technical ties among themselves for the benefit of their respective constituencies.

- The City of Bacoor has sister-city and twin-town agreements with several cities
  and municipalities in the Philippines and abroad but it does not have an
  administrative unit that manages the fulfilment of the various obligations of the
  City under the said contracts, identifies possible areas of cooperation among
  LGUs, and evaluates the establishment of contractual relationships between the
  City and its counterparts here and abroad.
- The Local Government Relation Unit (LGRU) shall have the following duties and functions:
  - assist the Mayor and the City Government foster understanding, friendship and goodwill;
  - assist the Mayor and the City in promoting cultural exchanges and understanding;
  - assess, identify, evaluate, and recommend to the City Mayor and to the Sangguniang Panlungsod various areas if cooperation;
  - formulate and update the Bacoor City Profile;
  - communicate and negotiate with the duly-designated officials of the city with which the City of Bacoor aims to establish sister-city ties
  - ensure the fulfilment by the City Government of its various obligations under the said agreement;
  - monitor the fulfilment by the sister-cities/twin-towns of the City of Bacoor of their various obligations under the agreement;
  - liaise between the various departments and units of the City Government and their counterparts.



A joint committee hearing was held on September 04, 2025 at the Sangguniang Panlungsod Session Hall regarding the aforementioned subject matter with the following attendees. (See attached attendance sheet)

The hearing was presided over by Committee Chair Hon. Miguel Bautista. He also led the prayer, gave his opening remarks and acknowledged the presence of all the committee members and resource persons as well.

Deliberation on the proposed ordinance creating a Local Government Relations unit under the Office of the Mayor which will take charge of sister-city and town-twinning agreements between the city government of Bacoor, Cavite and other local governments in the Philippines and abroad and identifying its various functions and duties.

Budget City Officer, Miss Elvie Guerrero was recognized. She commented on Section 3. Creation of Various Plantilla Positions. According to her the positions listed in Section 3 is not in accordance with the Index of Occupational Services of the Department of Budget and Mangement (DBM). She also added that if there's already an ordinance then they will include it in the 2026 Budget.

Miss Rachel Alcantara of the HRDMD affirmed that their office support the said ordinance and agree to what Ms. Guerrero said.

Atty. Marco Mendoza of the Office of City Legal Services was recognized. He asked if the positions stated in Section 3 is on a co-terminous basis. According to Ms. Guerrero it should be a permanent position since they are all Administrative titles.

There being no other matters to be discussed, the meeting was adjourned at 11:20am.




