13.1 To further support strategic procurement management and ensure smart and prudent use of government resources, Procuring Entities shall apply **Life Cycle Assessment (LCA)** and **Life Cycle Cost Analysis (LCCA)**, x x x

#### Section 73. Green Public Procurement Strategy

73.1 Green Public Procurement (GPP) is an approach whereby Procuring Entities seek to procure Goods, Infrastructure Projects, and Consulting Services with reduced environmental impact through their life cycle. x x x
