

- The City Administrator serves as the institutional mechanism for inter-office coordination, directly assisting the City Mayor in achieving effective local governance;

- It is deemed necessary and proper to institutionalize the office of the City Administrator as a permanent office within the City Government of Bacoor, defining its authority, structure, and staffing in accordance with existing laws, regulations, and administrative standards;
- The ordinance shall be known as the "Ordinance Strengthening the Office of the City Administrator of the City Government of Baccor";
- The position of Assistant City Administrator can't be found in the Local Government Code. The correct position title should be City Government Assistant Department Head 1 with a Salary Grade 23 which is aligned with the Civil Service Commission (CSC) qualification standards;
- To carry out the intent and purpose of this ordinance, the initial funding requirements for the creation of the position of City Government Assistant Department Head 1 with Salary Grade 23, shall be charged against available funds of the City Government of Bacoor, subject to the usual accounting and auditing rules and regulations.

RECOMMENDATION:

In view of the foregoing, the Committee found the proposed measure meritorious and recommends its APPROVAL.

The hearing was presided over by Committee Chair Hon, Miguel Bautista, He also led the prayer, gave his opening remarks and acknowledged the presence of all the committee members and resource persons as well.

Members recognized the necessity of the Ordinance to streamline administrative operations, strengthen inter-office coordination, and enhance the delivery of public services.

Clarifications were made regarding the scope of duties, funding source, and appointment processes, ensuring compliance with existing civil service and budgetary requirements.

The position of Assistant City Administrator can't be found in the Local Government Code. The correct position title should be City Government Assistant Department Head 1 with a Salary Grade 23 which is aligned with the Civil Service Commission (CSC) qualification standards.

The Body agreed that the proposal aligns with the goals of the local reorganization plan and will support the efficient management of City programs.

There being no other matters to be discussed, the hearing was adjourned at 11:05 am.


