Subject: An ordinance amending the position titles of the positions created by the Sangguniang Panlungsod for the Local Development and Investment Promotions Office (LEDIPO) under City Ordinance No. 286-2023 so that it will conform with pertinent policies of the Department of Budget and Management

The above mentioned proposed ordinance underwent its first reading on August 23, 2023 during the 57th Regular Session of the Sangguning Panlungsod. The said proposed ordinance was referred by the Presiding Officer Hon. Rowena Bautista Mendiola to the Committee on Ethics, Appointments, and Government Reorganization.

The Committee on Ethics, Appointments and Government Reorganization sent out invitations to the resource persons and conducted a committee hearing on September 07, 2023 at the Session Hall of the Sangguniang Panlungsod at 8:30 a.m.

FINDINGS:

The Sangguniang Panlungsod created City Ordinance No. 286-2023, "An ordinance amending Section 12 of the City Ordinance No. 157-2021 (The Local Economic and Investment Promotion Ordinance of the City of Bacoor) which created the Local Economic and Investments Promotion Office of the City of Bacoor, duly ordained last May 22, 2023.

Upon verification of position titles in the DBM issued Local Budget Circular No. 132 dated July 13, 2021, the subject of which is the Index of Occupational Services, Positions, Titles and Salary Grades in the Local Government (IOS-LGU) CY 2021 Edition, the following are the discrepancies in the newly created positions stated in City Ordinance No. 286-2023



LOCAL BUDGET CIRCULAR

No. 137 July 13, 2021

- TO All Provincial Govenors; City and Municipal Mayors; Members of the Sangguniang Panlalawigan/Panlungsod/Bayan; Barangay Chairmen; National/Provincial/CityMunicipal Presidents, Liga ng mga Barangay; Provincial/ City/Municipal Budget Officers; Provincial/City/Municipality Human Resource Management Officers; Regional Directors of the Department of the Interior and Local Government, Department of Finance, Civil Service Commission, Commission on Audit; and All Others Concerned
- SUBJECT: Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU), CY 2021 Edition
- 1.0 Pursuant to the mandate of the Department of Budget and Management (DBM) as the administrator of the Compensation and Position Classification System (CPCS) established under Republic Act (RA) No. 6758 dated August 21, 19891, and Section 3 (b) of Congress Joint Resolution (JR) No. 4 dated July 28, 20092, and the authority of this Department under Administrative Order No. 42, s. 19933 to continue to prescribe policies, standards and rules on compensation and position classification in the local government, an updated Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU for brevity) is hereby issued.
- 2.0 The IOS-LGU, CY 2021 Edition contains the updated list of classes or position titles existing in the local government units (LGUs) that are grouped by occupation.

Henceforth, all positions in the LGUs shall be allocated to their proper position titles and salary grades in accordance with said Index.

An Act Prescribing a Revised Compensation and Position Classification System in the Government and for Other Perposes.

Joint Resolution Authorizing the President of the Philippines to Michify the Compensation and Position Classification System of Circhan Personnel and the Base Pay Schedule of Military and Uniformed Personnel in the Government, and For Other Purposes.

Classifying the Role of the Department of Budget and Management in the Compensation and Classification of Local Government Positions under R.A. No. 7160



- 3.0 The IOS-LGU consists of two (2) parts:
 - 3.1 Part I covers all position titles applicable or may be created in municipalities, cities and provinces; and
 - 3.2 Part II covers position titles applicable or may be created in the barangays pursuant to Local Budget Circular No. 63⁴ dated October 22, 1996.
- 4.0 The DBM shall issue advisories whenever there are modifications in the IOS-LGU as a result of additional classes of positions, and the abolition, modification, retitling or modification of classes or position titles.
- 5.0 The Revised Index of Occupational Services, Position Titles and Salary Grades (IOS) in the Local Government under LBC No. 61 dated March 18, 1996 is deemed superseded with this issuance.
- 6.0 The CY 2021 IOS-LGU is available for downloading at the DBM website, http://www.dbm.gov.ph.
- 7.0 This Circular shall take effect immediately.






