Subject: *An ordinance strengthening the Strike sa Serbisyo Action Center as the Office of the City Mayor's frontline service for delivery of services to Bacoor residents belonging to the marginalized sectors of society such as Senior Citizens, Persons with Disabilities, and Single Parents and the creation of the Mayor's Socialized benefits for residents (MSBR) Unit under the Office of the City Mayor for the improvement of the delivery of social benefits, and assistance to qualified residents of the City of Bacoor. (PCO No. 2023-117:September 04, 2023)*

The above-mentioned proposed ordinance underwent first reading on September 04, 2023 during the 59th Regular Session of the Sangguning Panlungsod. The said proposed ordinance was referred by the Presiding Officer Hon. Rowena Bautista Mendiola to the Committee on Ethics, Appointments, and Government Reorganization.

The Committee on Ethics, Appointments and Government Reorganization sent out invitations to the resource persons and conducted a committee hearing on October 05, 2023 at the Session Hall of the Sangguniang Panlungsod at 10 a.m.

FINDINGS:

The City Government of Bacoor, thru the leadership of the City Mayor, Hon. Strike B. Revilla envisions a local government that is responsive and emphatic to the city, the elderly, the persons with disabilities, the solo-parents, and the underprivileged.

The City Mayor as chief executive of the city government is empowered by Section 455 (a) of the Local Government Code to exercise such powers and perform such duties and functions as provided by the Local Government Code and other laws.

In order to achieve such purpose, there is a need to strengthen the Strike sa Serbisyo Action Center that will serve as Frontline Service Provider for the Office of the City Mayor, catering the needs of the marginalized sectors in the City of Bacoor and for the creation of the Mayor's Socialized benefits for Residents (MSBR) Unit for the improvement of delivery of social benefits and assistance to qualified residents of Bacoor City.

8. The representatives manifested that the proposed ordinance needs some improvement and they suggested to conduct a dialogue among themselves to perfectly craft the proposed ordinance.

**PROPOSED CITY ORDINANCE NO. XXX-2023
SERIES OF 2023**

AN ORDINANCE STRENGTHENING THE STRIKE SA SERBISYO ACTION CENTER AS THE OFFICE OF THE CITY MAYOR'S FRONTLINE SERVICE FOR DELIVERY OF SERVICES TO BACOR RESIDENTS ESPECIALLY THE MARGINALIZED SECTORS OF SOCIETY, SENIOR CITIZENS, PERSONS WITH DISABILITIES, AND SINGLE PARENTS AND THE CREATION OF THE MAYOR'S SOCIALIZED BENEFITS FOR RESIDENTS (MSBR) UNIT UNDER THE OFFICE OF THE CITY MAYOR FOR THE IMPROVEMENT OF THE DELIVERY OF SOCIAL BENEFITS, AND ASSISTANCE TO QUALIFIED RESIDENTS OF THE CITY OF BACOR.

WHEREAS, the City Mayor as chief executive of the city government is empowered by Section 455 (a) of the Local Government Code (LGC) to exercise such powers and perform such duties and functions as provided by the LGC and other laws;

WHEREAS, the City Mayor has the duty to ensure that all executive officials and employees of the city faithfully discharge their duties and functions provided by law and the LGC under Section 455 (b)(1)(x) of the same Code;

WHEREAS, the City Mayor must ensure the delivery of basic services and the provision of adequate facilities under according to 455 (b) (4) of the same Code;

WHEREAS, the Sangguniang Panlungsod has the power to enact an ordinance to determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the city government under Section 458 (a)(1)(viii) of the same Code;

WHEREAS, the Sangguniang Panlungsod has the power to pass an ordinance to establish a scholarship fund for the poor but deserving students in schools located within its jurisdiction or for students residing within the city under Section 458 (a)(5)(xi);

WHEREAS, the Sangguniang Panlungsod has the power to pass an ordinance to provide for the care of disabled persons, paupers, the aged, the sick, persons of unsound mind, abandoned minors, juvenile delinquents, drug dependents, abused children and other needy and disadvantaged persons, particularly children and youth below eighteen (18) years of age; and subject to availability of funds, establish and provide for the operation of centers and facilities for said needy and disadvantaged persons under Section 458 (a)(5)(xiv);

WHEREAS, the Sangguniang Panlungsod has the power to pass an ordinance to formulate policies and adopt measures mutually beneficial to the elderly and to the community; provide incentives for non-governmental agencies and entities and, subject to the availability of funds to support programs and projects for the benefit of the elderly;

WHEREAS, Local Government Units are empowered by Section 17 of the LGC to execute necessary, appropriate, and incidental provisions of the basic services and facilities including social welfare services;

WHEREAS, the City Government of Bacoor, thru the leadership of the City Mayor – Hon. Strike B. Revilla envisions a local government that is responsive and empathic to the needs of the residents of the City of Bacoor most especially the marginalized sector of the City: the elderly, the persons with disabilities, the solo-parents, and the underprivileged.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Bacoor, Cavite that:

Section 1. TITLE. – This Ordinance shall be known as the "2023 STRIKE Sa Serbisyo Action Center and Mayor's Socialized Benefits for Residents (MSBR) Unit Ordinance of 2023".

Section 2. DEFINITION OF TERMS. – As used in this Ordinance, the following terms shall mean:

2.1. **Client** – refers to an individual who seeks assistance for himself/herself or on behalf of the beneficiary, due to their inability to be physically present.

2.2. **Financial Assistance** – refers to cash or GL provided to qualified beneficiaries.

2.3. **Medical Assistance** – This assistance shall cover hospitalization expenses, cost of medicines, and other medical treatment or procedures such as implants, common laboratory tests and diagnostic imaging procedures for any illness or ailment.

2.4. **Social Case Study Report** – refers to the document prepared by a professional Social Worker in public and private practice, that describes in detail the situation and conditions of the beneficiary, including his/her social history. The document likewise includes assessment, plan for intervention and recommendation.

SECTION 3. CREATION OF THE STRIKE SA SERBISYO ACTION CENTER PROGRAM. – Upon the effectivity of this Ordinance, the Strike sa Serbisyo Action Center is hereby created. It shall form part of the Office of the City Mayor and shall be headed by City Mayor himself/herself as the local chief executive.

SECTION 4. WHO MAY AVAIL. – The services provided by the Strike Action Center shall be available to disadvantaged, marginalized and vulnerable individuals, groups, families and communities. These may include, but are not limited to the following:

4.1 Abandoned, neglected, orphaned abused and exploited children and other children in need of special protection, e.g. children in conflict with the law.

4.2 Out-of-school youth and other youth with special needs

4.3 Women in especially difficult circumstances

4.4. Persons with disability or differently-abled persons which refers to those suffering from restriction of various abilities, as a result of mental, physical and sensory disorder

4.5. Senior Citizens, an individual who is sixty (60) years old and above

4.6. Marginalized and disadvantaged individuals, families and communities e.g. indigenous group/s, those in crisis situation/s, internally displaced due to armed conflict

4.7. Victims of natural and man-made calamities/disasters.

SECTION 5. SERVICES UNDER STRIKE SA SERBISYO ACTION CENTER. -

The Strike Action Center shall provide the following services to the disadvantaged, marginalized and vulnerable sectors residing within the City of Bacoor:

5.1. ***Aids to Individual in Crisis Situation*** – services for individuals who are currently experiencing an emergency situation which includes the following:

- a.) Burial Assistance;
- b.) Medical Assistance;
- c.) Financial Assistance;
- d.) Social Case Study Report (Hospitalization Assistance, Burial Assistance, and Financial Assistance);
- e.) and Certificate of Indigency.

5.2. ***Disaster Relief Assistance*** - Provision of timely and appropriate assistance at the onset of disasters to the disaster affected individuals/families.

5.3. ***Issuance of Solo Parent Identification (ID)*** - Issuance of ID to qualified and assessed solo parents pursuant to Republic Act No. 8972 or an Act providing for benefits and privileges to solo parents and their children. Availled of solo parents with minor children or those with special needs children above seventeen (17) years old but could not take care of themselves.

5.4. ***Self-Employment Assistance/Sustainable Livelihood Program*** - Provision of capital assistance to be used in engaging in an income generating project. It is a capability-building for poor, vulnerable and marginalized households and communities to improve their socio-economic conditions through accessing and acquiring necessary assets to engage in and maintain thriving livelihoods. Such may be availed of women, youth, PWD's, 4P's beneficiaries, among others.

5.5. ***Shelter for Boys*** - Residential/center-based Social Protection Services to Children/Youth for male children that are abused, abandoned, neglected, roaming the streets or considered as street children and foundling children that provides twenty-four (24) hours home-life services, other support services that aim to rehabilitate, improve the

condition of the children in preparation for their reintegration to their families/community or for long-term placement.

5.6. Social Services for Special Cases – Provision of special services to different beneficiaries which includes:

a.) **For Children** – services to children, his/her family which include counselling to child and his family, assistance in filing the case, referral to other agencies for the other support services involving cases such as children with behavioral problem, child custody, abused cases, abandoned/neglected, foundling, other concerns on children.

b.) **For Elderly and Persons with Disabilities (PWDs)** – Provision of special services to Elderly and PWD's which include referral to other agencies/institution when families are not found or working/locating their families for their reintegration

c.) **For Women in Especially Difficult Circumstances** – Provision of special social services to Women who are victims of battery/abuse, trafficking, exploitation, violence and those disadvantaged.

d.) **Special Tie-Up Project for Families** – Provision of special social services to families concerning housing, which include assessment, validation of families affected by demolition, litigation of civil cases, relocation, and those referred by the National Housing Authority (NHA), Courts, Housing Urban Development & Resettlement Department (HUDRD), Presidential Commission for the Urban Poor (PCUP), and Department of Public Works and Highways (DPWH).

5.7. Scholarship Program – provides financial assistance to augment the educational needs of the students to support the parents in sustaining their children's rights to education available for students in Junior High School, Senior High School and College/Tertiary Education, whether in public or private.

SECTION 6. CREATION OF THE MAYOR'S SOCIALIZED BENEFITS FOR RESIDENTS (MSBR) UNIT. – The Mayor's Socialized Benefits for Residents (MSBR) Unit is hereby created. It shall form part of the Office of the City Mayor and shall be headed by the City Mayor himself/herself as the local chief executive.

SECTION 7. DUTIES AND FUNCTIONS OF THE MSBR UNIT. – The MSBR Unit shall have the following powers and duties:

6.1. Receive application forms and validate documentary requirements necessary to avail of specific services submitted by clients/applicants.

- 6.2. Conduct assessment of application forms and documentary requirements submitted.
- 6.3. Forward validated documents for approval of Mayor Strike B. Revilla.
- 6.4. Inform the client/applicant of the release of the document/ assistance applied for.
- 6.5. Receive reports from barangays of affected families in cases of natural and man-made disasters.
- 6.6. Conduct intake interviews with the client/applicant.
- 6.7. Provision of relief and other support assistance.
- 6.8. Prepare and submit reports for consideration.
- 6.9. Refer cases to appropriate agencies/offices/unit, if necessary.

SECTION 8. COMPOSITION OF THE MSBR UNIT. – The Mayor's Socialized Benefits for Residents (MSBR) Unit shall be composed of:

SECTION 9. GENERAL REQUIREMENTS FOR THE AVAILMENT OF BENEFITS FROM THE CITY GOVERNMENT OF BACOR. – The following must be submitted by any applicant for any benefit from the City Government of Bacoor, among other documents as may be required by this Ordinance, its Implementing Rules, and Regulations (IRR), and such other orders, and guidelines as may be issued in furtherance of this Ordinance:

9.1. **COMELEC REGISTRATION.** The applicant must be a registered voter of the City Government of Bacoor, except those applicants who are less than eighteen (18) years of age at the time of their application of the benefits;

- a. The applicant must present his COMELEC issued Voter's ID, or a COMELEC certification showing that the applicant is a voter in the City of Bacoor;
- b. The Management Information Systems (MIS) Department is empowered to coordinate with the local COMELEC for the determination of the updated list of voters in the City of Bacoor subject to the applicable laws and principles of Data Privacy;
- c. The MIS Department has the duty to update the list of voters at least once every month.

9.2. **VALID GOVERNMENT ID.** The applicant must possess a valid government id to be presented to the Strike Action Center.

9.3. The requirements herein shall not apply in case relative national laws and guidelines providing the said benefit does not require the same.

SECTION 10. MANDATORY GUIDELINES. – The Strike Action Center and the MSBR Unit shall strictly adhere to the following guidelines and minimum standards for the efficient and effective delivery of much needed social welfare benefits:

10.1. If all the requisite documents submitted by the applicant are in order, all transactions shall not be more than **FIFTEEN (15)** minutes per applicant, except when the requested benefit requires the approval of the City Mayor him/herself;

10.2. Before ending the transaction with the applicant, the frontline service employee shall issue a transaction receipt detailing the following information:

9.2.1. Remarks on the submitted documentary requirements by the applicant on whether they correct or not;

9.2.2. Remarks on whether there are documentary requirements not submitted;

9.2.3. The date for the applicant's follow-up date;

9.2.4. The printed name, signature, and position of the officer/employee who took charge of the applicants requested benefit.

10.3. Frontline service lanes devoted to Senior Citizens and PWDs shall be created;

10.4. No application or request shall be returned to the applicant or requesting party without appropriate action. In case an application or request is disapproved, the officer or employee who rendered the decision shall send a formal notice to the applicant or requesting party within the prescribed processing time, stating therein the reason for the disapproval. A finding by a competent authority of a violation of any or other laws by the applicant or requesting party shall constitute a valid ground for the disapproval of the application or request, without prejudice to other grounds provided in this Act or other pertinent laws.

10.5. Any denial of application or request for access to government service shall be fully explained in writing, stating the name of the person making the denial and the grounds upon which such denial is based. Any denial of application or request is deemed to have been made with the permission or clearance from the highest authority having jurisdiction over the government office or agency concerned.

SECTION 11. IMPLEMENTING RULES AND REGULATIONS. The shall formulate the Implementing Rules and Regulations (IRR) necessary to implement the provisions of this Ordinance within days upon the final consideration and approval of this Ordinance by the Sangguniang Panlungsod of City of Bacoor.

SECTION 12. DATE OF EFFECTIVITY. This Ordinance shall take effect immediately after it has been published once in a newspaper of general circulation in the City of Bacoor, Cavite.

SECTION 13. AUTOMATIC REVIEW. The Sangguniang Panlungsod shall automatically review this Ordinance once every three (3) years after its approval or whenever the need for such review arises.

SECTION 14. REPEALING CLAUSE. All local ordinances, executive orders, resolutions, memoranda, regulations, or part thereof in conflict or inconsistent with any provisions of this Ordinance shall be considered hereby revoked and/or modified accordingly.

SECTION 15. SEPARABILITY CLAUSE. If for any reason, any provision of this Ordinance is deemed not valid by a court of competent jurisdiction, such judgment shall not affect or impair the remaining portions, provisions, sections, or parts thereof, which shall remain to be in full force and effect.
