Subject: An ordinance amending Section No. 5, Paragraph 1 of City Ordinance No. 324-2023 entitled: "An ordinance regulating the engagement, work, and termination of Job Orders and Contract of Services Employees of the various departments and offices of the Local Government of the City of Bacoor, Cavite and imposing penalties for violations hereof.

(Date referred: December 16, 2024)

The above-mentioned proposed ordinance underwent its first reading on December 16, 2024 during the 121st Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Ethics, Appointments, and Government Reorganization.

### FINDINGS:

Pursuant to R.A. 10911, an act prohibiting discrimination against any individual employment on account on age and providing penalties for violations, there came an equal opportunities employment program that does not require any age limitations for contract of service and job order employees.

Section 5, Paragraph 1 (Qualification for Engagement) of City Ordinance No.324-2023 is amended to wit:

- Must be on legal age on the day of his/her appointment signed by the appointing authority.
  - 2. Must be physically and mentally able to perform his/her duties.

WHEREAS, there is a need to amend Section 5 particularly on Qualifications for Engagement , Paragraphs No. I in order to remain the city government efficient and effective.

BE IT ORDAINED by the 5th Sangguniang Panlungsod in its regular session assembled THAT:

Section 1, Section 5 on Qualifications for Engagement of City Ordinarice No. 324-2023 is hereby amended to read at follows:

"Section 5. Qualifications For Engagement, Only persons who possess the following qualifications shall be engaged as job order or contract of services employees:

> 1. Must be of legal age but not exceeding years old on the day his/her appointment is signed by sither the appointing authority


