# COMMITTEE REPORT CRPLO-PCO-2024-231



Subject: An ordinance authorizing the forfeiture of unredeemed or abandoned impounded motor vehicles and prescribing the guidelines on the disposal thereof.

(Date referred: January 06, 2025)

The above-mentioned proposed ordinance underwent its first reading on January 06, 2025 during the 122nd Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Acting Presiding Officer, City Councilor and President Pro-Tempore Hon. Reynaldo C. Palabrica to the Committee on Rules and Privileges, Laws and Ordinances.

#### FINDINGS:

On October 7, 2013, the Sangguniang Panlungsod amended the Revised Traffic Code of the City of Bacoor, through City Ordinance No. 2013-047, Series of 2013 effectively re-numbering Section 122 to Section 125 and shall be read as "Authority of the BTMD Head to Dispose Unclaimed Vehicles."

The Bacoor Traffic Management Department found out that there has been a significant number of motor vehicles, parts and accessories in the designated impounding area of the City Government of Bacoor which remains unredeemed and appears to have already been abandoned by its registered owners.

The unredeemed motor vehicles, parts and accessories take up much needed space in the designated impounding area and the security of these causes additional financial burden on the part of the city.

This proposed ordinance is intended to properly dispose of the said impounded and abandoned motor vehicles within a shorter period of time to accommodate more vehicles, and likewise recover the expenses incurred in the maintenance and custody of the same.

Disposition of these unredeemed motor vehicles shall be done through public auction. Written notices shall be sent to the last known registered owner of the vehicle, and the person indicated in the violation ticket informing the person, on the first business date after six (6) months, that the unredeemed or abandoned impounded vehicles will be declared as forfeited and under the legal possession of the City Government.

The proceeds derived from such auction shall be used to defray the expenses of auction. Any balance thereto shall be applied to the accumulated charges and any other expenses incurred in the towing, clamping and storage of the vehicle.

### RECOMMENDATION:

After a thorough review of all the circumstances and statements from the resource persons, the Committee respectfully recommends that the Sangguniang Panlungsod approve the above subject matter.

By the motion of Hon. Reynaldo C. Palabrica duly seconded by all the members of the Sangguniang Panlungsod, the above subject matter was **APPROVED** during its 123<sup>rd</sup> Regular Session.

COUN. REYNALDO PALABRICA "For the record, in attendance to this hearing are the following honorable members of the city council. Here is Honorable councilor from District 2. Honorable Bok Nolasco."

COUN. REYNALDO PALABRICA "From District 1, our Honorable councilor, Councilor Levy Tela."

COUN. REYNALDO PALABRICA "From District 2, Honorable councilor, Simplicio Dominguez."

COUN. REYNALDO PALABRICA "Thank you very much."

COUN. REYNALDO PALABRICA "So we will be discussing about the proposed ordinance on proposed guidelines regarding the unredeemed motor vehicles or impounded motor vehicles under BTMD. First question is, gaano na karami ana impounded na motor o sasakvan?"

ADEL UDARBE "Ang impounded po natin ay nasa eight hundred po. Motor vehicles."

COUN. REYNALDO PALABRICA "Wow. Yung time period nun?"

ADEL UDARBE "Baka po 2017? Up to present po."

COUN. REYNALDO PALABRICA "Up to present?"

ADEL UDARBE "Yes po. Kasi, pag hinayaan po, this will be the first time na makakapag-auction po ng impounded na vehicle, hindi pa po ito nagawa ng city."

COUN. REYNALDO PALABRICA "Oo. Kasi wala ngang ordinansa, walang guidelines how to dispose, so hindi naman puwedeng by suggest ng mayor biglang, hindi naman puwede yun. ADEL UDARBE "Yes po. May inventory naman po kami."

COUN. REYNALDO PALABRICA "Properly recorded."

ADEL UDARBE "Yes po."

COUN. REYNALDO PALABRICA "Councilor Dominguez, parang may tanong po kayo?"

COUN. REYNALDO PALABRICA "Councilor Tela?"

COUN. LEVY TELA "Sa akin matanong ko lang, syempre marami tayong impounding vehicles diyan, paano ba gagawin diyan? Yung iba hindi naclaclaim diba po? 

COUN. REYNALDO PALABRICA "It is stated in the proposal that the vehicle owner. have only six months to redeem with redemption period, after six months, it is the authority of the city to dispose the vehicle in favor of the city, okay lang ba yun?"

ATTY. MARIUS D. SUMIRA "Yes po. Through ordinance po, base sa manual naman ng COA ng disposal, sa COA DBM ng government property, wala naman po tayong nava-violate kasi once na ma up for bidding, at wala makapag bid, or hindi po talaga siya ma process, halimbawa walang nag appear na magbibid, puwede na po talaga natin siya treat as government property for disposal."

COUN. REYNALDO PALABRICA "So after six months unredeemed, it will be declared by the City Government all those vehicles are government property."

ATTY. MARIUS D. SUMIRA "Ang proteksyon lang po natin doon, dapat masigasig po yung ating notification."

COUN. REYNALDO PALABRICA "Notification."

ATTY. MARIUS D. SUMIRA "Talagang makakarating doon sa tao."

COUN. REYNALDO PALABRICA "With regards doon sa notification, is there a law or requirement? How many times we should send notices to all concerned?"

ATTY. MARIUS D. SUMIRA "At least two notices po, prior. Dapat po hindi malapit. For example po, six months, dapat one month before matapos yung six months,





COUN. REYNALDO PALABRICA "Yes, Councilor Nolasco?"

COUN. ROGELIO NOLASCO "May tanong lang ako kay attorney. Attorney, in case na hindi ma verify, walang pagkakakilanlan, at walang mapadalhan na notices yung isang unit na naka impound, ano po ang dapat mangyari doon? O ano yung magiging sitwasyon ng unit na yun?"

ATTY. MARIUS D. SUMIRA "Idedeclare po siya as abandoned. COUN. REYNALDO PALABRICA "Yung sa ordinance natin."

COUN. ROGELIO NOLASCO "Attorney, pag po na impound, naka record sa inyo?"

ATTY. MARIUS D. SUMIRA "Opo. Ang problema po doon, is yung last known address, kung hindi na po sila doon nakatira or kung hindi pinapansin yung notices, so puwede parin pong mag proceed, hindi po magiging hindrance yun para sa government process."

COUN. ROGELIO NOLASCO "Thank you, attorney."

COUN. REYNALDO PALABRICA "Paano kung sub urban, no? Anyway, what is not stated in the proposed ordinance is the grace period for the proceeds, hindi nakasama dito. We will see to it that it will be included in another petition, to allow a grace period for the redemption for the proceeds for the auction. Walang problema sa BTMD?"

ADEL UDARBE "Yes po. Wala naman po."

COUN. REYNALDO PALABRICA "Also, we will state in the proposed ordinance, hindi kasi stated dito that the proceeds will go to the trust fund, there must be a creation of trust fund."

ATTY. MARIUS D. SUMIRA "Opo."

ATTY. MARIUS D. SUMIRA "Opo, inadvise lang po din namin baka kasi din po makita po dito."

COUN. REYNALDO PALABRICA "Okay. So, any other concern? Parang wala namang problema itong ordinansang ito. Any manifestastion? BTMD?"

ADEL UDARBE "No. We're all good po your honor. Thank you very much po. Ang ano lang po namin, that the longer we keep the vehicle, it depreciates lalo yung presyo, tapos mas napupuno yung impounding natin, yung problema lang po natin kung saan mailalagay yung sasakyan. So mas gusto po namin ito, para makapag-auction po kami kahit twice or three times a year."

COUN. REYNALDO PALABRICA "And also, requesting for the process. Attorney Marius, any manifestation if you want?"





SUBJECT: Request to Pass a City Ordinance Authorizing the Forfeiture of Unredeemed or Abandoned Impounded Motor Vehicles and Prescribing the Guidelines on the Disposal Thereof

Dear Hon, Bautista-Mendiola

Under City Ordinance No 2013-2. Series of 2013, otherwise known as the Revised Traffic Code of the City of Baccor, the City government is authorized to dispose of unclaimed vehicles. This authority was reiterated when the Sangguniang Panlungsod amended the Revised Traffic Code of the City of Baccor on 7 October 2013 through City Ordinance No. 2013-047. Series of 2013. Based on the findings of the Baccor Traffic Management Department, there has been a significant number of motor vehicles, motor parts and/or accessories in the designated impounding area of the City Government of Bacoor which remains unredeemed and appears to have already been abandoned by its registered owners after being impounded pursuant to the Revised Traffic Code of the City of Baccoor

In view thereof, I respectfully request the esteemed members of the Sangguniang Panlungsod to perform the appropriate action to pass a City Ordinance that will authorize the forfeiture of unredeemed or abandoned impounded motor vehicles and prescribing the guidelines on the disposal theraof. Attached herewith is a draft ordinance with the same purpose, for your reference and consideration.

AN ORDINANCE AUTHORIZING THE FORFEITURE OF UNREDEEMED/ABANDONED IMPOUNDED MOTOR VEHICLES AND PRESCRIBING THE GUIDELINES ON THE DISPOSAL THEREOF AMENDING FOR THE PURPOSE SECTION 122 OF CITY ORDINANCE NO. 2013-2, SERIES OF 2013, AS AMENDED BY CITY ORDINANCE NO. 2013-047, SERIES OF 2013, OTHERWISE KNOWN AS THE REVISED TRAFFIC CODE OF THE CITY OF BACOOR

WHEREAS the Sangguniang Panlungsod of the City of Baccor passed City Ordinance No. 2013-2. Series of 2013, otherwise known as the Revised Traffic Code of the City of Baccor, providing for the authority to dispose of unclaimed vehicles, viz.

"Section 122. Authority to Dispose of Unclaimed Vehicles. (a) The Head of BTMD is hereby authorized to recommend to the City Mayor the disposal of a vehicle that has been taken into custody. Such disposition shall be at public auction under such procedure, as the City Mayor shall establish with the approval of the Sangguniang Panlungsod. Written notice of such auction shall be sent to the last known registered owner by certified mail at least 10 days prior to the date of auction, and said auction shall be held not earlier than 60 days after the date upon such vehicle shall have been taken into custody. Any person entitled to such vehicle may claim the same at any time prior to such auction upon payment of all costs and expenses relating to the towing and storage of such vehicle. Its determined by said officer or his authorized subordinates.

(b) The funds derived from any such auction shall be used to definy the expenses of auction and any other expenses incurred in taking into custody and the balance if any, shall become part of the Bacoor Traffic Management Trust Fund.

WHEREAS, on 7 October 2013, the Sangguniang Panlungsod amended the Revised Traffic Code of the City of Bacoor, through City Ordinance No. 2013-047, Series of 2013, effectively re-numbering Section 122 thereof to Section 125 and shall read as follows:


#### Section 125. Authority of the BTMD to Dispose Unclaimed Vehicles.

(a) The Traffic Operations Officer is hereby authorized to recommend to the City Mayor the disposal of a vehicle that has been taken into custody. Such disposition shall be through public auction under such procedure, as the City Mayor shall establish with the approval of the Sangguniang Panlungsod. Written notice of such auction shall be sent to the last known registered owner by registered mail at least ten (10) days prior to the date of auction, and said auction shall be held not earlier than 60 days after the date the vehicle shall have been taken into custody. Any person entitled to such vehicle may claim the same at any time prior to such auction upon payment of all costs and expenses relating to the towing and storage of such vehicle, as determined by the Traffic Operations Officer or his authorized supportinates.

(b) The proceeds derived from such auction shall be used to defray the expenses of auction and any other expenses incurred in the towing and

storage of the vehicle. The balance if any, shall accrue to the Baccor Traffic Management Trust Fund.

WHEREAS, the findings of the Bacoor Traffic Management Department shows that there has been a significant number of motor vahicles, motor parts and/or accessories in the designated Impounding area of the City Government of Baccor which remains unredeemed and appears to have already been abandoned by its registered owners after being impounded pursuant to the Revised Traffic Code of the City of Baccor.

WHEREAS, there has been a continued increase in the number of impounded motor vehicles, motor parts and/or accessories due to the intensified clamping, towing and impounding operations of the City Government pursuant to City Ordinance No. 213-2022, Series of 2022, entitled, 'An Ordinance Amending Section 139 of the Revised Traffic Code of the City of Baccor and Penalizing the Tampering Destruction, or Unauthorized Removal of Tire Clamps:

WHEREAS, these unredeemed impounded motor vehicles, motor parts and/or accessories take up much needed space in the designated impounding area of the City Government and the security for said motor vehicles causes additional financial burden on the part of the City Government which could instead be utilized to fund more important project, programs or activities of the City;

WHEREAS in order to properly dispose of the said impounded and abandoned motor vehicles within a shorter period of time to accommodate more vehicles, and likewise recover the expenses incurred in the maintenance and custody of the same. there is a need to further amend certain provisions of City Ordinance No. 2013-2, as amended by City Ordinance No. 2013-047, Series of 2013.

NOW THEREFORE, be it ordained by the \_\_ Sangguniang Panlungsod of the City of Baccor THAT

SECTION 1. Short Title, This Ordinance shall be entitled "An Ordinance Authorizing the Forfeiture of Unredeemed or Abandoned Impounded Motor Vehicles and Prescribing the Guidelines on the Disposal Thereof".

SECTION 2. Amendment of Section 125 of the Revised Traffic Code. The provision of Section 125 of the Revised Traffic Code is hereby amended which shall now read as follows

Section 125 Authority of the BTMD to Declare the Forfeiture and Dispose Unredeemed or Abandoned Impounded Vehicles. -

- (a) Failure of the operator registered owner or any person duly authorized by the registered owner to redeem the impounded vehicles. pursuant to any violation of this Code which warrants the impounding at the designated impounding area of the City Government of Baccor, within six (6) months from the date it was impounded shall be considered as unredeemed or abandoned and shall be declared forfeited and in the legal possession of the City Government of Baccor, in particular the Baccor Traffic Management Department
- (b) The Head of the Bacoor Traffic Management Department is hereby authorized to recommend to the City Mayor the disposal of any vehicle that has been taken into custody by the City Government pursuant to any

violation of this Code which warrants the impounding thereof Such disposition shall be done through public auction, under such procedure as the City Mayor shall establish with the approval of the Sangguniang Panlungsod. Written notices shall be sent to the last known registered owner or person indicated in the documents of the vehicle, and the person indicated in the violation ticket, if available, by registered mail: (1) on the first business date after the sorth (6th) month informing the person that the unredeemed or abandoned impounded vehicle will be declared as forfeited and under the legal possession of the City Government, and (2) at least ten (10) days prior to the date of auction, and said auction shall be held not earlier than six (6) months after the date the vehicle shall have been taken into custody. Any person entitled to such vehicle may redeem the same, at any time prior to the day of auction, upon payment of penalties, all costs and expenses relating to the towing, clamping and storage of such vehicle at the designated impounding area of the City, as determined by the Head of the Bacoor Traffic Management Department, or, in his/her absence, the officer-in-charge of the Department

- (c) The proceeds derived from such auction shall be used to defray the expenses of auction. Any balance thereto shall be applied to the accumulated charges, i.e. fine, towing, clamping and impounding fees, and any other expenses incurred in the towing, clamping and storage of the vehicle. Any balance thereafter, if any, shall accrue to the General Fund of the City.
- (d) The BTMD shall likewise include in the written notice any creditor, mortgagee, or other persons interested in the impounded vehicle pursuant to immediately available documents or after it has discovered or has been made aware of the same.

SECTION 3. Impounding and Claiming of Vehicles Impounded Pursuant to the Revised Traffic Code of the City of Bacoor.

- 3.1. Impounding of Vehicles
  - a. Before impounding any vehicle, the Impounding Officer (Traffic enforcer/Deputized Traffic enforcer) shall make an inventory in the presence of the driver of:
    - The vehicle's parts/accessories, personal effects, damage. or defects, if any, in the Technical Inspection Report (TIR) Form.
    - 2. The Technical Inspection Report form should be properly accomplished by the BTMD traffic enforcer, duly concurred by the driver/owner of the impounded vehicle and witnessed by the security guard manning the perimeter.
    - 3. If the driver/owner of the vehicle is not present, picture documentation shall be necessary, detailing the outside and inside of the impounded vehicle.
  - b. The security designated by the City Administrator at the impounding area of the City Government of Baccor shall be field responsible for any osses/damages to the vehicles impounded in thereat.

 d. While at the impounding area, using of tow bar in lifting and/or assisting. impounded vehicle for starting purposes shall be prohibited to avoid unexpected cases of accidents or any damages to be incurred therein.

### 3.2. Claiming of Impounded Vehicles

maybe assigned by the Impounding Officer

When redeeming towed, clamped, or impounded vehicles, the owner/driver or the authorized representative shall present the motor vehicle's Certificate. of Registration before the BTMD's Office. The BTMD shall issue the necessary order of payment to the owner/driver or the authorized representative.

After obtaining the necessary order of payment, the owner/driver or his/him. authorized representative shall pay the accumulated charges by virtue of the clamping, towing and impounding of the subject vehicle as well as any other fine relative thereto, if any, to the Office of the City Treasurer.

After obtaining the receipt from the Office of the City Treasurer, the BTMD shall issue a Release Slip to be presented to the Impounding Officer.

The Impounding Officer shall release the impounded vehicle's including parts and accessories covered by the Trisflic Inspection Report form upon presentation of the following:

- a. Proof of being the legitimate driver/owner of the vehicle or an authorized representative; and
- b. Proof of payment, logether with the corresponding release.

SECTION 4. Guidelines and Procedure on the Disposal of Unredeemed or Abandoned Impounded Vehicles through Public Sale or Auction. - The Guidelines and Procedures on the Disposal of Unredeemed or Abandoned Impounded Vehicles through Public Sale or Auction shall be detailed in the Implementing Rules and Regulations of this Ordinance.

The IRR shall be subject of review by the Office of the City Mayor, as it deems necessary, for further improvement of its implementation

SECTION 5. Penalties. Any violation of this ordinance by any person shall be subject. to the following penalties:

First Offense	P3,000
Second Offense	P4,000
Third Offense	P5.000 plus imprisonment for a period not more than six (8) months, at the discretion of the Court

The filing of a case for violation of this Ordinance does not in any way prevent the filling of any administrative, civil, or criminal charges that may be filed against the offender.

SECTION 6. Implementing Rules and Regulations. The BTMD, with the assistance of the Office of the City Legal Service, shall formulate the implementing rules and regulations of this Ordinance and submit the same for approval of the City Mayor not later than sixty (60) days after the date of effectivity hereof.

SECTION 7. Mandatory Review of the Ordinance and IRR. This Ordinance shall be subject of a mandatory review every three (3) years by the Sangguniang Panlungsod

SECTION 8. Separability Clause. - If, for any reason, any provision or part of this Ordinance is declared invalid or unconstitutional, other provisions not affected thereby shalt remain in full force and effect.

SECTION 9. Repealing Clause. Any provisions of ordinances, executive orders. issuances, or rules and regulations inconsistent with the provisions of this Ordinance are hereby repealed, amended, or modified accordingly.

SECTION 10. Effectivity. - This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation in the City of Baccot.
