REVILLA, TO ENTER INTO A PUBLIC-PRIVATE PARTNERSHIP CONTRACT FOR THE "BACOR CITY DIGITALIZED TRAFFIC ENFORCEMENT" PROJECT, SUBJECT TO BIDDING OR COMPARATIVE CHALLENGE PURSUANT TO THE PPP CODE AND ITS IRR. (PCO 2025-242 dated March 3, 2025)

This report resolves a city ordinance authorizing the City Mayor, Hon. Strike B. Revilla to enter into a Public-Private Partnership contract for the "Bacoor City Digitalized Traffic Enforcement" project.

FINDINGS:

A proposal from the QPAX Traffic Systems Inc. was received by the City Government the unsolicited public-private partnership for the establishment of the **"BACOR CITY DIGITALIZED TRAFFIC ENFORCEMENT" PROJECT.**

On June 5, 2025 the City Government of Bacoor was referred to the Pre-Qualification, Bids and Awards Committee (PBAC) where a detailed evaluation was conducted for Project in coordination with officials of the Bacoor Traffic Management Department, the City Budget Office, the City Treasurer's Office, and other stakeholders. After the initial review on the proposal of the Project, the Pre-Qualification, Bids and Awards Committee (PBAC) that if this will be properly implemented this will lead to a substantial improvement in improvement in the enforcement of various traffic management ordinances within the City as this Project is advantageous to the City Government as it will not only modernized the manner by which Traffic Violation Receipts are issued to traffic ordinance violators and will also help discourage the commission of graft and corruption.

PBAC issued a Resolution No. 4 on November 4, 2024 declaring that a successful negotiation has been conducted and granting QPAX Traffic Systems Inc. "Original Proponent Status".

On November 18, 2024, the PBAC recommended to the City Mayor that the project proposal of the Proponent be formally transmitted to the Sangguniang Panlungsod for its review and consideration.

The Sangguniang Panlungsod passed a City Resolution No. 2024-626 on December 9, 2024 signifying the approval by the City Government of the Project. However, the PPP-Center belatedly informed the Sangguniang Panlungsod that "Section 5.2.5 of the PPP Governing Board (GB) Resolution 2024-07-02 provides that should the Local Sanggunian decide to approve the local PPP project, a Notice of Approval shall be issued to the LGU through an ordinance. Further, the notice shall contain authorization for the Head of LGU to enter into a contract containing the parameters, terms and conditions (PTCs) approved by the Local Sanggunian, subject to a successful bidding or comparative challenge following the required rules and processes under the PPP Code and its IRR."

On, February 28, 2025, the City Mayor, Hon. Strike B. Revilla formally requested to the Sangguniang Panlungsod to pass an ordinance authorizing him to enter into a public-private partnership contract for the "Bacoor City Digitalized Traffic Enforcement" project, subject to bidding or comparative challenge pursuant to the PPP Code and its implementing rules and regulations.

Committee hearing conducted on March 26, 2025 on the Project and recommending the approval of the proposed ordinance and be enacted by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite that:

Section 1. Authority of the City Mayor. The City Mayor, Hon. Strike B. Revilla, is hereby authorized enter into a public-private partnership contract for the "Bacoor City Digitalized Traffic Enforcement" project, subject to bidding or comparative challenge pursuant to Republic Act No. 11966 (the "PPP Code") and its implementing rules and regulations.

Section 2. Bidding and Comparative Challenge. The PBAC is hereby directed to proceed with the process of conducting the bidding and comparative challenge for the proposed Project by issuing an Invitation for Comparative Proposals, within seven (7) calendar days from issuance of the Notice of Approval, pursuant to Section 93 of its IRR.

Section 3. Repeal. All ordinances, resolutions, and executive orders inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 4. Effectivity. This Ordinance shall become effective immediately after it has been published at least once in a newspaper of general circulation in the City of Bacoor, Cavite.

RECOMMENDATION:

After very careful and precise review and deliberation by the Committee, it is recommended to **APPROVE** the proposed ordinance recommended by the Joint Committee.
