Subject: **"AN ORDINANCE MANDATING THE ESTABLISHMENT OF A SANGGUNIANG KABATAAN DATABASE IN THE CITY OF BACOR AND REGULATING THE ISSUANCE, RENEWAL, AND USE OF KATIPUNAN NG KABATAAN IDENTIFICATIONS CARDS IN THE CITY OF GOVERNMENT". (PCO 2025-244 dated March 3 , 2025)**

Referred into this committee on 130th Regular Session is the above subject matter for appropriate action and recommendation.

FINDINGS:

- Republic Act No. 8044 establishes the recognition of the youth's critical role in nation-building and the promotion of their welfare by imparting patriotism, nationalism, and other desirable values as a state policy.
- Republic Act No. 10160 or the Charter of the City of Bacoor provides under Section 11 that the Sangguniang Panlungsod has the power to enact ordinances, approve resolutions, and appropriate funds for the general welfare of the City and its inhabitants including the youths pursuant to Section 16 of the Local Government Code of 1991.
- Various youth groups have emerged in different communities and barangays of the City of Bacoor, which can be involved, centralized, or collaborate with the Sangguniang Kabataan (SK) and eventually benefit from government programs and projects.
- Sangguniang Kabataan Reform Act of 2015 (RA No. 10742), the local SK is mandated to formulate a comprehensive barangay youth development plan which shall be the basis of the annual barangay youth investment program.
- Republic Act 10742, the Pederasyon ng Sangguniang Kabataan and the Local Youth Development Council (LYDC) shall convene quarterly to ensure the implementation of the Local Youth Development Plan (LYDP) and alignment of Comprehensive Barangay Youth Development Program and Annual Barangay Youth Investment Program to the LYDP.





- It shall be the policy of the City Government of Bacoor to recognize the vital role of the youth in nation-building and to promote and protect their overall well-being. In relation to this, it is recognized that establishing a uniform system for the issuance and regulation of KK-IDs to prevent misuse and ensure these are solely used for legitimate purposes. The system shall enable the smooth delivery of programs and services intended for registered youths.
- The following terms used in this ordinance as follows:
 - a. Bacoor City Sangguniang Kabataan Database – a database containing all relevant and sensitive personal information of all qualified and enrolled Katipunan ng Kabataan members residing within the City of Bacoor or those who shall be issued a Bacoor City Katipunan ng Kabataan Identification Card.
 - b. Katipunan ng Kabataan ID – is an identification card issued by the SK Bacoor for its KK member.
 - c. Issuance of Katipunan ID – the release of Katipunan ng Kabataan ID after the youth applicant has complied with the various requirements for the issuance of the said proof of identity. The issuance of the said ID signifies that the holder of the same is entitled to the various privileges granted to SK members various laws and City Ordinances.
 - d. The renewal of the privilege of using a validity issued KATIPUNAN NG KABATAAN ID by the local government of the City of Bacoor. The renewal of the said ID signifies that the holder of the same is still entitled to the various privileges granted to SK members by various laws and City Ordinances.
 - e. Youth and KK members shall refer to those persons whose ages from fifteen (15) to thirty (30).
 - f. Youth Organization shall refer to those organizations whose membership or composition is youth.
- The City of Bacoor Sangguniang Kabataan Database is established, shall contain the following information gathered from the youth registrant:
 1. Full Name;
 2. Date of Birth;
 3. Place of Birth;
 4. Sex/Gender;
 5. Nationality;
 6. Residential Address;
 7. Contact Information (email/telephone/mobile)
 8. Name of Parents;
 9. Educational Background;
 10. Emergency Control Person;
 11. Position in SK, if any;
 12. Membership in any Youth Organizations;





13. Others as may required in the Implementing Rules and Regulations

- All qualified youths aged 15 to 30, residing in the City of Bacoor are encouraged to enroll themselves in the Bacoor City Sangguniang Kabataan Database in their respective barangays. The Local Youth Development Office (LYDO) may designate its personnel to the barangay to assist in the enrollment in the database. This database will serve as a various data, information, and knowledge on the SK members, as generated by the Sangguniang Barangay in each barangay.
- A Katipunan ng Kabataan ID shall valid for two (2) years and shall be issued either free of charge or with a fee of not more than One Hundred Pesos (100.00).
- All qualified and enrolled KK members to the Bacoor City KK Database and were issued KK ID may enjoy privileges from the City of Government of Bacoor.
 1. Financial Assistance
 2. Medical Assistance
 3. Educational Assistance
 4. Access to livelihood opportunities or skills training.
 5. Such other grants, benefits, privileges, aid, or assistance as may determined by the City Mayor.
 6. Other programs and projects in partnership with private organization.
- The Collection and processing of personal and sensitive personal information directly from youths as data subjects shall adhere to the provisions and principles of Republic Act No. 10173 or the Data Privacy Act of 2012.
- The Sangguniang Kabataan Federation-Bacoor shall allocate the necessary budget to support the implementation of this ordinance.

Recommendations:

Wherefore, the committee respectfully recommends for the Approval of "AN ORDINANCE MANDATING THE ESTABLISHMENT OF A SANGGUNIANG KABATAAN DATABASE IN THE CITY OF BACOR AND REGULATING THE ISSUANCE, RENEWAL, AND USE OF KATIPUNAN NG KABATAAN IDENTIFICATION CARDS IN THE CITY OF BACOR AND FOR OTHER PURPOSES".



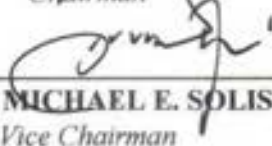

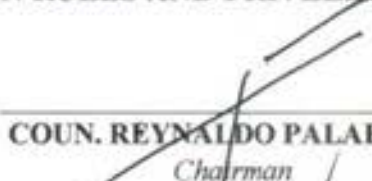

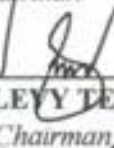

- Hon. Buncio: Magandang umaga po sa ating lahat, mabuhay. I would like to call this hearing on Committee on Youth hearing on an ordinance mandating the establishment of a sangguniang kabataan database in the city of Bacoor and regulating the issuance renewal and the use of Katipunan ng Kabataan identification cards in the city of Bacoor and for other purposes is now call to order. For the record in attendance, from my right po si Councilor Ray Palabrica.
- Hon. Palabrica: Good morning Madam Chair, good morning Honorable SK Chairman, my colleagues in the City Council, good morning mabuhay.
- Hon. Buncio: Councilor Alexander Felizardo Gutierrez.
- Hon. Gutierrez: Magandang tanghali po sa ating lahat, mabuhay.
- Hon. Buncio: Councilor Bok Nolasco.
- Hon. Nolasco: Thank you Madam Chair and good morning po sa lahat ang resource person, good morning.
- Hon. Buncio: From my left po, Councilor Levi Tela.
- Hon. Tela: Good morning Madam Chair, good morning everyone present, especially to all SK Chairman and all present resource person. Thank you po.
- Hon. Buncio: And Councilor Simplicio Dominguez.
- Hon. Dominguez: Magandang magandang umaga po sa ating lahat, mabuhay po tayo.
- Hon. Buncio: Before we begin, pakilala siguro muna natin ang mga kasamin natin ngayong umaga. Ang mga resource person po natin, unahin na po natin yung from our BMIS. Sige sir. Introduce sir.
- Hon. From Madam Chair, with your kind indulgence. We are requesting the resource persons present to introduce themselves and their representation for the record.
- BMIS Good morning, I'm Ferdineil Esguerra of BMIS, Barangay Information Management System. Good morning po.

Hon. Dominguez: Good morning po sa lahat. My name is Andre Dominguez Lopez. SK Chairperson of Barangay Talaba 3.

CSWD: Good morning po, Mr. Chair. Salamat sa lahat po Gina Pornelos po from CSW.

Hon. Buncio: Maraming Salamat po sa inyong pagdalo at pag participate para sa ordinansang ito. Para po sa ordinansa po natin na ito, layunin po ng ordinansa na ito na magkaroon po ng identity ang ating bawat kabataan po sa Lunsod ng Bacoor. Base po dun sa ating, nakatanggap po ba kayo ng ating mga papel po? Ayan po. Nakalagay po dito na ang saguniang kabataan po ang mismong mag-i-issue po neto na kung saan ito po ang coverage na edad po neto ay 15 to 30 years old. Parang ano po siya, yung barangay ID po natin, ihiwalay na po para sa kabataan naman po, yung 15 to 30. Magiging alternative po siya ng barangay ID natin pero magiging tatawagin natin siyang saguniang kabataang identification card. So ang ating participants po dito ay ang ating katipunan ng kabataan, ang ating mga kabataan sa bawat barangay na kung saan sila po ay kukuha sa SK na kung saan ang SK po ang mag-i-issue na po ng kanilang barangay ID o ang kanilang sangguniang kabataan identification card.





Hon. Palabrica:

Thank you Madam Chair. Basically this is an issuance of a identification card for all the citizens under sangguniang kabataan ages 15 to 30 para meron silang sariling card. Although meron tayo SBR card, meron ding ano pero ang nais kasi ng ating alkalde ay magkaroon ng sariling identification card for us to easily identify those persons or individuals in Bacoor under sangguniang kabataan. So the proposal is the responsibility of issuance of this ID is for the SK, sangguniang kabataan. Sa inyo, sa inyo ibigay ang responsibility. Siguro Madam Chair kung mapapaliwanag natin paano ang mechanics ng issuance and also the collection of all the data. Pag ganito kasi mga IDs marami tayo iniingat, ang tinatawag na data privacy. Bukod doon magkakaroon kayo ng collection, may bayad ba to? If there's a fee for the issuance of this ID I suggest Madam Chair that the fee shall be uniform. Hindi yung iba-iba, halimbawa magkatabing baranggay, Queenstown East 50 tapos huwag natin sa Central 100. Hindi maganda yun. Siguro mas maganda ay pare-parehas. And also to observe data privacy, the BMIS was stopped by the City Mayor, Honorable Mayor Strike Mayor B. Revilla, to manage and safekeep the data out from this data ID issuance by the SKs. So kaya nandito ang BMIS. So lahat ng data natin mapupunta sa BMIS being the Department of the City Government in charge and responsible for data gathering, data safekeeping of all residents and other matters under baranggay and SKs. So basically yun ang natin. Pinatawag tayo ng SK Federation President kung baka may opinion tayo, may suggestion tayo or maybe question para ma-discuss natin during this hearing. Para before we finally approve the ordinance in a regular session about the City Council ay mapolish na natin or ibig sabihin wala nang mali. Perfectly crafted na yung ordinance. First question siguro Madam Chair, mayroon bang nag-o-object na mag-issue kayo ng KKID na tinatawag, Katipunan ng Kabataan ID? Is there anybody who is in the possession of objection regarding this proposal? Wala. Wala. So your silence means yes, okay kayong lahat. Okay kayong lahat. Mag-issue tayo ID. Okay sa inyo lahat. So mag-issue tayo ng ID. The system is in place through BMIS. So yung mechanics na lang Madam Chair kung paano.

Hon. Buncio:

So check po natin yung pasuyo na lang po ng Section 4 natin. So yun po yung mga nilalaman po ng ating Sangguniang Kabataan database. Sa BMIS Sir Neil may-in-add lang kami ng onting details lang po yung sa mga youth organization para na-identify natin if kasali po yung youth natin sa youth organization po. So yun din po yung syempre po yung mga data nila na importante. Full name, date of birth, place of birth, yung gender nila, nationality, resident address, contact information of parents, educational background, emergency contact person, position in SK kung siya ay sangguni ang Kabataan if any or position po sa youth organization po kung siya po ay part ng organization. Tapos po voters sa this station status kaya gusto naman namin po na ma-check din po ng ating Mayor





- kung sila po ay mga voters na po para ma-check din natin yung mga Kabataan na botante na rin po sa lunsod ng Bacoor.
- So the particular provision under section 4 mentioned by honorable SK Federation President. Yan yung mga data na ilalagay sa ID. Any comment regarding this? Baka may gusto kayo patanggal o may gusto kayong idagdag? Wala din?
- Hon. Nolasco: Madam Chair, Siguro ay finalize din natin itong section 9 sa IDPs. And letter A, an amount of not more than 100 pesos shall be charged to the applicants of the SK ID. Be an amount of not more than blank shall be charged for the renewal of SK ID and letter C, in case of loss or damage of the SK ID, a replacement fee of the same amount shall be charged to the applicant KK member. So siguro po tama yung sinabi ni Konsehal Palabrika na nasa standard yung payment para hindi nagkakakwan yung sa kabilang baranggay, ibang amount sa ibang baranggay para nasa level. Thank you Madam Chair.
- Hon. Buncio: Thank you po, Councillor Bok Nolasco. So later on po i-check din natin yung sa ating Section 9 dahil medyo ano yung implementation natin dito, kailangan natin pag-isipan ng maigai dahil tayo po yung magbabayad o magbabayad po yung ating mga Kabataan. So before tayo magproceed po sa Section 9, i-scroll muna natin yung ating Section 5 na kung saan, nakalagay po doon ang qualified po dito sa Youth ID natin is 15 to 30 years old. Okay po, yung sakop po mismo ng sangguniang Kabataan.
- Hon. Palabrica: Madam Chair, there will be questions from ages 18 to 30 sa sabihin nila, kukuha na lang kami baranggay ID, hindi na kami kukuha ng KK ID. Ano ang opinion natin tungkol dito? Siguro tanungin natin ang mga resource persons natin, the SK Chairman para malaman natin kung papahan natin ni-address. Pwede ba yun? Maari may tanong na ganun eh. The baranggay is already issuing IDs for their residents but limited to ages 18 to 30. But on this part, on this proposed KK ID, ages 15 to 30 are covered. So may parang may overlap doon sa ages 18 to 30. So sa tingin ba ninyo magkakaproblema ang issuance ng KK ID? Any opinion from the resource persons present? Kasi siyempre kami may nasa isip kami, kami mga konsihal. Pero it is more appropriate or it is more helpful kung may opinion galing sa inyo kasi kayo mismo yung nasa grounds. Meron ba tayo ma-encounter na problema, na issue tungkol diyan? Wala din? The SK Kagawad of Molino 6, you're recognized by the Chair.
- SK Kagawad: Good morning, City Councilors. Regarding dito, gusto ko na saan na mag-jump kasi tinatanong din po if the 18 to 30 years old is kukuha pa rin sila ng SK ID na which is 15 to 30 years old. So sa akin po kasi, gusto ko na po saan na mag-jump into ano yung mga example of grants, benefits, and privileges. Kasi lalo na kung yun nga parang mamimili sila, mas pipiliin nila yung barangay ID which is ito yung mas na-acknowledge lalo na pag ginamit natin siya. So ano po yung purpose, yung pinaka-purpose ng SK card kung ano yung mga, saan pwede siyang magamit po?





Hon. Palabrica

The very purpose of this KK ID is to identify the person that he or she belongs to the katipunan ng kabataan on that particular barangay. In your case, barangay Molino 6. So we should highly encourage everyone na pasok doon sa ages 15 to 30 na kumuha pa rin ng KK ID. Kasi there are programs and projects designed for the katipunan ng kabataan. Katulad niyan kayo mismo, SK officials, nagmamamane kayo ng funds. May SK funds kayo, 10% of the NTA goes to your funds. So yung funds na yan ginagawa niyong proyekto at programa yan, proyekto at programan niyo yan. So isang benepisyong na kaagad yun. Na out from SK fund, si person o yung tao na pasok pa doon sa katipunan ng kabataan ages 15 to 30 na may SK ID, qualified siya kung ano man yung programa niyo on your own pa lang, qualified siya kasi nakaregister siya doon sa database natin at mayroon siyang pinapakitang identification na legitimate member siya ng community or ng SK diyan sa lugar na yan. Second, first yun yung benefits ng pag-uusapan. Every ID holder of KK ID are qualified doon sa inyong SK programs. May pera kayo eh. And also sa city government programs designed for the youth, pasok pa rin sila, makikinabang pa rin sila. So the use or the importance of being a holder of KK ID ay importante kasi ini-establish yung legitimacy na ikaw na nasa edad ka ng SK ay pwede kang or included ka dapat sa programa ng mga pangkabataan na programa. Both SK, Barangay, and the city government and even national kung meron man ang provincial.

Hon. Buncio:

Thank you po counselor. Gusto rin po kasi ni Mayor Strike po SKs na di ba Barangay ID, mayroon ng KK ID. So ang 18 to 30 years old, kailangan sa SK na kumuha ng Barangay ID. Nakaseparate na po dapat. Ang Barangay ID po ay SK ID na po. Yun po yung mangyayari po. Gusto po ni Mayor kaya invite din natin ang ating mga kapitan po dito para malaman din po ng ating mga kapitan na ang ating ID 18 to 30 po ay hahawakan na po ng ating sangguniang kabataan. Yun po ang gusto po ni Mayor Strike din po.

Hon Palabrica:

That is the suggestion of our Honorable Mayor na those ages covered by SK, SK ID ang ano. Pero di natin pwedeng ilimit sila doon kasi karapatan din nila na makakuha ng Barangay ID and any other IDs na qualified silang magpossess. But that is a proposal or suggestion from our Honorable Mayor. So ang target kasi diyan for us to register all those persons ages covered by the SK. So yun yung pinakatarget natin. Pero hindi yun magri-restrict na pwede silang kumuha ang 18 to 30 ng Barangay ID. Kasi there are circumstances na halimbawa mag-apply ng trabaho ang i-require is Barangay ID. So kaya hindi natin pwedeng ilimit. Okay?

Siguro Madam Chair, suggestion lang. Siguro dapat ang mga SK President natin ma-inform ang Barangay Captain and Barangay Secretaries. So hindi naman natin kinukuha na huwag silang kumuha ng Barangay ID. Siguro advise lang ng ating mga Secretaries yung mga kumukuha ng ID na kumuha na rin ang ID ng KKID para advise, i-advise ng Secretaries, ng





Barangay Secretaries na kumuha na rin kayo, bilang kayo belong sa 15 to 30. So bakit kawa na rin po kayo ng ID ng SK, ng KKID. So ang buhay natin na sa Secretaries o sa nag-issue ng Barangay ID sa bawat Barangay natin. So kaya inotify na lang po siguro yung ating pong taga-issue sa Barangay na kumuha na rin ng ID ng SK na po. Okay, thank you Madam Chair.

Hon. Buncio: Thank you, Councillor Ray and Councillor Bok Nolasco. Yes po, SK Chairperson from Bayanan.

Hon. Alamo: May tatanong lang po, iba po ba po yung Barangay ID na may nakalagay pong logo ng SK? Kasi sa Barangay Bayanan po ang nire-release namin na ID para sa 15 to 30, yung logo ng Barangay na may kasamang SK logo po?

Hon. May I suggest Madam Chair, tungkol doon sa design ng ID ang sinasabi natin, specifically yung logo. Kung mapapansinin ninyo, there was a directive from the Honorable Mayor Strike Revilla sa mga barangays na ang lahat ng logo uniform. Di ba yung ano na lang, yung pangalan na lang ang naiba, tas uniform na yung logo ng Barangay. And relative to that, mas maganda siguro uniform na rin ang mukha ng ID, tapos of course the logo of the SK should appear in the ID. Baka dahil katipunan ng kabataan ID yan eh. And also, to easily identify kung saang barangay yan, the logo of the barangay should also appear. And I personally suggest Madam Chair, that the logo of the City Government of Bacor be included in the design. And additional suggestion Madam Chair, siguro i-delegate na lang natin sa BMIS to design the ID para hindi makakaiba layout, isang layout lang. Just the same with what happened to the barangay logos, which was designed by BMIS.

BMIS: Neil Good morning Madam Chair, may I suggest din po sana. Let's inform po yung mga barangay halls natin, barangay secretaries, to put po yung privileges and benefits para po yung ating mga kabataan yung maingganyo kumukha. Kasi technically po, as of now, the system we had in Bacor is uniform. Mapapansin nyo po, meron na rin po kaming ininclude na SK Kabataan Identification Card. So may specific designs po siya with different colors. So naka-designate na po yung color coding natin with the barangay. Magkakaroon din po tayo ng implementation ng color coding eventually, properly pag ka na-address na po ng BDR, what sections are we are and what color we are. Kasi magkakaroon po tayo ng color coding indicators kung ano rin po yung mga disasters, preventions para din po dun sa system. So technically po ngayon, lahat po ng IDs natin is uniform, mapapansin po ng SK natin. So lahat naman po na nakainclude dito na provisions to include, nakalagay naman po sa lahat sa system natin. So we could demo rin po at we could check kung ano pa rin po yung mga enhancement na pwede po natin ilagay.

Hon. Buncio: Thank you po sir Neil. So based din po kasi din sa mga nag-issue na rin ng ID, nakita nyo rin po na may logo po ng SK. So gusto po sana din po na ni Mayor Strike na same na lang din po yung ano ID natin para uniform po





- lahat. Ang gagawin na lang po natin, ilagay na lang din po yung logo ng SK. And kung pwede siguro sir Neil na para maging uniform na rin po, para maging barangay ID but parang sangguniang ang kabataan ID din siya, kung okay lang po sana sir, lagyan na lang natin ng identification na ito po ay sangguni ang kabataan ID din sir.
- BMIS. Esguerra: Yes po, actually po Madam Chair ngayon po ganoon na po siya naka-design. Kung maa-ask nyo po yung mga Chairmans po natin, nakalagay na po yung logo ng City of Bacoor plus po yung uniform logo natin ng mga SK. Then may SK po na na nag-indicate na yung card na po yan is from SK. Ito po yung sample.
- Hon. Buncio: This is the proposed ID dito yung SK.
- Hon. Buncio: And ito po sa taas yung SK membership na sir Neil.
- Hon. Palabrica: Okay na pala to. Pwede? Ayos na to. But Madam Chair in response to the suggestion of the BMIS, ilagay daw sa ID yung mga benefits saka siguro ano na lang general term. Holder of this ID is entitled of City Government of Bacoor Programs and Projects for the Youth. Kasi pag inespecify natin isa-isa, marami tayong programa at paiba-iba ang programa. So I suggest that we use the general term, holder of this ID is entitled to all the programs benefits of the City Government of Bacoor. Ganoon lang siguro.
- Hon. Buncio: Thank you po, sir Neil and Consi Ripalabrica. Yes po, from Local Youth Development Office.
- LYDO: Good morning po ulit. I-clear po kasi natin yung pangalang po ng ID kasi po it was mentioned kanina na Sangguniang Kabataan ID. Sangguniang Kabataan po is a governing body. Yung ating pong ordinansa ay Katipunan ng Kabataan. So ang magiging identification niya sa SK is yung logo po. Pero let's call it Katipunan ng Kabataan ID kasi yung din po yung nasa ordinansa para to avoid confusion. And then po yung relative po dun sa sinabi ni sir Neil na ipaalam natin sa kabataan kung ano po yung mga services. This coming April po magkakaroon po ng Katipuna ng Kabataan Assembly ang mga SKs po natin. Siguro pwede po itong maging part ng kanilang agenda or maging part po inna-launch nila sa mga barangay po nila yung bagong Katipunan ng Kabataan ID. Ayun lang po.
- Hon. Palabrica: Kailan ba yung schedule ng KK Assembly?
- LYDO: Depende po konsi sa mga SK po kung anong exact date po nila ico-conduct basta po within the month of April po nila mai-conduct po.
- Hon. Palabrica: Ang challenge lang kasi natin is the process of the ordinance. Kasi katulad niyan kung ngayon taposin natin itong public hearing na to then on Monday we pass the ordinance. It will be submitted to the Sangguniang Panlalawigan for the review and approval. So hindi natin alam kung hanggang kailan nila matatapos and today is 27 so almost April. Baka bumalik sa atin to end of April. But I definitely agree with your suggestion kung hindi naman natin ma-launch during the K-K Day or Assembly, i-inform na natin sila i-announce na natin ito. And then later on saka na lang tayo ng magkaroon ng formal lunching, maybe city-wide launching to be launched by the Mayor.

- Hon. Buncio: Ayun po. Yes po, SK from Ligas po.
- Hon. Profetana: SK Chairperson ng Barangay Ligas 1 po. Question lang po ayun po sa Section 7 po is 2 years po ang validity po ng Katipunang kabataan ID po natin. Siguro po sa 15 to 30 years po, yung 30 years po siguro, pwede po natin gawin na 1 year na lang po yung validity ng ID po nila. Para pag ating po ng 31 years old po nila, is pwede na po sila kumuha ng Barangay ID po. Valid po ba yun pagdating po sa mga benefits po for regarding sa Katipunan ng kabataan?
- Hon. Palabrica: So the concern is the validity of the ID. What do you suggest SK?
- Hon. Profetana: Suggest ko lang po yung 30 years old po is sana gawin na lang po ng 1 year validity na lang po. Baka din po sa 30 years old.
- BMIS Esguerra: Madam Chair, I will answer po yung question. So yung system po natin technically, if you are 31 years old, mag-o-automatic po yun na hindi na po sila makakuha ng KKID. So meron po siyang progression. So lahat po ng ID's natin is may progression. So pag nai-reach niya po yung edad na yun, certain age sa birthday niya, ang makukuha niya na po ng ID is yung Barangay ID na po directly. So any issue once din po ng ID natin, with duplication process, yung isa po pinalitan, once na naprint po ng panibago, nai-invalid na po yung isa.
- Hon. Palabrica: So meaning our system is aging?
- BMIS Esguerra: Yes po.
- Hon. Palabrica: So automatic?
- BMIS Esguerra: Hanggang pag tanda po tulad sa senior, ganoon din po.
- Hon. Palabrica: Okay yun.
- BMIS Esguerra: Yes po. Once po na, halimbawa na create po yung ID 30 years old ako, plus 2 years po, di ba po? So papakita ko po mamaya, pag tinacle na po natin yung section for fake and dito po sa ating section 15 para po sa issuance ng KK ID. Meron po tayo dito ang provisions para sa mga fake. Meron po tayong pang-check para po diyan, ipapakita po namin mamaya. Na once you scan it, kailangan po may valid na lalabas.
- Hon. Palabrica: So okay yun, for the information of everybody, the application ba tawag dito? System.
- BMIS Esguerra: Yes, parang application with system na.
- Hon. Palabrica: Application with system, yun na lang para hindi nakakalito, will be provided by the BMIS to all the Sangguniang Kabataan Council. So wala na kayong problema kung di i-install lang ng BMIS sa inyong mga computer sets, yung system na to na siyang mag-facilitate to produce the ID. So iikutan niyo lang, or dadalin nila dito yung...
- BMIS Esguerra: Ano po?
- Hon. Palabrica: Ah magbibigay ng PC si Mayor. Bakit di magbigay ng PC si Mayor?
- BMIS Esguerra: Yun po yung mas maganda siguro. Different printers para magkaroon tayo ng sectoral approach.
- Hon. Palabrica: That will be provided by the city government or kanya-kanya sila? The budget will come from the office and supplies ng bawat Sangguniang Kabataan Council. Okay.





- Hon. Buncio: So thank you, Sir Neil. Proceed na lang muna sa Section 8, yung Katipunan ng Kabataan ID application. Ito po yung mga requirements po, or documentary requirements na kailangan po ng ating mga KK. Barangay certificate as proof of residency, 2 pieces of 1x1 picture, 1 piece of 2x2 pictures, birth certificate or valid ID. So any suggestion po, if okay na po ito, na ipapasa po ng ating mga KK po?
- Hon. Palabrica: Papano kung Madam Chair, in behalf of the resource persons present or the SK officials in particular. Papano kung 15 years old ako, kukuha ko ng KK ID, tapos wala naman akong valid ID, hindi ako nag-aaral, wala akong school ID. Tapos hiwalay ang nanay at tatay ko, hindi ko alam ko nasa ng birth certificate ko. How can I acquire the ID? How can I comply with the requirement?
- Hon. Buncio: Pwede siguro Konsi yung HOA sir, yung proof of residency sa HOA po.
BMIS: Mr. Chair, I would like to suggest po, let's provide din po dito sa section natin additional confirmation from the barangays. Kasi po yung barangay officials natin and the barangay chairmans, nag-issue naman po sila ng fact of birth. So that's one factor na nag-indicate kung ano yung identity ng tao. So kasi dito po sa provisions parang LYDO na SK Federation lang po yung, dapat lagay po natin yung ating mga barangays para po makatulong sa identification ng mga residents.
- Hon. Palabrica: So what is being suggested is the applicant, the ID applicant must secure barangay certification?
- BMIS: Yes po. Since nag-issue po tayo ng residency and required.
- Hon. Palabrica: The proposed ordinance that we are provided today is only a draft. So pwede natin dagdagan yan, pwede natin bawasan. So maganda yung question na yun kasi nga, papano kung wala talaga maproduce. Hindi rin alam kung nabinyagan siya o hindi, hindi siya makakuha ng baptismal certificate. So the remedy is a barangay certification issued by the barangay.
- Hon. Buncio: Thank you po Sir Neil and Konsi Rey. Any other suggestion or clarification sa ating Section 8? So hearing none, let's proceed po sa Section 9 natin yung ID fees. As mentioned po by our City Councilor Bok Nolasco, with regards po sa ating Section 9, ID fees. So dito na po papasok yung ating fee with regards sa ID. So suggestion po ng ating Councilor Ray Palabrica kung pwede daw po na uniform po yung ating paniningil para po wala din pong silipan po sa bawat barangay. So any suggestions po siguro with regards this sa pag-process po ng paniningil po natin?
- Hon. Palabrica: First maybe Madam Chair, first we talk about the amount, how much. The amount should come from the resource person kung magkano. Magkano ba yun sa barangay? Ipantay na lang siguro.
- Resource Person: 100.
- Hon. Palabrica: Magkano ba sa barangay ninyo?
- Resource Person: 100 po.





- Hon. Palabrica: 100 lahat? Naku po 100, parang mabigat sa isang bata yun. Siguro pag SKID as suggested by LYDO Chief half of the barangay fee, halimbawa 100 sa barangay, 50 na lang KK ID. Do you agree?
- Hon. Buncio: Agree po ba tayo doon na half po sa SK?
- Hon. Palabrica: Ganito na lang para malaman natin kung agree or disagree. Doon sa mga disagree na 50 pesos lang pakitaas ang kamay. So ibig sabihin, agree lahat. Kasi ang tanong natin kung sino nag-disagree. So agree lahat na 50 pesos. Maybe we can, Madam Chair, para mapagtibay yung 50 pesos, during the SK Federation meeting, you passed a resolution identifying the amount of the KK ID to be issued by each Sangguniang Kabataan Council na 50 pesos. Para may papel yun na may basihan kung bakit 50 pesos. Siguro makaroon kayo ng SK Federation resolution.
- Hon. Buncio: This is noted po, Councilor Ray Palabrica.
- Hon. Palabrica: Siguro ganito, may mga baranggay na free. Katulad ng Molino 4. Lahat doon libre. Lahat libre doon eh. Pwede naman. Pwede naman but siguro ilalagay natin sa ordinance, hindi mag-exceed sa 50 pesos. Pwede ibababa. Pwede yung libre. Pwede yung palit kalakal. Basta hindi lalagpas sa 50 pesos. But I strongly suggest, dapat uniform. Kasi magkakasilipan ang magkatabing baranggay.
- BMIS Esguerra: Madam Chair, may I add po sana sa provisions? Yes, Sir Neil. Pwede po bang i-include natin yung mga anak ng mga 4Ps beneficiaries? Kasi tingin ko po hindi rin nila ma-avail yung 50 pesos. Kawawa naman po yung mga bata na mga indigent po natin.
- Hon. Palabrica: Siguro ganito. Tama rin ang ni-raise na issue ni Mr. Neil. If the applicant possesses a certificate of indigency from the punong baranggay, pwede niyong i-libre o i-discount?
- Hon. Buncio: Agree po ba yung mga SK po? If indigent po yung mga kukuha po, okay po sa inyo na free po of charge po sila?
- Resource Perons: Yes
- Hon. Buncio: Yes daw po. Sige po. Ilagay po natin sa provisions.
- Hon. Palabrica: But there's an issue or a question. Ang SK Treasurers ba natin, ang SK Council natin, kayo ba may resibo? Wala kayong OR, di ba? Government entity kayo. When you collect fees, all government offices entities are required to issue official receipt. Yun ang isang difficulty natin dito. Kailangan natin ma-resolve. Pero sa papel lang to ah, kasi pwede naman niya na off the record na lang. Dami naman kumukuha ng baranggay clearance sa baranggay, hindi naman ni-issuehan ng OR. Or, eto kasi ang option na pwede ko sabihin sa inyo, pweding idaan sa baranggay. Magkakaroon ng isang baranggay resolution and an SK resolution na mag-issue kayo ng ID, ang mga o-collecta ng fee ay ang baranggay treasurer. Tapos ang na-collecta niyang amount ay ire-remit sa SK Fund, monthly. Parang pag-irimit din ang nata-share ninyo monthly, isasabay na doon. Pweding ganun. Pweding ganun. Or iri-research lang namin kasi we are not yet sure kung pwedeng bigyan ng power o ng authority by Sangguniang panlungsod ang SK Council para mangolekta at mag-issue





- ng OR. Or makakuha ng OR. Pero parang remote yun. Kasi wala kayong collecting power. Hindi ko lang alam kung kayang remediuhan ng isang local legislation. Pero ang most probable at practical ay yung bibigyan ng magkakaroon ng resolution, siguro joint resolution, baranggay resolution, or kahit baranggay resolution na lang. Na ang baranggay treasurer ang authorized mangolekta ng fees doon sa ID sa bayad pero subject to be remitted religiously papunta doon sa SK Funds kasi sa SK yun. Yun ang possible remedy. Nandito pala si Atty. De Leon. Baka may insight ka diyan. Bigyan mo naman kami papano ba?
- Atty. De Leon: Your Honor, pwede pong ano. Ang payment po ay na sa City Government. City Government po mag-issue ng OR. Tapos mayroon pong yung ginagawa po natin sa ibang ordinance may special trust account. Hindi ang po trust fund pero trust account na dun po mapupunta. Isang option po yun. Isa pang option kung gusto ng OR, is idadaan po sa baranggay na nakakapag-issue ng OR. Tapos si baranggay ang mayroon special trust account. Diretso naman sa SK na pwedeng ma-access po ng SK. Hindi na po siya papasok sa general fund nung baranggay para po hindi mag-comingle doon sa general fund. So pwede naman po yun. Mag-establish lang po ng hiwalay na trust account para lang po doon sa mga IDs.
- Hon. Palabrica: Siguro dalawa ang pwede ilagay na sa ordinance. Pwede yung trust account. Kaya ang problema lang kasi dito, to be realistic, may mga politikahan sa baranggay eh. Minsan magkalaban ang Kapitan sa SK Chairman eh. Yung doon sa magkakampe, walang problema. Doon sa mga baranggay na may problema. Kaya talagang ilalagay natin sa ordinance sa para lahat magkalaban o hindi ay sumunod o obligado silang yun ang sundin, kung di there will be violation. So ang suggestion mo is to create a trust account.
- Atty. De Leon: Yes, Your Honor.
- Hon Palabrica: Kaya lang maliliit lang naman to. Magkano-mangkano lang to. Malaking trabaho pa to sa baranggay treasurer. Kasi siyempre ano eh, hindi naman to miliyunan. Baka hindi pa nga ito umabot sa P10,000 eh. Lalo na sa maliliit na baranggay, although na-merge na, maliliit pa din parang matrabaho masyado sa baranggay treasurer. Whereas kung magkakaroon lang ng i-require natin sa ordinance na properly accounted ng treasurer, yung mga issuances na yun, tapos subject for remittance nila doon sa or transfer ng pondo, isabay na para isang cheque lang.
- Atty De Leon: Your Honor, basta po magkaroon tayo ng clause po dito sa ating ordinance na subject to proper government accounting, tapos sa IRR na lang po natin ilagay yung details sa kung paano ma-transfer po yung mga amounts na yun kung kailangan pang i-deposit sa bank or pwede nang i-transfer cash. Kasi usually cash naman po lahat po, wala naman po siguradong dito ng credit. So pwede po natin ayusin sa IRR yun. Depende sa needs at kung ano ang circumstances na ma-encounter natin po after mapasa po yung ordinance.





- Hon. Buncio: Thank you, Atty. De Leon. So sa IRR natin ilagay yung magiging collection po kung paano yung magiging process po or manner ng ating collection po. So next po yung section 10 natin renewal of KKID. So based din po sa ating draft ordinance. Ayun po 30 days prior to expiration of current ID. So maganda po yung system natin sa BMIS kasi nadidetected naman na po natin. So hindi tayo magkakaproblema dito. So let's proceed to the section 11, the assistance of the Barangay Management and Information System. So sila po yung katawang natin with regards to issuance of this ID and of course the maintenance of records and KK database. Ayun. So yes po. Same amount na lang din. So eto po yung use of KKID. So sa section 30 natin, nabanggit natin kanina.
- Atty. De Leon: Your Honor, may concern lang po sa section 12. Doon po kasi sa mga data sets na i-enroll po doon sa database. Your Honor, sa section 12 po kasi, apat lang po na data set ang ilalagay sa database. Pero yun po nasa section 4, labing-apat po yung information. So baka po magkaroon ng issue as to ano po ang mangyayari doon sa 10 po na hindi kasama sa database? Baka magka issue lang po tayo sa data privacy as to proportionality nung hinihingi nating data. Kung apat lang naman po pala ang ilalagay natin sa database. Pero ang ire-require natin sa forms ay 14. So ang suggestion po is kung ano po yung nakalalagay sa section 4, siguro po dapat yun din ang nasa section 12.
- Hon. Palabrica: Dapat harmonize siya.
- Hon. Buncio: Ayun po. Thank you for the suggestion, Atty. De Leon. So based po din sa suggestion atty, section 4 and yung section 12 natin na data po must be same para maging maayos po yung ano natin sa pag-release.
- Hon. Palabrica: I suggest, Madam Chair, that the suggestion of our legal office representative be noted, and the issue be addressed during our deliberation in a regular session.
- BMIS Esguerra: Madam Chair may I answer po. Bali under section 4 po is the data that will be saved doon sa system natin. In section 12, that will be displayed on the ID. So that's the correct permissions.
- Hon. Buncio: Displayed na po sa ID.
- BMIS Esguerra: This will be displayed atty for the ID po.
- Atty. De Leon: Yes po. Kaya lang your honor ang wording po kasi ng section 12 ay the said database shall contain a record of all enrolled KK members with ID numbers issued and with the following data sets. Wala po siyang, hindi po nakaankla yung provision sa section 4. So kung exclusively data set po ang pinag-uusapan natin, itong apat lang po talaga yun.
- Hon. Palabrica: Siguro i-rephrase na lang natin.
- Atty. De Leon: Opo i-rephrase na lang natin.
- Hon. Palabrica: Ang gagawin natin doon sa section 12 ba yan? Yung kukunin ng database natin, i-rephrase natin doon sa section 4 na mga data na kinuha natin doon sa applicant, yung strictly, gamitan natin ng term na strictly na yung 4 out of 16 or 14 or whatever kung anong number yun, should be stored by the BMIS in our database. Para walang conflict.





- BMIS Esguerra: Nagkaroon po kasi ng confusion doon sa ID numbers issued. So the ID number issued is equals to the set of information based doon sa database.
- Hon. Buncio: So palitan na lang po natin yung wordings natin na displayed po.
- Hon. Palabrica: I-re-replace na lang natin.
- Hon. Buncio: Kung kaya din natin sir Neil na ilagay na lang din po siguro yung mismong itsura ng ID sa ating ordinance para makita po. Thank you Atty.De Leon. So pinapagusapan natin kanina yung sa section 14 po yung Grants Benefits and Privileges. So based din po doon sa as per ang rin ng ating mayor, isa rin itong ID na isa sa magiging way para mabigyan din ng assistance, para mas mabilis din po yung assistance natin lalo na sa mga kabataan. So first is yung financial aid natin, medical aid, educational aid, access to livelihood opportunities or skills training such as other grants privileges or assistance as may be determined by the city mayor by the implementing rules and regulations of this ordinance. Other programs and projects in partnership with private organization or institution. So ito po ay base po sa city na magiging programa po. Sa SK po, may suggestion po ba kayo na pwede natin ilagay din sa Grants Benefits and Privileges naman po? With regards naman po na pwede na maging benefit po sa ating sangguniang kabataan.
- Hon. Palabrica: General term na lang siguro Madam Chair. Kasi nga ang paiba-iba yung program So ang general term na lang na siguro na idagdag natin diyan na ang ID holder diyan ay entitled na makasama doon sa mga projects, programs, benefits na pwedeng ibigay ng SK Council.
- Hon. Buncio: So based po sa suggestion po ng ating City Councilor Ray Palabrica and general idea na lang po ng entitled projects and programs and benefits po para sa ating mga kabataan. So isa din po ito sa, ipapaliwanag din po natin sa kanila. Okay? Para maengganyo din po sila na kumuha ng ID. So syempre sa Section 15 natin issuance of fake ID. So nakalagay din po ang penalized natin diyan sa Article 172. Ofcourse yung based din sa pinagusapan natin yung sa data privacy as mentioned by Council Ray Palabrica yung data privacy na Section 16. And yun, of course the budget sa ating Section 17 ay aallocatan ng ating sangguniang kabataan federation to support po ng implementation ng ating ordinance. Section 18 implementing rules and regulations. So doon na natin ipapasok yung magiging manner or procedure po ng ating ordinance. And ayun po syempre, ordinance sa ito. So asahan po natin or asa inasahan din po ng ating alkalde na lahat po ng SK kaya po ba at gagampanan po ba ang pag-iissue po ng card po na ito?
- Hon. Palabrica: Madam Chair, by virtue of the ordinance, all the SK Council are required to comply with this ordinance or else ganito ang kaharapin ng ano eh, kahit naman sa barangay, kahit sa inyo sa SK. Kapag may viniolate kayong ordinance, so subject kayo for action, appropriate action. So halimbawa, hindi kayo nag-comply dyan, ang mangyayari, marirreport kayo sa City Government. Si City Government naman, si Mayor re-endorse siya dito sa Sanggunian for investigation. If ever may violation

Maybe the most appropriate statement is maraming salamat po sa pagtutulungan natin.

Hon. Buncio: Thank you po, Councillor Rey Palabrica. So we are obliged po to comply po sa ating ordinance. So we would like to adjourn na po ng ating meeting. So Konsi Alex Felizardo Gutierrez.

Hon. Gutierrez: Madam Chair, since there's no other matters and special concern to be discussed, I move for the adjournment of this hearing. So I move.

Hon. Palabrica: Madam Chair, before we act on the motion of Honorable Gutierrez, Siguro gusto lang natin iparating sa lahat ng resource person, specially SK officials, na kung meron kayong iba pang opinion or suggestion regarding this proposed ordinance, iparating ninyo sa amin bago mag-session, para mahabol pa natin ang iba ninyong concern. Maybe hindi pa nagsisink-in sa ating mga provision na nabasa ninyo. Baka later on may mapuna kayo at gusto ninyo sabihin, you are free to express your opinion and suggestion dito sa ating City Council kasi very consultative ang City Council. Kaya kagad ipagbagay, alam nyo lang sa amin. Yun lang, Madam Chair. And I second to the motion of Honorable Gutierrez.

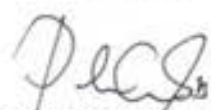
