Subject: AN ORDINANCE AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE PETITION FOR THE EXPROPRIATION OF A PARCEL OF LAND SITUATED IN BARANGAY MOLINO 2, BACOOR CITY, CAVITE, FOR AND ON BEHALF OF THE CITY GOVERNMENT INTENDED TO BE USED FOR THE DEVELOPMENT AND CONSTRUCTION OF AN IN-CITY RESETTLEMENT AND RELOCATION SITE AND TOWNSHIP DEVELOPMENT PROJECT FOR THE BENEFIT OF INFORMAL SETTLER FAMILIES AND ECONOMICALLY CHALLENGED FAMILIES IN THE CITY OF BACOOR, CAVITE. Acting on the proposed ordinance filed during the 138th Regular Session on 28 April 2025, the Committee on Housing, Land Utilization, and Urban Development, chaired by Hon. Alde Joselito F. Pagulayan reports the following:

Section 19 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers local government units, through their chief executive and acting under an ordinance, to exercise the power of eminent domain for public used, upon payment of just compensation.

FINDINGS:

- 1. The City Government of Bacoor has identified a suitable site in Barangay Molino 2 as the most viable location for the construction of an in-city resettlement and relocation site and township development project for informal settler families (ISFs) and economically challenged families residing in danger zones, coastal communities, and areas affected by government infrastructure projects.
- 2. In full compliance with the 1987 Constitution and relevant laws and regulations, the City Government issued a formal notice and made an offer to purchase the subject property from the registered owner.
- Despite repeated offers, the property owner has not responded. Given the urgent need for an adequate relocation site, the City Government now seeks to acquire the property through expropriation.

4. Pursuant to Section 19 of the Local Government Code, expropriation proceedings may only commence upon the passage of an ordinance expressly authorizing the City Mayor to do so.

RECOMMENDATION:

Upon due evaluation, the Committee recommends the APPROVAL of the proposed ordinance authorizing the City Mayor, to sign the petition for the expropriation of the subject parcel of land located in Barangay Molino 2. The property shall be used for the establishment, development, and construction of an in-city resettlement and relocation site and township development project for the benefit of ISFs and economically disadvantaged residents of the City of Bacoor.
