Subject: *A resolution adopting the revised Internal Rules of Procedures of the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite for 2025-2028.*

(Date referred: June 30, 2025)

The above-mentioned proposed resolution underwent its first reading on June 30, 2025 during the Inaugural Session of the 6th Sangguniang Panlungsod. The said proposed resolution was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

FINDINGS:

The goal of the Sanggunian is to enact resolutions and ordinances that will respond to the needs and aspirations of the people of the City of Bacoor based on laws and established rules and procedures, that will govern its conduct and performance of its roles and functions. The Sanggunian shall adopt a gender fair language in all its proceedings and shall endeavor, as far as practicable, to translate the resolutions or ordinances it passes into Filipino and to institute changes in its procedures and processes that conforms with the provisions of Republic Act No. 9485 also known as the "Anti-Red Tape Act of 2007" as amended by Republic Act No. 11032 also known as the "Ease of Doing Business and Efficient Government Services Delivery Act of 2028"

The Sanggunian shall use technological advances made possible by the internet in gauging the sentiments and ideas of the people by Bacoor on all pending local legislation but also enable it to function as a collegial body even during a major crisis that make meeting in person unsafe or inconvenient.

The Sanggunian shall also vigorously preserve its independence, pursue a policy of transparency, and perform its functions in ways that will bring about positive social transformation.

To comply with the various amendments to the Anti-Red Tape Act of 2007 brought about by R.A. 11032, there is a need to make the concomitant revisions to the Internal Rules and Procedures of the Sangguniang Panlungsod.

Under Section 12 of the Republic Act No. 10160 or the "Charter of the City of Bacoor", the Sangguniang Panlungsod has the power to adopt its own rules of procedures on the first regular session following the election of its members and within ninety (90) days thereafter.


RECOMMENDATION:


