Subject: *A resolution approving the composition and reorganization of the standing committee of the Sangguniang Panlungsod of the City of Bacoor from July 2025 to June 2028.*

The above-mentioned proposed resolution underwent its first reading on June 30, 2025 during the Inaugural Session of the 6th Sangguniang Panlungsod. The said proposed resolution was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

FINDINGS:

Pursuant to Republic Act No. 7160 also known as the "Local Government Code of 1991" mandates the Sangguniang Panlungsod to approve its internal rules and procedures and the composition of standing committee within (90) ninety days after its initial regular session.

After due deliberation on the duties and functions of the various standing committees and their reorganization as provided under Rule VI of the Internal Rules of Procedures of the Sangguniang Panlungsod, the composition and reorganization of the various Standing Committee have been voted upon by the members of the Sangguniang Panlungsod.

The Sangguniang Panlungsod in its initial regular session approved the revised list of 27 standing committee of the Sangguniang Panlungsod of the City of Bacoor and its composition under its 2019 Internal Rules of Procedures.
