

Subject: COMPLAINT FROM ATTY. MERLINDA B. SUALIBIOS, MD. AGAINST PUNONG BARANGAY ARMANDO D. OBLIGACION OF BARANGAY QUEENS ROW CENTRAL REGARDING TO THE INACTION OF THE LATTER ON THE REQUEST OF NGG PROPERTIES, INC. (PCR 007-2025 dated 07 July 2025).

This report pertains to the administrative complaint of Atty. Merlinda B. Samuel-Sualibios against Hon. Armando D. Obligacion, Jr., Barangay Chairman of Queen's Row Central, Bacoor City, Cavite.

The said complaint was referred to this Committee by the Presiding Officer, Hon. Rowena B. Mendiola, during the 1st Regular Session of the 6th Sangguniang Panlungsod on July 07, 2025.

Acting on the referral, a committee hearing was conducted on July 31, 2025 at the Session Hall of the Sangguniang Panlungsod relative to the above-stated subject matter. The hearing was presided over by Hon, Miguel N. Bautista, Chairperson of the Committee on Ethics, Appointments and Government Reorganization.

The hearing was attended by the members of the joint committee as well as the resource person. Attached as an integral part of this report is the Attendance Sheet of the said hearing.

FINDINGS:

Upon extensive consultation and discussion, the Committee reports the following:

- On April 07, 2025, the Office of the City Legal Services received a letter by way of electronic mail from the Anti-Red Tape Authority (ARTA):
- The complaint pertains to the alleged inaction of the Punong Barangay Armando D. Obligacion, Jr. over the request of Atty. Sualibios on behalf of NGG Properties Inc., to wit;

- a.) To refrain from issuing any Barangay Business Permits/s, Clearance for any establishment/s within the subject lots, without any contract or written consent from NPI;
- b.) in case Barangay Business Permit/s were already issued to any establishment/s within the subject lots, that we be furnished with the names of the owners thereof, their addresses and the documents presented to your office which lead to the issuance of Barangay Business Permit/s; and
- c.) for assistance from your office to conduct an inspection to enable us to identify the names and addresses of the owners of the establishments within the subject lots.
- Section 61 of the Local Government Code provides that administrative complaints against elected Barangay Officials are under the jurisdiction of the Sangguniang Panlungsod;
- On July 22, 2025, a letter was sent to Punong Barangay Obligacion informing him that an administrative complaint was filed against him by Atty. Sualibios;
- Punong Barangay Obligacion was directed by the committee to submit to the Sangguniang Panlungsod Secretariat a duly-notarized counter-affidavit not later than five (5) working days from receipt hereof;
- Punong Barangay Obligacion complied with the directive and the said counteraffidavit was received by the Sangguniang Panlungsod Secretariat on July 30, 2025. PB Obligacion denied the said allegations through his counter-affidavit, to wit:
 - a.) Barangay Queen's row Central is not authorized to issue Barangay Business Permit/s for any establishment/s within the subject lots owned by the client of Atty. Sualibios;
 - b.) Atty. Sualibio's request that her firm be furnished with the names of the owners of the establishment/s within the subject lots, their addresses and the documents presented to the Barangay is a mere violation of the Data Privacy Act of 2012 (Republic Act no. 10173) and contradicts the instructions of the National Privacy Commission (NPC) and the Department of the Interior and Local Government (DILG);
 - c.) Barangay Queen's Row Central is not authorized to inspect the said establishment/s if the purpose is to find out the names and identities of the owners as what is stated in the letter of Atty. Sualibios, especially if there is no existing court order.

A joint committee hearing was held on July 31, 2025 at the Sangguniang Panlungsod Session Hall regarding the above-mentioned subject matter with the following attendees. (See attached attendance sheet)

Committee Chairperson Councilor Miguel Bautista lead the prayer, gave his opening remarks and acknowledged the presence of all the members of the committee and the resource person as well.

The committee recognized the presence of the respondent in the person of Punong Barangay Armando D. Obligacion of Barangay Queen's Row Central. The Committee Chairperson explained to PB Obligacion regarding the administrative complaint filed against him by Atty. Merlinda S. Sualibios that pertains to his alleged inaction over the request of the latter on behalf of NGG Properties, Inc. (NPI), to wit:

- a.) To refrain from issuing any Barangay Business Permits/s, Clearance for any establishment/s within the subject lots, without any contract or written consent from NPI;
- b.) in case Barangay Business Permit/s were already issued to any establishment/s within the subject lots, that we be furnished with the names of the owners thereof, their addresses and the documents presented to your office which lead to the issuance of Barangay Business Permit/s; and
- c.) for assistance from your office to conduct an inspection to enable us to identify the names and addresses of the owners of the establishments within the subject lots.

Considering the aforementioned facts, Committee Chair Coun. Miguel Bautista sent a letter to PB Obligacion directing him to submit a duly-notarized counter-affidavit to the Sangguniang Panlungsod Secretariat. PB Obligacion complied with the directive and explained to the committee that his counter-affidavit will dispute the facts and allegations filed against him by Atty, Sualibios. PB Obligacion denied the said allegations through his counter-affidavit, to wit;

- a.) Barangay Queen's row Central is not authorized to issue Barangay Business Permit/s for any establishment/s within the subject lots owned by the client of Atty. Sualibios;
- b.) Atty. Sualibio's request that her firm be furnished with the names of the owners of the establishment/s within the subject lots, their addresses and the documents presented to the Barangay is a mere violation of the Data Privacy Act of 2012 (Republic Act no. 10173) and in accordance to the instructions of the National Privacy Commission (NPC) and the Department of the Interior and Local Government (DILG);
- c.) Barangay Queen's Row Central is not authorized to inspect the said establishment/s if the purpose is to find out the names and identities of the owners as what is stated in the letter of Atty. Sualibios, especially if there is no existing court order.

In conclusion, PB Obligacion expressed his gratitude to all the members of the Committee for giving him the chance to deny the allegations filed by Atty. Sualibios and to respectfully request to the esteemed members of the Committee to dismiss the said complaint in view of the foregoing.

There being no other matters to be discussed, the meeting was adjourned at exactly 1:15 PM.





(NPI), to inform that NPI is the registered and lawful owner of certain parcels of land situated in Queen's Row Central, Bacoor City, covered by TCT Nos. 167-2022003327 (2,892 sq. meters); 167-2022003328 (2,891 sq. meters); 167-2022003325 (6,624.50 sq. meters); and 167-2022003326 (6,624.50 sq. meters). 



Dear Mr. Obligacion,

On February 28, 2025, you personally received our letter on behalf of NGG Properties, Inc. (NPI), to inform that NPI is the registered and lawful owner of certain parcels of land situated in Queen's Row Central, Bacoor City, covered by TCT Nos. 167-2022003327 (2,892 sq. meters); 167-2022003328 (2,891 sq. meters); 167-2022003325 (6,624.50 sq. meters); and 167-2022003326 (6,624.50 sq. meters).

Corollary thereto, being the incumbent Chairman of Queen's Row Central, Bacoor City, Cavite, we made the following requests, thus:

- a. for your office to refrain from issuing any Business Permit's, clearance for any establishment's within the subject lots, without any contract or written consent from NPI;
- b. in case Business Permit/s were already issued to any establishment/s within the subject lots, that we be furnished of the names of the owners thereof, their addresses and the documents presented to your office to secure the Business Permit/s; and
- c. for assistance from your office to conduct an inspection to enable us to identify the names and addresses of the owners of the establishments within the subject lots.

Unfortunately, we have not been favored of any reply nor informed of the action/s which may have been taken by your office.

Sections 5 (d) and (e) of RA 6713 provides, thus:

"(d) Act immediately on the public's personal transactions.
— All public officials and employees must attend to anyone who wants to avail himself of the services of their offices and must, at all times, act promptly and expeditiously.

"(e) Make documents accessible to the public. - All public documents must be made accessible to, and readily available for inspection by, the public within reasonable working.

Similarly, Section 9.b.1 of RA 11032 (the Anti-Red Tape Act of 2007), provides:

"(1) All applications or requests submitted shall be acted upon by the assigned officer or employee within the prescribed processing time stated in the Citizen's Charter which shall not be longer than three (3) working days in the case of simple transactions and seven (7) working days in the case of complex transactions from the date the request and/or complete application or request was received.

Relatedly, Section 21 of the same law provides:

"(e) Failure to render government services within the prescribed processing time on any application or request without due cause.

and a violation of the foregoing may subject the person/s responsible to the penalties prescribed under Section 22 thereof.

Accordingly, may we reiterate our requests and be favored of your written reply thereto and promptly informed of the action you may have taken in connection therewith. Thereafter, we may already be constrained to take the appropriate legal action as may be warranted and seek the assistance of the ARTA and the Office of the Ombudsman to protect the interest of our client.

Ako si, ARMANDO D. OBLIGACION JR., Filipino, nasa wastong gulang, may-asawa, at naninirahan sa Barangay Queens Row Central, Bacoor City, Cavite matapos makapanumpa ng nasayon sa batas ay nagdedeklara na:

- Ako ang kasalukuyang nakaluklok na Punong Barangay ng Queens Row Central, Bacoor City, Cavite.
- 2. Noong 22 July 2025 ay nakatanggap ako ng liham mula sa Acting Vice Mayor ng Bacoor City, Cavite na si Kgg. Miguel Bautista na inuutusan akong mag-submit ng isang sinumpaang counter-affidavit bilang tugon sa reklamong isinampa laban sa akin ni Atty. Merlinda SamuelSualibios hinggil sa: (1) diumano ay pagbibigay ko ng business permit sa ilang negosyante na diumano ay naka pwesto sa lupang pag-sari ng kaniyang kliyente, (2) ang pagtanggi ko na ibigay sa kanya ang address, pangalan, at mga dokumento ng mga nabanggit na negosyante na diumano ay sinumite sa aking tanggapan kaugnay ng nabanggit na business permits at (3) ang hindi ko pagsama sa kanya na inspeksyunin ang mga nabanggit na negosyo.
- Ang pagsusumite ko ng counter-affidavit na ito ay bilang pagtalima sa nabanggit na kautusan at bilang pormal na pagpapasinungaling sa mga paratang laban sa akin ni Atty. Samuel-Sualibios.
- 4. UNA: wala pong katotohanan na ako o ang Barangay Queens Row Central ay nagissue ng business permit sa mga negosyanteng naka-pwesto diumano sa lupang pagaari ng kliyente ni Atty. Samuel-Sualibios. Wala pong kapangyarihan ang mga barangay na mag-issue ng business permit at tanging ang Business Permits and Licensing Department po ng Bacoor City government ang nagtataglay ng nabanggit na kapangyarihan. Dahil batid ko at nang mga opisyal ng aming barangay na wala kaming kapangyarihan na mag-issue ng Business Permits, imposible po na kami ang nag-issue na mga permit na binanggit ni Atty. Samuel-Sualibios. Kung totoo man po na may taglay na business permit ang mga negosyanteng nabanggit ni Atty. Samuel-Sualibios, hindi po ako ang nag-issue noon at malaki pong kasinungalingan na ako o ang iba pang opisyal ng aming barangay ang nag-issue noon.
- 5. PANGALAWA: ang hinihiniling ni Atty. Samuel-Sualibios na ibigay ko sa kanya ang mga pangalan, address, at dokumento ng mga negosyanteng diumano ay naka-pwesto sa lupa ng kanyang kliyente ay hindi lamang paglabag sa Data Privacy Act of 2012 (Republic Act No. 10173) kung hindi isang malaking kabalintunaan dahil papaano ko maibibigay ang mga nabanggit na impormasyon gayong wala akong kinalaman sa mga business permits na binanggit sa kanyang liham sa Pamahalaan?
- 6. Ang hindi ko pagbibigay sa mga impormasyon na hinihiling ni Atty. Samuel-Sualibios ay alinsunod sa tagubilin ng National Privacy Commission at ng Department of Interior and Local Government na nagpapaalala sa mga barangay officials na hindi namin pwedeng i-release ang mga personal data ng aming mga residente alinsunod sa RA 10173. Higit pa dito, ang mga nabanggit na impormasyon ay imposibleng maibigay ko sa kanya dahil sa walang kinalaman ang aking tanggapan at ang iba pang opisyal ng Barangay Queens Row Central sa issuance ng mga business permit na nabanggit at wala sa amin ang pangalan, address o anumang dokumento na may kaugnayan sa nabanggit na business permits.
- 7. PANGATLO: walang kapangyarihan ang Barangay Queens Row Central na maginspection ng mga nabanggit na negosyo kung ang pakay ng nabanggit na inspection ay alamin ang pangalan at iba pang pagkakakilanlan ng mga nabanggit na tao. Malinaw sa liham ni Atty. Samuel-Sualibios na ang purpose ng hinihiling niyang inspection ay upang matulungan siya na alamin ang pangalan at address ng mga negosyanteng diumano ay nakapwesto sa lote ng kaniyang kliyente. Buong galang ko pong ipapabatid sa Sangguniang Panlungsod ang aking pangamba na kung pagbibigyan ko po ang kahilingan ni Atty. SamuelSualibios ay baka malabag ko at ng mga opisyal ng aming barangay ang mga karapatan

ng mga nabanggit na negosyante sa ilalim ng RA 10173 dahil walang hukuman na nag-uutos sa akin o sa aking mga kasama sa barangay na gawin ang nabanggit na inspection. Ito po ang rason kung bakit ako at ang aking mga kasamahan ay nag-aalinlangan na pagbigyan ang kahilingan ni Atty. Samuel-Sualibios at hindi dahil sa anuman pong kadahilanan.

8. Bilang pagtatapos, nagpapasalamat po ako sa Sangguniang Panlungsod sa pagbibigay sa akin ng pagkakataon na pabulaanan ang mga paratang laban sa akin ni Atty. SamuelSualibios. Buong galang ko pong hinihiling sa mga kagalang-galang na kasapi ng Sangguniang Panlungsod na pawalang saysay ang nabanggit na reklamo laban sa akin batay sa mga kadahilanang nabanggit.
