



Subject: A RESOLUTION REVOKING BACOOR CITY AUCTION COMMITTEE RESOLUTION NO. 01, SERIES OF 2024, ENTITLED: "A RESOLUTION TO HOLD IN ABEYANCE THE UPCOMING AUCTION ACTIVITIES IN THE CITY OF BACOOR PURSUANT TO SECTION 30 OF REPUBLIC ACT NO. 12001 GRANTING AMNESTY ON REAL PROPERTY TAXES." - PCR 008-2025 (PCR 813-2025) dated July 7, 2025.

Referred to the Joint Committee on the 1st Regular Session of the 6th Sangguniang Panlungsod is the above-subject matter for appropriate action and recommendation.

INFORMATION:

In pursuance of Republic Act No. 12001 which provides the grant of amnesty on real property taxes, the Bacoor City Auction Committee resolved in its Resolution No. 01. Series of 2024, to hold in abeyance the conduct of auction activities involving the levied real properties of delinquent landowners.

LEGAL BASIS:

Section 30 of Republic Act 12001 as the basis of Bacoor Auction Committee Resolution No. 1, Series of 2024 is hereunder quoted for ready reference, to wit:

"SEC. 30. Grant of Tax Amnesty on Real Property Taxes and Special Levies on Real Property. - There is hereby granted a real property tax amnesty which shall cover penalties, surcharges, and interests from all unpaid real property taxes, including Special Education Fund, idle land tax, and other special levy taxes, prior to the effectivity of this Act: Provided, That the real property tax amnesty hereby authorized and granted can only be availed within a period of two (2) years after the effectivity of this Act."

FINDINGS:

During the Joint Committee hearing held on July 10, 2025, the resource persons representing the City Finance Department, City Assessor's Department and Office of the City Legal Services discussed and explained the mandates in Republic Act No. 12001, particularly the amnesty provisions.

As discussed, the Honorable Members of the Joint Committee anchored on the exceptions in the same Section 30 of Republic Act No. 12001 which provides that the amnesty shall not extend to the following real properties, as follows:

- (a) Delinquent real properties which have been disposed of at public auction to satisfy the real property tax delinquencies;
- (b) Real properties with tax delinquencies which are being paid pursuant to a compromise agreement; and
- (c) Real properties subject of pending cases in court for real property tax delinquencies.

Also, it has been noted that nothing in the provisions of Republic Act No. 12001 that prohibits the conduct of public auction sale by the local government units (LGUs) involving the real properties subject of Warrant of Levy.

Thus, the City Government of Bacoor after giving a reasonable grace period to delinquent landowners may now proceed with the public auction sale involving their levied properties in accordance with the provision of Republic Act No. 7160 otherwise known as "The Local Government Code".

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Joint Committee hereby recommend TO APPROVE the Bacoor City Auction Committee Resolution No. 01, Series of 2025 which resolves to revoke its Resolution No. 01, Series of 2024 that held in abeyance the conduct of public auction sale activities by the City Government of Bacoor involving the real properties subject of Warrant of Levy.

Nolasco: "The Committee on Finance, Budget and Appropriation, as the lead committee, conducted a hearing on January 9, 2025 to tackle the processes and procedures in relation to the implementation of the real property tax amnesty under the propoed city ordinance PCO-2024-216 entitled: "Request for city ordinance in support of Republic Act 12001, particularly on the grant of amnesty on Real Property taxes enshrined under section 3 of the said Law." The only unresolved critical issue and concern which were raised by the concerned resource persons from the office of City Treasurer, Office of the City Legal Services and office of the City Assessor's Department is here under quoted: "The impending implementation of public auction involving the levied properties." As per BLGF central office memorandum circular no. 003-2025 dated January 06, 2025 and BLGF Regional memorandum circular no. 10-2025 dated January 17, 2025 addressed to Regional, Provincial, City, Municipal Assessor and Treasurers. Subject: "Tax Amnesty on Real Property Taxes under Republic Act (R.A.) No. 12001 or the "Real Property Valuation and Assessment Reform Act" The amnesty shall not extend to the following real properties: a. Delinquent real properties which have been disposed of at public auction to satisfy the real property tax delinquencies; b. real properties with tax delingencies which are being paid pursuant to a compromise agreement; and c. Real properties subject of pending cases in court for real property tax delinquencies." 

Pursuant to Section 16 Republic Act No. 7160, otherwise known as the Local Government Code, (e)very local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

The revocation of BCAC Resolution No. 01 s. 2024 is a part of a broader effort of the City Government of Bacoor to strengthen tax collection and ensure the financial stability for the city, and should the auction activities be initially put on hold due to amnesty on real property taxes, lifting that pause could signal a shift towards encouraging taxpayers to settle their dues more promptly.

WHEREAS, on October 04, 2024, the Bacoor City Auction Committee issued Resolution No. 01 s. 2024 entitled "A Resolution to Hold in Abeyance the Upcoming Auction Activities in the City of Bacoor Pursuant to Section 30 of Republic Act No. 120001 Granting Amnesty on Real Property Taxes;"

WHEREAS, the aforementioned Resolution suspends the upcoming public auction in the City of Bacoor to ensure compliance with Republic Act No. 120001, also known as the Real Property Valuation and Assessment Reform Act (RPVARA), which aims to establish and maintain standards for the valuation of real property across the Philippines;

WHEREAS, the RPVARA law, specifically Section 30 thereof, grants tax amnesty on real property on taxes and special levies on real property, which may be availed of by the taxpayers within two (2) years from the effectivity of the law;

WHEREAS, on 07 April 2024, the BCAC met and discussed the possible resumption of the auction of delinquent properties and the possible revocation of BCAC Resolution No. 01 s. 2024;

WHEREAS, the revocation of BCAC Resolution No. 01 s. 2024 is part of a broader effort of the City Government of Bacoor to strengthen tax collection and ensure the financial stability for the city, and should the auction activities be initially put on hold due to amnesty on real property taxes, lifting
