**Subject:** LETTER OF REQUEST FROM ADDAS VILLAGE II HOME OWNERS ASSOCIATION FOR THE INSTALLATION OF EQUIPMENT AND REPAIR IN CONNECTION WITH THE SOLIDARITY ROUTE CITY ORDINANCE. - PCR 012-2025 (PCR 836-2025) dated July 07, 2025

Referred to this Committee is the above-subject matter for appropriate action and recommendation.

#### INFORMATION:

In the letter dated April 25, 2025 of the City Administrator Office, Bacoor City addressed to City Vice Mayor, Hon. Rowena Bautista-Mendiola, Presiding Officer of Sangguniang Panlungsod, Bacoor City, the requests of ADDAS Homeowner's Association involving the Solidarity Road are hereunder presented, as follows:

- Installation of Gate Boom Barrier.
- Paint to be used in repairing of the humps along the Solidarity Road.
- Additional solar streetlights to be installed at St. John Street and St. Lorenzo Street considering that most of the existing solar streetlights are covered by trees.

#### ACTION TAKEN:

The Committee conducted three (3) hearings relative to the said request in order that specific actions could be properly clarified and verified.

For that matter, the representatives from the Office of the City Engineer, Bacoor Traffic Management Department, City Administrator Office and Office of the City Legal Services were invited, as resource persons.

During the first and second hearings, the following situations/issues were established:





Office of the City Engineer

- The request of the Homeowner's Association requires actual inspection, cost estimates, and the preparation of work program which are subject to the approval of concerned city authorities and Office of the City Mayor.

Bacoor Traffic Management Department

- Actual inspection and coordination with concerned city department will be conducted to address the complaint of the Homeowner's Association concerning the accident-prone area due to non-operational traffic light and lack of assigned traffic enforcers.

**FINDINGS:**

1. The request of ADDAS Village II Homeowner's Association does not require legislative measure to be enacted or to be approved by the Sangguniang Panlungsod.
2. As per the report and recommendations of resource persons during the last committee hearing held on September 3, 2025;
  - a. **City Engineering Office** – The actual inspection, estimation and the preparation of work program addressing the request of ADDAS Village II Homeowner's Association have already been accomplished. The work program will be implemented upon approval of the cost by the Office of the City Mayor, including the request for installations of new solar streetlights and replacement of busted lights along the Solidarity Roads within the village; and
  - b. **Bacoor Traffic Management Department** – As per the complaint and request of ADDAS Village II Homeowner's Association.
    - The traffic light has been repaired and is now operational.
    - As recommended, the assignment of traffic enforcers on the identified accident-prone area will start at 6:00 o'clock in the morning and will end at 10:00 o'clock in the evening.





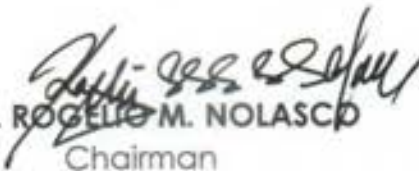
## RECOMMENDATION:

**Mr. Michael Gonzales:** "More or less mga 500 meters po yung naco cover niya. Actually, mayroon na pong nailagay na noong nakaraan pa, kaya lang po masyado pong malalayo yung agwat."

**Hon. Reynaldo Palabrica:** "Additional lang?"

**Mr. Michael Gonzales:** "Opo, additional lang po yung nirerequest ng Addas 2."

**Hon. Reynaldo Palabrica:** "Mga 50 piraso siguro ito."

**Mr. Michael Gonzales:** "Hindi naman po siguro, roughly mga 20 to 25 pieces po siguro."

**Hon. Reynaldo Palabrica:** "20 to 25 Poles para magkaroon tayo ng estimate kung magkano. Kasi, pasensiya na po kayo hindi kami ang magbibigay kasi wala sa amin ang disbursement, kasi nasa executive department po, pero we have an oversight function na kung ano ang aprubahan namin yun pinapatupad ng excutive department syempre ang mag aapprove noon finally ay si Mayor Strike. Ngayon tinatanong sa mga offices under Mayor Strike kung kaya nila kasi pag dating sa budget sila ang nakaka alam ng technical aspects sila ang makaka sagot kaya tanong ko ang estimate nila kung magkano."

**Mr. Romeo Austria:** "Ang rough estimate Sir ay more or less Php 3,000,000.00 po including solar and repaintings."

**Hon. Rogelio M. Nolasco:** "Mayroon pa yung installation ng boom barrier."

**Mr. Romeo Austria:** "Depende po kasi sa barrier na gagamitin."





**Mr. Michael Gonzales:** "Ah sorry po, actually naka install na po yung boom barrier the reason po kasi, pinag submit kami ng request for boom barrier naisama lang po iyan actually naka install na po iyan yung operation po ng boom barrier yun pa po ang wala. Ang sabi po sa akin noong gumagawa they will conduct kapag i ooperate na yun ang sabi sa amin, eh as of the moment kasi po noong March pa."

**Hon. Reynaldo Palabrica:** "Pasensya na po kayo kung medyo nagtatagal, ang plano po kasi ni Mayor Strike diyan lahat ng entrance gate na solidarity route natin ay magkaroon ng boom barrier kaya yung ating solidarity sticker ay may RFID kasi mag iinstall pa lang, basta may kaunting problema pa doon sa porlton na iyon. Para kung sino yung dapat na dadaan ay may solidarity sticker. Kaya may RFID, antay antay lang."

**Mr. Michael Gonzales:** "Wala pong problema doon, to add lang po total naandito na lang din po ang City Engineering, nanggaling po ako sa office ng City Mayor nag submit po ako ng request kasi as of June 22, 2025 may nangyari na pong aksidente doon sa corner po namin sa intersection papunta po doon sa Bacoor Boulevard connecting Addas, eh ano na pong petsa na po ngayon yung stop light po wala pa ring nangyayari eh ang mga tumatawid po kasi laging sa akin pumupunta eh, tulungan kong tumawid kasi nakakatakot naman po talagang tumawid. June 22 pa po noong may nangyaring aksidente."

**Hon. Reynaldo Palabrica:** "Mr. Chair, in the absence of traffic managment operations mayroon namang dapat traffic enforcer."

**Mr. Michael Gonzales:** "Mayroon po Sir kaso po nawawala rin."

**Hon. Reynaldo Palabrica:** "Anong oras po nawawala?"

**Mr. Michael Gonzales:** "Hindi ko po alam Sir, actually pinipicturan ko na nga yung area eh, kasi nga ho tinatawag ako ng mga homeowners ko yung elderlies ako pa po ang nag aassist na tumawid kung minsan. Eh wala po ang enforcer doon."

**Hon. Reynaldo Palabrica:** "So, may we call the attention of BTMD. By the way the representative of BTMD is present."

**Hon. Rogelio M. Nolasco:** "We acknowledge the presence of our BTMD representative."

**Mr. Adel Udarde:** "Your honors, sorry for being late."





**Hon. Reynaldo Palabrica:** "Siguro alam mo yung concern ng Addas, baka pwede namang mabigyan natin ng attention yung kanilang concern."

**Mr. Adel Udarde:** "Yes po your Honor, actually po even before na buo yung traffic light mayroon na hong enforcer talaga doon, for some reason minsan po kasi nagkakaroon po ng biglaang aksidente na pinupuntahan. Actually, kanina po may nag message sa akin kanina na taga Addas na walang enforcer, so kinall ko po yung attention nila, nagkaroon po ng sanggian doon sa may may walter mart at pinuntahan nila. So, yung mga ganoon naman po consistent naman na may tao po tayo doon mula alas seis ng umaga hanggang alas diyas ng gabi."

**Hon. Reynaldo Palabrica:** "So, kung sino man yung enforcer na naandoon hindi lamang sila mag abang sa huhulihin kundi mag assit lalo na sa mga tumatawid lalo na sa mga elderly."

**Mr. Michael Gonzales:** "Infairness naman po Sir, kapag naandoon po siya talaga naman pong nag ta trabaho. Hindi naman po natin talagang sasabihing nanghuhuli lang siya pero from time-to-time po lagi pong nawawala eh masyado pong delikado."

**Hon. Reynaldo Palabrica:** "Ang sinsabi ko lang naman, reminder lang baka kaya nga siya nawawala ay gaya nga may vehicle accident na pinupuntahan dahil siya nga detailed enforcer or maybe baka naihi lang siya."

**Mr. Michael Gonzales:** "Oo nga, naiintindihan naman po namin iyon, eh ako kasi bombarded ako ng mga homeowners namin, Sir nawawala na naman."

**Hon. Reynaldo Palabrica:** "Siguro Mr. Adel, kailangan ang close coordination."

**Mr. Michael Gonzales:** "Salamat po."

**Ms. Leonila M. Herrera:** "Excuse me po, kasi po nag isa lang po iyon hindi ba pwedeng lagyan ng dalawa para in case na nawawala yung isa may kapalit?"

**Hon. Reynaldo Palabrica:** "Hindi po namin kaya sa ngayon, pasensya na po kayo hindi po namin kaya yung dalawa sa bawat intersection, unang una kasi sa laki ng budget kinakapos po tayo talaga kaya sa bawat major intersection doon ang dalawa yung secondary intersection tulad ng naandiyan ay isa lang talaga ang na de deployed natin. Pagpasensyahan nyo na po yun lang po ang kakayahan namin hanggang doon lang po talaga."





**Ms. Leonila M. Herrera:** "Pero hindi po magagawan ng paraan na ma repair yung stop light doon?"

**Hon. Reynaldo Palabrica:** "Itanong natin sa BTMD kasi sila ang nakaka alam. Sira pa ba yung traffic light doon?"

**Mr. Adel Udarde:** "Currently po hindi po nagana yun, pero nasabi na po namin yan sa engineering at doon po sa contractor eh, once po kasi na nakita ng enforcer na hindi nagana ni rereport po sa amin agad, ngayon po ang pagkaka alam ko po kagagawa lang po nyan. Hindi po namin mapagalaw sa iba kasi po baka ma void yung warranty, kaya po kinall namin ang attention ni Engineer Shalwa at sa contractor po to have it fix. At saka yung dati po laging nawawala yung cable, nilalagyan po ng bagong cable pero recently hindi na po yung cable, nasira na po. Yun po yung issue diyan."

**Hon. Reynaldo Palabrica:** "So, engineering papano ba ito? Kaya bang ayusin agad yan bukas? How you fix this situation?"

**Mr. Romeo Austria:** "Inspect po namin yung site nila and for schedule na lang po."

**Hon. Rogelio M. Nolasco:** "I refer mo sa contractor kasi under warranty po yan."

**Mr. Romeo Austria:** "Yes po kasama po doon yung contractor."

**Hon. Reynaldo Palabrica:** "Medyo bigyan nyo yung contractor kasi syempre it means in danger human rights so, kailangan nating bigyan ng matinding pansin yan."

**Mr. Michael Gonzales:** "Yes po Sir, kasi po noong June 22, may namatay na po dyan. Kasi po yung stop light na naandito sa area ko sa Addas 2A may tatawid pong fortuner sa greenfields, patay po yan since, if I am not mistaken June 12 wala na siyang ilaw. Both yung pa metro at pa tango naka ilaw po yan nakita nya walang stop light dito papunta siyang Addas 2A galing siyang greenfields, umistop yung papuntang tango at PTT po, yung pa metro naman po nagkaroon po ng gap pero noong nakita namin sa CCTV 38 seconds pa nag go siya. Hindi namin nakita kasi walang nakitang stop light tumawid siya, pag tawid ho nya may mabilis na motor na parating seeing may 38 seconds pa, daredaretso siya. Yung fortuner umusod ng ganoon eh, sa lakas ng impact, yung motor undescrivebale yung pasahero mag asawa po kasi yan eh nasa ilalim yung babae ng fortuner patay ho yung babae. Yun po ang sinabi ng pulis na nagpunta sa akin sa office ko to gather ng cctv footage. Patay daw po





yung babae and that was on the 22<sup>nd</sup> po ng June, up to now wala pa po tayong stop light doon. Kaya po talagang medyo concern lang po kami."

**Hon. Reynaldo Palabrica:** "This is very much noted, kaya nga we are calling the attention of engineering office to act promptly on this request. Kasi nga hindi na in danger the human rights kasi namatayan na nga tayo."

**Mr. Michael Gonzales:** "Kasi po July 17 na tayo eh pag dating ng 22 isang buwan na pong nangyayari yan."

**Hon. Rogelio M. Nolasco:** "Noted po."

**Ms. Leonila M. Herrera:** "Yung sa aming subdivision na idonate na namin yung aming city ordinance kaso ang aming mga home owners hindi sila naniniwala, pwede bang ma actionan na mabigyan ng kopya para maipakita na totoong may city ordinance."

**Hon. Reynaldo Palabrica:** "Ordinance regarding saan po?"

**Ms. Leonila M. Herrera:** "Yung pong sa street parking po. Kasi solidarity route po kami."

**Hon. Reynaldo Palabrica:** "Mam, Sir, kasi ganito tungkol sa city ordinance ng mga subdivision, nasa legislation process pa po. Hindi ba nag hearing tayo dito? Under my committee po yun eh, ngayon naipasa na namin yung ordinansa dito papunta na pong sangguniang panlalawigan for their review and approval po afterwards pagbalik dito gagawan na natin ng Implimenting Rules and Regulations, after drafting IRR may 10 days posting and then iimpliment na yun. Iinform naman po kayo kapag na implement na natin."

**Ms. Leonila M. Herrera/ Mr. Michael Gonzales:** "Salamat po."

**Hon. Reynaldo Palabrica:** "Hindi pwedeng pag hearing natin kinabukasan ay implement na natin. Kapag inimpliment natin yun kapag nireklamo tayo talo tayo kasi wala pang IRR. Patapusin muna natin ang legislation process."

**Hon. Rogelio M. Nolasco:** "Kunin naman natin ang opinion ng ating Legal ano po masasabi ninyo."

**Atty. Marius D. Sumira:** "Base po doon sa sinabi ng mga resource persons saka ng sumulat po, your honors, Mr. Chair, mayroon nga pong kulang sa implementation at saka communication regarding doon sa nasirang traffic light. Hopefully with the commitment po ng engineering at saka support ng BTMD enforcer natin maiwasan pong maulit muli yung aksidente."





**Hon. Reynaldo Palabrica:** "Mr. Chair regarding doon sa request nila, nakausap nyo na ba ng direct si Mayor Strike sa request nyo?"

**Mr. Michael Gonzales:** "Ano pong request Sir."

**Hon. Reynaldo Palabrica:** "Itong mga nasa letter."

**Mr. Michael Gonzales:** "Well actually Sir sa Addas 2 po iyan, actually po Sir isinabay po kasi nila yan may pinapasok po kasi kaming board resolution regarding boom barrier, isinabay po kasi nila para ma reach."

**Hon. Reynaldo Palabrica:** "Kayo po Mam nakausap nyo na po si Mayor Strike? Ano po ang sabi sa inyo?"

**Ms. Leonila M. Herrera:** "Sabi po aactionan naman niya kaya po inaantay ko baka kako ma aprubahan na nya."

**Hon. Reynaldo Palabrica:** "Nakarating po kasi dito sa sanggunian, it will be favorably endorsed to the mayor para ma actionan, kasi po wala naman kaming power and authority para mag execute or mag implement ng infrastructure project, purely legislation lang po kami. Through legislation we will favorably endorse your request to the executive department. Okey po Mam?"

**Hon. Rogelio M. Nolasco:** "Mam may tanong lang po ako dito kasi nag okey si Mayor regarding paint materials. Na receive nyo na po ba itong paint materials? Naibigay na ba sa inyo ng engineering?"

**Ms. Leonila M. Herrera:** "Okey na po ito after ng mag usap kami ni Mayor ibinigay na sa amin yung pintura, yung sa Solar po ang inaantay namin."

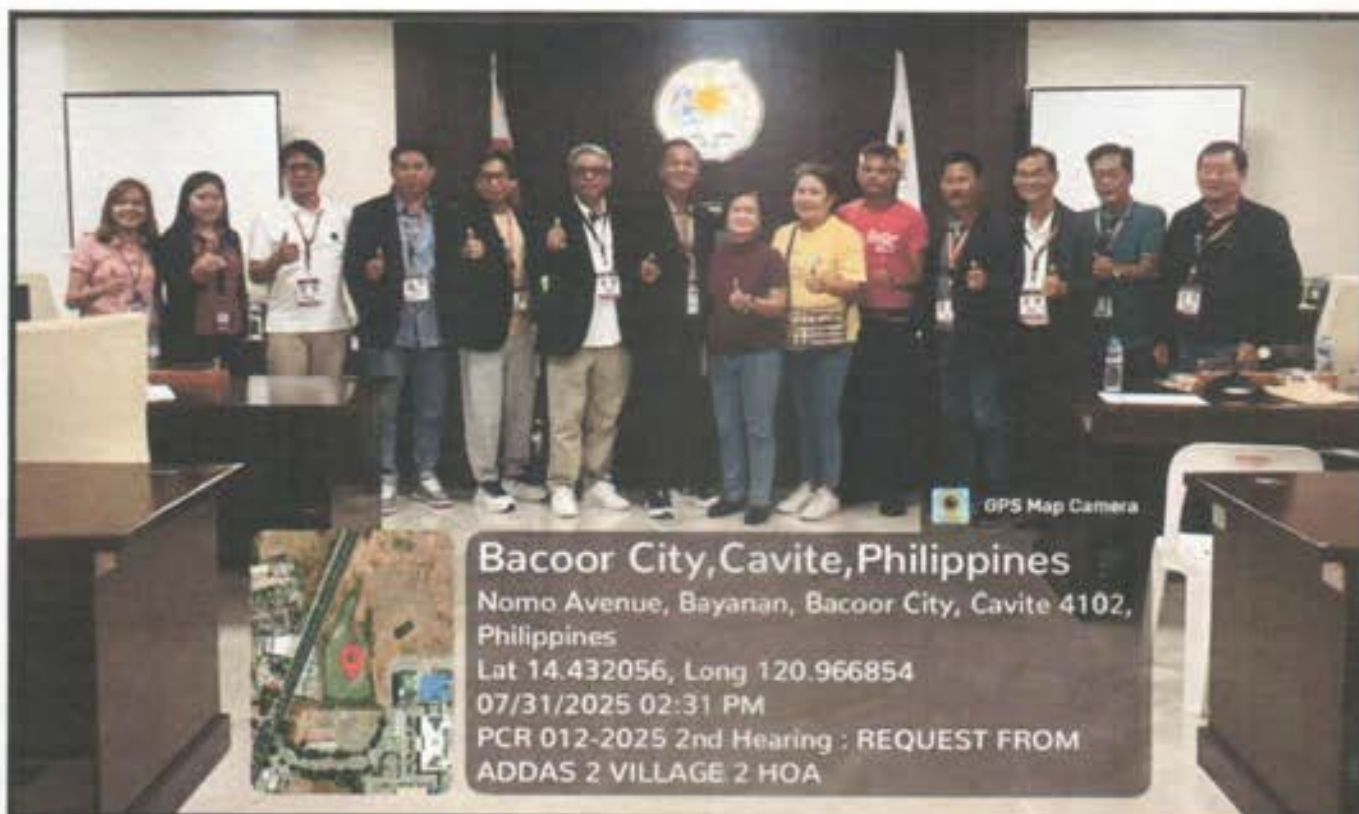

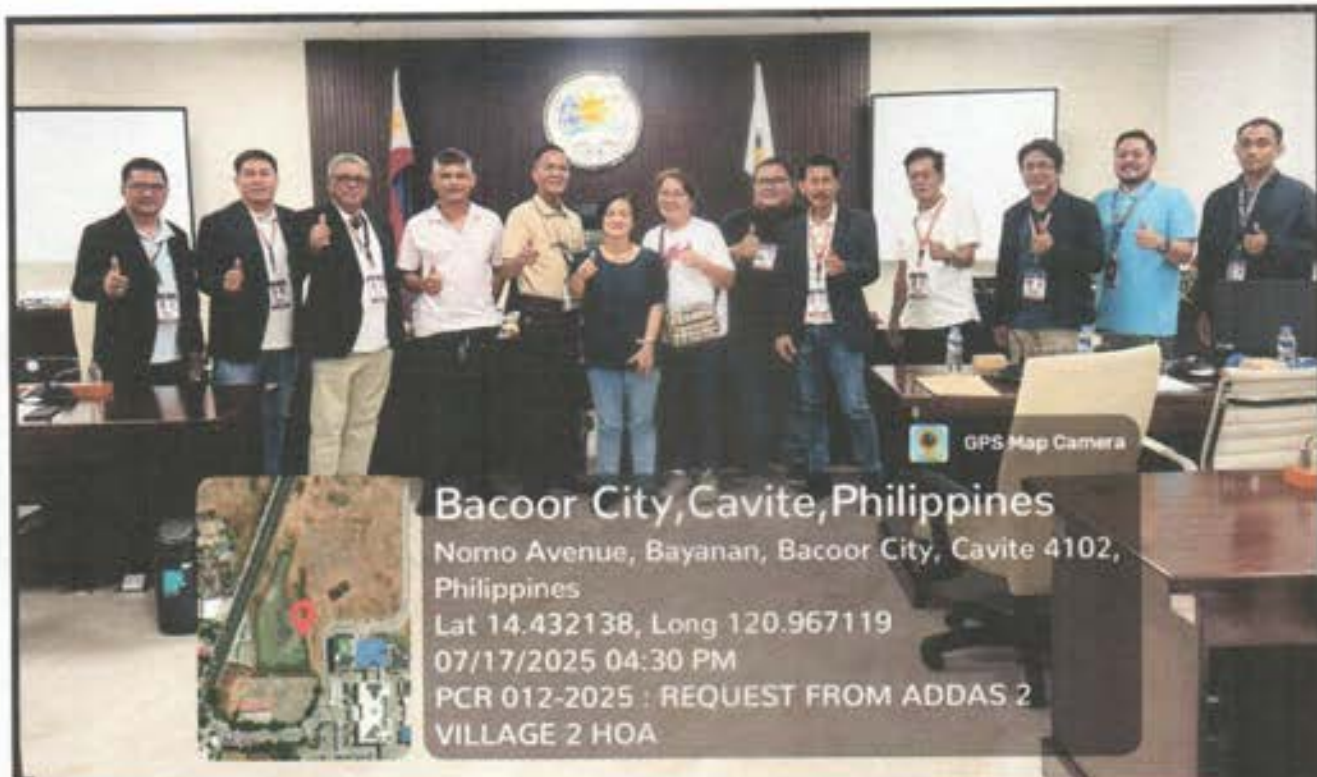

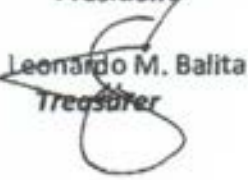
**NOW THEREFORE, RESOLVED AS IT IS HEREBY RESOLVED**, the Board approved the following:

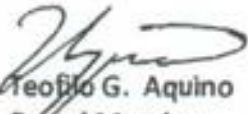
1. The HOA will allow the City Government of Bacoor to install a Boom Barrier in our main gate.
