

COUN. MIGUEL BAUTISTA "Magandang hapon po Mr. Chair at sa ating resource persons."

COUN. REYNALDO PALABRICA "May I request the resource persons present to introduce themselves and their representation."

**DRA. IVY MARIE YRASTORZA** "Good afternoon po honorable councilors. I am Dra. Ivy Marie Yrastorza City Health Officer."

COUN. REYNALDO PALABRICA "Representative from CSWD."

RICA CALAPIT "Good afternoon po sa ating mga City Councilors, Dra. Ivy and Atty. Bambi. Ms. Rica po Social Worker Officer po."

COUN. REYNALDO PALABRICA "Thank you Ms. Rica. Next, from City Legal Department."

**SALVE VALENCIANO** "Good afternoon to everyone and honorable members of the City Council. Salve Valenciana po from Office of the City Legal Services, mabuhay po."

COUN. REYNALDO PALABRICA "Thank you very much Attorney. First and foremost, I would like to express my apology to CSWD kasi hindi kayo napadalhan ng invitation, although kayo ang kailangan dito. Thankful ako kasi sa isang tawag lang, nandito kayo agad, thank you."

COUN. REYNALDO PALABRICA "Basically and apprubahan natin yung renewal ng kontrata ng agreement with the hospitals and funeral parlors tungkol dito sa assistance and guarantee letters. So, may I ask the CSWD representative from the list being furnished about with the hospitals, labing apat ito, wala bang kulang dito? Wala bang kulang sa labing apat na ito."

RICA CALAPT "So far naman po konsi, wala naman po."

COUN. REYNALDO PALABRICA "Wala ba tayong i-bablock list sa labing apat na ito?"

RICA CALAPIT "As of now, sa hospitals po natin konsi meron pong nag refuse which is yung Binakayan Hospital. They decided not to renew their MOA."

COUN. REYNALDO PALABRICA "Because they intended to refuse their agreement, we will remove the Binakayan Hospital from the list."

COUN. REYNALDO PALABRICA "Thank you very much for the information. Other than that, wala na bang ibang concerns regarding sa hospitals?"

RICA CALAPIT "So far, wala naman po pero as of now yung diagnostic center po natin, as per advised po ni Mayor Strike to be hold po muna. Pero the rest funerals and hospitals igo-go po yun."

COUN. REYNALDO PALABRIC "So, when it comes to diagnostic as per advised by the mayor to CSWD that is it to hold the memorandum of agreement with the laboratories and diagnostic centers. So, we will abide by the advised, hindi muna natin ito iinclude kung sakaling i-approve to today."

COUN. REYNALDO PALABRICA "How about yung funeral parlors, meron ba tayong idadagdag o ibabawas?"

RICA CALAPIT "So far po all funeral parlors are willing to renew their memorandum of agreement sa LGU.

COUN. REYNALDO PALABRICA "Active pa?"

RICA CALAPIT "Yes po, active pa naman po."

COUN. REYNALDO PALABRICA "Pero hinihingi na ni mayor yung authority to sign. Dahil pangalawang term, pipirma siya ulit."

RICA CALAPIT "Yes po, as per Atty. Marco we already sent the draft MOA to all funerals and waiting na lang po kami sa kanilang comments."

COUN. REYNALDO PALABRICA "Okay, kapag may comment na sila ipapadala na lang."

RICA CALAPIT "Yes po."

COUN. REYNALDO PALABRICA "Dito sa list natin, this is 16. May kulang pa dito?"

RICA CALAPIT "Sorry we apologize po. Sorry po, People's Funeral."

COUN. REYNALDO PALABRICA "linclude na lang natin."

COUN. REYNALDO PALABRICA "Please make it on record that People's Funeral Services been included in the list. Please take note on that."

COUN. REYNALDO PALABRICA "Dra. Ivy, do you have any questions, suggestions or opinions regarding this request?"

DRA. IVY MARIE YRASTORZA "Sa hospitals naman po, wala naman pong problem. Most of them naman po ay compliant regarding sa mga health compliance nila, yun nga lang po mga funerals, meron pa rin pong hindi compliant sa health sanitation permit nila."

COUN. REYNALDO PALABRICA "Sino dito ang hindi compliant sa sanitary permit?"

DRA. IVY MARIE YRASTORZA "Most of them."

COUN. REYNALDO PALABRICA "Most of them? Hindi natin pwede bigyan ng memorandum of agreement kung may violations sa local ordinance. We should put hold on this, please advised them to comply with the government requirements before we enter on an agreement with their company and the City Government."

DRA. IVY MARIE YRASTORZA "Actually may mga concerns din po kami sa funeral parlors natin katulad po na we encounter na mga patay na kine-cremate kaagad even without the death certificates. Actually, binanggit ko po yan kay mayor kasi ano po yung proof namin na may namatay? Ipapakita sa amin abo na lang. Tapos wala rin kaming documentations, even sa barangay hindi po siya nai-blotter na may namatay na ganung date o oras. Tapos papapirmahan saamin yung death certificate, paano kung may foul play? So ang nangyayare kapag namatay ng weekend, walang pangpa-burol, kine-cremate agad. Pwede naman kasi yun i-coordinate agad sa health worker natin, at least may mag cecertify na may namatay sa kanilang lugar na ganitong araw at oras. Hindi rin kasi kami nai-inform tapos magugulat na lang kami may lalapit po saamin after a few days then magpapapirma ng death certificate."

COUN. REYNALDO PALABRICA "Yes, Councilor Ugalde you are recognized."

COUN. RICARDO UGALDE "May tanong po ako kapag ganun na halimbawa weekend kasi gusto ilibing na agad, syempre di pa kaagad maaayos yung death certificate, papaano yun pwede ba yung certification na mangagaling sa inyo?"

DRA. IVY MARIE YRASTORZA "Yes po. Actually, during COVID time konsi kasi diba meron po kasing ganun na kailangan agad-agad pinapa cremate natin. So, we deputized our barangay health workers, kapag na-inform sila, sila yung magbibigay ng certificate na pede na ma-pick-up ng funeral and then sila yung nagrereport sa health center na may namatay and irerecord."

COUN. RICARDO UGALDE "So, pwede yun?"

DRA. IVY MARIE YRASTORZA "Opo, pwede yun. At least may proof po tayo. Then kung kinakailangan din pong tawagan yung BHW natin, pupunta naman po yung mga BHW natin."

COUN. RICARDO UGALDE "Basta naireport at nairecord sa barangay, pwedeng ipa-cremate yun?"

DRA. IVY MARIE YRASTORZA "Yes po."

COUN. RICARDO UGALDE "Thank you."

COUN. REYNALDO PALABRICA "For the information of everyone here. Meron paring requirement and regulations sa City Cemetery and Crematory Office natin, na hindi sila magke-cremate ng walang death certificate and cremation permit. Kasi kahit namatay naman pwede namang dalhin ng funeral parlor yan, kasi meron namang refrigerator yung mga yan kung saan pwedeng irefrigerate yung cadaver, pwede namang saksakan ng formalin."

COUN. REYNADLO PALABRICA "Dra. Ivy, can you identify all the funeral parlors na nakapag comply na sa sanitary permit? It is very important dahil yung waste ng funeral parlors are hazardous. Can you identify, mabigyan niyo kami ng list ng naka comply na sa health compliance para yung mga nag comply papapirmahan natin kay mayor tapos yung hindi pa compliant, hindi natin pwedeng bigyan. Kasi batas natin tas hindi naman kino-comply then tutulungan pa natin, mali naman yun. All the funeral parlos should be compliant."

DRA. IVY MARIE YRASTORZA "Sige po. Kukunin ko po sa office then ifufurnished ko po."

COUN. REYNALDO PALABRICA "If you can send us the copy thru email so that on Monday we will approve. Dahil ito hindi ito pwedeng idelay, kapag dinelay natin to baka ma-apektuhan naman yung mga indigent people natin na nagangailangan ng serbisyo."

COUN. REYNALDO PALABRICA "You are recognized Councilor Mike Bautista."

COUN. MIGUEL BAUTISTA "Mr. Chair tanong ko lang yung sa low compliance, and ano yung mga low compliance?"

DRA. IVY MARIE YRASTORZA "Bale yung sa sanitary permit po konsi yung di pa rin po nila nako-comply, kailangan lang po kasi doon nalinspect ng sanidad. And with regards po sa DOH permit po ng ating embalmers tapos po mga health permit po ng kanilang empleyado. So, ayun po yung nirerequire natin kasi nga po as mention po ni Konsi Palabrica mga hazardous waste yung hinahandle nila

doon. Kasi meron po tayong mga concerns regarding sa kapag inilibing ang cadaver nakikita ng families na may kagat ng daga."

COUN. MIGUEL BAUTISTA "So ibig sabihin, yearly nagka-conduct kayo?

DRA. IVY MARIE YRASTORZA "Yes po, yearly po nila kailangan mag comply sa sanitary permit."

COUN. MIGUEL BAUTISTA "Thank you."

COUN. REYNALDO PALABRICA "Honorable Galvez, earlier you are raising your hand. You are now recognized."

COUN. MANOLO GALVEZ JR. "Mr. Chair, ang tanong ko lang kay Dra. Ivy is ano po yung protocol bago icremate yung isang cadaver po?"

DRA. IVY MARIE YRASTORZA "Usually po kailangan po talaga na may death certificate. Kasi tulad po ng sinabi ko kanina, kapag po inspecting of foul play, nirerequire po minsan ng ating PNP na i-autopsy muna. Unless lang po talaga na mag waive po yung family, although sa batas po kasi kapag nag require po yung PNP kailangan po talaga na i-autopsy ang isang cadaver. Then yun lang naman po yun, death certificate lang po."

COUN. MANOLO GALVEZ JR. "Thank you Dra. Ivy. Mr. Chair follow up question lang po for legal. Ma'am pwede po bang iimprove po natin dito sa memorandum na kapag nag violate yung funeral services, lalo na doon sa concern ni Dra. Ivy, they are liable? Kung pwede natin sila kasuhan, kung pwede lang naman yun? Or penalty? Kasi parang nagiging practices na nila yung binabalewala tayo."

SALVE VALENCIANO "During the course of the discussion naisip ko lang po na diba po Dra. Ivy ang sanitary permit is a requirement before the issue of business permit?"

DRA. IVY MARIE YRASTORZA "Actually that is not the case po eh. Nauuna po kasi yung business permit natin bago po sila nag aapply for sanitary permit."

SALVE VALENCIANO "Pero sa normal procedure po diba dapat?"

DRA. IVY MARIE YRASTORZA "Technically po dapat nauuna po yung sanitary permit."

SALVE VALENCIANO "Kailangan po kasi macomply muna nila yung sanitary permit bago sila maisyuhan ng business permit."

COUN. REYNALDO PALABRICA "Actually sa regulation, yun dapat mauna yung sanitary permit but sa situation ng ating BPLD at health because of lack of our personnel nauuna na maissue yung business permit kesa sa sanitary permit."

SALVE VALENCIANO "Tsaka I believe din po na may mga undertaking din po na sinusunod ang ating mga business owners kapag may kulang pa na need nila icomply for a certain period."

COUN. REYNALDO PALABRICA "Meron. Tama."

SALVE VALENCIANO "Doon po sa tanong ni konsi. Ano po ba konsi yung particular case? Kasi ang iniisip ko po kanina."

COUN. REYNALDO PALABRICA "The question is in case of any violation on the existing rules and regulations based on the local ordinance and even national law. Dapat meron ding penalty yung establishments or funeral parlors na ilalagay sa MOA. Para sakin kasi wag na muna nating ilagay sa MOA dahil may separate ordinance tayo doon, an ordinance penalizing, kung ano yung violation. With regards to the MOA ang pwede nating ilagay, to satisfy the suggestion of our honorable colleague Noly Galvez ay icancel yung MOA."

SALVE VALENCIANO "Actually, yun nga po yung mga proposed MOA natin ay within 3 years po ang validity. So, once po na magpirmahan tayo ngayong July for example, it runs until June 2028. During the period po na nagkaroon ng violation at meron po talagang recommendation, that will be the basis of the termination of MOA in that particular entity."

COUN. REYNALDO PALABRICA "That will be automatic termination of MOA."

SALVE VALENCIANO "Yes po."

COUN. REYNALDO PALABRICA "Syempre after due process."

COUN. REYNALDO PALABRICA "Any other suggestions, Rica? So, that's it. Ang ating consensus ngayon ay aprubahan na yung sa mga hospital, kasi may mga pasyente tayo na nasa hospital except ang Binakayan dahil nag voluntary withdraw sila doon sa MOA. Doon sa mga funeral parlors, ana aaprubahan natin sa Monday ay yung mga compliant lang sa ating local regulations na isa-submit ni Dra. Ivy."

COUN. REYNALDO PALABRICA "With that may I request for the motion of the adjournment of this hearing."

COUN. SIMPLICIO DOMINGUEZ "I moved for the adjournment."

#### MEMORANDUM OF AGREEMENT

#### KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (the "Agreement") is made and entered into in the City of Bacoor, Province of Cavite, by and between.

The CITY GOVERNMENT OF BACOOR, a local government unit created and existing under the laws of the Philippines, with official address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Cavite, represented herein by its City Mayor, Hon. STRIKE B. REVILLA, hereinafter referred to as the "FIRST PARTY".

- and -

The ST. DOMINIC MEDICAL CENTER, a corporation duly organized and existing under the laws of the Republic of the Philippines, with business address at Talaba, Aguinaldo Highway, Baccor, Cavite, represented by its President, Dr. GREGORIO A. ANDAMAN, Jr., of legal age, Filipino, hereinafter referred to as the SECOND PARTY.

#### WITNESSETH:

WHEREAS, under the Republic Act No. 10160, the City Mayor is mandated to ensure delivery of basic services and the provision of adequate facilities which include health services;

WHEREAS, the numerous indigent residents of the City of Baccor have requested the FIRST PARTY for assistance in relation to their medical problems and conditions:

WHEREAS, the FIRST PARTY desires to extend free medical services to its indigent residents, as well as to public school employees and local government employees, and as such suitable hospital facilities are required for such purpose;

The

WHEREAS, the SECOND PARTY has suitable facilities needed to accomplish the FIRST PARTY's needs for its free medical services program and it has intimated to FIRST PARTY that it is willing and able to render such medical services to patients referred by FIRST PARTY at the latter's expense;



WHEREAS, the SECOND PARTY, duly accredited by Philhealth, is one of the referral hospitals of the FIRST PARTY.

NOW, THEREFORE, for and in consideration of the foregoing premises, and of the mutual coverants herein contained, the PARTIES have AGREED to be bound, as follows:



GUARANTEE LETTER (GL). All patients referred by the FIRST PARTY to the SECOND PARTY as service patients under the City of Bacoor Hospitalization Program (CBHP) of the Office of the City Mayor must be issued a GUARANTEE LETTER (GL) bearing the signature of the City Mayor of Bacoor. The existing GL pro-forms will be used by the FIRST PARTY under this Agreement. GL's shall be valid for a period of fourteen (14) days only from date of issue as appearing thereon.

The GL shall be deemed to be an acknowledgment by the FIRST PARTY of its obligation to pay for costs, charges, expenses and fees incurred by the SECOND PARTY in the treatment of the service patient from his admission to discharge A billing statement under the GL shall be submitted by the SECOND PARTY to the FIRST PARTY every end of the month, payable within thirty (30) days from receipt of such statement. The FIRST PARTY shall review the billing statement within fifteen (15) days from receipt from the SECOND PARTY. Should the SECOND PARTY receive no notice of dispute as to the content of said billing statement within the stated period, it shall be deemed conclusive as to the amount payable without further need of demand from the SECOND PARTY. The patient or his family member shall be interviewed for profile intake. No interview, no GL if the GL is presented the SECOND PARTY shall not consider the patient to be covered by the CBHP.

2. TREATMENT OF PATIENTS. Upon mittal assessment, SECOND PARTY shall evaluate the patient condition and provide an estimate of costs, charges, expenses and fees which may be incurred in the treatment of the patient who will be applying for coverage under the CBHP. This estimate shall be submitted to the Office of the City filegor for application for coverage in the CBHP. The FIRST PARTY may lastue a valid GL which will be submitted by the service patient to the SECOND PARTY for provision of the necessary and appropriate treatment, medical attention and services. Admission under this program/agreement shall be limited strictly to Service Ward facilities of SECOND PARTY.

Should the costs, charges and fees be in excess of the amount covered by the GL, the service patient may apply for additional coverage with the FIRST PARTY only after three (3) months from issuance of the previous GL, and the additional coverage shall be under a new and separate GL.

The SECOND PARTY shall not demand from the service patient bearing a valid GL any deposit or upfront payment as a pre-condition for admission, treatment or discharge. Nor shall it refuse admission by reason of the amount in the GL being deemed as insufficient to cover the patient's complete treatment.

TREATMENT OF EMERGENCY PATIENTS. In case of emergency, the SECOND PARTY shall treat and provide emergency medical treatment to a patient in accordance with applicable laws and regulations. The SECOND PARTY may inform the patient regarding the CBHP and may advise the patient or his family to apply for coverage. The application may also be submitted by the nearest of kin or the patient's family member to the FIRST PARTY in behalf of the patient, and the latter is given the next working day, or official twenty four (24) hours within which to approve or deny such application for GL. Should the application submitted by SECOND PARTY in behalf of the emergency patient remain unacted upon by the FIRST PARTY after the said period shall have lupsed it cannot be deemed approved, but the patient or his family will have to make a personal follow up with the FIRST PARTY or file another application. No GL will be issued without prior personal interview with patient or his family for intake of patient's profile.

The SECOND PARTY shall accommodate emergency calls from the FIRST PARTY's centers for the protection and welfare of children and youth such as the Girls Home. Shelter for Boys and Halfway House at any time of the day.

MEDICAL SERVICES. The SECOND PARTY shall provide the patients, referred by the FIRST PARTY, different types of medical services, taboratory and/or diagnostic services, medicines and other medical products it generally offers to the public. Likewise, the rates of the professional services of medical professionals or practitioners under this Agreement shall also be provided to the FIRST PARTY.

- PSYCHOLOGICAL/PSYCHIATRIC SERVICES. In case of calamities or disaster, whenever, necessary, the health professional who finds that the internally displaced person (IDP) requires psychological assistance, the same may be referred to the SECOND PARTY if Psychological Department is available.
- VISITATION OF PATIENTS. The FIRST PARTY may visit patients covered by the program during designated variation hours for the purpose of monitoring the medical conditions of service patients. The representatives of FIRST PARTY may coordinate this visit with the Office of the Deputy Director for Health Operations, subject to existing laws, rules and hospital regulations on visitation and/or copying or disposition of records. Expenses incurred in relation to this paragraph shall be for the expense of the FIRST PARTY.
- MEDICAL BENEFITS. The SECOND PARTY shall deduct the applicable Philhealth Employees' compensation and other government mandated medical benefits from the billing statement of a service patient. The SECOND PARTY shall be responsible in ensuring that all requirements for the availment of these benefits are duly accomplished and submitted by the patient prior to his discharge;

The SECOND PARTY shall remit to the FIRST PARTY any compensable charges. paid or reimbursed by the PHILHEALTH in excess of the amount deducted by the SECOND PARTY from the account of the patient within thirty (30) days from receipt of payment from Philhealth. Should Philhealth remittance be less than the amount deducted by the SECOND PARTY, the discrepancy shall be included in the monthly billing statement of the SECOND PARTY to the FIRST PARTY;

- ADDITIONAL SERVICES. The SECOND PARTY shall conduct, free of charge. an annual minor surgical-medical mission in an area designated by the FIRST
- BUDGET ALLOCATION. The FIRST PARTY shall allocate from its funds specific budget to be used for payment of its obligations to SECOND PARTY under this Agreement, subject to existing laws, rules and ordinances. The SECOND PARTY shall allow the FIRST PARTY to pay in cash, check or via online transfer in settling the obligations of the latter.
- 10. VALIDITY. This Agreement shall be valid for three (3) year from July 1, 2022 to June 30, 2025. This Agreement shall be subject to renewal after its expiry date. unless either party gives notice of its intention not to renew, at least thirty days prior to expiration. Either party may pre-terminate this agreement on valid and equitable grounds by giving the other party at least thirty days prior written notice.

Should the application submitted by SECOND PARTY in behalf of the emergency patient remain unacted upon by the FIRST PARTY after the said period shall have lapsed it cannot be desired approved, but the petient or his family will have to make a personal follow up with the FIRST PARTY or file another application. No GL will be issued without prior personal interview with patient or his family for intake of patient's profile.

The SECOND PARTY shall accommodate emergency calls from the FIRST PARTY's centers for the protection and welfare of children and youth such as the Girls Home. Shelter for Boys and Hatlway House at any time of the day.

MEDICAL SERVICES. The SECOND PARTY shall provide the patients, referred by the FIRST PARTY, different types of medical services, laboratory and/or diagnostic services medicines and other medical products it generally offers to the public. Likewise, the rates of the professional services of medical professionals or practitioners under this Agreement shall also be provided to the FIRST PARTY.

- PSYCHOLOGICAL/PSYCHIATRIC SERVICES. In case of calambes or disaster, whenever, necessary, the health professional who finds that the internally displaced person (IDP) requires psychological assistance, the same may be referred to the SECOND PARTY if Psychological Department is available.
- VISITATION OF PATIENTS. The FIRST PARTY may visit patients covered by the program during designated visitation hours for the purpose of monitoring the medical conditions of service patients. The representatives of FIRST PARTY may coordinate this visit with the Office of the Deputy Director for Health Operations, subject to existing laws, rules and hospital regulations on visitation and/or copying or disposition of records. Expenses incurred in relation to this paragraph shall be for the expense of the FIRST PARTY.
- MEDICAL BENEFITS. The SECOND PARTY shall deduct the applicable Philibealth Employees' compensation and other government mandated medical benefits from the billing statement of a service patient. The SECOND PARTY shall be responsible in ensuring that all requirements for the availment of these benefits are duly accomplished and submitted by the patient prior to his discharge;

The SECOND PARTY shall remit to the FIRST PARTY any compensable charges paid or reimbursed by the PHILHEALTH in excess of the amount deducted by the SECOND PARTY from the account of the patient within thirty (30) days from receipt of payment from Philhealth. Should Philhealth remittance be less than the amount deducted by the SECOND PARTY, the discrepancy shall be included in the monthly billing statement of the SECOND PARTY to the FIRST PARTY:

- ADDITIONAL SERVICES. The SECOND PARTY shall conduct, free of charge. an annual minor surgical-medical mission in an area designated by the FIRST PARTY:
- BUDGET ALLOCATION. The FIRST PARTY shall allocate from its funds specific budget to be used for payment of its obligations to SECOND PARTY under this Agreement, subject to existing laws, rules and ordinances. The SECOND PARTY shall allow the FIRST PARTY to pay in cash, check or via online transfer in settling the obligations of the latter.
- VALIDITY. This Agreement shall be valid for three (3) year from July 1, 2022 to June 30, 2025. This Agreement shall be subject to renewal after its expiry date. unless either party gives notice of its intention not to renew, at least thirty days prior to expiration. Either party may pre-terminate this agreement on valid and equitable grounds by giving the other party at least thirty days prior written notice.
