Subject: **PCR- 022 – 2025 - A RESOLUTION FOR RECOMITTMENT FOR STABLE INTERNAL PEACE AND SECURITY (SIPS) IN THE CITY OF BACOOR**

FINDINGS:

An endorsement letter dated 16th June 2025 was referred to the Committee on Peace and Order and Public Safety from the office of the City Administrator requesting for a Resolution for the recommitment to Stable Internal Peace and Security upon the assumption to the office of the newly-elected local officials. This is in relation to the Section 16 of the Republic Act No. 7160 (the "Local Government Code of 1991") which mandates all Local Government Units (LGUs) to guarantee and maintain peace and order within its respective areas of jurisdiction. This is also in relation to the City Resolution No. 2024-569 passed last August 2024 entitled: A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF BACOOR, CAVITE REPRESENTED BY ITS CITY MAYOR, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE ARMED FORCES OF THE PHILIPPINES – TASK FORCE UGNAY, 2ND INFANTRY DIVISION, PHILIPPINE ARMY REGARDING THE DECLARATION OF STABLE INTERNAL PEACE AND SECURITY (SIPS) IN THE CITY OF BACOOR, CAVITE".

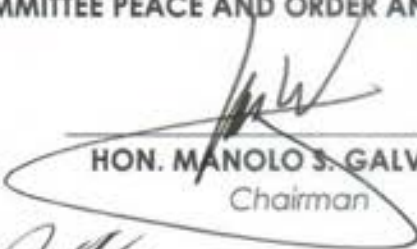

Greetings from your Army in Southern Tagalog!

With the proclamation of newly-elected officials following the Mid-National and Local Elections 2025, the 202nd Infantry (Unifier) Brigade looks forward to continuing engagements with Local Government Units (LGUs) to sustain the Stable Internal Peace and Security (SIPS) status in CALABARZON. To recall, as defined in the Revised Joint Implementing Rules and Regulations to Executive Order No. 546 in relation to EO 110, series 2015, SIPS is the stage where the locality is "...categorized as *Cleared and Unaffected and are relatively peaceful*. The LGU-PNP acknowledges and accepts that only LEOs (referring to Law Enforcement Operations) are needed." and will signify that the area is already normalized.

Along this line, even as the existing SIPS Memorandum of Understanding (MOU) entered into between the LGUs and this Brigade remain effective, this Brigade would like to request for the issuance of a Memorandum to the DILG Provincial Directors and the City and Municipal Local Government Operations Officers (LGOOs) to recommend to the newly-elected Local Chief Executives and the Presiding Officers of the Sanggunian for a Resolution of Re-Commitment to Stable Internal Peace and Security. This recommendation is aimed at reiterating the obligations of LGUs to conduct activities designed to enhance Law Enforcement Operations and prevent the resurgence of the Communist NPA Terrorists. LGUs are also obliged to ensure that community development efforts and people empowerment activities are being conducted by different agencies within their respective fields to prevent and counter Communist Terrorist Group (CTG) Ideological, Political and Organizational (IPO) works to recover loss mass bases and network of supporters.

To more thoroughly discuss the SIPS, this Brigade respectfully requests for the inclusion of the SIPS MOU in the mandatory training for Newly-Elected Officials (NEO). This initiative aims to reaffirm the commitment of all stakeholders to uphold the gains of peace and ensure the continuity of peace-building, development, and conflict-prevention programs. Recommitting to the SIPS will reinforce collaboration and align future initiatives with the national government's peace and security agenda.
