







Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A DEED OF DONATION ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH MASAITO DEVELOPMENT CORPORATION RELATIVE TO ITS INTENT TO DONATE ROAD LOTS LOCATED AT MASAITO DRIVE, BARANGAY MOLINO 3, BACOOR CITY, CAVITE. (PCR 035-2025 dated July 14, 2025).

The committee held a joint committee hearing on July 17, 2025, at 9:10 am. It was presided over by the Chairperson of the Committee on Housing, Land Utilization and Urban Development, Hon. Horacio M. Brillantes Jr. The minutes, attendance sheets, and pictures taken during the said hearing are attached hereto and shall be made integral parts of this report.

FINDINGS:

Under the Local Government Code of 1991 (Republic Act No. 7160), LGUs are empowered to acquire, hold, and manage real property for the benefit of their constituents. Section 22(c) of the Code specifically allows LGUs to "enter into contracts and such other transactions as may be necessary" in the exercise of their corporate powers, including accepting donations of real property such as roads, provided these donations are duly approved by the local sanggunian.

Masaito Development Corporation has expressed its formal intent to donate seven (7) road lots to the City Government of Bacoor. These lots collectively constitute a single

road that currently functions as a vital access route connecting Molino Boulevard to Bahayang Pag-asa.

At present, the road includes a guardhouse, and users are required to pay a fee in order to pass through. However, once ownership of the road lots is officially transferred to the City Government, the guardhouse will be removed, and the practice of collecting passage fees will be discontinued. Consequently, the road will be converted into a public city road, fully accessible to all residents and motorists free of charge. This transition is expected to significantly enhance public access, reduce transportation costs, and improve traffic flow in the area—ultimately benefiting the general public and contributing to the city's urban development goals.

Furthermore, road lots donated for public use, once accepted by the LGU and classified accordingly, become public property and form part of the public domain. They must then be maintained using local government resources and opened for free and unrestricted access, in line with the principle of public utility and welfare.

The joint committee hearing was executed on July 17, 2025, at the 6th Floor Pantry of the Sangguniang Panlungsod. City Councilor Honorable Horacio Brillantes, Jr. presided over the Joint Committee Hearing and was called to order at exactly 9:10 AM and proceeded with the roll call.

Masaito Development Corporation intended to donate the Masaito Drive (Solidarity Route from Molino Boulevard going to Bahayang Pag-Asa Subd.) to the City Government of Bacoor. Engineer Marvin Mejico mentioned nine (9) road lots will be donated. Honorable Reynaldo Palabrica clarified that there are only seven (7) road lots in the list submitted to the City Government. Masaito Development Corporation must submit an amended copy of the list of roads lots to be donated.

Engineer Mejico advised that the collection of convenience fee being administered by the Masaito Development Corporation security will be discontinued once the deed of donation has been approved.

Engineer Arthur San Jose mentioned that some lots are being tagged as unknown due to non-payment of Real Property Tax. Engineer Mejico informed that the nine (9) road lots in their inventory are updated in the payment of the Real Property Tax.







DEED OF DONATION AND ACCEPTANCE

KNOW ALL MEN BY THESE PRESENTS:

This Deed of Donation and Acceptance ("Deed") is made and executed by and between:

MASAITO DEVELOPMENT CORPORATION, a duly organized and existing association under the laws of the Republic of the Philippines, with office address at 3rd Floor Masaito Square Corner Citihomes Subd. Molino IV, Bacoor City, Cavite, herein represented by its Technical Services Manager, ENGR. MARVIN MEJICO, pursuant to his authority conferred and embodied in Secretary's Certificate dated ______1, hereinafter referred to as the "DONOR";

and

The CITY GOVERNMENT OF BACOOR, a local government unit created and existing under the laws of the Republic of the Philippines, with principal office and postal address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Cavite, represented herein by its City Mayor, HON. STRIKE B. REVILLA, pursuant to his authority conferred and embodied in City Resolution No. ____2, hereinafter referred to as the "DONEE").

Both shall be collectively referred to as the "Parties".

WITNESSETH:

WHEREAS, the DONOR is the registered owner and developer of Masaito Drive located at Molino III, Baccor City, Cavite;

WHEREAS, as the developer of the Subdivision, the DONOR provides adequate roads, alleys, sidewalks, and other open spaces inside the subdivision, pursuant to Presidential Decree (P.D.) No. 957, as amended by P.D. No. 1216;

WHEREAS, the DONOR has already been issued with a Certificate of Completion for the development of the Subdivision by the Department of Human Settlements and Urban Development (DHSUD) dated _____;³

WHEREAS, the DONOR is the registered owner of the following road lots comprising the Masaito Drive (collectively "Subject Properties")

WHEREAS, the Masaito Drive has been designated as a Solidarity Route by the City Government of Baccor;

WHEREAS, the DONOR has paid all the real property taxes due on the Subject Properties that will be donated to the DONEE;6

WHEREAS, the DONOR issued and adopted Board Resolution No. ____ wherein it intends, authorizes, and resolves to donate the Subject Properties to the City Government of Bacoor, in accordance with the law;

NOW, THEREFORE, for and in consideration of the foregoing and the terms and conditions hereinafter set forth, the Parties hereby agree, as they have agreed, as follows:

- The DONOR hereby voluntarily and freely gives, transfers, and conveys by way
 of donation unto the DONEE, its successors, and assigns (as the case may be)
 all its rights, interests, titles, and participations over the Subject Properties
 together with the improvements thereon but excluding all the water lines
 attached to the road lots free from all liens and encumbrances.
- The DONOR affirms that this donation is not made with the intent to defraud its creditors, and that it has sufficient funds and properties reserved for itself.
- All taxes, fees, charges, and expenses necessary for transferring the certificate
 of title and tax declaration pertaining to this donation shall be borne by the
 DONOR.
- The maintenance of the Masaito Drive shall be the responsibility of the DONEE immediately after the signing of this Deed;
- This Donation shall be subject to the following restrictions:
 - The DONEE shall use the following road lots only for the specific purpose for which they are respectively intended.
 - ii. The use or conversion of the road lots, or any portion thereof, for purposes other than the specific purpose for which each of them is respectively intended by any person or entity shall entitle the DONOR, the DONEE, or any interested person or persons, as the case may be, to any and all injunctive relief with damages against the person or entity(ies) responsible

- therefore and to demand the latter to demolish at his/her/its own expense any and all such constructions built thereon, if there be any.
- iii. The DONEE shall grant the DONOR, its affiliates, subsidiaries, employees, successors, and assigns, a perpetual RIGHT OF WAY, including the free ingress and egress into the DONOR's subdivision projects along the Masaito Drive, in order to conduct repairs and maintenance on the DONOR's unsold units and other ongoing work items. DONOR is identified in this case as Masaito Development Corporation, and its affiliate companies, Richfield Properties Incorporated, and Citihomes Builder and Development Incorporated.

ACCEPTANCE

- The DONEE hereby receives and accepts this donation made in its favor by the DONOR and hereby expresses its gratitude for the kindness and generosity of the DONOR.
- This Deed shall be binding upon and inure to the benefit of the parties hereto and their respective permitted successors and assigns.
