A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A DEED OF DONATION ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH ECOTREND SUBDIVISION PHASE 5 HOMEOWNERS' ASSOCIATION RELATIVE TO THEIR INTENT TO DONATE OPEN SPACES TO THE CITY GOVERNMENT OF BACOOR. (PCR 036-2025- dated July 14, 2025).

The committee held a joint committee hearing on July 17, 2025, at 9:45 am. It was presided over by the Chairperson of the Committee on Housing, Land Utilization and Urban Development, Hon. Horacio M. Brillantes, Jr. The minutes, attendance sheets, and pictures taken during the said hearing are attached hereto and shall be made integral parts of this report.

#### FINDINGS:

The company has been under court-supervised rehabilitation for the past fifteen (15) years due to financial challenges and operational difficulties. Initially, the management of the company was handled by its founders, the late Mr. Enrique Trinidad and the late Mrs. Aurora Trinidad. Since both have passed away, the company is now being managed by their children, who have assumed full responsibility for overseeing the business and ensuring compliance with the rehabilitation plan.

The current management is continuing efforts to stabilize the company's financial position, address outstanding obligations, and restore the company's viability. However, it is important to note that despite the ongoing rehabilitation process, there remain unresolved financial liabilities, particularly in relation to real property tax obligations.

One significant issue that the company currently faces is the status of the real property

tax for properties under its name, particularly those within Ecotrend Subdivision Phase 5 located in Barangay Ligas 3.

As of this writing, the payment of real property taxes is not up to date. The company has not settled its obligations for several years, and the current management has admitted that they are uncertain whether the company has the financial capacity to pay the accumulated real property taxes at this time.

This unresolved tax liability poses a potential obstacle to formal processes such as the donation or turnover of open spaces to the local government, as real property tax clearance is typically a requirement for such legal transactions. The company is currently assessing its financial standing and exploring possible options, including negotiation with the local government for possible settlement schemes, condonation, or restructuring of the unpaid taxes.

Ecotrend Subdivision Phase 5 was officially turned over to the Homeowners' Association (HOA) in 1996. Since then, the HOA has taken on the responsibility of maintaining the subdivision and promoting the welfare of its residents. The HOA has recently expressed the intention to formalize the donation of open spaces within the subdivision to the City Government, as part of efforts to legitimize and preserve these areas for public use, especially for recreational and community activities. These spaces are essential for the health and well-being of the residents and serve as communal areas for gatherings, leisure, and environmental preservation.

The company has no objection to the intention of the Homeowners' Association (HOA) to donate these open spaces to the city government, provided that the areas being referred to are properly identified and confirmed to be genuinely used for recreational or community purposes. It is essential that the classification of these spaces aligns with their actual use specifically, that they are functioning as parks, playgrounds, or similar community spaces that benefit the residents.

Proper documentation, site validation, and a formal agreement process will need to be undertaken to ensure that the donation complies with local government regulations and urban planning standards. The company, through its current management, has expressed its willingness to cooperate fully with the Homeowners' Association (HOA) and relevant government offices in order to facilitate this process.

#### RECOMMENDATION:

In view of the foregoing, the committees respectfully recommends that the proposed city resolution mentioned above be TEMPORARILY ARCHIVED.



With the passing of the founders of Ecotrend Development, the company was inherited and now being managed by their children; it is also under rehabilitation for fifteen (15) years.

Open spaces of Ecotrend Subdivision Phase 5 are intended to be donated to the City Government of Bacoor. Titles of the aforementioned open spaces have not been turned over to the Homeowners' Association Board of Directors and must be handed over to them by the developer.

City Councilor Reynaldo Palabrica instructed the City Assessor's Office to help the HOA Board of Directors to identify the intended open spaces for donation in order to secure the copies of lot titles from the developer.

Ms. Agnes Pacio also advised that the subdivision plan is not updated when they verified it from the City Assessor's Office, an approved plan must be submitted for the tax declaration and settlement of the Real Property Tax.

Ms. Agnes Pacio will schedule a meeting with her employer to discuss the outcome of the hearing to work out on all of the concerns.

Honorable Reynaldo Palabrica moved for the suspension of the Joint Committee Hearing and was duly seconded by the presiding officer City Councilor Honorable Horacio Brillantes, Jr. The Joint Committee Hearing was suspended at exactly 10:15 AM.


