The referral of the above subject matter was made during the 3rd Regular Session on the 6th Sangguniang Panlungsod on July 21, 2025. A committee hearing was convened on August 7, 2025 considering a letter from Mr. Geronimo Del Rosario, Head of the Public Safety Department which was endorsed by the Office of the City Administrator.

FINDINGS:

An ocular inspection was conducted and evaluated by the Public Safety Department that the billboards located at Kaunlaran, Longos, Barangay Zapote 3 poses an imminent threat to the public safety due to its current condition and placement. Furthermore, the said billboards are in violation of applicable building, zoning, and /or safety regulations of the City of Bacoor

A letter received 4th of July, 2025, from the Office of the City Administrator and was referred to the Committee on Peace and Order and Public Safety requesting for a resolution authorizing the City Mayor to officially declare the above-mentioned billboards as nuisance and to authorize the Hon. City Mayor to order its removal / dismantling of these billboards through the Department of Public Safety in coordination with the City Engineering Office.

RECOMMENDATION:


In view of the foregoing, the Committee respectfully recommends that the proposed resolution mentioned above be **APPROVED**.



The letter contained the recommendations from Mr. Del Rosario on the imminent threat on the public safety of the Billboards located at Kaunlaran, Longos, and Barangay Zapote 3. These billboards, a picture attached to the letter, showing a burned and rusty billboard which can be considered hazardous to the people living around the it.

Considering the current status of the subject billboards, representative from the City Engineering Office suggest for the declaration and immediate dismantling of the said billboards to avoid any tragedy brought about by the collapse of these billboards.

As per the City Legal Services representative, Atty. Valenciano, it would be in the best interest of the City of Bacoor for the dismantling of the said billboards. This is also to avoid any accidents and injuries to the residence.

Hearing all the facts and comments from all the representatives, Hon. Galvez asked if there is any more question. Hearing none, Hon. Dominguez raised a motion for the adjournment of the said hearing. And was seconded by the Hon. Francisco.

The motion was approved by Hon Galvez. The committee hearing was adjourned at 10:57 am

A RESOLUTION DECLARING THE BILLBOARD LOCATED AT KAUNLARAN, LONGOS, BARANGAY ZAPOTE 3, BACOR CITY, CAVITE AS A NUISANCE PER SE AND AUTHORIZING ITS IMMEDIATE REMOVAL SO AS NOT TO ENDANGER PUBLIC SAFETY.

WHEREAS, on 4 July 2025, the Public Safety Department informed the Honorable Mayor Strike B. Revilla through the City Administrator that the billboard located at Kaunlaran, Longos, Barangay Zapote 3 was burnt and dilapidated and that it is endangering life and property in the said vicinity based on ocular inspections conducted by the said department.

WHEREAS, on 15 July 2025, the City Administrator's Office formally requested the Sangguniang Panlungsod to pass a resolution declaring the billboard located at as a nuisance per se.

WHEREAS, the aforementioned matter was referred to the Committee on Peace and Order and Public Safety and to the Committee on Rules, Privileges, Laws and Ordinances;

WHEREAS, on 7 August 2025, the said joint committee conducted a hearing and decided to recommend that the billboard be considered a threat to public safety and for it to be declared as a nuisance per se.

NOW THEREFORE, upon motion of Hon. Manolo S. Galvez, Jr., unanimously seconded by the City Council in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite to pass a resolution declaring the billboard located at Kaunlaran, Longos, Barangay Zapote 3, Bacoor City, Cavite as a nuisance per se and authorizing its immediate removal so as not to endanger public safety.

RESOLVED FURTHER, to furnish the Office of the City Mayor, the Public Safety Department, the Barangay Officials of Zapote 3

and other government agencies concerned with copies of this resolution.
