

Subject: A LETTER OF COMPLAINT FROM MR. RAMIL P. SIXSON AGAINST BARANGAY COUNCILOR AURELIO "JHAYE" MARTIN JR. OF BARANGAY SALINAS 1 FOR THE ALLEGED GRAVE MISCONDUCT OF BARANGAY OFFICIALS AND VIOLATION OF THE LOCAL GOVERNMENT CODE OF THE PHILIPPINES (PCR 056-2025 dated 04 August 2025).

The said complaint was referred to this Committee by the Acting Chair, Hon. Catherine Sarino-Evaristo, during the  $5^{th}$  Regular Session of the  $6^{th}$  Sangguniang Panlungsod on August 04, 2025.

Committee Chair Hon. Miguel N. Bautista informed the Council members that the committee will not accept the said complaint because it was not duly-notarized and it did not conform with the prescribed form for such a complaint as mandated under Sections 2, 3, 4 and 5 of Rule 4 of City Ordinance No. 362-2024 (otherwise known as the "2024 Rules for Barangay Administrative Cases").

#### RECOMMENDATION:

In view of the foregoing, the Committee respectfully recommends to disregard the said complaint since it did not conform with the prescribed form and to remove the said subject matter from the Council's next order of business.
