Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, ON BEHALF OF THE CITY GOVERNMENT OF BACOOR TO SIGN A DEED OF DONATION WITH NEW PACIFIC RESOURCES MANAGEMENT INC. REGARDING THE DONATION OF OPEN SPACES, ROAD LOTS, AND OTHER EXCLUDED AREAS OF SOLVIENTO VILLAS PHASE 1, PHASE 2 AND PORTION OF PHASE 3 AT BACOOR BLVD., MAMBOG IV, BACOOR CITY, CAVITE. The committee held a joint committee hearing on August 27, 2025, at 11:23 AM. It was presided over by the Chairperson of the Committee on Housing, Land Utilization and Urban Development, Hon. Horacio M. Brillantes, Jr. The minutes, attendance sheets, and pictures taken during the said hearing are attached hereto and shall be made integral parts of this report.

Pursuant to Presidential Decree No. 957, as amended by Presidential Decree No. 1216, a subdivision developer may manifest willingness to donate open spaces, road lots, and other reserved areas to the local government unit (LGU) for public use and community welfare. Such donation requires the execution of a Deed of Donation, which must be formally accepted by the LGU through a Sangguniang Panlungsod or Sangguniang Bayan resolution, and accompanied by documentary requirements including the approved subdivision plan, corresponding land titles, tax clearance, and relevant permits to ensure proper transfer and legal recognition of the donated property.

FINDINGS:

The New Pacific Resources Management Inc. has formally expressed its collective desire and intention to donate the designated open spaces, road lots, and other excluded areas of Solviento Villas Phase 1, Phase 2, and a portion of Phase 3 to the City Government of Bacoor.

During the committee hearing, it was emphasized that certain documentary and development requirements must first be complied with prior to the processing and approval of said donation. However, the proponents have not yet submitted the following:

- 1. Homeowners' Association Board Resolution of No Objection;
- 2. Certified copies of the land titles and tax declarations;
- DHSUD Certificate of Completion, or in the absence thereof, an Affidavit of Undertaking with proof of application filed before DHSUD;
- 4. Local Government Unit inspection report for DHSUD issuance;
- 5. Documentary stamp tax and other applicable fees;
- 6. Draft Deed of Donation; and
- 7. Tax Clearance.

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Joint Committee hereby recommend to TEMPORARILY ARCHIVE the proposed city resolution authorizing the City Mayor, Hon. Strike B. Revilla, on behalf of the City Government of Bacoor to sign a deed of donation with New Pacific Resources Management Inc. regarding the donation of open spaces, road lots, and other excluded areas of Solviento Villas Phase 1, Phase 2 and portion of Phase 3 at Bacoor Blvd., Mambog IV, Bacoor City, Cavite.

The joint committee hearing was executed on August 27, 2025, at 11:23 AM at the Sangguniang Panlungsod Session Hall, 6th floor, Bacoor Legislative & Disaster Resilience Building, Bacoor Government Center, Bacoor Boulevard, Brgy. Bayanan, City of Bacoor, Cavite. It was presided over by Committee on Housing, Land Utilization and Urban Development Chairman, Honorable Horacio Brillantes, Jr. and proceeded with the roll call.

Before proceeding with the committee hearing, Honorable Reynaldo Palabrica inquired about the real property tax status of Solviento Villas. Ms. Carol Marges from the Treasury Department reported that, based on the tax declaration of Solviento Villas, the real property taxes have been paid up to the current year.

With regard to the donation to the City Government, it was clarified that before proceeding, New Pacific Resources Management, Inc. must comply to the list of requirements for the approval of the donation. All essential development requirements must first be complied with.

According to Atty. Marco Mendoza, they must also submit certified copies of the land titles and tax declarations. The Zoning and Land Development Department, through Engr. Arthur San Jose, likewise requested additional requirements to be submitted before the donation may proceed:

- A Homeowners' Association Board Resolution of No Objection regarding the donation.
- A Certificate of Completion issued by DHSUD (Department of Human Settlements and Urban Development), or if the project is still ongoing, an Affidavit of Undertaking together with a duly received application by DHSUD.
- The Local Government Unit's inspection report as a requirement for the issuance of the DHSUD Certificate of Completion, along with other provisions related to documentary stamp tax, other applicable fees.
- 4. The draft of the Deed of Donation, Tax Declarations, and the Tax Clearance.

The City Legal Department will conduct a presentation of the actual documents for comparison purposes. The same process will be observed in the execution of the Deed of Donation for Solviento Villas.

Honorable Reynaldo Palabrica stated that once the Legal Department reports that all requirements have been fully complied with, the Committee shall reconvene for possible approval of the proposed donation. He then moved for the suspension of the joint committee hearing, which was duly seconded by the Presiding Officer, Honorable Horacio Brillantes, Jr.

The joint committee hearing was adjourned at exactly 11:40 AM.
