The above-mentioned proposed resolution underwent its first reading on August 04, 2025 during the 5th Regular Session of the 6th Sangguniang Panlungsod. The said proposed resolution was referred by the Acting Presiding Officer, City Councilor and President Pro-Tempore Hon. Reynaldo C. Palabrica the Committee on Rules and Privileges, Laws and Ordinances.

The Committee on Health and Sanitation sent out invitations to the resource persons and conducted a committee hearing on September 11, 2025, 10:00 a.m. at the Session Hall of the Sangguniang Panlungsod. After due consultation and deliberation hereby report back to this August Body the findings, information gathered, and recommendation on the above-subject matter. Attached hereto are the attendance sheet and photos taken during the said hearing.

FINDINGS:

Local Legislation under the Local Government Code (R.A. 71600 refers to the authority of local government units (LGUs) to enact laws, referred to as ordinances, and to adapt resolutions that address the needs of the local community within the framework of the law.

An Executive-Legislative Agenda (ELA) is a mutually developed, three-year plan for a local government unit that outlines the shared priorities and strategic

directions of both the executive and legislative branches for the local government's development.

The members of the 6th Sangguniang Panlungsod of the City of Bacoor prepared a list of proposed legislative measures in support of the Executive Agenda of the City Mayor, Hon. Strike B. Revilla.

The said legislative measures, after it was publicly heard was revised by the Sangguniang Panlungsod and incorporated the ideas and suggestions of the stakeholders and came up with a revised list of proposed legislative measures in support of the Executive Agenda of the City Mayor for 2025-2028.

Drafting of the ordinances and resolutions in the legislative measures will be done in cooperation with the Office of the City Administrator, Office of the City Legal Service and the Sangguniang Panlungsod.

After a thorough review of all the circumstances and statements from the resource persons, and the provisions of the proposed resolution, the Committee respectfully recommends that the Sangguniang Panlungsod approve the above subject matter on 2nd reading during its next regular session.
