Subject: A RESOLUTION ADOPTING THE REGIONAL DEVELOPMENT COUNCIL RESOLUTION NO. IV-A-37-2025 REGARDING THE TUTOK KAINAN DIETARY SUPPLEMENTATION PROGRAM OF THE NATIONAL NUTRITION COUNCIL. (PCR 078-2025 dated August 11, 2025).

The committee held a joint committee hearing on August 27, 2025, at 10:22 am. It was presided over by the Chairperson of the Committee on Social Services, Hon. Horacio M. Brillantes Jr. The minutes, attendance sheets, and pictures taken during the said hearing are attached hereto and shall be made integral parts of this report.

The Tutok Kainan Dietary Supplementation Program (DSP) is one of the flagship programs of the National Nutrition Council (NNC), specifically designed to address the persistent and widespread issue of malnutrition in the country. It targets the most nutritionally vulnerable sectors of our population, especially during the first 1,000 days of life—from conception up to two years old—which is considered a critical window for a child's physical and cognitive development.

FINDINGS:

Currently, we are implementing existing nutrition interventions through the Complementary Feeding Program under the City Child Protection Council (CCPC), which includes feeding for nutritionally at-risk children, and the First 1,000 Days (F1K) Feeding Program for pregnant women, also under the CCPC. However, a significant update in the Tutok Kainan DSP is that the program must now be implemented for a full 180 days, instead of the previously shorter duration.

To support this, a proposal of the adoption of a local resolution that will authorize the request for additional funding to ensure the full 180-day implementation period. This resolution is essential for the sustainability and continuity of the program and will allow us to better address the nutritional needs of our target beneficiaries.

For the current year, the implementation is a 120-day feeding program, with 89 days already completed as of this report. The program beneficiaries include all nutritionally atrisk individuals identified through our Barangay Nutrition Scholar (BNS) Program.

In the Complementary Feeding Program, the main beneficiaries are children 6 months old and above who have been identified as undernourished or at risk of malnutrition. The Tutok Kainan DSP covers the broader scope of the first 1,000 days, from pregnancy up to 2 years of age, ensuring that both mothers and their children receive adequate nutrition support during this critical developmental stage.

Over the years, our city has shown significant improvements in its efforts to reduce malnutrition. Each year, we have consistently received the Green Banner Seal of Compliance Award, a recognition given to local government units that demonstrate excellence in implementing nutrition programs. This indicates a continuous decline in the prevalence of malnutrition in our locality.

However, despite our progress, there is still room for improvement. From being ranked 1st in the Province of Cavite in previous years, we are now ranked 14th. This decline emphasizes the need to strengthen and sustain our nutrition programs, particularly by ensuring the successful and complete implementation of the Tutok Kainan DSP.

With the support of our local government officials, stakeholders, and the community, and, more importantly, continue to improve the health and well-being of our constituentsstarting with proper nutrition in the earliest stages of life.


RECOMMENDATION:



program of the National Nutrition Council addressing the persistent existence of malnutrition in the country, which consists of stunting, wasting and underweight. This also includes the First One Thousand (F1K) days from pregnancy up to 2 years of age. This program should run for one hundred and eighty (180) days.

This program previously functions and was patterned after the supplementary feeding program for the daycare learners and children between the ages of three (3) to five (5) years old, which follows the one hundred and twenty (120) days guidelines. However, this updated complementary feeding program for children six (6) months old should run for one hundred and eighty (180) days.

With the current 120 days program that the city is implementing, the adoption of this resolution may also be used to request for additional funding for the continuity of the program.

The Tutok Kainan Dietary Supplementation Program will cater those who are nutritionally at-risk children 6 months old and above and the pregnant women as identified by the Barangay Nutrition Scholars (BNS) from the forty-seven (47) barangays.

Councilor Manolo Galvez cited that there must be a close coordination between the CSWD and the City Nutrition Council to properly identify the nutritionally at-risk beneficiaries of the program.

Honorable Reynaldo Palabrica recommended for the resolution to be approved and was seconded by the other Council members. The Joint Committee hearing was adjourned and seconded at exactly 10:40 AM.

Dear Hon. Sarino-Evaristo.

Greetings in the name of public service!

Under Section 17 of Republic Act No. 7160, local government units are mandated to discharge functions and responsibilities of national agencies and offices devolved to them under the Code, including the discharge of functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities including nutrition services for women and children, particularly those in vulnerable sectors.

In June 2024, the Regional Development Council of Region IV-A passed a resolution mandating all member local government units to implement a targeted dietary supplemental feeding program for children aged 6-23 months for 180 days. The said resolution also requires that the feeding program for nutritionally at-risk pregnant mothers include teenage pregnancies. While the City is currently implementing a feeding program for children aged 6-23 months, the said program runs only for 120 days.

In line with the new directive from the Regional Development Council, the city recognizes the need to strengthen its efforts in implementing nutrition programs, particularly the feeding program for target children and pregnant mothers, by providing additional funding or partnering with stakeholders in order to support the program's expanded implementation.

In light of the foregoing, I respectfully request the esteemed members of the Sangguniang Panlungsod to enact a resolution adopting the RDC Resolution for *Tutok Kainan* Dietary Supplementation Program. Attached here is a copy of the said resolution for reference.

RDC RESOLUTION NO. IV-A-37-2025

"ENDORSING TO ALL LOCAL GOVERNMENT UNITS IN CALABARZON THE TUTOK KAINAN DIETARY SUPPLEMENTATION PROGRAM OF THE NATIONAL NUTRITION COUNCIL"

- the National Nutrition Council (NNC) CALABARZON has requested the Sectoral WHEREAS, Committee on Social Development and Social Protection to endorse Regional Sub-Committee on Nutrition (RSCN) Resolution No. 1, series 2025, entitled "Enjoining All LGUS in CALABARZON to Adopt the Tutok Kainan Dietary Supplementation Program (TK DSP)":
- WHEREAS. the TK DSP is a flagship initiative of the NNC under the National Dietary Supplementation Program of the Philippine Plan of Action for Nutrition, which aims to provide targeted dietary supplementation for children aged 8 to 23 months for 180 days and for nutritionally-at-risk pregnant women for 90 days;
- from 2021 to 2024, CALABARZON was among the project beneficiaries of the TK DSP, WHEREAS. with 57 local government units (LGUs) from the provinces of Cevite, Laguna, Rizal, and Quezon, and a total of 8,935 beneficiaries;
- WHEREAS. in line with the Devolution Transition Plan (DTP) of the NNC, the TK DSP is one of the programs specified for adoption and funding by LGUs, consistent with the full devolution of certain national functions to local governments;
- WHEREAS, under the DTP, the TK DSP shall be fully devolved to municipalities not identified as priority areas, including full financial responsibility for all program components such as the procurement, preparation and distribution of commodities;
- the RSCN, through the NNC CALABARZON, shall continue to provide technical WHEREAS. guidance, assistance, orientations, and capacity-building activities for LGUs and Local Nutrition Focal Points to ensure effective implementation, as well as monitoring and reporting mechanisms;
- WHEREAS. the Sectoral Committee on Social Development/Social Protection, during its 2025 second quarter meeting on May 6, endorsed to the RDC for subsequent endorsement to all local government units in CALABARZON the continued implementation of the Tutok Kainan Dietary Supplementation Program of the National Nutrition Council;
- NOW THEREFORE, on motion duly seconded, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to endorse to all local government units in CALABARZON the Tutok Kainan Dietary Supplementation Program of the National Nutrition Council.
